# Sandeshkhaliagitation was BJP's ploy to win: CM

She has urged the voters not to vote for the BJP in this Lok Sabha polls

incident Sandeshkhali was a blueprint prepared by the BJP to win the polls in West Bengal, alleged chief minister Mamata Banerjee at Birbhum today, a day before the third phase of election in the state.

Speaking at an election rally in favour of Birbhum TMC candidate Shatabdi Roy, the TMC chief said that one day the truth will be definitely exposed, but can the BJP return the amount of social losses these women have suffered since the past few months.

The truth will be exposed, pointing at the viral audio and video of Sandeshkhali a few days ago, she said.

"They had planned to defame the sisters and mothers of Sandeshkhali. For them money has never been a big factor but the real factor for them has always been social respect," the chief minister added.

Pointing fingers at both the Prime Minister Narendra Modi and Union home minister Amit Shah, she asked what will be the future of those 26,000 teachers. "Narendra Modi and Amit Shah are brothers in arms. Tell me why you don't say anything about the Vyapam scandal, which had occurred in your BJP-ruled state of Madhya Pradesh. Many persons who were related to that Vyapam scam have been murdered," the TMC chief said.

She has urged the voters not to vote for the BJP in this Lok Sabha polls otherwise they will implement CAA, NRC and uniform civil code in the country.

"As long as I am the chief minister of the state, I will not allow the Centre to implement CAA, NRC or uniform civil code in the country. I will give my life but will never surrender before the BJP," Miss Mamata Banerjee said.

Since the last three years the funds of 100 days' NREGA have been stopped by the Centre, but her government has brought a Karmashree scheme to provide jobs for at least 50 days, the CM said. At her election rally in Durgapur the chief minister reiterated that the BJP will not cross 200-mark in the Lok Sabha polls.

Few days ago, Prime Minister Narendra Modi stated in an election campaign in Bengal that Trinamul Congress will get 15 seats and the Congress 50 seats in the Lok Sabha polls.



#### Indian Coast Guard intercepts Iranian fishing vessel



**NEW DELHI, 6 MAY** 

In a swift sea-air coordinated operation, the Indian Coast Guard (ICG) successfully intercepted and detained an Iranian fishing vessel off the Kerala coast, west of Beypore. The boat has been brought to Kochi, Kerala for further investigations.

"The detention of a foreign fishing boat by the ICG, with (six) Indian crew onboard, once again highlights the complexities of maritime security and the challenges being faced by any maritime law enforcement

whether it was involved in any anti-national activity.

Investigations revealed that the boat is owned by an Iranian sponsor named Syed Saud Ansari, who had employed six Indian fishermen (from Kanyakumari region in Tamil Nadu) by issuing them Iranian Visas for fishing off Iran Coast in his boat. The crew alleged that the sponsor had been ill-treating them and not providing them with even basic living conditions. Further, they also alleged that the sponsor confiscated their passports. The crew subsequently decided to escape from Iran to India using the same boat.

The stage is set for voting in the third phase of the 18th Lok Sabha election on Tuesday in 93 constituencies spread over 11 states and Union territories.

The voting is scheduled to commence at 7 am in all the polling stations amid tight security to avert any untoward incident, and culminate at 6 pm.

Of the 93 Lok Sabha seats going to polls in the third phase, 25 are from Gujarat, 14 from Karnataka, 11 from Maharashtra, 10 from Uttar Pradesh, nine from Madhya Pradesh, seven from Chhattisgarh, five from Bihar, four each from West Bengal and Assam, two each from Goa, Dadra and Nagar Haveli, and Daman and Diu.

# Battleground Bengal: Fate of 57 candidates in 4 constituencies to be sealed in 3rd phase today

In Maldah (Uttar), a total of 18,48,918 voters, including 9,08,854 female voters will exercise their democratic rights

he fate of 57 candidates, including that of the CPI(M) Politburo member and Secretary in West Bengal Mohd Salim, will be sealed on Tuesday in the third phase of elections in four Lok Sabha constituencies.

The four constituencies that will be going for polls on Tuesday include Maldaha-Uttar, Maldaha-Dakshin both in Malda District and Murshidabad and Jangipur in Murshidabad district. A total of 36,18,925 voters, including 17,85,791 women will exercise their franchise in two parliamentary constituencies -Maldah (Uttar) and Maldah (Dakshin) tomorrow when the third phase of polling will be conducted across the country tomorrow.

In Maldah (Uttar), a total of 18.48,918 voters, including 9,08,854 female voters will exercise their democratic rights. On the other hand, 17,70,007 electors, including 87,6,937 women will elect their Member of Parliament from Maldah (Dakshin). Notably, two Assembly segments Farakka and Samserganj in Murshidabad district are under Maldah (Dakshin) Lok Sabha seat.

In Malda district a total of 144 companies of Central Forces have been engaged for conducting a free and fair polling in polling stations. The state police forces have been engaged in elections by setting up 30 police booth across the district to maintain law and order.

A total of 8,190 polling personnel for Maldah (Uttar)

It may be noted that the two

LS seats were under the control of the Congress. In 2019, the BJP candidate Khagen

Murmu, a former CPM leader,

was elected from the Maldah (Uttar) LS seat by defeating both the Congress and Trinamul Congress candidates.

Significantly, the TMC candidate Mousam Noor, was in second position. Ms Noor was elected as an MP from this seat in 2009 and 2014 on Congress ticket. As a result Trinamul Con-

gress, under the leadership of chief minister Mamata Banerjee is trying hard to win a Lok Sabha seat from Malda district in 2024 by fielding a former IPS officer Prasun Banerjee from Malda (Uttar) and Sehnaj Ali Rehan from Maldah (Dakshin).

Notably, TMC had bagged several Assembly seats from Malda, which was traditionally a Congress dominated belt, unexpectedly in 2021.

During election campaigning in Malda district, TMC chairperson Mamata Banerjee expressed her happiness over the remarkable results in 2021, disclosed that her disappointment having failed to win at least one LS seat from Malda district and then earnestly requested the Malda people to elect her candidate in 2024.

In both the LS seats, there is a triangular fight among the candidates belonging to the BJP, Congress and Trinamul Congress. Interestingly, the BJP candidates in both the seats are at an advantage due to the fight between the Congress and the Trinamul Congress to keep control over the anti-BJP vote bank in this Muslim

Notably, a senior Congress leader Mostaque Alam is contesting from Maldah Uttar LS seat. The Congress MP AH Khan Choudhury had won from Maldah (Dakshin) by a narrow margin in 2019 when the TMC bagged huge votes.

# Sting operation video: TMC holds protest in Sandeshkhali against BJP for insulting women of Bengal

The Trinamul Congress (TMC) held a protest march in Sandeshkhali's Trimohini area against Bharatiya Janata Party's (BJP) alleged conspiracy against women in the riverine island after a sting operation revealed that the BJP was involved in scripting the entire incident.

Scores of TMC workers participated in the protest march and also screened the video of the sting operation under the initiative of Sandeshkhali MLA Sukumar Mahato.

"Women in Sandeshkhali were insulted. The BJP conspired and insulted women in West Bengal through women in Sandeshkhali. We are protesting against that," a TMC leader said.

#### Asthma awareness required to combat disease: Doctors

KOLKATA, 6 MAY

Doctors feel that with the sharp rise in the incidents of asthma, more awareness drives are required to improve the quality of life for asthmatic patients.

India accounts for 13 per cent of the global burden of asthma. Globally, 42 per cent asthma-related deaths take place in India. It has been seen that only 20 per cent of the diagnosed patients are aware about asthma, said doctors today on the eve of World Asthma Day, which falls on

7 May. The recent Global Burden of Disease (GBD 1990-019) estimated the total burden of asthma in India as 34.3 million, accounting for 13.09 per cent of the global burden.

Dr Angira Dasgupta, HOD chest department, BR Singh Hospital emphasized that despite the increasing prevalence of asthma in India, there is still lack of awareness about asthma and its symp-

Asthma is not a disease that can be permanently cured but can only be managed better with right inter-

vention and medication. Among 20 per cent of patients who are diagnosed with asthma, the majority are youngsters in the age group of 20 to 40 years. Similarly, those who are unaware about the disease are usually in the age group of 35 to 55 years. So, it is high time that the general public should be sensi-

Dr Dasgupta said awareness about asthma is required for better management of the disease by understanding the symptoms and causes of

asthma. If people are aware then they can take steps to avoid the things that trigger asthma and thus reduce the asthma attacks. For example, exposure to allergens like dust mites, pet dander and pollen can help to reduce inflammation and narrowing

of the airways. "By sensitizing and promoting right information, we can significantly improve quality of life for asthmatic patients," Dr Dasgupta added.

"You are directed to immediately disclose your identity including name and residence. If the information sought is not revealed, you shall be liable for legal action u/s 42 CrPC," read a post from the Kolkata Police responding to the tweet.

Over the years, many have faced legal action across the country for posting content against other leaders, including Shiv Sena founder Bal Thackeray and former Tamil Nadu chief minister late J Jayalalithaa. The meme comes amid a fierce tussle between the ruling Trinamul Congress and the BJP over Bengal's 42 seats. The war on social media between supporters of both parties has turned ugly.

Dum Dum Lok Sabha constituency in North 24 Parganas District, which has a history of changing its voting pattern in consecutive elections since 1977, will be an interesting watch this time, with three veteran politicians clashing with each other.

For Trinamul Congress' three-time MP since 2009 from Dum, Saugata Roy, the concern is his winning margin in 2019 which came down sharply to 52,999 from 1,54,934 in 2014.

The second factor that might be cause of concern for Saugata Roy is that the CPI(M) this time has fielded party veteran and central committee member, Dr Sujan Chakraborty, from Dum Dum, where his party still has a dedicat-



In case Dr Sujan Chakraborty, with his vast experience in party organisation activities as well as electoral politics, is able to grab a substantial share of the anti-BJP votes from Dum Dum, it could be rough going for

Saugata Roy. At the same time, the BJP has fielded Shilbhadra Dutta, who as an erstwhile Trinamool Congress leader from North 24 Parganas District has substantial experience in handling the ruling party's organisa-

tional affairs there.

BJP before the 2021 West Bengal Assembly polls and also contested unsuccessfully as the party's candidate from Barrackpore Assembly con-

stituency that year. However, he was one of the few who did not rejoin the Trinamool Congress even after being defeated, which substantially enhanced his political credibility. The factor that might make Dum Dum any-

body's game is the change in the voting pattern since 1977. In 1977 it was the Janata

Party's Ashok Krishna Dutta

who won from that constituency, but only for a single term. In 1980, the CPI(M)'s Niren

Ghosh emerged as the victor from Dum Dum. However the equation changed again in 1984, when the Congress' Asutosh Laha got elected from the constituency.

Thereafter, the CPI(M)'s Nirmal Kanti Chatterjee got elected from Dum Dum for three consecutive terms in 1989, 1991 and 1996.

In 1998 BJP's Tapan Sikdar emerged as the surprise winner from Dum Dum and he got re-elected from the same constituency again in 1999. Again in 2004, Sikdar got defeated by CPI(M)'s Amitava Nandy. However, since 2009 Dum Dum has become a Trinamul Congress bastion with Saugata Roy winning three consecutive terms, though

### City schools do well in ICSE, ISC results

The students of both Class X and XII in West Bengal have put up a stellar performance in the Council for the Indian School Certificate Examinations results this year with a rise in the total pass percentage as well as gender wise categorization. The results by the council were declared

today. In the Class X results, a total of 99.22 per cent students from the state passed the examination this year. Last year, 98.71 per cent in total had cleared the Class X exams from the state. In the genderwise performance, a total of 99.41 per cent girls of West Bengal cleared the exam witnessing a rise than 2023 when the total pass percentage of

girls in the state was 99.01. Even the performance of boys in the Class X board exams this year has seen an improvement with 99.07 per cent of them becoming eligi-



ble for the next class. Last year, the number stood at 98.47 per

Likewise, the students' performance in the Indian School Certificate Examination (ISC) in the state has witnessed improvement in

the results declared today. Atotal of 97.80 per cent students from West Bengal passed the ISC exam this year unlike 2023 when the percentage

was recorded as 96.88. As per the data shared by the council, the girls who had outperformed the boys with 98.04 per cent of them clearing the exam in 2023, once again won the race and 98.86 per cent of the former emerged

XII results.

Registering a marginal rise, a total of 42,372 students from West Bengal had appeared for the ICSE exams from 426 schools this year. A similar rise was seen in the council data for ISC in which the total number of students who appeared in the exam from the state was 27,621 from 320 schools. Notably, until last year the council issued a merit list in which several students from the state with many of them even appearing from var-

ious city schools would make

a mark. However, aiming to avoid unhealthy competition

among students, the council

decided to discontinue the system of merit list this year.

Even in cases of compartment examination, the council has decided to discontinue the system.

Students wishing to improve their marks or grades in the same year of the examination would have the opportunity to sit for an improvement exam for maximum two subjects. As per the information available, the improvement examination is likely to be conducted in the month

of July by the council. The council would allow its students to opt for re-evaluation and re-checking of the results for both ICSE and ISC examinations. According to the board, the ICSE examination starting date was 21 February and it was concluded on 28 March while the exam was conducted on 18 days.

For ISC, the examination starting date was 12 February and concluded on 4 April 2024. The examination was conducted for 28 days.



In his petition, Kuzhalanadan alleged that Exalogic Solutions, the firm owned by Veena Vijayan, received monthly payments as a reward for providing improper assistance to a private mining company, Cochin Minerals and Rutile Ltd.

The court had sought evidence from Kuzhalnadan regarding the alleged wrongful assistance to the private company. Following this, the MLA's lawyer during the previous hearing submitted five documents to the court

against the CM and his daughter. However, the Vigilance Court said that it did not find any evidence of wrongful assistance provided government in these documents.



ongress leader Rahul Gandhi on Monday promised to remove the 50 per cent cap on reservation if the opposition-backed INDIA bloc comes to power in Madhya Pradesh.

Taking a jibe at the BJP's "abki baar, 400 paar" war cry, he claimed the saffron party would not be able to win even 150 seats in the general election.

Gandhi said the Congress has drafted an innovative plan which no other government has ever thought of, adding that it would provide Rs 8,500 per month, totaling more than Rs one lakh a year, to one woman from each poor family.

Addressing two poll rallies at Segaon in the Khargone (ST) Lok Sabha constituency and



Alirajpur in Ratlam (ST) Lok Sabha seat of Madhya Pradesh, he reiterated that Prime Minister Narendra Modi, the Bharatiya Janata Party (BJP), and the Rashtriya Swayamsevak Sangh (RSS) are planning to end the Constitution.

"All that the dalits, tribals, OBCs, poor and downtrodden of the country have received handful of his industrialist friends.

He cautioned that if the BJP forms the government again, about two-dozen industrialist friends of Modi would control all the resources of the nation and they would run the entire government. He said Modi waived off loans worth more than Rs 16 lakh crore of his industrialist friends, but did not waive off a single penny of the farmers' pending loan amounts.

The Gandhi scion asserted that the Congress has genuinely worked for the welfare of the poor and tribals. He said the Congress believes that the adivasis or tribals have the first right on the resources of the country.

"... leave aside snatching your reservation, we are going to raise it above the 50 per cent limit," he promised.

The Supreme Court, how-

ever, has capped the reservation limit to 50 per cent.

"When the Congress forms the government, we will put Rs one lakh a year directly into the bank account of one woman from each poor family till that family is brought above the poverty line," the Congress leader underlined.

"Narendra Modi has made some people crorepatis, but we are going to make crores of people lakhpati," Rahul Gandhi asserted.

He encouraged the Congress workers, calling them lions, and urged them to toil in the ongoing Lok Sabha polls, to save the country's democracy and Constitution. The Ratlam and Khargone Lok Sabha seats would go to polls along with six other seats of the state in the fourth phase of polling on 13 May, the last phase for Madhya Pradesh.

#### 'Modigovt playing directly into hands of Chinese'

General Secretary in-charge

of Communications Jairam Ramesh said, "Today is the fourth anniversary of the clashes that began between Indian and Chinese troops at Pangong Tso in eastern Ladakh. These culminated in the fatal engagement in Galwan on 15th June 2020 in which 20 of our brave soldiers made the supreme sacrifice. The PM's clean chit to China four days later when he said 'na koi hamari seema mein ghus aaya hai, na hi koi ghusa hua hai' was a profound insult to our fallen soldiers and became the legitimisation of Chinese control over 2,000 square kms of land in eastern Ladakh."



Referring to the India-China border talks, he said, "Despite 21 rounds of military talks over four years, the situation remains unfavourable. Leh's Superintendent of Police has clearly shown that our troops were unable to reach 26 out of 65 patrolling points that they could access prior to 5th May 2020. Chinese forces continue to block Indian access in the strategic Depsang Plains in five locations (Patrolling Points 10, 11, 11A, 12 and 13)."

Alleging that China's aggressive build up and intrusions are not restricted to Ladakh, the Congress MP

said, "Along Arunachal Pradesh, the Chinese continue to build forces and infrastructure that pose a direct threat to India's Siliguri Corridor, which connects northeast India with the rest of the country. The Modi government has overseen the destabilisation of Manipur and other parts of the northeast, playing directly into the hands of the Chinese. This sorry situation is a complete indictment of the PM's gullibility and naiveté regarding China."

Arunachal Pradesh shares a 1,080 km border with China. He asserted that China has made significant inroads into our neighbourhood on the Modi government's watch.

"Do you still believe your 19 June 2020 statement? Has your government surrendered to Chinese control over thousands of square kms in Depsang and Demchok for the foreseeable future or are you still trying to return to the status quo ante before 5 May 2020? #### Raj govt bans use of mobile phones by school teachers

JAIPUR, 6 MAY

Rajasthan's Education Minister Madan Dilawar on Monday said strict action will be initiated against teachers in government schools for using mobile phones during duty hours. An order has been issued to stop the use of mobile phones by teachers in schools at the ground level. Teachers will have to stop bringing mobile phones to schools, Dilawar said.

"Mobile phones are a kind of disease. Teachers in school are busy watching the stock market. Mobile phones will be completely banned in schools. Students suffer loss in studies due to mobile phones..Phones will have to be deposited with the principal," he expressed his

objections. "If they bring mobile phones by mistake, then they will have to be deposited with the principal. Action will also be taken against performing puja or offering namaz during school time without permission", he added.

#### **Karnataka Crucible**

s votes are cast in the third phase of the general A elections today, in Karnataka, where the remaining 14 of its 28 Lok Sabha constituencies go to the polls, the spotlight sharply turns to the north of the state. This follows the second phase on April 26, where constituencies dominated by the Vokkaliga community had their say. Today, it's the turn of North Karnataka, a region where the Lingayat community has a significant demographic and political influence. This phase of elections is crucial, not just for the immediate electoral outcomes but for the deeper political narratives it may establish. The battle lines are drawn between seasoned BJP stalwarts such as former chief ministers Jagadish Shettar, Basavaraj Bommai, and union minister Pralhad Joshi, against a younger brigade from Congress, signalling a deliberate clash of generations and ideologies. These contests underscore a pivotal theme in Indian politics: the enduring tug-ofwar between traditional caste dynamics and the evolving aspirations of a new voter base. Historically, the Lingayat community has been seen as a cornerstone of electoral politics in Karnataka, wielding substantial influence over election outcomes. Their vote has often been perceived as a bloc that could make or break political fortunes, particularly for the BJP. However, the strategic decision to field non-Lingayat candidates in places like Hubballi raises questions about whether traditional loyalties will hold firm or give way to broader issues such as development, governance,

and policy impact. The "Modi factor" that the BJP leans on heavily is tested here anew in the context of local socio-political dynamics. Will the charisma of a national leader sway voters in a region where local issues and identities are deeply rooted? This election might provide some answers, testing the waters for how far-reaching the Prime Minister's appeal really is in the granular politics of Karnataka. Moreover, the introduction of younger Congress candidates could potentially recalibrate voter interest and expectations, particularly among the youth and first-time voters. These candidates bring with them a promise of change and a focus on progressive governance, challenging the traditional political narrative that has often been centred around caste and community. As voiced by local leaders and influential seers, there's a palpable call for a shift towards meritocratic and development-oriented politics, moving beyond the caste-driven electoral strategies that have dominated the landscape. This sentiment resonates with a broader national desire for politics to transcend traditional boundaries and focus on inclusive growth and governance.

As voters in North Karnataka head to the polls today, they carry with them the potential to influence not just the electoral map but the very nature of political engagement in the region. Will they reinforce the traditional caste equations, or will they pivot towards a more issue-based voting pattern? The outcomes here could signal a significant shift in how political parties strategise and campaign in the future, not just in Karnataka but across India.

# Western Bias

The West has grudgingly ceded space to India's growing heft in international affairs as champion of the global south and its economic rise within a short period of a decade under the NDA rule, which has seen India overtaking its erstwhile colonial master. India is comfortably poised to become the third largest global economy before the end of this decade. While the West has taken note of India's achievements in space and technology benefiting millions of poor, it never misses a chance to denigrate India's rise



The West has never been too comfortable with India's rise. Indeed, at independence, nobody expected India to survive as a hands of rascals, rogues, freebooters", the imperialist Prime Minister of Britain Winston Churchill is supposed to have remarked on the independence of India, adding "all Indian leaders will be of low calibre and men of straw." Now after leaders like Boris Johnson and Liz Truss, it is perhaps their leaders who deserve to be called "people of low calibre".

In his 1968 book "Population Bomb", the Nobel laureate Paul Ehrlich, and before him in 1967, the Paddock brothers, William and Paul, had predicted that India would splinter into anarchy and chaos over famine and food riots. The Paddock brothers in fact argued that there was no point in giving food aid to India as it would be a sheer waste ~ Indians should rather be left to their own fate. After India's third Parliamentary election, Aldous Huxley wrote, "When Nehru goes, the government will become a military dictatorship ~ as in so many of the newly independent states, for the army seems to be the only highly or-

ganised centre of power." On the eve of the 1967 elections, the *Times of London* ran a series of articles titled "India's disintegrating democracy". Its Delhi correspondent, Neville Maxwell, wrote that "the great experiment of developing India within a democratic framework has failed" and that Indians would soon vote in the "fourth ~ and surely last ~ general election." India has not only survived all these dismal predictions, but has thrived and prospered. No one today calls us a third world country or the "Sick

Man of Asia". The West has grudgingly ceded space to India's growing heft in international affairs as champion of the global south and its economic rise within a short period of a decade under the NDA rule, which has seen India overtaking its erstwhile colonial master. India is comfortably poised to become the

before the end of this decade. While the West has taken note of India's achievements in space and technology benefiting

millions of poor, it never misses a chance to denigrate India's rise by highlighting contrary views, especially of Indian academics positioned in American univerdemocracy. "Power will go to the sity campuses who, for some strange reason, are also not comfortable with India's rise.

Now the Western media is turning its ire towards the Indian polity, focusing especially on the current parliamentary elections. A country practices and manages its democracy according to its own culture, values and ethos, which need not necessarily be Western. The Western media overlooks the fact that despite its many flaws, India's democracy remains a most vibrant one, evidenced by the high participation of citizens in the

electoral process which dwarfs the low participation rate in their own democracies.

Some time back, the Swedenbased V-Dem Institute's Democracy Report 2024 termed India's democracy as an "electoral autocracy". Now, in an editorial titled "The mother of democracy is not in good sha-

pe", UK's *Financial* Times has said that the "gap between pro-democratic rhetoric and reality is widening in India". Citing "an intensifying clampdown on opposition parties", in particular the arrest of Arvind Kejriwal, it said "this matriarch of representative government is in ill health, with worrying implications for the coming polls and what may follow." Most Western media have highlighted Mr. Kejriwal's arrest. Only the courts will decide whether the

arrest was justified or not. But the Western media has universally highlighted the arrest as a sure indicator of India's regression from democratic principles, while the string of cases filed against Donald Trump in US courts in its election year are just upholding the "rule of law" and letting the law take its own course in a proper democracy! "A desire to woo India has third largest global economy often led western democracies to hold their tongue over democratic backsliding", the *Financial Times* continued and advised Western governments to be

more robust in criticizing India, since "preserving political freedoms is in the best interests of Indian growth and prosperity, and of the Modi government's ambitions to enhance the country's role as a leading member of the global community.'

One FT journalist has wondered, "Will this be India's last democratic election?" recalling the Western media's inherently entrenched bias against India. In an editorial, the *Guardian* wrote that BJP's win would mean that Indian democracy would be the loser. "Democracies run best when there is a contest of ideas and equal treatment of citizens in everyday administration", it says, before concluding that "these are in

> short supply in Modi's India." In another article, its columnist Kenneth Mohammed wrote "Behind a veneer of progress, injustice and inequality propped up by corruption and the caste system haunt the subcontinent ..... It seems to be a global south problem that leaders are more enthusiastic to sp-

end taxpayers' funds on expensive vanity projects than concern themselves with fixing basic issues of infrastructure, health and education to raise the standard of living for

all its people.' Christophe Jaffrelot, a professor of political science in France, wrote in *Le Monde*, "India's elections this year stand out for their undemocratic nature", arguing that Mr Modi is turning democracy into electoral authoritarianism. The *Los Angeles Times* questioned, "Is Narendra Modi's India still a democracy?" In an article titled "The Modification of India Is Almost Complete", Michael Kugelman wrote in *Time* magazine, "The Modiera actions are highly controversial because of India's constitutionally enshrined secular traditions and resilient democracy. But .... it has far too many backers to be characterized as a wholesale trampling on the public will.

This may be the tyranny of the majority, but it's also something that enjoys a public man-

date." Aijaz Hussain and Sheikh Saaliq wrote in the *Washington Post*, "A decade into power, and on the cusp of securing five more years, the Modi government is reversing India's decadeslong commitment to multiparty democracy and secularism." All of India's institutions are suspect in their eyes, "civil liberties are under attack. Peaceful protests have been crushed with force. A once-free and diverse press is threatened. Violence is on the rise against the Muslim minority. And the country's judiciary increasingly aligns with the

Every democracy has its flaws. But one wonders whether the Western media would have been so critical of India's democracy and its electoral process if the opinion polls did not predict such an emphatic victory for the BJP alliance. They are apparently buying the Opposition campaign about 'democracy in danger'. After the collapse of the Soviet empire, when Francis Fukuyama wrote his essay "End of History" claiming that the Western political, economic, and social systems constituted the culmination of humanity's sociocultural evolution, the West expected all countries to follow their unique model.

To measure this convergence, they then started devising a series of arbitrary indexes on liberty, human rights, freedom of religion and even human happiness, styled on their values. That is how they wanted to keep their control in a multipo-

lar, post-colonial world. When countries like China and India started charting their own independent paths by defying their values, they started vilifying them. Now with low population, low productivity and the prospect of a wider economic recession, the West is facing an uncertain future, while India is rising. A rising India, like a rising China, refuses to buy the Western model of development and Western values.

It is now becoming increasingly assertive, if not confrontational and combative, almost adopting China's wolf-warrior diplomatic approach. The West wants India's democracy to be under its continuous vigilance and control, and whichever alliance comes to power after the elections will be most unlikely to allow it.

After two days of a tiger conference this week in Paro, where about 200 government leaders, ecological experts, and wildlife supporters, articulated scientific justifications to save the tiger, you could say we learnt that we can actually save the world by riding on the tiger. The premise of the validation is that this noble beast is an umbrella species whose habitat houses numerous other species. It is the apex of that food chain. So, protecting the tiger habitat helps maintain ecological balance which will ensure the harmony between man and nature and, therefore, the health of the planet itself.

The "Sustainable Finance for Tiger Landscapes" conference declared the determination to raise USD 1 billion by 2034. Veteran conservationists, funders, and government leaders also acknowledge that it is as important, to be conscious of how the money is used. Given the intricacies of international funding mechanisms and processes, that sometimes go astray, this is good thinking. A unanimous view at the conference was that Bhutan, given its image and track record, is the right country to take the lead in a global venture to protect the

tiger landscape, thereby helping to safeguard the planet. According to the President and CEO of WWF-US, Carter Roberts, this is obvious because good leadership is critical for such a task, and Bhutan has "an abundance of good leadership". It was visible at the conference with Her Majesty The Gyaltsuen, as the Royal patron, opening the conference and Bhutan's Prime Minister and citizens of influence joining prominent conservation leaders at

the largest global meet of its kind. The ambience of the conference, and the spirit of the participants, was elevated to a new high when His Majesty The King joined the participants in an informal moment after the conference. Participants of the conference agreed that, as the patron of the Tiger Conservation Coalition, Her Majesty The Gyaltsuen has triggered a triple win ~ for the tiger, for nature, and for the people. This is particularly meaningful because it overshadows the triple crisis ~ climate change, bio-

diversity loss, and pollution.

Another unique feature of the conference is that tigers are showing the way for the phenomenon of survival. This magnificent beast is fighting its way back from what was feared as an eminent extinction. It is not a small fight. Sadly, nothing matches the tragedy of human greed and we see in the lucrative black-market value of every part of the tiger. Tigers are better known today as inmates of a zoo and even tiger farms that breed tigers for commercial trade. Of the nine sub-species of tigers in the world, three of them have gone extinct. and currently, there is an estimated 5,574 tigers in the 13 tiger range countries.

Even as the tiger population is depleting in many countries the Bengal Tiger is growing in numbers. If we could understand "tiger talk", they are likely to tell us that Bhutan is an ideal home. Our protected biological corridors provide the space for tigers to roam from one corner of the country to another, from lush subtropical jungles to the highest Alpine ranges that the tiger has ever climbed.

# Campus protests reveal the West's hypocrisy

ince 17 April, pro-Palestine sitin demonstrations have impacted multiple American universities, bringing education to a standstill. Riot police employed force to take down protestors' encampments while arresting thousands. Clashes between students and riot police are being reported across the US as also between pro-Palestine and pro-Israel demonstrators. Protests on this scale were last witnessed during the Vietnam war. Within days, protests spread to universities in the UK, Canada, France and Australia. In most countries, riot police were called in to quell the

Protesting students are accusing Israel of committing 'genocide' in Gaza while demanding that educational institutions 'divest' from businesses linked with Israel as also companies providing military equipment to them. Most US universities invest their funding, donations as also earnings, in shares of major companies including defence suppliers. Brown, Northwestern and Rutgers universities are the few to have come to an agreement with protestors.

Authorities classify these demonstrations as anti-Semitic, and controlled by 'professional protestors.' Professionals guiding protests is a global phenomenon and not a discovery of the West. Professionally organized protests in India, funded by anti-India organizations and lobbies abroad, when quelled by employment of police power led to India being accused of 'subverting freedom of speech' and lowering its 'democratic credentials.' Why are those institutions and nations, which questioned India, silent now?



In the US, even professors were manhandled and treated worse than criminals, but not a single entity objected. Universities across the West are threatening students with suspension if they do not terminate their protests. Not a single voice was raised in support of demonstrating students but many had supported protesting Indian students and farmers.

Even President Biden backed the crackdown mentioning, "Dissent must never lead to disorder." He added, "Vandalism, trespassing, breaking windows, shutting down campuses, forcing cancellation of classes and graduation — none of this is a peaceful protest. Threatening people, intimidating people, instilling fear in people is not a peaceful protest."

But this is exactly what the US condemned as suppressing 'freedom of speech and right to protest' when India cracked down on Shaheen Bagh, JNU and farmers' protests. Why these double standards?

In the US, Green Party presidential candidate Jill Stein was amongst

those arrested and handcuffed. There was not a word of criticism or support in the media. The suspension of Rahul Gandhi from parliament by courts resulted in a series of comments by US and European government spokespersons and their media.

The US media, which led the charge against the Indian government in its handling of different protests, is currently backing employment of force rather than negotiations. The New York Times had a headline, 'Crackdowns at four college protests lead to more than 200 arrests.' CNN's headline said, 'How universities are cracking down on a swell of tension months into student protests over Israel's bombardment of Gaza.' The Washington Post said, 'How a Columbia protest sparked a student revolt.'

In no case were authorities accused of employing brute force, even though videos emerging from campuses showed use of disproportionate force by riot police against peaceful protestors. There were no tweets backing the

'peaceful protestors' from Rihana, Greta Thunberg, Malala and Mia Khalifa.

In contrast, the New York Times headline on the farmers' protest in India, despite the government avoiding employing force, said: 'Modi's response to farmer protests in India stirs fears of a pattern.' The Washington Post had a headline, 'Protesting farmers are teaching India a hard - but much needed - lesson.' CNN stated, 'Angry farmers once forced India's hardline leader into a rare retreat.' Rihana tweeted, 'why aren't we talking about this?! #FarmersProtest.' Mia Khalifa tweeted, 'I stand with the farmers.' India was singled out because the farmers' protests were largely Western-funded and profes-

During the Jawaharlal Nehru university protests of 2016, the Washington Post's headline said, 'Indian students called it free speech. The government called it sedition.' The New York Times mentioned, 'Sedition arrests in India inflame old freespeech tensions.' Should we not wonder why the same concept of 'free speech' becomes 'anti-Semitism' when it comes to continental US and

Western media avoided commenting on the crackdown in US universities. However, they feel it is their right to comment when protests arise in other nations. The BBC supported the US government when it headlined, 'Columbia students defy deadline to disband pro-Palestinian encampment.' Al Jazeera did defend the protestors when it said, 'Generation gap: What student protests say

about US politics, Israel support.'

The US State department, which finds fault with every other democracy, including India on freedom of speech, will maintain

silence and blame protestors in campuses ignoring police highhandedness and use of disproportionate force. While both Trump and Biden support Israel, it is likely that the brutal crackdown will impact Biden more than Trump.

India was amongst a few nations which showed the US the mirror, but only gently, when its spokesperson mentioned, "we are all judged by what we do at home and not what we say abroad." Indian media reaction was also not at the level expected, possibly due to ongoing elections. Comments from the Indian spokesperson should have been more forthright.

In Germany police employed force to break up pro-Palestinian demonstrations at Humboldt University, Berlin, which comments on Indian democracy.

In Canada, protestors established encampments in multiple university campuses. Demands are being raised to employ force to evict them. Justin Trudeau had mentioned during his bilateral with PM Modi during the G20 summit, "Canada will always defend freedom of expression, freedom of conscience, and freedom of peaceful protest and it is extremely important to us."

India must remind Canada that the freedoms which Trudeau has sworn to protect must not be tampered with. Further, there would be many Indian-origin students amongst those protesting for whom the government would be naturally concerned, as Trudeau was during the farmers' protests.

It is payback time for India. Keeping quiet and displaying niceties is never globally appreciated. No nation would thank India for not commenting on their internal matters.

THE new Reichstag meets in about three weeks, and until then the present Government carries on. Meanwhile, says the Times Berlin correspondent, it may be stated definitely that no combination of parties will be capable of securing the two-thirds majority necessary for the execution of the Experts' report. The Government still thinks it can revive a great Coalition which might control some 229 votes but it would be confronted by an Opposition which would number at the best 180 and at the worst 219, but even here the two-thirds

majority would not be possible.

In addition, under the requirements of the Experts' report, not one but several alterations in the constitution will be necessary each involving a two- thirds majority. The outlook for the continuity of Germany's present Foreign policy is therefore not a very healthy one as any conceivable Government would probably suffer a defeat on the Exports' report at a very early stage, and in that case it is presumed that another election would be held.

# Is de-escalation in Sino-US ties possible?

Hypocrisy!

Increased diplomatic engagement between the US and China has helped to bring down the temperature in their fraught relationship. But it has not yielded any agreement on the key issues that divide them and drive tensions in their intense strategic competition — Taiwan, the war in Ukraine, trade, technology curbs and military postures, especially in the South China Sea.

The visit of the US secretary of

state to Beijing in late April was part of the effort to improve communication and contain tensions between the two countries. Antony Blinken's trip took place against a mixed background of escalating tensions but also modest advances in cooperation and communication in certain areas. This resulted from the meeting

This resulted from the meeting last November between Presidents Joe Biden and Xi Jinping on the sidelines of the Asia Pacific Economic Cooperation forum in San Francisco. Their first faceto-face meeting in over a year produced a tentative thaw in frosty ties. It led to restoration of high-level military-to-military contacts, suspended by Beijing in 2020, and agreement on counter-narcotics cooperation.

Last month, the two leaders also spoke on the phone. Increased dialogue was reflected in the conversation between the defence ministers and US Treasury secretary Janet Yellen's visit to China last month. The first talks on artificial intelligence between the two countries are due to take place in coming weeks.

But just hours before Blinken's arrival in Beijing, the US Congress approved billions of dollars of assis-



tance for Taiwan and to counter China in the so-called Indo-Pacific region. This was part of a \$61bn aid package that included funding for Ukraine and Israel. It also involved the requirement for TikTok's Chinese parent company to sell its stake in the social media platform or face a ban in America. In election year, US officials have threatened higher tariffs on Chinese imports, with Biden calling for tripling tariffs on Chinese steel and aluminium — clearly as part of his re-election

Not surprisingly, Blinken was told at the outset of his trip that the US had to choose between cooperation and confrontation. China's Foreign Minister Wang Yi said during the talks that while dialogue and cooperation had increased in "various fields", "negative factors" in the relationship are "still rising and accumulating". He warned against any transgression of China's red lines. A Chinese foreign ministry statement said Wang also criticised

Washington for taking "an endless stream of measures to suppress China's economy, trade, science and technology", aimed at containment of

But he acknowledged "the China-US relationship is beginning to stabilise" and called for progress in areas where the two countries agreed. This was echoed by Blinken, who said the US "seeks to deepen cooperation where our interests align", while reaffirming US commitment to "maintaining and strengthening lines of communication to advance that agenda and deal responsibly with differ-

ences to avoid any miscalculations".

The high point of Blinken's visit was of course the meeting with President Xi. That the Chinese president received him indicated Beijing's desire to calm tensions with Washington. Warning against "vicious competition", President Xi told Blinken that the US and China should be partners and not rivals — who "help each other succeed"

and not harm each other". China, he said, wants to see a "confident, open and prosperous United States" but expected the US to see China's development in a positive light. According to a statement issued by the Chinese foreign ministry, Xi also told Blinken that both sides "should honour words with actions rather than say one thing and do another". He called for "mutual coexistence" and emphasised the need to follow through on what was agreed between him and President Biden in San Francisco to improve bilateral relations.

The readout from the American side was that Blinken conveyed US concerns on a number of issues, especially China's military assistance to Russia in the Ukraine war. Speaking to the media before the meeting, he said Russia "would struggle to sustain its assault on Ukraine without China's support", pointing out that Beijing supplied machine tools and several dual-use items critical for Russia's defence industry. This posed a threat not just to Ukraine but also to Europe and was a red line for Washington. He said after the meeting the US will wait to see how China addresses this concern, warning that sanctions could be imposed if Beijing did not respond. This injected a jarring note into the otherwise positive atmospherics of Blinken's trip.

The Chinese reaction was predictably sharp. A foreign ministry spokesman rejected "groundless" US accusations as an effort to shift blame, while Wang made it clear that "China is neither the creator of the Ukraine crisis nor a party to it". But days later, Washington went ahead and sanctioned several Chinese companies for

supplying Russia with components for military use. Nevertheless, Blinken's visit

reflected an effort by both sides to stabilise the relationship and limit the turbulence and volatility that have come to characterise Sino-US ties. But beyond this effort to ease tensions, which is important, there was no evidence of any narrowing of differences between the two sides on core issues. Moreover, the run-up to the US presidential election in November is likely to see a significant amount of Chinabashing, given the political consensus and popular sentiment in America that advocates a tougher posture towards Beijing. Both Biden and Donald Trump can be expected to vie with each other in striking a more aggressive stance on China.

Taiwan will continue to be a dangerous flashpoint in the US-China confrontation, especially as the region surrounding it is bristling with heightened military activity. The military build-up and a series of recent incidents in the South China Sea also present obvious risks. The resumption of high-level military contacts between China and the US will be important to enable the two countries to reduce the risk of any inadvertent or accidental conflict.

Even if the recent US-China diplomatic engagement has not produced any breakthroughs on contentious issues, it indicates that neither side wants unmanaged tensions to push the two countries onto a collision course, which would have unpredictable consequences for them as well as the rest of the world.

#### E-Rupee has transformative potential, scope for digitisation of payments: RBI Guv

STATESMAN NEWS SERVICE NEW DELHI, 6 MAY

Reserve Bank of India (RBI) Governor Shaktikanta Das on Monday said, "e-Rupee has transformative potential and sees considerable scope for digitisation of payments."

"Goingforward, other instruments like commercial papers and certificates of deposits will be tried out in the pilots along with securities tokenisation features," he added.

RBI is working to make its digital currency available without being dependent on internet access, Das said.

While speaking at the BIS Innovation Summit 2024, at Basel, Switzerland, Governor Das said, RBI may try usage of Central Bank Digital Currency (CBDC) in commercial papers and certificates of deposits going forward on a pilot

The RBI Governor also highlighted that the private digital currencies are potentially dan-

gerous, and the CBDC is a safer alternative.

He said that so far the central bank has gained significant insights from the two pilots on various aspects such as design, technology, and user behaviour. These insights are facilitating scalability, resilience and vagility of CBDCs system.

'The pilot is also enabling us to make informed decisions like positioning the CBDCs alongside the UPI," Das added.

"India is one of the few economies to experiment with a digital currency backed by a central bank, even as developed nations tread cautiously. The country expanded the use of its digital currency on a pilot basis, with at least 1.3 million customers and 300,000 merchants using it. CBDC usage in India has reached 1 million a day, but people still prefer using instant mobile payments mode," Das said.

"The key objective of the pilots has been a change in consumer behaviour vis-a-vis bank deposits — we need many more transactions to understand its wider economic effects, especially on monetary policy and the banking system," he added.

The central bank had launched the wholesale pilot of CBDC on November 1, 2022, to settle trades of G-Secs using the digital rupee. Further, the retail CBDC pilot was started on December 1, 2022.

In the latest MPC announcement last month, the RBI proposed allowing non-bank payments system operators (PSOs) to offer CBDC (Central Bank Digital Currency) wallets in order to make CBDC-R (Retail) more accessible to a broader segment of users.

The looming operation in Rafah—where more than 1 million Palestinians are sheltering and a high number of deaths is feared — has raised global alarm and Israeli's closest allies have warned against it. On Monday, the United Nations agency serving Palestinian refugees said it would not comply with the evacuation

Israel has described Rafah as the last significant Hamas stronghold after some seven months of war, and has repeatedly said the invasion is necessary to defeat the Islamic militant group, which unleashed the current conflict with an attack on Israel on Oct. 7.

But Hamas and key mediator Qatar have warned that invading Rafah—along the border with Egypt — could derail efforts by international mediators to broker a cease-fire.

Lt. Col. Nadav Shoshani, an army spokesman, said some 100,000 people were being ordered to move to a nearby

Jan Egeland, secretarygeneral of the Norwegian Refugee Council, condemned the "forced, unlawful" evac-

uation order and the idea that people should go to Muwasi.

"The area is already overstretched and devoid of vital services," Egeland said.

About 1.4 million Palestinians — more than half of Gaza's population — are jammed into Rafah and its surroundings. Most of them fled their homes elsewhere in the territory to escape Israel's onslaught and now face another wrenching move or the danger of staying under a new assault.

They live in densely packed tent camps, overflowing U.N. shelters or crowded apartments, and are dependent on international aid for food, with sanitation systems and medical facilities infrastructure crippled.

Palestinians in Rafah said people gathered to discuss their options after receiving the flyers.

"So many people here are displaced and now they have to move again, but no one will stay here it's not safe," Nidal Alzaanin told The Associated Press by phone.

A father of five, Alzaanin works for an international aid group and fled to Rafah from Beit Hanoun in the north at the start of the war.

He said people are concerned since Palestinians have said they were fired at during previous evacuations. Israel denies shooting at civil-

Alzaanin said he has packed his documents and bags but will wait 24 hours to see what others do before relocating. He said he has a friend in Khan Younis whom he hopes can pitch a tent for his family.

The U.N. agency that has helped millions of Palestinians in Gaza and the West Bank for decades, known as UNRWA, warned Monday of devastating consequences of a Rafah offensive, including more civilian suffering and deaths.

Juliette Touma, communications director for the agency, which has thousands of employees in the city, said it has not evacuated and has no plans to do so.

# SC grants anticipatory bail to Umar Ansari in 2022 violation of MCC case

#### PARMOD KUMAR

The Supreme Court on Monday granted anticipatory bail to Umar Ansari, son of late gangster-turned-politician Mukhtar Ansar, in a criminal case involving an alleged violation of the Model Code of Conduct (MCC) during 2022 assembly elections in Uttar Pradesh.

Granting bail to Umar Ansari, a bench of Justice Hrishikesh Roy and Justice Prashant Kumar Mishra noted that other accused in the case have been granted bail and the offending statement attributed to Ansari is the matter for

The court asked Ansari to



participate in the trial of the case, as the Uttar Pradesh government objected to his plea for anticipatory bail and told the bench that he must first surrender before the trial court

and then seek bail. Senior advocate Kapil Sibal, who appeared for Umar Ansari, told the bench that other accused in the case have already been granted bail in the case.

Mukhtar Ansari, who was undergoing incarceration, died of cardiac arrest at a hospital in the Banda district of Uttar Pradesh on March 28.

Umar Ansari was booked

for delivering a provocative speech against the Mau district administration while the model code of conduct was in place. Earlier the Allahabad High Court had declined anticipatory bail to him in the same case. He approached the top court against the High Court's December 2023 order. Rejecting Umar Ansari's plea for anticipatory bail in the case on December 19, 2023, the High Court had said that looking at the facts and the circumstances of the case, the offence

All arrangements for free and fair polling have been completed for the third phase polling in 10 Lok Sabha seats in Uttar Pradesh on Tuesday.

Over 2 lakh policemen, including over 230 companies of central forces, have been deployed for peaceful polling.

Polling in these 10 Lok Sabha seats will commence at 7AM and will end at 6PM.

There are 1.89 crore voters in the 10 Lok Sabha constituencies of the third phase, of which 1.01 crore are male voters, 87.48 lakh are female voters and 752 are of third genpolling stations and 20415 polling booths in these constituencies.

State Chief Electoral Officer (CEO) Navdeep Rinwa said here on Monday that poll parties have been dispatched for their respective booths.

He said during the polling webcasting will be done in more than 50% of the booths. Over 88,000 polling personnel have been deployed in this phase.

The CEO said direction has been given to all booth authorities to provide all facilities to the voters to cope with the heatwave conditions.

To keep a vigilant eye on the voting, the Commission has also deployed 3 special observers, 10 general observers, 6 police observers and 14 expenditure observers. Apart from this, 1887 Sector Magistrates, 241 Zonal Magistrates, 668 Static Magistrates and 2859 Micro Observers have also been





he Statesman talks to people in different professions about why they chose their particular field and what advice they have for youngsters who want to pursue it as a career. This week, Grace Andrew interviews Sabarni Das, she was a fashion journalist and is a National Award winning costume designer who has worked on a number of films.

#### What made you choose to be a costume designer?



s the race to the IPL play-offs heats up, the inconsistent ■ Delhi Capitals are faced with a must-win situation when they take on a confident Rajasthan Royals at the Arun Jaitley Stadium in the national capital on Tuesday.

The Capitals have endured yet another roller-coaster ride this season, winning five and losing six of their last 11 games. Hence, the Rishabh Pant-led outfit will need to win their remaining three games, which could take them to 16 points but might not be enough to qualify for the last four stages of the tournament.

Apart from KKR (16 from 11 games) and RR (16 from 10 games), there are at least three teams—Chennai Super Kings (12 from 11), Sunrisers Hyderabad (12 from 10 games) and Lucknow Super Giants (12 from 11 games), who can breach the 16-point mark. And in case, one of these teams finish on 16, along with DC, it will eventually come down to the net run-rate.

While those permutations and combinations are beyond their control, Pant and

#### 'Bharat Chess Rating System' by AICF is a welcome move: Players, coaches

Indian chess players and coaches have welcomed the All India Chess Federation's (AICF) decision to have a National Rating System or 'Bharat Chess Rating System' as it would result in the emergence of large number of tournaments, enthuse chess masters to play in the strong domestic circuit, tingle the chess body's cash

chest amongst other bene-

According to them, the casualty may be FIDE rated chess tournaments as the tournament organisers might opt for AICF rated tournaments and in the process save costs (FIDE fees) and may pass on the benefits to the players as prize money or lower entry fee, they added.

The international body, too, has no objection to AICF's move. "Internal rating system is the decision of each National Federation. FIDE does not interfere. At present dozens of thousands of Indians have FIDE rating, but obviously there are hundreds of thousands in India who play regularly in competitions of various kinds. So, it is sensible to rate them," chess Grandmaster (GM) Emil Sutovsky, CEO, FIDE, told

Terming AICF's move as a great step forward GM Pravin Thipsay told IANS: "It means that even the performance in

district events will be measured. As all national and international tournaments in India will be counted for the Indian Rating List, every national player will have an Indian rating and ELO rating of FIDE."

According to Thipsay, the comparison between these two ratings will set some standards and district-level players will be able to judge themselves. The player's growth (or otherwise) can be checked from a very low level and the growth graphs could enable the fraternity to judge the future starts at a very young age.

The US and several countries have their own rating system and India with a large number of chess players is a bit late to enter this club.

"Here in the US they have their own rating system and in factWashington state has their own rating system which does not use the US Chess Federation (USCF) rating system," GM Arun Prasad told IANS.

According to him, having your own rating system means it is easier to keep the rules according to your preference and one need not to follow the FIDE rules.

Continuing further he added that players beyond a certain level have to surely play in the FIDE-rated tournaments to get globally recognised chess titles like the Candidate Master (CM), FIDE Master (FM), International Master (IM) and GM.

The Himachal Pradesh Cricket Association (HPCA) Stadium on Monday witnessed an unveiling of India's first-ever hybrid pitch.

IPL Chairman Arun Dhumal and Paul Taylor, former England international cricketer and SIS's International Cricket Director along with other dignitaries from HPCA were present on the occasion.

"I'm thrilled to witness the inauguration of India's first SIS-Grass hybrid pitch at the HPCA Stadium in Dharamshala. By adopting innovative solutions like the ICC-approved hybrid pitches, we aren't just ensuring a sustainable future for the sport, but also building another avenue for growth," Dhumal said at the event.

He further said, "The HPCA's relentless commitment to advancements like introducing SISGrass Hybrid Pitches, LED Flood Lights, and the SIS Air System demonstrates their leadership in creating a world-class cricketing infrastructure. The completed installations are still predominantly natural grass, with only 5% polymer fibre used. This ensures that the characteristics of an all-natural pitch

are maintained

Taylor, SIS's International Cricket Director, said, "We extend our sincere appreciation to the Himachal Pradesh Cricket Association (HPCA) for collaborating with us on this pioneering project. We are pleased to announce the successful installation and implementation of hybrid cricket pitches at the iconic Dharamshala Stadium.

"As a BCCI-approved initiative, this encourages us to set the stage for further explorations of hybrid pitches in Mumbai and Ahmedabad.

We aim to expand opportunities that strengthen cricket at the grassroots level for more participation and ensure that our pitches can endure the game's rigours."

The 'Universal Machine' used in Dharamshala to install the hybrid surface, was first developed by SISGrass in 2017. It has already demonstrated its effectiveness in the UK where it was used to install SIS-Grass at almost every County ground in England, including internationally recognised venues like Lord's, The KIA Oval, Edgbaston, Emirates Old Trafford and Trent Bridge.

The machine will then be moved to Mumbai and Ahmedabad to create more pitches for practice and matches. Once the first three installations are complete, the machine will remain in India and be immediately available to other grounds and facilities as projects are approved.

SISGrass has invested in India after the International Cricket Council (ICC) allowed the use of hybrid surfaces for T20 and 50-over competitions.


