## Harnessing Genetics to Combat Tobacco Addiction

Each puff of a cigarette or hookah perpetuates a cycle of addiction that traps millions, impeding their pursuit of happiness and well-being. The World Health Organization (WHO) has recognised 'World No Tobacco Day' on May 31 to raise awareness about tobacco's health risks and advocate for policies to reduce consumption.

Each year, 'World No Tobacco Day' is commemorated with a specific theme, seeking to tackle various aspects of tobacco control, including advocating for smoke-free spaces, enhancing the availability of cessation support, countering tobacco industry influence, and championing policy adjustments like higher taxes on tobacco goods and restrictions on advertising, alongside public awareness initiatives. The theme for 2024 is "Protecting Children from Tobacco Industry Interference." The theme focuses on safeguarding the youth from tobacco corporations' marketing strategies, urging for protective policies to shield them from such influences.



### Tobacco: A Public Health Issue in India

Tobacco addiction is a significant public health issue in India, with a high prevalence of tobacco use across various forms such as smoking and smokeless tobacco. Tobacco addiction among Indians is fuelled by various factors including cultural norms, social acceptance, and aggressive marketing by the tobacco industry. Despite efforts to regulate tobacco products and implement tobacco control measures, tobacco consumption remains widespread,

particularly among men and in rural areas.

The consequences of tobacco addiction in India are severe, contributing to a wide range of health problems including respiratory diseases, cardiovascular disorders, cancers, and reproductive health issues. Additionally, exposure to Second- Hand Smoke (SHS) further exacerbates health risks, affecting non-smokers as well.

Efforts to combat tobacco addiction in India include tobacco control policies such as pictorial warnings on tobacco products, bans on tobacco advertising, promotion,

and sponsorship, as well as tobacco cessation programmes. However, the multifaceted nature of tobacco addiction requires a comprehensive approach involving coordinated efforts from government agencies, healthcare providers, civil society organisations, and the community to effectively address this public health challenge and reduce the burden of tobacco-related diseases in India.

### What Makes Tobacco Addictive

When we discuss of tobacco and its ill effects, the most pertinent question that comes to mind is - what makes tobacco so hard to resist?

Nicotine, this potent alkaloid, nestled within the leaves of *Nicotiana glauca*, holds the key to tobacco's addictive grip. Nicotine affects the brain by binding to nicotinic acetylcholine receptors, causing neurotransmitters like dopamine to be released. This process contributes to the cravings and compulsions associated with addiction. Nicotine is found in the leaves of tobacco plant and is generally

# Significance of Effective Communication in Fostering Scientific Temper

According to Article 51A(h) of the Indian Constitution, it is a fundamental duty of every citizen to develop a scientific temper, humanism, and the spirit of inquiry and reform. India has a remarkable history of scientific achievements, with significant Research and Development (R&D) occurring across numerous laboratories and institutions nationwide. Despite these advancements, effectively disseminating scientific knowledge to the general public has been a challenge. Often, scientific breakthroughs remain confined within academic circles and fail to reach the broader population, thus limiting their impact on societal progress and individual empowerment. Effective science communication can bridge this gap, making scientific knowledge accessible and relevant to everyday life.

## S&T Communication in India

While India's scientific community continues to thrive, the lack of a common body dedicated to disseminating R&D breakthroughs hindered efforts to showcase the nation's scientific prowess to the masses for long. Recognising this need, the National Institute of Science Communication and Policy Research (NIScPR), a constituent laboratory of the Council of Scientific and Industrial Research (CSIR), took a pioneering step by establishing the Science Media Communication Cell (SMCC). The SMCC aims to serve as a conduit between scientific research and public understanding, democratising access to scientific knowledge and fostering greater engagement between scientists and society. With a legacy of over seven decades in science communication, NIScPR has used popular science magazines, books, and various outreach programmes to connect with different stakeholders in society. The SMCC adds a new dimension to these efforts by utilising audio-visual, digital, social media, print, and public engagement avenues to bring Indian science closer to the people.

In the last two decades, India's R&D ecosystem has evolved significantly, with an increase in the number of scientific publications, emerging innovations, and start-ups. This growth reflects both quantitative and qualitative improvements in the nation's scientific endeavours. Scientific laboratories and research institutions have played a pivotal role in generating new knowledge, technologies, and innovations, thereby enhancing the quality of life for citizens. In



this context, the SMCC is a timely and essential initiative to disseminate Indian R&D breakthroughs through various media platforms. By effectively communicating scientific achievements and making them accessible to the public, the SMCC not only promotes scientific temper but also inspires future generations to engage with science. This comprehensive approach ensures that the benefits of scientific advancements are widely recognised and utilised, fostering a more informed and rational society.

SMCC's collaborative initiatives include joint workshops, seminars, and training programmes



Here are the excerpts from the interaction with Prof. Ranjana Aggarwal, Director, CSIR-NIScPR on various aspects and dimensions of the Science Media Communication Cell (SMCC).

**What was the motivation behind establishing the Science Media Communication Cell (SMCC) by CSIR-NIScPR?**

**Ranjana Aggarwal:** The establishment of SMCC was a pivotal step towards the dissemination of R&D breakthroughs of Indian labs through different media. CSIR-NIScPR is a unique lab which not only formulates evidence-based Science, Technology & Innovation policies but it nurtures and ensures dissemination of scientific information to society very effectively. NIScPR has been designated as the nodal laboratory to plan, conceptualise and promote Indian R&D breakthroughs in the national media and increase the scientific awareness among citizens of the country. Creating a single window for this purpose was crucial, and SMCC has excelled in fulfilling this role.

**Could you please elaborate on SMCC's recent initiatives to enhance science communication and outreach of breakthroughs of Indian labs?**

**Ranjana Aggarwal:** SMCC came into existence on September 11, 2023 and in a short span of 8 months, this platform has coordinated media publicity of a number of programmes and activities of science departments. A few such activities are Chandrayaan-3 Mission; DST's INSPIRE-Manak, National Science Day; CSIR's One Week One Lab Program, 82nd Foundation Day and Decadal Achievements Celebrations. Furthermore, the recent inclusion of a weekly column from SMCC in Employment News underscores its growing impact and recognition as a vital platform for science communication.

**How did SMCC contribute to the India International Science Festival (IISF) 2023?**

**Ranjana Aggarwal:** Notably, during the Indian Science Festival (IISF) 2023, SMCC made significant contributions by coordinating media publicity of all the 17 events of this mega science festival. SMCC utilised electronic, print and social media to percolate the significant outcomes of IISF. In the IISF 2023, SMCC roped in more than 400 stations of the community radio. Through this endeavour, the message of IISF reached to rural public of the country. Our social media posts during IISF attained huge public attention and engagement. Each post on Twitter garnered over 10 thousand impressions, with SMCC's real-time coverage during the 4-day event further amplifying interest. While all posts received significant reach, a milestone was reached with the post of the ISRO Chairman's speech, which gained 60,000 impressions within a day, now totaling 95 thousand impressions. This achievement represents an unprecedented level of engagement for any previous IISF edition.

# ICMR Dietary Guidelines for Indians

## A Universal Blueprint for Health and Well-Being

### EN EXPLAINS

India's vibrant and diverse culture is a testament to its rich identity, woven through its myriad states, regions, and culinary traditions. There is a popular saying in North India, "water changes around every ten kilometers and language every thirty to forty kilometers." Amidst this mosaic of diversity, it becomes essential to tailor our diet to the climate, season, time, and individual needs. Recognising this, the Indian Council of Medical Research (ICMR) periodically updates dietary guidelines to ensure the nation's health and well-being.

On April 24, 2024, the ICMR unveiled its latest dietary guidelines, marking the first update in nearly 12 years. These comprehensive guidelines underscore the universal importance of nutrition from birth to old age, advocating for balanced and healthy eating habits across all age groups and health conditions in India. With 17 directives, these guidelines address the nutritional needs of different age groups, boost immune health, and offer protection against bacterial and viral infections.

These guidelines are meant for the benefit of the general population and for practicing nutritionists, dietitians, health professionals and other stakeholders.

#### 17 Dietary Guidelines by ICMR

1. Eat a variety of foods to ensure a balanced diet.
2. Ensure provision of extra food and healthcare during pregnancy and lactation.
3. Ensure exclusive breastfeeding for the first six months and continue breastfeeding till two years and beyond.
4. Start feeding homemade semi- solid complementary foods to the infant soon after six months of age.
5. Ensure adequate and appropriate diets for children and adolescents both in health and sickness.
6. Eat plenty of vegetables and legumes.
7. Use oils/fats in moderation; choose a variety of oil seeds, nuts, nutriceals, and legumes to meet daily needs of fats and Essential Fatty Acids (EFA).
8. Obtain good quality proteins and Essential Amino Acids (EAA) through appropriate combination of foods and avoid protein supplements to build muscle mass.
9. Adopt a healthy lifestyle to prevent abdominal obesity, overweight, and overall obesity.
10. Be physically active and exercise regularly to maintain good health.
11. Restrict salt intake.
12. Consume safe and clean foods.
13. Adopt appropriate pre-cooking and cooking methods.
14. Drink an adequate quantity of water.
15. Minimise the consumption of high fat, sugar, salt (HFSS) and ultra-processed foods (UPFs).
16. Include nutrient-rich foods in the diets of the elderly for health and wellness.
17. Read information on food labels to make informed and healthy food choices.

#### Key Highlights

- **Diet in a Diverse World:** Whether it's the spicy curries of the south, the rich gravies of the north, or the varied coastal cuisines, each region offers unique flavours and nutritional benefits. The ICMR's guidelines take this diversity into account, promoting dietary habits that cater to local food availability and cultural preferences.
- **Addressing Nutritional Challenges:** India faces significant nutritional challenges, with undernutrition and anemia affecting many, especially children. Concurrently, obesity is on the rise, creating a dual burden where undernutrition and obesity coexist within the same communities. Alarmingly, 56.4% of all diseases in India are linked to unhealthy diets. A healthy diet and regular physical activity can significantly reduce the risk of chronic diseases, including coronary heart disease, high blood pressure, and type 2 diabetes.

- **'My Plate for the Day': A Model for Balanced Nutrition:** ICMR-NIN's 'My Plate for the Day' model provides a balanced approach to nutrition, recommending a minimum of eight food groups: vegetables, fruits, leafy greens, grains, millets, pulses, meat, eggs, nuts, seeds, and dairy products. The guidelines suggest limiting grain consumption to 45% of the diet, while ensuring pulses, eggs, and meat constitute 14-15%, and total fat intake remains 30% or less. Nuts, seeds, and dairy should account for 8-10% of daily intake.
- **The Lifelong Importance of a Balanced Diet:** A well-balanced diet with adequate nutrients is essential for maintaining good health throughout life. Proper nutrition from the womb to old age can prevent the negative impacts of nutrient deficiencies, support optimal growth, and reduce the risk of non-communicable diseases. The ICMR's guidelines highlight the importance of including fruits, vegetables, whole grains, pulses, nuts, and dairy products in our diet. Emphasising local and seasonal foods not only ensures freshness and nutritional value but also supports local agriculture and the economy.
- **Age-Specific Nutritional Needs:** ICMR's guidelines cater to specific nutritional requirements at different life stages. For infants and young children, the focus is on breastfeeding and the timely introduction of complementary foods. School-aged children and adolescents are encouraged to choose healthy snacks and engage in regular physical activity to support their growth and development. For adults, the guidelines recommend limiting fats, sugars, and salt while incorporating ample protein, whole grains, fruits, and vegetables. Hydration is emphasised, and caution is advised against excessive consumption of processed foods and sugary beverages. As people age, their diet should include nutrient-rich foods that support health, cognitive function, and overall well-being. For older adults, the guidelines stress the importance of proteins, calcium, vitamin D, and B vitamins to address age-related nutritional challenges.

- **Tackling Diabetes, Obesity, and Heart Disease:** With rising cases of obesity, diabetes, and heart disease, the guidelines provide crucial strategies for weight management and disease prevention. These include regular physical activity and mindful eating practices.
- **Information Dissemination:** Education and awareness are pivotal in ensuring adherence to these guidelines. ICMR collaborates with government bodies, healthcare services, and community organisations to disseminate information on healthy eating habits through various media, workshops, and campaigns.

## International Year of Camelids 2024

# Recognising Livestock's Contribution in Sustainable Development

The world turns its attention to the often overlooked yet crucial members of the animal kingdom: camelids this year. Designated as the 'International Year of Camelids' by the United Nations, the year 2024 marks a significant moment for millions of families globally, whose lives are intricately linked with these remarkable creatures. From the deserts of Africa and Asia to the Andean highlands of South America, camelids, including camels, llamas, alpacas, and their relatives, play indispensable roles in the livelihoods, cultures, and ecosystems of over 90 countries.

The journey towards recognising the importance of camelids began with a resolution proposed by the Government of Bolivia and championed by Ecuador, representing the Group of Latin American and Caribbean Countries (GRULAC). This resolution, backed by the Food and Agriculture Organization (FAO), garnered approval from the UN General Assembly on October 17, 2017, paving the way for the official launch of the International Year of Camelids on December 4, 2023.

Throughout this yearlong celebration, the UN and its partner organisations aim to disseminate knowledge and raise awareness about the multifaceted roles that camelids play. These roles extend far beyond mere beasts of burden; camelids contribute significantly to food and nutrition security, drive economic growth, and safeguard sociocultural heritage. Their resilience in harsh environments, coupled with their ability to provide valuable resources such as wool, milk, and meat, underscores their deserving recognition on the global stage.

Yet, despite their invaluable contributions, the potential of camelids remains under-recognised. The International Year of Camelids 2024 seeks to rectify this oversight by raising awareness of their untapped potential and advocating for increased investment in the camelid sector.

### Objectives of celebrating the International Year of Camelids

**Raising Awareness:** By showcasing the economic and cultural importance of camelids, the initiative underscores their vital role in supporting livelihoods and preserving cultural heritage. By educating the public and policymakers, the initiative aims to highlight the significant role of camelids in protecting ecosystems, conserving biodiversity, ensuring food security, and adapting to climate change.

**Promoting Potential:** Through awareness campaigns, the initiative seeks to shed light on the untapped potential of camelids, encouraging stakeholders to explore new avenues for utilising these animals sustainably.

**Addressing Hunger and Malnutrition:** By fostering the consumption of camelid goods, the initiative aims to contribute to the eradication of hunger, food insecurity, and malnutrition, particularly in vulnerable communities.

**Advocating Investment:** By calling for increased investment in the camelid sector, the initiative advocates for greater research, capacity development, and the utilisation of innovative practices and technologies, ensuring the long-term sustainability of camelid-based livelihoods.

### Understanding Camelids

Camelids, belonging to the biological family Camelidae, are fascinating creatures that inhabit diverse environments across the globe. These varied environments have shaped camelids' physical characteristics and behaviors, allowing them to survive and thrive in extreme conditions.


There are seven existing species of camelids divided into two groups: Old World Camelids and New World Camelids.

#### Old World Camelids

**Dromedary Camel (*Camelus dromedarius*):** Also known as the single-humped or Arabian camel, primarily inhabits the hot arid deserts of Africa and Asia, with a small feral population in Australia.

**Bactrian Camel (*Camelus bactrianus*):** Commonly referred to as the double-humped or Mongolian camel, thrives in the cold desert regions of Mongolia, China, Kazakhstan, Iran, and Afghanistan.

**Wild Bactrian Camel (*Camelus ferus*):** Found in northwestern China and southwestern Mongolia, existing in the wild.



#### New World Camelids

**Llama (*Lama glama*):** Domesticated member inhabiting the Andes of South America, used as a pack animal and a source of food and wool. Commercial llama farms are established outside their natural habitat in countries like the USA, Canada, England, New Zealand, and Australia.

**Alpaca (*Vicugna pacos*):** Also domesticated, inhabits mountainous areas from southern Colombia to northern Argentina, prized for its fiber production.

**Guanaco (*Lama guanicoe*):** Wild species found in Argentina and Chile.

**Vicuña (*Vicugna vicugna*):** Predominantly inhabits Peru, with smaller populations in Chile, Bolivia, Colombia, Ecuador, and Argentina.

#### Significance of the International Year of Camelids for India

India boasts a rich diversity of camel genetic resources, with nine breeds officially registered by the ICAR National Bureau of Animal Genetic Resources (ICARNBAGR). These breeds serve various purposes and are distributed across different regions of the country. The International Year of Camelids holds particular importance for India due to several key factors:

##### Breed Diversity:

- India's diverse landscape supports a range of camel breeds, each with unique characteristics and adaptations to their respective environments.
- Registered breeds like the Bikaneri, Jaisalmeri, and Kutchi camels are well known for their draught survival capabilities, milk production, and suitability for agricultural operations.
- Other breeds, such as the Malvi and Marwari camels, serve specific purposes like milk production and heavy load carrying.

##### Socio-economic Significance:

- Camels play a crucial role in the livelihoods of communities residing in regions like the Thar Desert of Rajasthan and Rann of Kutch in Gujarat.
- Groups like the Raika/ Rabari, Fakirani Jats, and Hajiyani Jats heavily rely on camels for transportation, milk, and other essentials, particularly in harsh desert environments.
- Camel carts are integral for transporting goods and people, while camels are also used in agricultural operations by small and marginal farmers.

##### Health Benefits:

- With India ranking second globally in adult diabetes cases, the nutritional benefits of camel milk are particularly significant.
- Regular consumption of camel milk has been shown to reduce blood sugar levels, improve insulin resistance, and enhance lipid profiles.
- Additionally, camel milk offers beneficial effects for conditions like tuberculosis, hepatitis C, and autism, making it a valuable resource for public health initiatives.

##### Cultural Heritage and Tourism:

- Camels hold deep cultural significance in India, with

references dating back to ancient texts like the Rigveda and Mahabharata.

## Harnessing Genetics to Combat Tobacco Addiction

consumed by addicts by smoking the dried leaves. Using a snuff preparation or chewing the leaves, tobacco may also be absorbed through the nasal mucosa or oral-buccal cavity. This yields complex effects in the brain that are presumably related to the behavioural effects of relaxation, mental stimulation, and focussed attention experienced by tobacco users. By increasing heart rate and blood pressure, Nicotine also stimulates the cardiovascular system.



*Nicotiana tabacum* is the scientific name for common tobacco, a plant species cultivated for its leaves, which are dried and processed for various tobacco products, including cigarettes, cigars, and smokeless tobacco. It is one of the most widely grown species of tobacco and is known for its high nicotine content.

### Health Consequences of Tobacco Consumption

The toxic ramifications of tobacco consumption on human health are multifaceted and severe, affecting nearly all human bodily system. Chronic exposure to nicotine sets the stage for a cascade of health complications, with cardiovascular disease at the forefront. This chronic exposure increases the risk of heart attacks and strokes, as nicotine constricts blood vessels and elevates blood pressure.

Moreover, tobacco smoking is notorious for its association with lung diseases, notably lung cancer and emphysema. The smoke itself, rife with irritants and carcinogens, wreaks havoc on the delicate lung tissues, paving the way for malignant transformations and debilitating respiratory conditions. Adding insult to injury, carbon monoxide, a noxious component of tobacco smoke, compounds the cardiovascular strain by impairing the blood's oxygen-carrying capacity.

Beyond nicotine, tobacco harbours a sinister arsenal of carcinogenic

compounds, chief among them being nitrosamines. These insidious substances, generated during tobacco curing, inflict DNA damage and fuel tumor growth, precipitating various forms of cancer, particularly in long-term smokers. While not directly responsible for addiction, their presence in tobacco products amplifies the overall health hazards associated with tobacco use.

The spectrum of tobacco's detrimental effects extends far beyond the confines of cancer and cardiovascular disease. Smokeless tobacco products, such as chewing tobacco and snuff, pose their own set of perils, primarily targeting the oral cavity. Oral cancers, gum disease, tooth decay, and precancerous lesions proliferate in the wake of prolonged exposure to these products, escalating the risk of gastrointestinal malignancies.

Furthermore, the dangerous reach of tobacco extends to non-smokers and children through second-hand smoke exposure. This involuntary inhalation of toxic chemicals and carcinogens engenders a plethora of health issues, ranging from respiratory infections to exacerbated asthma symptoms and heightened cardiovascular risks.

The devastating impact of tobacco on human health is undeniable, resulting in a significant burden of disease, premature death, and reduced quality of life worldwide. Yet, amidst this bleak reality, a ray of hope emerges: the potential for genome editing of tobacco plants to regulate nicotine levels.

### Genome Editing for Reduced Nicotine Content

The tobacco plant has been the subject of genetic exploration by researchers worldwide aiming to unravel their genetic makeup, seeking insights into traits, disease resistance, and nicotine content. Employing genetic engineering techniques, efforts have been made to manipulate tobacco plants for various ends, including lowering nicotine levels as part of harm reduction strategies or bolstering their resilience against pests and diseases.

In India, scientists at the Council of Scientific and Industrial Research-Central Institute of Medicinal and Aromatic Plants (CSIR-CIMAP) have made significant strides in reducing nicotine content in tobacco plants using genome editing tools, marking a promising development in tobacco harm reduction strategies with

potential implications for public health.

Nicotine, the primary addictive component of tobacco, plays a central role in sustaining tobacco addiction. CSIR-CIMAP's innovative approach to lowering nicotine levels in tobacco plants addresses this critical issue by targeting the genetic pathways responsible for nicotine synthesis. By employing genome editing tools such as CRISPR-Cas9, CSIR-CIMAP researchers have been able to precisely modify specific genes involved in nicotine biosynthesis within the tobacco plant genome. This targeted genetic modification allows for the development of tobacco plants with significantly reduced nicotine content while maintaining other desirable agronomic traits.

Recent advancements in genome editing, particularly CRISPR-Cas9 technology, have revolutionised the field of molecular biology. CRISPR-Cas9 allows for precise modification of DNA sequences, offering unprecedented control over genetic traits. CSIR-CIMAP researchers have leveraged this technology to target genes involved in nicotine biosynthesis within tobacco plants. The research team at CSIR-CIMAP identified key genes responsible for nicotine biosynthesis in tobacco plants. By using CRISPR-Cas9 technology, CIMAP scientists selectively disrupted these genes, thereby inhibiting nicotine production while preserving the overall integrity and viability of the plants. This targeted approach represents a significant breakthrough in tobacco modification, offering a promising avenue for reducing 60-70% nicotine content without compromising plant health.

### Advantages of Genome Editing in Tobacco Plants

- ♦ **Reduced Nicotine Content:** Genome editing techniques offer the possibility of lowering nicotine levels in tobacco plants. This reduction could significantly diminish the addictive nature of tobacco products.
- ♦ **Reduced Allure for New Users:** By reducing the addictive allure of cigarettes, genome-edited tobacco plants could help prevent the onset of nicotine dependence and subsequent tobacco-related diseases.
- ♦ **Facilitate Smoking Cessation:** With lower nicotine levels, smokers may find it easier to quit smoking or reduce their tobacco consumption.
- ♦ **Reduced Healthcare Cost:** Nicotine addiction lies at the core of tobacco-related diseases. By addressing this

key factor through genome editing, the widespread adoption of low-nicotine tobacco varieties has the potential to yield substantial public health benefits, including a reduction in disease burden and healthcare costs.

### Challenges to Genome Editing of Tobacco Plant

While CSIR-CIMAP's genome editing approach offers promising prospects, several challenges and considerations must be addressed. Regulatory approval processes for Genetically Modified Organisms (GMOs) vary across jurisdictions, posing potential barriers to the commercialisation and widespread adoption of low-nicotine tobacco varieties. Additionally, concerns regarding unintended off-target effects and ecological impacts necessitate rigorous safety assessments and monitoring protocols.

### Ethical Implications

The ethical implications of genome editing in tobacco plants warrant careful examination. Questions regarding consumer acceptance, informed consent, and equitable access to modified tobacco products must be addressed. Moreover, the potential for unintended consequences, such as the emergence of resistant tobacco pests or unintended alterations to other plant traits, underscores the importance of responsible stewardship and regulatory oversight.

### Conclusion

CSIR-CIMAP's innovative use of genome editing tools to reduce nicotine content in tobacco plants represents a significant stride towards addressing the public health challenges associated with tobacco use. By targeting the addictive properties of tobacco at the source, this approach has the potential to usher in a new era of harm reduction and tobacco control. However, the successful translation of this research into tangible public health benefits hinges on addressing regulatory, ethical, and technical considerations in a comprehensive and collaborative manner. Conclusively, the journey towards a tobacco-free future requires sustained commitment, interdisciplinary collaboration, and evidence-based policy-making.

job opportunities while promoting local culture and products.

**Climate Action (SDG13):** Camels emit less methane compared to ruminant livestock, contributing positively to climate action efforts. Their use in agricultural operations and transport reduces reliance on fossil fuels, aligning with climate mitigation strategies.

**Life on Land (SDG15):** Camels play a vital role in desert ecosystems, facilitating seed dispersal and promoting the growth of native plants. Their browsing patterns promote sustainable use of forest resources, preventing damage to smaller plants and fostering ecosystem resilience.

### Stakeholders and Their Roles

Numerous stakeholders,

including governmental bodies, Non-Governmental Organisations (NGOs), private enterprises, local community-based organisations, and research institutions, collaborate to foster an environment conducive to the development of camel herders and entrepreneurs. Their concerted efforts aim at promoting camel conservation, harnessing camels for dairy and ecotourism purposes, organising capacity-building programmes for camel herders and entrepreneurs, creating markets for camel milk and its products, and raising public awareness about the natural benefits of camel milk.

# News Digest

## NATIONAL

### India and Iran Sign Long-Term Deal for Chabahar Port Operations



India and Iran have reached a significant agreement to enhance cooperation and transform Chabahar Port into a regional trade and connectivity hub. The two countries signed a long-term contract on May 13, for operating the Shahid-Beheshti Port Terminal. Under the contract, India Ports Global Ltd (IPGL) will invest approximately \$120 million to equip and operate the port, with plans for further cooperation beyond the initial 10-year period. Additionally, India has offered a line of credit worth \$250 million for infrastructure projects related to Chabahar. Chabahar Port holds strategic importance for India as it serves as a vital transit point for trade with Afghanistan and Central Asian countries.

### India's Biggest Skill Competition Held in New Delhi



IndiaSkills 2024, the nation's largest skill competition, was held in Yashobhoomi in the national capital with over 900 candidates from more than 30 states and Union Territories, competing in 61 diverse skills from May 15 - 19. Participants displayed their talents across various domains, from construction and fashion to technology and logistics. The event aimed at nurturing dreams and to foster innovation in order to prepare India's participation at the WorldSkills Competition in Lyon, France to be held later this year. The event included onsite and offsite competitions and opportunities for participants to earn credits under the National Credit Framework.

### 144 Participants Selected for Sangam's AI-Driven Infrastructure Revolution

The Department of Telecommunications (DoT) has announced the Stage-I participants for its transformative "Sangam: Digital Twin with AI-Driven Insights Initiative." Launched in February 2024, Sangam aims to revolutionise infrastructure planning using digital twin technology and AI for real-time insights and predictive analytics. The initiative has received an overwhelming response with 144 participants, including 112 organisations and 32 individuals, comprising tech giants, startups, and academic institutions. These participants bring expertise in AI, AR/VR, data platforms, and scenario planning. To accommodate more participation, the DoT has extended the proposal submission deadline to June 25, 2024.

### IAF Tests Indigenous Mobile Hospital for Airdrop in Agra



The Indian Air Force conducted a successful test of the BHISHM Cube, an advanced indigenous mobile hospital designed for airdrop operations in Agra on May 15. The innovation aims at delivering rapid and comprehensive medical assistance during emergencies nationwide. Part of Project BHISHM (Bharat Health Initiative for Sahyog, Hita, and Maitri), the cube is engineered to accommodate up to 200 patients, boasting

robust, waterproof, and lightweight construction suitable for various emergency scenarios.

## INTERNATIONAL

### Biden Boosts Tariffs on Chinese Imports, Sparks Trade Tensions

US President Mr Joe Biden implemented a series of steep tariff hikes on various Chinese imports, including electric vehicles, computer chips, and medical supplies. The move aims to address what the White House calls "unacceptable risks" to US economic security posed by unfair Chinese trade practices. The tariffs, impacting \$18

billion in goods, include significant increases on products like steel, aluminium, semiconductors, and solar cells. The administration contends that these measures are necessary to counteract China's flooding of global markets with underpriced exports. Analysts warn of potential repercussions on electric vehicle costs and manufacturing jobs, underscoring the delicate balance in US-China trade dynamics.

### Russian President Wraps Up State Visit to China



Russian President Mr Vladimir Putin and President of the People's Republic of China Mr Xi Jinping concluded negotiations on May 16 following the Russian President's two-day state visit that included detailed talks on Ukraine, Asia, energy and bilateral trade. The Chinese President said at a joint news conference that both countries agreed that a political settlement of the Ukrainian crisis would be the right direction. The two leaders also oversaw the signing of several bilateral agreements in sectors such as trade and infrastructure. Russia is China's most powerful political backer and fellow geopolitical rival of the United States. The two sides had declared a "no limits" partnership in February 2022.

### India Condemns Gaza Civilian Deaths Amid Israel-Hamas Conflict

India has strongly denounced the rising civilian casualties in Gaza as Israel's military campaign against Hamas intensifies. At the UN Emergency Special Session on Palestine, India's UN representative, Ms Ruchira Kamboj labeled the situation "simply unacceptable." She criticised the seven-month conflict for exacerbating the humanitarian crisis, emphasising India's stance on upholding international law. She also condemned Hamas' October 7 attack on Israel, urging unequivocal condemnation. She called for immediate escalation of humanitarian aid to Gaza and reiterated India's support for a Two-State solution, urging direct peace negotiations between Israel and Palestine. Additionally, Ms Kamboj reaffirmed India's backing for Palestine's bid for full UN membership, hoping for Security Council reconsideration.

## ECONOMY

### Exports Reach \$64.56 Billion, Up 6.88% from Last Year

India's total exports of merchandise and services surged to \$64.56 billion in April 2024, marking a 6.88% increase from April 2023, according to the Ministry of Commerce & Industry. Merchandise exports grew slightly by 1.08% to \$34.99 billion, driven by significant increases in electronic goods (25.8%), organic and inorganic chemicals (16.75%), and drugs and pharmaceuticals (7.36%). Non-petroleum and non-gems and jewellery exports rose by 1.32% to \$26.11 billion. Total imports for April 2024 also showed robust growth, rising 12.78% to \$71.07 billion. The trade balance recorded a deficit of \$6.51 billion. Services exports were estimated at \$29.57 billion, a 14.68% increase over the previous year.

### India Aims for 50% Increase in Non-Fossil-Fuel Electricity Capacity by 2030

During the World Hydrogen Summit 2024 in Rotterdam, Netherlands, New and Renewable Energy Secretary Shri Bhupinder Singh Bhalla revealed India's ambitious plans to boost its installed electricity capacity from non-fossil-fuel sources by 50% by 2030. Currently, approximately 43% of the country's electricity capacity comes from non-fossil-fuel sources. He noted India's potential to become a significant player in shaping the global hydrogen economy, offering competitive pricing and presenting an attractive landscape for both domestic and international investments in renewable energy projects.

## SPORTS

### Football Legend Sunil Chhetri Announces Retirement

Sunil Chhetri, the iconic captain of India's national football team, has announced his retirement from international football. Chhetri will play his final match against Kuwait in the FIFA World Cup qualification on June 6. Having debuted in 2005 against Pakistan, he has scored 94 goals so far for India, making him the country's all-time top scorer and most-capped player. Chhetri also ranks third among active international goal scorers, behind Cristiano Ronaldo and Lionel Messi. Throughout his illustrious career, the 39-year-old striker has won six AIFF Player of the Year awards and received the Padma Shri in 2019 and the Arjuna Award in 2011.



### Indian Gymnast Srishti Khandagale Secures Silver at Asian Championships

Srishti Khandagale made history as the first-ever Indian to secure a medal at the Asian Trampoline Gymnastics Championships by clinching the silver in the Women's Individual Age group category at the 6th Asian Trampoline Gymnastics Championship held in Hong Kong, China, on May 12, 2024. Despite her achievement, she did not qualify for the upcoming Paris Olympics, as she competed in an age group event. The gold medal went to Kazakhstan's Dolgoplova, with Hong Kong's S Hung earning the bronze.

### FIFA Announces First-Ever Women's Club World Cup Set for 2026



FIFA has officially scheduled the inaugural Women's Club World Cup for January and February 2026, marking a significant milestone in women's football. The tournament will feature 16 teams from around the globe, including top European clubs and teams from the National Women's Soccer League in the United States. The new event is expected to enhance global competitiveness and provide a platform for clubs from

developing women's football nations.
