Modi set for historic 3rd term, but allies drive hard bargain

NDA elects PM its leader | TDP eyes Speaker's post, 5 berths, JD(U) 3

NEW DELHI, JUNE 5

Prime Minister Narendra Modi is all set for a historic third term in office after the National Democratic Alliance partners unanimously backed him for the top post, hailing India's strides under his decade-long leadership.

In a meeting convened this evening, kingmakers Telugu Desam Party's N Chandrababu Naidu and Janata Dal-United's Nitish Kumar joined 16 bloc leaders in passing a unanimous resolution electing Modi as their leader. Sources said Modi could take oath as early as Saturday, with a meeting of the BJP and NDA MPs scheduled for June 7.

Global top guns, including US President Joe Biden, British premier Rishi Sunak and Russian President Vladimir Putin, also congratulated the PM for the historic win, cementing his claim to a third term in office, which would put him in the league of the late Jawaharlal Nehru.

The ruling BJP, which fell short of a majority in the 2024 Lok Sabha election result, moved quickly on Wednesday to secure written assurances of support from NDA leaders amid signals that the Congress-led opposition INDIA bloc was also keen on engaging Naidu and Nitish. A formal endorsement from

Next step at right time, says Kharge after INDIA meet

NEW DELHI, JUNE 5

Hinting that it has not given up on the plan to form a government at the Centre, the INDIA bloc on Wednesday said it will "take appropriate step at the appropriate time to fulfil people's desire not to be ruled by the BJP government".

Briefing reporters after a meeting of INDIA bloc constituents here, Congress Mallikarjun president Kharge said the participants discussed the political situation in the country and made a number of suggestions.

Reading out a statement issued jointly by the allies after the meeting, Kharge said, "The constituents of the INDIA bloc thank the people of India for their overwhelming support. The people's mandate has given a befitting reply to the BJP and their politics of hate, corruption and deprivation. This is a political and moral defeat of Prime Minister Narendra Modi."

Congress-AAP alliance led in 46 Assembly segments in state, BJP in 44

CHANDIGARH, JUNE 5 Despite the BJP and Congress bagging five seats each in the Lok Sabha elections, it appears the Congress is in a dominant position ahead of the state Assembly elections, scheduled September-October.

Besides the Congress-AAP alliance having a higher vote percentage, it also leads in 46 Assembly segments as compared to the BJP which is leading in 44 segments.

The vote percentage of the INDIA bloc constituents stands at 47.61 per cent, with the Congress garnering 43.67 per cent across nine seats and the AAP securing 3.94 per cent in one seat. This is 1.5 per cent higher than the BJP's vote share of 46.11 per cent.

While the BJP experienced a dip of over 12 per cent in the vote share as compared to 2019 Lok Sabha polls, the Congress alone has seen an increase of over 15 per cent in the vote share. With a vote share of 43.67 per cent, this is the highest the Congress has achieved since 1989.

The Congress has secured a lead in all nine Assembly segments of both Rohtak and Sirsa. Additionally, it is ahead of the BJP in five Assembly segments of Ambala parliafour in Sonepat. The party



has also garnered a lead in three Assembly segments each of Gurgaon, Faridabad, and Bhiwani-Mahendragarh.

The grand old party leads in five Assembly constituencies represented by BJP ministers, namely Agriculture Minister Kanwar Pal Gujjar (Jagadhri), Power Minister Ranjit Singh (Rania), Finance Minister Jai Prakash Dalal (Loharu), Transport Minister Aseem Goel (Ambala City), and Social Justice and Empowerment Minister Bishamber Singh (Bawani Khera). However, the party has lost in all nine Assembly segments of Kamal.

Hooda urges Governor to dismiss 'minority' BJP govt

ROHTAK, JUNE 5

Former Chief Minister and Opposition of Bhupinder Singh Hooda has urged the Governor to dismiss the "minority" BJP govemment in Haryana and hold elections to the state Assembly at the earliest.

"It will be better if the BJP regime in the state resigns itself on moral grounds. However, if it does not, then the Governor should dismiss the government as it has lost its majority status," Hooda said at a media interaction in Rohtak on Wednesday.

Launching a scathing attack on the BJP, Hooda accused the ruling party of resorting to dividing the residents on the basis of their caste and religion. The Leader of Opposition commended the people of Haryana for not falling prey to BJP's deceptive strategies.

He thanked the state residents for unitedly voting in favour of the Congress, effectively debunking BJP's ambitious slogan of crossing 400 seats.

"Electoral success achieved through hard work and not by mere slogans," he said, adding that the BJP's slogans are losing steam and the people are making them

He said the Congress vote share had recorded a remarkable increase from 28 per cent in 2019 to almost 48 per cent in 2024, while the BJP's vote share saw a decline from 58 per cent to 46 per cent.

This shift, Hooda asserted, indicated a strong antiincumbency wave Haryana, predicting a Con-

gress victory in the forthcoming Assembly elections.

He said Haryana, which used to be on the top in terms of per capita income, investment, employment generation and development during the Congress rule, now tops the charts in unemployment, crime, corruption and drug-addiction under the BJP regime.

He criticised the BJP government for having failed in carrying out infrastructural development or bringing projects to Haryana over the past decade despite amassing a debt of Rs 4.5 lakh crore.

Singh, who is the son of former Deputy Prime Minister Devi Lal, lost the poll by 63,381 votes to the Congress' Jai Prakash. In a press conference, Singh said he would write a letter to the party leadership about the "role" of some party leaders in Hisar during the campaign.

According to political experts, Jindal, the third of the turncoat, however, managed to scrape through by a thin margin of 22,021 votes over his nearest rival AAP candidate Sushil Gupta. "Jindal got a blessing in disguise in INLD candidate Abhay Singh Chautala, who secured about 78,000 votes, which is stated to be a loss for the AAP leader, who was a joint candidate of the INDIA bloc," an expert said.

Was it the performance of Chautala "bahus" that spoiled the chances of their father-in-law Ranjit Singh (Devi Lal's son) of BJP of winning the elections in the Hisar Lok Sabha constituency. He lost to Congress' Jai Prakash by 63,381 votes. Both Chautala "bahus" — JJP candidate Naina Chautala (wife of Ajay Chautala) and INLD nominee Sunaina Chautala (wife of Ravi Chautala) secured a total of 44,335 votes. Sunaina polled 22,303 votes while Naina got 22,032 votes. Thus, people calculated that their collective votes could have inflicted a body blow to Singh's prospects in the elections. Ranjit and his two "bahus" had reached out to the voters by staking the claim for the legacy of Devi Lal. Interestingly, Sunaina edged past Naina in the number game as the former got 271 more votes than the latter, who is the mother of former Deputy Chief Minis-

candidate must secure more than one-sixth of the valid votes polled in his constituency to save the deposit.



BJP's Rao Inderjit blames state govt for dip in his margin

Perturbed over his winning margin being way less than expected, BJPMPRao Inderjit Singh has blamed the state government for the party's poor performance in Gurgaon. While talking to *The Tribune*, he said the winning margin highlighted angst of local citizens against the state government, which was earlier led by Manohar Lal Khattar and now

by Nayab Singh Saini. "The votes that we got were for the Centre's initiatives and projects. However, we underperformed in many key pockets, which were our strongholds, due to the poor performance of the state govemment. While people voted for Singh, Modi, Dwarka Expressway, AIIMS and Metro, they voted against us for power and sanitation crises. Though Gurgaon accounts for around 70 per cent of the state's revenue, the city is in civic mess. In the run-up to elections, sanitation, power and other infrastructure was at

its lowest and the state government ignored it and thus people expressed their angst through votes," he said.

The only six-time MP from Haryana, Singh is known to have his set of differences with the state government, especially with Khattar in the past 10 years. Singh has openly accused the government of being indifferent to South Haryana, especially Ahirwal and Gurugram.

"Trepresenta set of people and voice their concerns. If there is any difference of opinion on needs of my constituency and people's welfare, I see it as a healthy dissent and not rebellion. As party is in a review mode, it needs to look at the treatment meted out to Gurugram and loss it caused," he added. Singh's supporters have complained to the party high command about how several local leaders of the 'Khattar camp" remained absent from election campaign and failed to mobilise voters in stronghold pockets. They have demanded a special review of Sohna Assembly seat where Singh scored a lead of meagre 5,000 votes.

Day after results, BJP MLAs favour e-tendering rollback

Favouring complete or partial rollback of the e-tendering process for development works in villages, the BJP legislators unanimously complained against delay in the implementation of various projects.

The rollback suggestion was made at a meeting of the BJP legislature party chaired by Chief Minister Nayab Singh Saini here today. This comes a day after the Lok Sabha poll results in which the party could win only five of the 10 seats, seeing 12 per cent drop in its vote share.

At the meeting held at the CM's residence, the MLAs maintained that there was growing resentment in rural areas due to e-tendering since works were not being implemented despite sanctioning of requisite funds, sources said.

Sarpanches took to the roads when the government launched this process for development works to be undertaken in panchayats maintaining that a majority of the projects had come to a standstill. The same senti-


ment was echoed by the MLAs who favoured reverting to the policy where sarpanches had the authority to carry out works up to Rs 20 lakh on their own. The BDPO called tenders of projects worth more than Rs 20 lakh.

The MLAs also flagged their concerns regarding slow redressal of complaints related to Parivar Pehchan Patras (PPPs). Faulty entries and slow disposal of complaints resulted in denial of benefits to the beneficiaries under various schemes, which was adversely impacting the party and the government's image, they said.

The MLAs reportedly suggested that instead of centralising redressal of complaints at the headquarters, the system should be decentralised and the districts should be given the power to redress grievances related to wrong entries.

The MLAs urged the CM to look into harassment being faced by the people due to property IDs and give directions to the officials to settle all pending cases at the earliest. Deliberations were also held

on the Lok Sabha poll results. Most of the MLAs were of the opinion that retaining five seats after two terms was a "favourable result" and the party should work on consolidating its position over the next three months. The party has reportedly also directed the ministers to organise night stays in villages, reach out to disenchanted workers and take them along, besides making themselves asily accessible to public.



HC raps judge for casual approach in ordering conviction

Judges acting in a casual manner at times has been a matter of surmise for long. However, an order passed by the Punjab and Haryana High Court has confirmed that an Additional District and Sessions Judge's court acted in a casual and lackadaisical manner in convicting an accused for an offence he was never chargesheeted for.

Justice Manisha Batra said such conduct was not expected from an Additional Sessions Judge, who is assumed to be a knowledgeable and experienced judicial officer. The judgment is significant as it highlights concerning lapses within the system, where procedural diligence and adherence to proper legal standards are paramount.

"Interestingly and strangely, the trial court had also held the accused guilty of committing an offence punishable under Section 452 of the IPC(trespass) without noting that the accused had never been chargesheeted under this Section. By holding the accused guilty under Section 452, the trial court is shown to have adopted a very casual and lackadaisical approach, which is not expected from an officer of the rank of Additional Sessions Judge, who is assumed to be an experienced ACCUSED WAS NEVER CHARGESHEETED

officer," Justice Batra said.

The matter was placed before

Justice Batra after the accused appealed against his conviction and 10-year RI sentence for a rape-related offence under Section 376(2)(n) of the IPC in October 2023. The Bench was also told that the accused was sentenced to another seven years under Section 452 of the IPC. An FIR was registered in Faridabad. After hearing arguments and

reviewing the case record, Justice Batra concluded that the trial court's findings were liable to be reversed. No positive, cogent, convincing, reliable, and direct incriminating evidence had come on record to prove that the accused at any point in time criminally intimidated the complainant or repeatedly committed rape on her. Justice Batra added that the evidence produced did not make out any case for the commission of an offence punishable under Section 452 against the accused. The trial court's findings holding the appellant-accused guilty of the offence under this provision of lawwere not sustainable "at all".

Nine-member family gets citizenship certificates under the CAA

"It-'s a rebirth for our family, excited to get new identity after over 20 years," says teary-eyed sexagenarian Suba Ram, a migrant from Pakistan, whose nine-member family got citizenship certificates under the Citizenship (Amendment) Act today.

In fact, getting Indian citizenship seems to be a dream come true for the family, which has been facing identity crisis since May 4, 2004, when it landed in India after being persecuted in Pakistan.

Hailing from the Lahia area of Kotla Mughlan in Punjab province, Suba Ram's family owned about 12 acres and led a "comfortable" life. After 2000, locals started harassing them on one pretext or other.

Acute staff shortage hits power supply

90% lineman posts vacant in F'bad

FARIDABAD, JUNE 5

With around 90 per cent posts of lineman lying vacant, the Faridabad circle of Dakshin Haryana Bijli Vitran Nigam (DHBVN) is facing a tough time to ensure maintenance of the power supply system. Complaints of power line breakdown or faults have surged with the onset of summer.

Sources said 59 linemen, who were responsible for rectification of faults, were working in the circle against the total sanctioned posts of 602.

As the circle gets more than 100 complaints in an hour, the sources said, staff like assistant foreman and junior engineer (electrical) were also being sent to attend the complaints and restore power supply.

Similarly, 56.30 per cent regular posts of assistant lineman, 29.8 per cent posts of assistant foreman and 67.6 per cent posts of junior engineer have been vacant for the past many months. fuse replacement, repairing of the broken lines, damaged poles and transformers may take two to three times of duration due to shortage of the staff, it is claimed. "It took more than 30 hours

Rectification of faults like

to repair an uprooted line that affected the supply recently," said Nirantar, a resident of a Greater Faridabad colony. "The shortage of technical

staff results in delays in attending breakdowns in the network," said Satpal Narwat, a former employee of the department. He said lack of a proper field staff recruitment policy was responsible for the crisis.

Subhash Lamba, general secretary of All India Electricity Employees Federation, said lack of regular recruitment against vacant posts has led to the problem getting acute.

Naresh Kakkar, Superintending Engineer, DHBVN, said the issue was being dealt with as per the official policy, and measures were in place to ensure smooth functioning of the department.

Expect rain, thunderstorm for four days

Amidst above normal temperatures prevailing in the region, the Weather Department has predicted that some parts of north-west India could experience rain and thunderstorms over the next four days.

Dust storm or thunderstorm along with lightning and gusty winds with speed of 50-60 kmphat isolated places in Punjab are expected till June 7, according to a bulletin issued by the India Meteorological Department (IMD) on June 5. Heat wave conditions are also likely at isolated places.

During the past 24 hours, the maximum temperature recorded in Punjab ranged from 39.7°C at Thein Dam near Pathankot to 45.8°C at Faridkot. "Yesterday, there was fall of 1.2°C in average maximum temperature in Punjab. However, it was appreciably above normal by 3.2 degrees," the bulletin said. Wake-up call for AAP; led in just 32 Assembly segments

The Lok Sabha elections in Punjab should be a wake-up call for the ruling Aam Aadmi Party. Had the Punjab Vidhan Sabha elections been held now, the party, which got a thumping majority in the 2022 Assembly poll, would have been reduced to just a 32-member party in the

state Assembly. AAP had won 92 of the 117 Assembly seats in the Vidhan Sabha elections, promising "badlav". Since the change has not been felt by the voters of the state, the party has lost in 60 of the Assembly segments it won in 2022, a perusal of the Assembly-wise performance of each party in the Lok Sabha poll has revealed. Eight of the ministers in

the AAP government have also trailed in their own Assembly segments. The party also trailed in Budhlada, the constituency of Punjab AAP working president Budh Ram. The ruling party in Punjab has scored the second position in 54 seats, and managed a vote share of 26.02 per cent.

The Congress has not only won the highest number of seats (seven) in the Lok Sabha elections in Punjab, but an Assembly-wise data analysis of the poll results, declared on Tuesday, also reveals that the party took a lead in 38 Assem-

ly seats in the Vidhan Sabha poll.

Interestingly, though PPCC chief Amarinder Singh Raja Warring won the LS poll from Ludhiana, the Congress was at the third spot in his own Assembly segment of Gidderbaha, where Sarabjeet Singh Khalsa, son of Indira Gandhi's assassin Beant Singh, got the lead.

The most interesting revelation in the data is the lead obtained by the BJP in 23 Assembly segments. Though the party scored a duck in the LS poll, it increased its vote

share to 18.56 per cent. The party also bagged the second place in nine seats. The party got the lead in urban centres, besides satellite towns of Mohali and Patiala, and Bathinda, Abohar, Balluana and Ferozepur city. In the current Vidhan Sabha, the party has just two MLAs.

The SAD, which managed towin just its family borough of Bathinda, in the Lok Sabha elections, got a lead in nine Assembly segments, and was second in six. Its influence, according to the data, is restricted to just Bathinda and Ferozepur. The party has just three MLAs in the current Vidhan Sabha.

Alliance Air to start new Kullu-Delhi flight from July 3

KULLU, JUNE 5

The national regional flag carrier, Alliance Air, has released a schedule of an additional flight between Delhi and Kullu on Sundays and Wednesdays starting from July 3. An ATR-72 aircraft will be pressed into service for the additional flights while one ATR-72 plane was already operating daily flights to the Kullu-Manali Airport at Bhuntar. The Tribune had highlighted the issue of the requirement of additional flights on the Kullu-Delhi route on May 27.

The one-way ticket of the Delhi to Kullu flight is available for Rs 7.413, including additional Rs 199 web charge collected by the airline's website. The Kullu to Delhi flight return ticket is available for Rs 9,473 but the price varies as it is flexible and depends upon demand. The additional flight will depart from Delhi at 7.30 am on Wednesdays and at 6.50 am on Sundays. The flight will return from Kullu at 9.20 am on Wednesdays and at 9 am Sundays.



The UP verdict

SP, Cong ticked the right boxes to upset BJP

Nits manifesto for the 2024 Lok Sabha elections, the BJP patted itself on the back for turning the 'people's dream of five centuries' into reality by building the Ram Mandir in Ayodhya. The party was hopeful that the inauguration of the temple by PM Narendra Modi would bring rich electoral dividends, especially in the Hindi belt. It was a rude shock for the BJP when it lost the Faizabad parliamentary seat in Ayodhya district to the Samajwadi Party (SP). A BJP supporter candidly admitted that the grandeur of the Ram Mandir might have impressed outsiders, but residents of the town were unhappy over the inconvenience they were subjected to. The Ayodhya upset summed up the reversal of fortunes in UP as the SP-Congress combine punched well above its weight to upstage the mighty BJP.

This was no mean feat for the Opposition duo. The BJP had become nearly invincible in the state over the past decade. The saffron party won 71 Lok Sabha seats out of 80 in 2014 and bagged 62 five years later. The victories in the Assembly elections of 2017 and 2022 were also impressive. With CM Yogi Adityanath firmly at the helm, the party looked set to do an encore in the 2024 elections, but SP chief Akhilesh Yadav and the Gandhi siblings had other ideas.

Akhilesh has attributed the resounding success of the INDIA bloc in UP to the troika of backward classes, Dalits and minorities. The alliance fought the elections on the plank of PDA (Pichhada, Dalit and Alpsankhyak) unity. The BJP, wallowing in complacency, missed no opportunity to ridicule the SP and the Congress while going overboard with communal polarisation. This divisive ploy got a massive pushback from voters, restricting the BJP to 33 seats in the state and dashing its hopes of securing a majority on its own in the Lok Sabha.

Naidu's comeback

TDP chief emerges as crucial power-broker

N a remarkable turn of events, N Chandrababu Naidu has been catapulted from political obscurity to the pivotal role of 'kingmaker' — along with Nitish Kumar and Tejashwi Yadav — after the 2024 Lok Sabha elections. This shift not only underscores their political acumen but also highlights the fluid dynamics of our democracy. The TDP's impressive performance in Andhra Pradesh, securing 16 LS seats, combined with the BJP's failure to achieve a majority, has propelled Naidu into a central position. His alliance with the BJP and Janasena signifies not just his strategic resurgence but also his enduring appeal to the electorate. The NDA won a landslide victory in the simultaneous Lok Sabha and Assembly polls in Andhra Pradesh, bagging 21 parliamentary and 164 Assembly seats.

This re-emergence into prominence that also puts him in the king's position in the state is laudable. Naidu's tenure as Chief Minister from 1995 to 2004 was marked by economic reforms and a techdriven vision, earning him the moniker 'CEO of Andhra Pradesh'. Next, after a decade in the Opposition, Naidu made an impressive comeback in 2014, but the political landscape proved challenging. His alliance with the BJP was short-lived and the TDP suffered a heavy defeat in the 2019 elections. Adding to his woes, his 52-day incarceration last year in a skill development scam seemed to mark the end of his political career.

Today, with a majority eluding the BJP at the Centre, hectic parleys to garner the required numbers are on, and even INDIA bloc leaders are reportedly wooing Naidu. But he has reaffirmed his allegiance to the NDA — for now. India will be closely watching Naidu's moves as a power-broker. They will undoubtedly be instrumental in determining the country's political direction.



Mahatma's suggestions

WHEN we turn from the Mahatma's analysis of the causes responsible for the present Hindu-Muslim tension to the remedies suggested by him, we are at once struck by their undue generality and their obvious inadequacy. Practically, the only remedy suggested by him is summed up in the word 'non-violence'. To those who advocate a pact of some kind between the communities, he says that so far as religious matters are concerned, such matters as cow slaughter and the playing of music before mosques, there is no question of bargain and, therefore, a pact is no good, while as regards political matters, the restoration of mutual friendly feeling is a condition precedent to any effectual pact, necessary as the last undoubtedly is. "Are both parties," he writes," sincerely willing to accept the proposition that no disputes, religious or otherwise, should ever be decided by an appeal to force i.e. violence?" Where the parties are practically co-extensive, as they are in this case with the whole country, a question like this is, we must be permitted to say with all possible respect, nothing short of an absurdity. If the two communities as such were sincerely willing to accept the Mahatma's proposition, the problem he is so anxious to solve would not exist at all. The fact that it does exist can only mean that there are large sections of the communities which so far are not "sincerely willing" to accept the Mahatma's proposition; and the whole practical question in this case is how to make them willing. It is perhaps his consciousness of this fact that makes the Mahatma add: "I am convinced that the masses do not want to fight if the leaders do not."

Kashmiris affirm faith in democratic polity

Their realisation that they can be part of governance of the country is manifest

HE union territories of J&K and Ladakh, remains of the erstwhile state Jammu and Kashmir, went to the polls in five phases. According to reports, Kashmir, home to the bulk of the UT's population but the smallest in size, record-

ed a voter turnout that was the highest since 1996. Srinagar saw 38.49 per cent polling, Baramulla 59.1 per cent and Anantnag — its Kashmiri predominance sought to be blunted by the addition of Jammu division's Poonch-Rajouri districts - 54.84 per cent.

The results demonstrate a communal divide between the Muslim-majority Kashmir and Ladakh and Hindu-majority Jammu, a polarisation accentuated by the religious appeal made to voters by contenders on both sides of the Pir Panjal. The Hindutva agenda of the BJP, which took both seats in Jammu - constituencies crafted by the Delimitation Commission to buttress their religious identity — was matched by the distinct religious grounding of each of the candidates in the Valley, although the latter was free from sectarianism. In fact, Aga Syed Ruhullah Mehdi, the triumphant National Conference (NC) candidate from Srinagar who belongs to the first family of the Shia Muslim community in Kashmir, broke with precedent by openly apologising on behalf of his community for having failed to prevent the exodus of Kashmiri Pandits from the Valley when J&K was, like now, under the adminis-

tration of the Union Government in 1990-96.

Is this then the beginning of a new era in the troubled region? It is well to remember that this was the first election in Jammu and Kashmir since the Modi government's revocation of the limited political autonomy that the state had enjoyed under the Constitution with the abrogation of Article 370 in 2019. The turnout in the elections in the Valley and Ladakh is indicative of the determination of Kashmiris and Ladakhis to oust the BJP government at the Centre. Although the trends from the beginning favoured former NC leader Mohammed Haneefa, who won the Ladakh seat as an independent, this is not necessarily a resurgence of the party but a bid to rally behind it to defeat the ruling party at the Centre. The fact that the NC's star candidate, former CM Omar Abdullah, was unseated simply affirms this as the elected candidate, Engi-

neer Rashid (who got nearly 46 per cent of the vote against Abdullah's 26 per cent) has himself been an advocate of Azadi, for which he has been in the Tihar Jail for the past five years under UAPA. His campaign got going at the last moment, led by his two sons.

What we are witness to specifically is a consolidation of the votes against the BJP. the party responsible for the abrogation. It might be recalled that earlier, both leading parties rooted in Kashmir - the NC and the PDP - had been willing to work with the BJP. The last elected government was a BJP-PDP combine. As borne out by the election campaigns of each, even the BJP's supposed allies like Sajjad Lone's People's Conference have been obliged to distance themselves from that party before making any appeal for support to the public.

The BJP did not field any candidate from any seat in Kashmir. Home Minister Amit Shah was quoted as saying that it would take time for the lotus to bloom in Kashmir. But the election results show that unless the party reinvents itself for the Kashmiris and Ladakhis, this is unlikely. Of all Indian leaders whom J&K has seen as PM. Atal Bihari Vajpayee is readily the most loved.

Let alone support for the BJP, then, even association with

that party has no takers in Srinagar. I was in the Valley in the first week of May, staying in homes of friends in Srinagar, including downtown, and in Sopore. Engineer Rashid's emergence as a possible challenger to Abdullah was yet to crystallise. Hostility to the BJP was palpable and universal.

Candidates had more to say against the BJP on the campaign trail than against each other. Different segments of Kashmir's political firmament were united against the party ruling in New Delhi. The message that the Kashmiris have given is loud and clear. Although violence has indeed abated in the UT - and I venture to continue to hold this view despite the violent incidents that rocked Kulgam and Poonch during the election process - the reasons for this are not to be found in any sense of satisfaction among the people with the extant administration, but instead an increased alienation.

Yet, simultaneously, for those who hold Kashmir dear like myself, there is a bright silver lining. The people who turned out to vote show that increasingly, despite the alienation, there is a realisation that the democratic process, rather than the gun, has the potential to bring remedies to political and social travails. Although there is anger against the current political leadership, there is a new-found faith in India and the leverage given to its people through the vote.

The representatives of the two leading political dynasties of the region, both Kashmiris, faced a rebuff. But the democratic process eclipsed since the 1990s is alive and vibrant and, in their confidence in participating in the process, what is manifest is the realisation of the Kashmiris that they can be part of the governance of the country that is theirs as much as it is of any other Indian.

Aregimental celebration of unity

Y regiment celebrated its Raising Day at Dehradun recently. Christened 'Rendezvous 2024', it was a soul-rejuvenating homecoming for over 250 veterans and serving soldiers, ranging from the 1960s to the 2020s. People travelled from places like Guwahati, Coimbatore, Pune, Ahmedabad, Jabalpur and Hyderabad, validating poet Robert Southey's words: 'No distance of place or lapse of time can lessen the friendship of those who are thoroughly persuaded of each other's worth.'

When the movie of the regiment's glorious past was played, every photo had a story to tell. 'I took the telegram to your dad, and we celebrated your birth with rum and shakkarpaare amidst the booming of our guns,' my first commanding officer (CO), a walking encyclopaedia of the regiment's history, told me as he regaled everyone with stories of the 1971 war. Everyone had something to say about the bits of history flashed on the screen.

There were tears of mirth as we recounted hilarious anecdotes, the idiosyncrasies of our colleagues and the quixotic quests of our bosses. Such was the regimental spirit that during the Barakhana, even those with walking sticks and waist belts did bhangra, exhibiting a rebellious defiance of age. I met my dad's batman, who would take me to school, my Siachen days' radio operator, the Subedar Major during my command, to name a few.

It was a solemn occasion when the wife of a fallen hero, a Kirti Chakra awardee, inaugurated a motivation hall named after him. He was my senior subaltem and she fondly remembered the day I received the newlyweds at Bhuj railway station three decades ago. A daughter of another officer was very curious to know all she could about her late father, who was killed in an air crash when she was still in her mother's womb.

Ours is a 'Khandani Paltan', having seven second-generation officers and over a dozen second-generation jawans. The regimental photographer was quick to capture us in the frame when we got together. It was an honour to share the stage with former Cos, including my father, my first CO (son of the founder CO) and a former commander, while addressing the regiment. With my brother posted at the same station, for me it was a family reunion as well.

As we bid au revoir, everyone was brimming with gratitude to the current CO, a crowd-puller, for getting us together. His wife was in tears while handing over the goody bags with customised souvenirs to departing guests. Their well-knit team was already planning for the platinum jubilee, seven years away.

'It is this sense of belonging and esprit de corps that differentiates you guys from others,' said a civilian guest, overwhelmed by the camaraderie on display. A happy memory never wears out; the moments captured in our cameras will be recalled many times to relive those three days of 'celebration of unity'.

Sustaining growth must be a priority of new govt

HE management of the economy is bound to be at the the governnew ment's agenda. 'It's the economy, stupid' is a catchline made famous by Bill Clinton's 1992 election campaign, and it is still relevant. The Indian economy may be in relatively good shape, with GDP growth outpacing all others globally, but this is still a developing country with sizable segments in the poor and underprivileged categories. Pulling them out of poverty and reducing the inequality that has virtually created two Indias on a single subcontinent will have to be the focus of the new set of policymakers. The concept of a viksit or developed Bharat is unexceptionable, but the elements of society that are lagging behind will have to catch up before the country can truly reach the status of a

developed nation. To reduce the inequalities that exist between the burgeoning urban middle class and the less privileged masses in rural areas, the biggest task will be to move jobs in this direction, bureaucracy

away from agriculture and towards the more vibrant industrial and services sectors. Right now, 45 per cent of jobs are dependent on agriculture, a sector that comprises only 15 per cent of the GDP The NDA (2019-24) government had taken an initiative on this front, infusing massive public capital expenditure into infrastructure development over the past few years. But this laudable policy measure has not created as many jobs as needed, given the enormity of the country's workingage population.

There are differing estimates of actual unemployment in the country. The latest Periodic Labour Force Survey shows that the unemployment rate was 3.1 per cent in 2023, the lowest in three years. On the other hand, a private sector think tank, Centre for Monitoring Indian Economy, puts the unemployment rate for 2023-24 at 8 per cent. Despite the differing data,

the underlying conclusion is that more jobs need to be created rapidly. The drive to set up the much-needed infrastructure through a big capex thrust now needs to be accompanied by much more investment from the private sector, both from domestic and foreign sources. This will have to be aided by improving the ease of doing business. Though the current regime made some headway

and procedural complexities still abound.

Officials involved in this exercise at the Central level say the problem is with the states. To some extent, this is true. It can be seen from the fact that some states, especially in southern India, attract far more foreign direct investment than others. For instance, tech giant Apple is clearly only interested in setting up projects in Tamil Nadu, Karnataka and Andhra Pradesh. Gujarat is another state that has for long attracted investors and is now catching the attention of semi-conductor firms considering massive investments in this high-tech area.

The uneven scenario in individual states is likely to

presage a pivot in the reform process from the Central to the state level. The brief economic statement that replaced the annual survey in this year's Interim Budget talks of the states' role in making future economic reforms more 'purposeful and fruitful'. It goes on to highlight the need for improving governance at the district, block and village levels, making them both citizen- and business-friendly.

One must not forget that the Budget provided the first ever interest-free loan of Rs 75,000 crore for states to frame growth- and development-oriented reforms. This is clearly a bid to lure less investmentoriented states to carry out business-friendly reforms.

But it is not enough to attract investments. There is a need to ensure that there is skilled labour to use the job opportunities thrown up by new manufacturing projects. Providing an education that makes the much-talked-about youth demographic more employable is the need of the hour. This must start at the school level and continue through vocational institutions that impart relevant technical skills. An economy known for its expertise in software and computers should be able to provide a high-quality education in ancillary areas. Excellence in learning must go beyond the renowned engineering and science institutions.

In evolving new education policies, it would be useful to involve the industry closely. This could help improve the employability of those seeking to enter the manufacturing sector. At the same time, the private sector needs to reduce the share of contract jobs so that there is greater security of employment. The long-term nature of government jobs is the reason they are considered the goal of millions in this country. It has created the myth that only government jobs are worthwhile. Some political parties have unwisely promoted this theme during election campaigns by promising government jobs as sops for voters.

On the contrary, entrepreneurship should be given deal of hard work.

greater encouragement, for this truly yields sizable returns, especially in hightech areas. Startups have been adopted enthusiastically by the youth in this country. In fact, India now nurtures one of the biggest global ecosystems for unicorns and decacorns. Even micro and tiny enterprises are being given support through Internet marketing platforms. This is the future, and employment opportunities need to be viewed through a different prism now rather than as the 'pukki naukri' (secure jobs) of old. The long-term agenda for

any new government will thus have to be holistic, as GDP growth already reached an encouraging 8.2 per cent in 2023-24. Sustaining this growth will mean raising private investment currently lagging behind public capex. Foreign direct investment flows will also need a boost, as the latest data shows a decline in the last fiscal. This could reflect the challenges of external headwinds, especially geopolitical tensions. Raising growth in rural areas will also need to be kept in focus, though the forecast of a normal monsoon this year means agricultural output is set to be higher than the 1.4 per cent of last year. Rural consumption is already picking up and could soon reach a broad-based recovery. The goal of more equitable growth is thus achievable but will need a great

HE outcome of the 2024 Lok Sabha election in Punjab has raised many questions about the ruling Aam Aadmi Party (AAP). The party won just three seats out of 13, falling well short of the clean sweep predicted by Chief Minister Bhagwant Mann. The verdict has rocked AAP just two years after it registered a landslide victory in the Assembly elections, winning 92 seats in the 117member House.

AAP's vote share fell drastically to 26.02 per cent from 42 per cent in 2022. This indicates a surge in frustration and disappointment of the masses with the ruling party and Mann's leadership.

The party largely failed to address key issues such as the agrarian unrest, drug trade, law and order, and corruption. Endemic factionalism, organisational weaknesses, dominance of the Delhi-based top and ideological

bankruptcy have seemingly put AAP on a perilous path in a short period of time. The victory of two independent radical candidates is a manifestation of these unresolved issues.

This benefited the Congress, which finished on top with seven LS seats, thus recovering from the rout it had suffered in the 2022 Assembly polls. The Congress' vote share (26.3 per cent) was, however, only slightly better than that of AAP this time.

The verdict of the Punjab electorate in favour of the Congress was against the broad national trend. This is not a new phenomenon as the party had won eight seats in the 2019 elections amid a Modi wave in the country. In the just-concluded elections, where there was no noticeable wave, Punjab's 'exceptionalism' was very much on display. This was the only state in north India where the BJP drew a blank, even though Hindus account for around 40 per cent of the border state's population. During his recent rallies in Punjab, the Prime Minister focused on Sikh issues. such as the 1984 riots and the Kartarpur corridor. However, this narrative did not receive much attention in the state. The party recorded a vote share of 18.56 per cent; five of its 13 candidates lost their

deposits. The strong opposition to BJP candidates and other leaders by farmers' organisations during campaigning sealed the party's fate. Incidentally, the BJP had won two seats out of the three it contested in the 2019 parliamentary polls in the state.

A significant development in the 2024 election was the rejection of the BJP's agenda by the state's voters. The party tried to connect with Dalits and urban Hindus, but failed to a great extent. The BJP, which had been a junior ally of the Shiromani Akali Dal (SAD) for long, went solo this time after talks with the one-time partner

In recent years, the BJP has neither succeeded in broadening its traditional urban upper-caste voter base nor has been able to raise a tall state-level leader. Its strategy has been to win over Congress leaders. It does not qualify as a winnable party on its own despite having had a longterm presence in the state right from the days of its precursor, the Bharatiya Jana Sangh.

As for the SAD, it suffered yet another electoral rout, winning only one Lok Sabha seat — its traditional bastion, Bathinda. The party had pulled out of the

BJP-led NDA in 2021 over the three controversial 'pro-corporate' agriculture laws after having drawn the farmers' wrath by initially supporting the legislation.

The leadership crisis in the party and its 10-year 'misrule' in the state (2007-17) are among the factors responsible for the loss of its core support in the state. The party also significantly lost the support of its key vote bank, the Jat Sikh community. There is a question mark over the leadership of Sukhbir Badal, especially after the demise of his father, former CM Parkash Singh Badal.

It was an election where the same pressing issues farmers' distress, drug menace, lack of jobs, largescale migration of the youth to Western countries, industries shifting to neighbouring states, corruption, depleting water table, lack of development, and law and order — were raised by Opposition parties, but they hardly received any positive response from the state and Central governments.

The election campaign was lacklustre, going by the generally low participation at poll meetings and rallies.

The overall apathy was also reflected in the lower turnout, which was surprising as Punjab is known for recording a consistently higher turnout than the national average, whether it is the Lok Sabha or Assembly elections. As compared to the national average, Punjab's turnout was about three percentage points lower this time. There was 62.8 per cent polling this time, as against 65.77 per cent in 2019 and 70.6 per cent in 2014.

The field was unusually wide open - in the fray were SAD, BJP, Congress, AAP and the Bahujan Samaj Party (BSP). The entry and huge victory of two radical candidates -Amritpal Singh and Sarabjeet Singh Khalsa from Khadoor Sahib and Faridkot, respectively, not only made these elections very interesting but also posed a tough challenge to mainstream political parties. Their wins will have far-reaching consequences for Punjab.

Though the BSP put up its candidates from all parliamentary seats in Punjab, it failed to make its presence felt despite the fact that Dalits account for one-third of the state's population.

At the end of the day, the Congress was the biggest gainer, winning seven seats, though the odds were against it as most of its senior leaders had defected to the BJP and other parties. Voters have sent out the message that they are banking on the Congress to raise the state's issues in the Lok Sabha and work towards resolving them on priority.

The armed wings of Hamas and Islamic Jihad said they had fought gun battles with Israeli forces in areas throughout the enclave and fired anti-tank rockets and shells as the two sides sought the upper hand amid pressure to lay down their arms.

At least 44 Palestinians have been killed in Israeli military strikes in central Gaza Strip areas since Tuesday, health officials in the endave said. Two children were among the dead laid out on Wednesday.

The EU's Copernicus climate change service, a global reference for tracking world temperatures, cited an average surface air temperature of 15.9 degrees Celsius last month - or 1.52 C higher than the estimated May average before industrial times.

The report was highlighted by UN chief Antonio Guterres to ratchet up his concerns about climate change. - AP

You don't need to have an eidetic memory to remember the man. Sometimes the name - Sunil Chhetri - is enough. That's how strong an impact his long career, with its full panoply of accomplishments, has made on Indian football; that's how sprawling his stardom has been over the years.

And so, it will be an end of an era when Chhetri steps out to play his last match for India against Kuwait in Kolkata tomorrow.

Widely regarded as the face of Indian football, he recently called time on his international career. It was a call that led to a cascading of fervent tributes and blessings from people from all walks of life.

It's hard to imagine that this will be his swansong match. Such is the nature of the belief and hope Chhetri has managed to instil in his faithfuls during his journey.

Every time the ball is at his feet, the expectant crowd can sense that the smooth cadence of his legs will serve up a goal or a killer pass that in turn will lead to one; that his first touch will not gift the ball to the opposition; that no matter how big the trouble, you can always rely on him, both on and off the field — the skipper has been a professed elder brother to his teammates.

"He was simply extraordinary," remembers Anit Dhuliya of Delhi's Mamta Modern Senior Secondary School, which happens to be Chhetri's alma mater. "I have seen many players come and go but he was a different breed altogether. The vision, the aggressiveness, the finishing... he had it all," added



Dhuliya, who was also a mentor to Chhetri.

The notion of reassurance is what the 39-year-old brings to the table, something the national side will miss sorely after he's gone. Seemingly, the 'who next' morass is more or less an extension of deep-seated dread, which gradually turned into a reality simply because of

the dearth of quality strikers

at the team's disposal.

Nagaur. While Kashwan, a two-time BJP MP, switched to the Congress after being dropped, and secured a win in Churu by over 72,000 votes. Even, Umeda Ram a close confidante of Hanuman, had switched to Congress and defeated independent Ravindra Bhati by a margin of 1.18 lakh votes, pushing BJP's sitting MP and Union Minister Kailash Choudhary at the third position.

Similarly, the high-profile loss of Smriti Irani, who famously defeated Rahul Gandhi in Amethi in 2019, was a major shock. Having his roots in Ludhiana of Pun-Congress candidate Kishori Lal Sharma who contested his first election won Amethi by 1.67 lakh votes.

In Gujarat, Congress's Geniben Thakor prevented the BJP to retain all 26 seats, as she defeated BJP candidate Rekha Chaudhary in the Banaskantha Lok Sabha seat by a margin of 30,000 votes. Banaskantha

has long been a stronghold for the BJP. In the 2019 elections, BJP candidate Parbatbhai Patel won the seat with a significant margin of 368,000 votes over Congress's Parthi Bhatol.

The border state of Assam also witnessed a surprise as the deputy leader of the Congress legislature party in the state Rakibul Hassan trounced three-term MP and businessman Mohammad Badrudin Ajmal by an astounding 10.12 lakh votes, securing 60 per cent or 14.71 lakh votes in total.

This election also witnessed

two candidates winning from jail. Amritpal Singh, 31, a Khalistan ideologue currently lodged in Assam's Dibrugarh jail under NSA charges, won from the Khadoor Sahib constituency in Punjab. Similarly, Engineer Sheikh Abdul Rashid lodged in Delhi's Tihar jail under UAPA, won the Baramullah seat in Kashmir with 2,04,142 votes, defeating former CM Omar Abdullah of the National Conference.

Have neverfaced any political pressure: CJI

Chief Justice of India DY Chandrachud has said he has never faced a "sense of political pressure from the powers that be" in his 24 years as a judge.

Addressing the famous University of Oxford institution on Tuesday on the topic of the humanising role adjudicators can play in society, he said: "We live lives which are relatively isolated from the political arm of the government ... but obviously judges have to be conversant with the impact of their decisions on the polity at large. That's not political pressure but an understanding by the court of the likely impact of a decision."

Answering a question on the recently concluded General Election, he said the elections lie at the core of India's constitutional democracy, judges reflect a sense of continuity of constitutional values that protect the system.

"Elections lie at the core of constitutional democracy ... judges are not elected in India and for areason; judges reflect a sense of continuity of conditions, a continuity of constitutional values," he said in response to a question.

"The judiciary has a vital role to play in a democracy, which is that we reflect a sense of tradition and we also reflect a

sense of what the future of a good society should be," Chief Justice Chandrachud said.

He also highlighted the role of technology in injecting greater transparency into the judicial system. Acknowledging some of the "unfair" criticism aimed at judges on social media, the Chief Justice asserted that the overall impact of technology is to help the judiciary reach out to a wider section of society. — PTI


