
















# No riders by allies, BJP to keep key ministries, Speaker's post

NDA MPs to elect Modi as leader today | Oath-taking likely on June 9

NEW DELHI, JUNE 6

Newly elected MPs of the Democratic National Alliance (NDA), including the BJP, will meet here on Friday to elect Narendra Modi as their leader, paving the way for his third term and for him to stake claim to form the government.

Ahead of the crucial meeting, the top BJP brass huddled in the national capital for nearly six hours on Thursday to finalise the contours of the new Council of Ministers.

BJP chief JP Nadda, Union Defence Minister Rajnath Singh, Home Minister Amit Shah, Commerce Minister Piyush Goyal, Health Minister Mansukh Mandaviya, Railway Minister Ashwini Vaishnaw and BJP national general secretaries BL Santosh and Tarun Chugh were among those who attended. Santosh is the pointman between the BJP and the RSS.

The Tribune has learnt that the BJP will retain all top ministries — Defence, Home, CONTINUED ON PAGE 8

The N Chandrababu Naidu-led Telugu Desam Party is learnt to have pitched for three or four berths in the Council of Ministers with sources saying it is keen on the Finance portfolio, even Minister of State, and may also seek IT, besides special financial assistance for Andhra where it is keen to develop the capital city of Amravati. The TDP has sought the Speaker's post, but may have to settle for the post of Deputy Speaker. The TDP in NDA 2.0 had one Cabinet (Civil Aviation) and one MoS berth (IT) when it had 16 MPs.

### TDP pitches for 3-4 JD(U) keen on Rlys, berths, eyes Finance spl package for Bihar

The JD(U) is learnt to be seeking three Cabinet positions - Railways, Rural Development and Jal Shakti, A JD(U) source said the NDA convener's post was also a probable negotiation point, besides a special package for Bihar, caste census and a review of the Agnipath scheme. In NDA 2.0, Nitish Kumar, who along with the BJP had won 39 of Bihar's 40 seats in the 2019 poll, had refused to join the Modi Cabinet as he had been offered one Cabinet position whereas he had asked for four. Later, Nitish had quit the NDA to join the Mahagathbandhan.

### SC directs HP to give 137 cusecs ofwater to Delhi

The Supreme Court today directed the Himachal Govemment to release 137 cusecs of its surplus water to Hathnikund barrage for its onward supply to Delhi to enable it to deal with peak summer crisis.

Terming it "an existential problem" for Delhi, the top court directed the Haryana Government to facilitate the further release of water received at Hathnikund barrage from Himachal Pradesh for its onward supply to Wazirabad barrage, INSIDE





In his first press conference

here after the election results were announced on June 4, Rahul Gandhi said the stock market rose after "fake" exit polls and then crashed the day the Lok Sabha poll votes were counted on June 4. The Congress leader also trained his guns on Finance Minister Nirmala Sitharaman for commenting on the stock market before the results.

"The PM told the country three-four times that the stock market was going to skyrocket. The Home Minister directly said the stock market would skyrocket on June 4, and people should

## Cobwebs, dust greet visitors at Jang-e-Azadi

Built at ₹315 cr, Kartarpur memorial to freedom fighters lies in neglect

Even as the Punjab Government spent a staggering Rs 315 crore on raising the colossal structure of the Jang-e-Azadi memorial at Kartarpur, it seems to be finding it hard to spare money for its monthly maintenance.

The memorial, located on the Jalandhar-Amritsar highway, is a famous stopover for a large number of tourists visiting the holy city. However, many of these visitors are left disappointed because of poor



maintenance of the site. Cobwebs, layers of dust, excreta of stray animals and bird drop-

pings greet visitors at the five galleries inside the memorial. When a team of The Tribune

visited the site, it appeared that the floor had not been swept for days. Items on display had layers of dust. The glass top of the model of the memorial kept in the reception areade was found broken and miniature pieces inside it had withered. Some tablemounted screens had lost their touch sensitivity.

The laser show at the memorial is no longer in a working condition. Tiles on the upper floors of the building have started falling off. The wall papers in the high CONTINUED ON PAGE 8

'Cong could have made clean sweep

with better ticket distribution'

Congress president Sonia Gandhi has a soft corner for her. Of the nine seats the Congress contested in Haryana sabha and one term as Rajya Sabha MP. tions coming together for the Assembly elections, that are expected to take place in October. But she isn't afraid of speaking her mind about the ticket-distribution for this election that was said to be managed by Hooda.

"We could have made a clean sweep with better ticket-distribution. We lost Bhiwani-Mahendergarh and we were crawling in Sonepat and Gurgaon where we fielded candidates whose names we had never heard of. The general secretary in charge, Deepak Banwaria, did not give a fair assessment to the party high command or we could have done better," she says, adding that he was "less than impartial".

Selja underlines that it was she who suggested MLA

Varun Chaudhry's name from Ambala, a constituency she has represented in the past. "I gave his name, I urged him to contest and I went to campaign for him in Ambala in the middle of my own campaign," she says, adding that the party's interest comes first and she suggested the candidatewho was best suited unlike the selection of candidates from some other seats.

This election, the party's surveys showed the people wanted me to contest from Sirsa and the margin of my win did end up reflecting they chose me. I didn't go into the election with the margin in mind but it was during the campaign that I got a sense of the way the public opened its heart to me," she said.

"I was keen on contesting the Vidhan Sabha elections

but had maintained that if the party high command wants me to contest the parliamentary elections, I would abide by their decision and I did," Selja, the Dalit face of the Congress who has also served as Union cabinet minister during the UPA regime, quips.

The newly elected MP was also critical that Deepak Banwaria wrote a "public" letter to say that everyone should campaign for the party. While Banwaria was also referring to the third faction in the Harvana Congress — that of former Union minister Birender Singh who had left the Congress in the 2019 election to join the BJP for which his son, Brijendra, got a ticket to fight from Hisar, and who returned to the Congress on the eve of this poll, even though Brijendra did not

get a ticket from the Congress Selja wonders if there was any need for Banwaria to go public with his advice.

"Where was the need to go public with the letter? That is what all leaders should do

and that is what every leader was doing," she said. As it turned out, Birender Singh hardly went into Hooda territory, nor did Hoodas return the favour. But Birender Singh, says Selja, campaigned for her, as did Rajya Sabha MP Randeep Singh Surjewala and MLA Kiran Choudhry.

The state unit chief, Udai Bhan, did not visit her constituency even once.

On whether the Congress can come to power in the assembly elections, Selja says the issues that come into play in the state elections are very different from those in the general elections.

"Though Prime Minister Narendra Modi and the failures of the central government we're among the top issues, the state situation, too, had a bearing on the parliamentary polls. The change of the Chief Minister, the confusion about who was in the driver's seat, the break-up of the BJP and the JJP among others also impacted the outcome. However, there are three months still to go for the assembly polls but one thing is evident---the people don't want the BJP because its failures are too glaring. The party, too, will have to introspect and strike a balance while taking everyone along when it comes to the assembly polls," she signs off

## PUBLIC HEALTH ADVISORY FOR SUMMER SEASON



### Do's

### Stay hydrated:

- Drink sufficient water at frequent intervals, even if you are not thirsty.
- Carry drinking water when traveling.
- Preferably take water, Iemon water (Nimbu Pani), Lassi, Chaach, Jaljeera, Aam panna, Coconut Water or other locally available natural drinks.
- Eat seasonal fruits and vegetables with high water content like Watermelon, Muskmelon, Cucumber, Orange, Lettuce etc.

### Stay covered:

- Avoid direct exposure to sun.
- Stay indoors in well ventilated and cool places.
- Wear thin loose, cotton garments preferably light coloured.
- Cover your head, use umbrella, hat etc.
- · Wear shoes or chappals while going out in the sun
- · Keep windows and curtains of your home closed during the day and open them up at night.

### Check regularly the vulnerable who are at greater risk:

- Infants and young children
- Pregnant women
- People working outdoors.
- People who have a mental illness
- · People who are physically ill, especially with heart disease or high blood pressure.
- Elderly or sick people living alone.

### Don'ts

### Assembly elections last chance for INLD to retain party tag, election symbol

CHANDIGARH, JUNE 6 The 2024 Assembly elections will be the last chance for the INLD, the grand old party of Haryana led by former Chief Minister Om Prakash Chautala, to retain its recognition as the state

party and election symbol.

At the receiving end of the dismal performance in parliamentary and state Assembly elections since 2019, the INLD will have to fulfil the norms under the Election Symbols (Reservation & Allotment) Order, 1968, in the 2024 Assembly elections, failing which it would risk derecognition from the Election Commission.

Under the Order, the party to be recognised as the state party "must return at least one member to the House of the People for every 25 members or any fraction thereof allotted to that state".

Alternatively, the candi-

### **GLORIOUS PAST, UNCERTAIN FUTURE**

The INLD, earlier known as Haryana Lok Dal (Rashtriya), was recognised as the state party after the 1998 parliamentary elections when it won four Lok Sabha seats. However, in the 2024 Assembly elections, the party will have to fulfil statutory Election Commission norms to retain the state party tag and save

its reserved party symbol.

dates put up by the party must have secured not less than 8 per cent of the total valid votes polled in the state in the last state Assembly. Besides, candidates of a party securing not less than 6 per cent of the total valid votes polled with at least two elected MLAs can also be considered as a condition for recognition as the state party.

The party securing 3 per cent of the total number of seats or at least three seats in the Assembly, whichever is

more, is also recognised as the state party and allotted a permanent election symbol.

The INLD did not fulfil any of the above conditions in the 2019 Assembly and parliamentary elections and 2024 Lok Sabha poll. The party secured 1.9% and 2.44% votes in the parliamentary and Assembly elections, respectively, in 2019. In the recently concluded parliamentary elections, the party polled 1.74 per cent votes.

However, an amendment to

the Election Symbols (Reservation & Allotment) Order, in 2016 provided relief to the INLD. The amendment allowed a political party to retain the 'state party' or 'national party' tag even after it loses eligibility in the next Lok Sabha or state

Assembly elections. However, if the party fails to regain eligibility in the subsequent election to the state Assembly or the Lok Sabha, then it will lose its status of the state or national party. The INLD currently falls in

this category. Ram Narain Yadav, a former additional secretary of the Haryana Vidhan Sabha, confirmed that the amendment had come to the rescue of the INLD. "The INLD will have fulfil the statutory conditions for recognition as the state party in the 2024 Assembly elections, failing which the Election Commission may start the derecognition process," Yadav added.

"The quota of country liquor has been fixed for 18 lakh proof litres of IMFL for the district. The government has also fixed a quota of 54 lakh proof litres of country liquor for the district," said Kumar.

Last year, there were 52 zones of IMFL and country liquor in the district and a target of Rs 212 crore as revenue was fixed from the auction of the said zones.

### Ensure family pension for widowed daughter: HC death or becomes widow after following her husband's

The Punjaband Haryana High Court has ruled that a woman is entitled to family pension even if she is widowed or divorced after her father's death.

Justice Harsimran Singh Sethi also emphasised that the family pension's function was to ensure subsistence of a widowed or divorced daughter. Denving benefit on the grounds that the employee died before the daughter was divorced or became a widow was arbitrary and illegal.

### SUSTENANCE MUST

The intention was to ensure that widowed or divorced daughters were maintained through family pension. It was, as such, required to be granted regardless of whether the daughter was widowed or divorced after her father's demise or at the time of death. Justice Harsimran Singh Sethi

The ruling came after Justice Sethi's Bench was told that the petitioner-daughter was not being granted family pension even though she was eligible for it after she became a widow.

The Bench was also told that the petitioner was paid family pension keeping in view the service rendered by her father till she married in 1996. She applied for the restoration of family pension

demise in September 2017 as she had no other source of income.

Opposing the prayer, the submitted that widowed or divorced daughters were indeed entitled to the grant of the family pension in accordance with the instructions issued by the Harvana Government. But the daughter "should be a widow or divorced at the time of her father's death". The benefit could not be extended to the petitioner as her husband died much after

Justice Sethi asserted that the family pension was to be paid to ensure that a widow or a divorced daughter was able counsel for the respondents to sustain herself. Justifiable reason was not cited for distinguishing between a daughter already divorced at the time of her father's death, or subsequently. The primary issue was whether divorced or widowed daughters were entitled to family pension for their sustenance.

> Justice Sethi asserted: "Even if a daughter gets divorce after her father's

her father's death, she is entitled to be maintained. The classification being raised to decline the benefit that the petitioner's father had died before she became widow cannot be a ground to deny the benefit of family pension."

Before parting with the order, Justice Sethi directed the respondents to restore the family pension to the petitioner from the date of her husband's death. Directions were also issued to pay arrears. For the purpose, the Bench set an eight-week deadline.

## Jailed candidates can take oath after winning Lok Sabha elections

Jailed candidates can take oath after winning the parliamentary elections, but only with the permission of the court concerned. The issue has surfaced as two candidates, currently behind bars, including "Waris Punjab De" Amritpal Singh, emerged victorious in the recently concluded elections.

Article 99 of the Constitution requires every Member of Parliament to take an oath or affirmation before taking the seat. The provision does not explicitly disqualify imprisoned individuals from taking the oath.

Additional Solicitor-General of India and an expert on constitutional and electoral affairs Satya Pal Jain asserts permission becomes mandatory, when the candidate concerned is in judicial custody. "Any person in jail and elected

#### NO TIME FRAME

Neither the Constitution nor any law prescribes a specific time frame for taking oath. But attending parliamentary sessions requires judicial permission post-oath. Satya Pal Jain says the Constitution stipulates that a seat can be declared vacant, if a member does not attend a session for 60 days. As such, nod from the Speaker becomes must

to Parliament has to seek the court's permission," he says.

Elaborating on the procedure, Jain says the oath can be administered to the candidates on the floor of the House or in the chamber, depending upon the discretion of the Speaker or the pro-tem Speaker as the case may be.

Punjab and Haryana High Court's former Judge, Justice Mahesh Grover, says Section 8 of the Representation of the People Act makes it clear that individuals convicted of certain offences are disqualified from contesting elections. But, if a candidate is already in jail and is subsequently elected, the Act does

The Supreme Court of India has addressed related issues in various rulings. In the Lily Thomas versus the Union of India case, the court ruled that MPs and MLAs convicted of crimes attracting a minimum imprisonment two-year would be immediately disqualified from holding their seats. But the ruling applies only after conviction and not during pre-trial detention or before conviction.

Referring to "Lok Prahari versus the Union of India" case, Additional Solicitor-General of India and

Harvana's former Advocate-General Mohan Jain says the Allahabad High Court had ruled that a person under lawful detention, who is yet to be convicted, does not lose his fundamental rights, including the right to represent his constituency.

An individual remains an MP unless disqualified, once the oath is taken, Jain adds. Attending parliamentary proceedings, again, will require permission from the judiciary. Courts may allow temporary release for attending sessions, considering the nature of the charges.

"While constitutional and statutory provisions do not outright prohibit jailed winners from taking the oath or attending Parliament, practical implementation hinges on judicial discretion. Courts balance the rights of the individual with public interest and the gravity of the charges," Justice Grover says.

Chief Minister Sukhvinder Sukhu today reviewed various projects of four-lane and other roads being constructed by the National Highways Authority of India in the state. He directed the departments to expedite the ongoing projects to meet the timelines while ensuring quality in con-

struction works. Sukhu directed the NHAI authorities to fully develop the Shimla-Matour and Mandi-Pathankot roads into a four-lane to facilitate smooth travel for commuters. "The state government is developing Kangra district as the tourism capital of the state and both the four-lanes would help bolster the tourism activities," he said.

He also stressed on enhancing aesthetic appeal of both the four lanes and emphasised on the construction of tunnels to minimise unnecessary cutting of hills. He further said that construction work of the Shimla-Nauni road segment will commence after the monsoon and is expected to be completed by September, 2026.

Sukhu said that the construction work of Pinjore-Nalagarh-Baddi four lane would be speeded up to benareas and issued directions to complete this project by the end of 2025. He also reviewed the Shimla bypass project, Shimla-Solan fourwidening strengthening of the Mandi-Hamirpur and Paonta-

Shillai roads.

## SC tells Himachal to release 137 cusecs of water for Delhi

Directs Haryana to facilitate process to save national capital from crisis

SATYA PRAKASH

NEW DELHI, JUNE 6 The Supreme Court on Thursday directed the Himachal Pradesh Government to release 137 cusecs of its surplus water to Hathnikund barrage for its onward supply to Delhi to enable it to deal with peak summer water crisis.

"Since Himachal Pradesh has no objection and is ready and willing to release the surplus drinking water available with it, we direct that the state shall release 137 cusecs of surplus drinking water available with it from upstream so that the water reaches Hathnikund barrage and reaches Delhi through Wazirabad barrage," a Vacation Bench led by Justice PK Mishra said.

Terming it "an existential problem" for Delhi, the Bench, which also included Justice KV Viswanathan, directed the Haryana Government to facilitate the further release of water received from Himachal to save the national capital from acute water shortage. "Considering the urgency in the matter, we direct Himachal to release the surplus water by tomorrow with prior intimation to the Haryana Govern-

ment," it said. The Bench directed the efit the industries in these Upper Yamuna River Board to measure the excess water received at Hathnikund barrage from Himachal for its onward supply to Wazirabad with the assistance of Haryana. The top court asked the governments of Delhi, Haryana and Himachal Pradesh to file compliance

ernment, senior counsel AM Singhyi told the Bench that the Himachal Pradesh Government had agreed to release surplus water to Delhi during June and Haryana should simply facilitate its further release for use of Delhi during peak summer. The Board was of the tentative that Delhi needs approximately 150 cusecs of additional drinking water to deal with the shortage of drinking water in view of the ongoing heatwave condition.

"The Board asked the Delhi Government to send a formal request to Haryana for consideration to release 150 cusecs of additional water on humanitarian grounds up till June 30, 2024, or onset of monsoon, whichever is earlier," Singhvi said, adding the Haryana Government hadn't responded to the request made by the Delhi Government.

However, Haryana Senior Additional Advocate General Lokesh Sinhal disputed the Delhi Government's claim that surplus share of water of Himachal was available. He said the issue was still pending before the Upper Yamuna River Board. He said Harvana was also facing a similar heatwave condition and water crisis.

According to the minutes of the Board's June 5 meeting. Haryana has been releasing 1,050 cusecs of water to Delhi, which was more than the agreed quantity since the supply was in compliance with the February 29, 1996, order, and the same was not disputed by Delhi.

### Cong has lost mandate, Sukhu should step down, says Jai Ram

SHIMLA, JUNE 6

Pointing out that the Congress couldn't secure a lead in 61 Assembly segments out of the total 68 constituencies, including that of Chief Minis-Sukhvinder Singh Sukhu, Leader of Opposition Jai Ram Thakur said the Sukhu government has lost the mandate of the people.

"Despite having its govern-

ment in the state, the Congress lost 61 constituencies. The Chief Minister and most of his ministers failed to get a lead even in their constituencies. In just 15 months, this government has lost the popular mandate. On moral grounds, the CM should resign," said Thakur, who guided political novice Kangana Ranaut to a victory against Vikramaditya Singh of the Congress in the Mandi Parliamentary segment.

"The Mandi election was hyped up a lot and the Congress threw in all its might to win this seat. The CM called me a flop director and made several other comments, but now the results are in front of us. I did the job my central leadership had assigned to me," said Thakur.

The former CM further said Himachal was the only state other than Delhi where the BJP made a clean sweep despite not having its government in the state. "Overall, we secured 56.29 per cent votes, 14.72 per cent more than the Congress. Our biggest win came in Kangra, where we got 61 per cent votes, followed by 58 per cent on Hamirpur, 54 per cent in Shimla and 53 per cent in Mandi. The people of the state have yet again reposed their faith in the lead-

ership of the Prime Minister," said Thakur.

As for the defeat in the

bypoll elections, in which the BJP won two seats as opposed to the Congress pocketing four, Thakur refused to see it as the rejection of BJP's 'Operation Lotus' in the state. "It's wrong to assume that Operation Lotus was executed in the state. The Congress MLAs were simmering with anger due to the humiliation they were facing in the party, and they decided to leave the party of their own accord. The mess was created by the Congress, the BJP was not responsible," said Thakur.

Thakur, however, warned that the Congress government was still not out of the troubled waters. "The win in four bypolls is merely a momentary relief for the government; the trouble is not over yet. The High Court has reserved its decision on six Chief Parliamentary Secretaries, and we hope it would be pronounced soon after the courts reopen," said Thakur.

### BJP seeks strict action in Kangana slappingcase



### Economic hurdles

BJP must walk the talk on jobs, inflation

CONOMIC issues such as unemployment, high inflation and falling income levels played a key role in determining voters' choices in the Lok Sabha elections, according to a postpoll survey conducted by the Centre for the Study of Developing Societies (CSDS) and Lokniti. These factors proved crucial as the ruling BJP fell short of securing a majority. At least 30 per cent of the respondents who voted in the General Election said they were worried about inflation, whereas the corresponding figure was 20 per cent in the pre-poll survey. Unemployment was the main worry for 32 per cent of the respondents in the pre-poll survey; this dropped to 27 per cent after the elections, possibly due to the employmentrelated promises made by various political parties.

What clicked with a significant section of the voters was PM Modi's leadership and the BJP-led government's efforts towards developing the country, besides its governance and welfare schemes. Ironically, the construction of the Ram Mandir was the 'most liked work' of the government, as per the survey, even though the BJP lost the Faizabad seat in Ayodhya district and performed well below the expectations in Uttar Pradesh.

Even as coalition pulls and pressures are set to test Modi's mettle during his third term, the BJP needs to realise that the PM's aura is no longer what it was a decade or even five years ago. The party can't always rely heavily on his mass appeal to win elections. It will have to walk the talk on generating employment opportunities and taming inflation. Making India a developed country (Viksit Bharat) by 2047 is too distant a goal. The country's young citizens, in particular, can't wait too long for the fulfilment of guarantees of high-quality education, world-class sports facilities and lucrative employment and entrepreneurial avenues.

### Delhi's water crisis

SC orders smooth flow from HP via Haryana

HE Supreme Court's directive to Haryana to ensure that the additional water Himachal Pradesh has agreed to supply reaches Delhi underscores the issue of water politics in India. Since HP does not share a border with Delhi, the water must be routed through the Wazirabad Barrage in Haryana. Amid a scorching heatwave, Delhi is grappling with a water crisis. The court's call for an apolitical approach to water distribution highlights the fundamental need for cooperation and rational resource management among states.

Delhi relies heavily on neighbouring states for its water supply, making it vulnerable to inter-state disputes and inefficiencies in water management. The matter has been contentious for years, reflecting deeper systemic issues in water governance. Haryana has frequently been accused of withholding Delhi's fair share, citing its own water needs and lack of clear mechanisms to measure surplus supplies from HP. These disputes escalate during summers, leading to legal battles. The Upper Yamuna River Board (UYRB), meant to mediate in such cases, has been criticised for its ineptitude, highlighting the need for a cooperative, transparent approach to water management. The ongoing crisis not only threatens publichealth but also highlights the necessity for sustainable and equitable water management practices.

Meanwhile, the Delhi government also needs to fix its inefficiencies, including water wastage — which is reported to be over a shocking 50 per cent due to leakage, theft and the tanker mafia — and crack down on illegal connections. Simultaneously, efforts must be intensified to spur robust inter-state cooperation and effective implementation of agreements facilitated by bodies like the UYRB. This requires an apolitical, collaborative approach to water management that prioritises the needs of all citizens. Sustainable water practices must become the norm to prevent future crises and ensure equitable distribution of this precious resource.

O'Dwyer-Nair case

AFTER a protracted hearing, the O'Dwyer-Nair libel case came to a close on Thursday last. Sir Michael O'Dwyer has won the case and has been awarded damages. No one in India, no one at any rate who followed the latest proceedings in the case, can say that this result was unexpected. It was in fact the very result which the public had been anticipating ever since the Judge had opened his lips in the case. From the first, he had made no secret of his sympathies. He had simply been 'out-O'Dwyering' O'Dwyer. He found nothing wrong in anything that any authority, whether civil or military, had done in the unforgettable days of Martial Law in Punjab and in every single case in which he interrupted a witness or put a question to him, he was defending some authority or some case of official bungling or other. The summing up was entirely worthy of all that the Judge had done before. It was not only a complete whitewashing of Sir O'Dwyer but an equally complete whitewashing of Gen Dyer, who was not before the court and who had not even been produced as a witness and subjected to a cross-examination. Even Sir O'Dwyer has said in his evidence that from Dyer's statement before the Hunter Committee, his conduct was indefensible. The Judge would not allow even this qualified condemnation to pass unchallenged. His own deliberate conclusion, based upon the whole evidence given in the case, he said, was that "Gen Dyer, under grave and exceptional circumstances, had acted rightly and that he was wrongly punished by the Secretary of State for India."

# Oppn parties must keep INDIA intact

The bloc has done well to disprove Modi-Shah's prediction of a runaway victory for the NDA

"ARENDRA Modi has won his third term as the Prime Minister. It was not the cakewalk that the exit polls had predicted. The BJP managed just 240 seats, well below the half-way mark of 272. It will have to accommodate its partners in the NDA in order to govern. The Telugu Desam Party (TDP), the Janata Dal (United) and others together picked up 50-odd seats; this will pose a problem for Modi in allocating Cabinet portfolios.

The NDA, which includes the parties that had a pre-poll understanding with the BJP, secured more than a hundred seats less than the 400-mark that Modi had set. He is still the most capable political leader in the country, but his authority has diminished. He will have to rethink his strategy of governance, particularly how he treats political opponents and the minorities.

Modiused the 'Hindu majority versus Muslim minority' card to gain electoral victory. It worked in 2014 and 2019. But with this modified mandate, he will have to change his approach. Clearly, it is not a winner anymore. He needs to discipline the fringe elements in the Sangh Parivar who had free rein in the first 10 years of his reign and had tasted blood. Taming them will take some doing. It is not easy to rebottle the genie once it is released.

Modi will have to concentrate on jobs and unemployment. This should be his first and foremost concern in his third term. His meditation at the Vivekananda Rock Memorial must have filled him with thoughts of things to do and also, I hope, things he should not do. All that will need to be revised in the light of the

harsh message that Indian voters have delivered. He will have to start with the basics education and health.

Here, he should draw lessons from his opponent, Arvind Kejriwal, and the Aam Aadmi Party. That party has made major strides in both fields. Unless the productivity of our labour force is raised by many notches, we will not be able to match our neighbour to our east, which has stolen a march of 50 years or more on us. For productivity to improve, the levels of education and health of the lowest economic brackets have to be lifted by their bootstraps.

Modi also needs to moderate his dislike for those he calls 'urban Naxals'. Most of them come from affluent families but have developed an outsized concern for the poor and the dispossessed. Last week, I wrote about Alpa Shah and her book on the 16 Bhima Koregaon accused. Two or three of the 'BK 16' were deeply concerned for the tribals. Eight were Dalits fighting for the empowerment of their community. None had shown any violent streak. None had pushed their followers into activities that could be classified as violent. Yet, they had been incarcerated for years under the draconian UAPA. Modi should give the green signal for the release on

bail of those still in jail. That would signal a change of heart that is urgently needed.

With the BJP failing to secure a majority on its own, stability is not assured. Chandrababu Naidu's TDP and Nitish Kumar's JD(U) do not share the BJP's Hindutva ideology. What is needed now is course correction on the lines spelt out by me earlier. That course correction is necessary to retrieve Modi's fast-fading reputation as a 'oncein-a-lifetime' leader with the qualities that befit a statesman.

The INDIA bloc had come together to oust Modi from power. Its members were aware that when he ruled from his vantage position as the elected leader, he was likely to crush them one by one, like he had disposed of the old leaders in his own party and kept upcoming leaders guessing. Modi is a natural-born leader with a sharp instinct for survival. He is not going to allow this 'defeat' to demoralise him.

Modi had declared that INDIA

would dissolve into thin air after its defeat in the polls. Taking a cue from his own wisdom, these leaders should think positively. They have fought a valiant battle and should not consider this electoral loss as a defeat. They have disproved Modi's and Shah's prediction of a runaway victory for the NDA as a gross miscalculation. It could even be interpreted as a slap on the face of the two leaders. The BJP enjoys only 37 per cent backing of the Indian people. The NDA collectively is slightly better at 41 per cent. The majority of the Indian electorate is not with Modi and his ideology.

Keeping this in mind, INDIA constituents need to stick together for survival. Sharad Pawar, once Maharashtra's strongman, predicted that smaller parties in INDIA would merge with the Congress. I doubt if that would happen. An up-and-coming leader like Kejriwal has his sights on the PM's chair. There is no chance of his party merging with the Congress, which AAP has already reduced to irrelevance in the national capital territory. Incidentally, AAP's own

performance in these elections was quite miserable.

The Election Commission of India (ECI) was the recipient of much flak, mostly uncalled for but some well-deserved. Its hesitation to rein in the PM, particularly for vituperative remarks bordering on the scandalous, was the real cause of the epithets hurled at the commission. The loss of credibility of the ECI is the biggest negative outcome of this year's Lok Sabha polls. That could have been avoided in the 'Mother of Democracy'.

The exit polls were unanimous in proclaiming the BJP as runaway winner of the Lok Sabha polls. I had calculated that the BJP would win but not with such a wide margin. The less affluent sections of the country's population were solidly behind Modi. The domestic help, security guards and others of the same economic bracket, hailing from UP, Uttarakhand and Bihar, were solidly pro-Modi.

The BJP had lost traction among those who had benefited the most from its economic policies. Iam not referring here to the captains of industry and the businessmen at the top of the corporate ladder, but to their highsalaried employees.

Even the monthly dole of 5 kg of rice or wheat for each 'below poverty line' ration-card holder seemed to have swayed them. The direct transfer of subsidy to individual bank accounts, the pension payments to widows and welfare grants to women for education or their marriage expenses - all these played on the minds of the less fortunate, without whose votes victory was out of the question.

The salaried and, more than them, the intellectual class, which would normally have supported aright-wing dispensation, had begun questioning the government's approach to human rights and freedom of speech. Some of the political moves against its adversaries also came up for scrutiny. The BJP lost the votes of these people, but the loss was compensated by the freshly minted votes of the poor.

### With a *namaste*, touch the hearts

HE other day, my nephew came home. He had been living in Canada for almost a decade before family commitments made him return to India. He always greets me with a hug, saying 'hello, maasi' with a wide smile. But this time, he greeted everyone with a namaste. When asked why, he said he missed the warmth of namaste abroad and believed that this word expressed reverence for the person he greeted.

I was transported to the times when, as kids, we used to wish our teachers with folded hands and a namaste; later, it became 'good morning' and, finally, 'hello ma'am'. Among family and friends, it was 'hello, aunty' or 'morning, uncle'. While I appreciate all these forms of greetings, I think the culture of namaste ingrained in the Indian sensibility is more than just a casual greeting. It is a gesture transfixed in the rich tapestry of tradition and imbued with spiritual significance.

Namaste transcends a cursory hello; it embodies a connection with oneself, with the others and the universe. Namaste finds a mention in the Vedas. It is a combination of two Sanskrit words: namah, which means 'bow', and te, which means 'to you'. Hence, it translates to 'I bow to you' or 'the divine in me bows to the divine in you.' Namaskara is more polite, as kara means 'making' or 'doing'. Combined with namah, it means 'showing reverence'.

The gesture is also an integral part of Indian classical dance forms, religious rituals, yoga, auspicious ceremonies and spiritual practices.

In 1985, during my sister's marriage, my brother-in-law's paternal uncle instructed the bride and groom to greet each other with folded hands before the 'Jai Mala' ceremony. Pin-drop silence followed the request. The uncle explained that namaste in the 'anjali mudra' (the prayer pose) was a symbolic gesture; the pressing of palms together in front of the heart, accompanied by a slight bow of the head, had spiritual significance. It was a powerful tool for fostering respect and understanding in a diverse and inter-connected world, a way of creating a spiritual connection between souls, he said. Then, not only the bride and groom but everyone also greeted each other with a namaste. The moment was crystallised in many photographs.

As the world has become a global village, the age-old gesture of namaste has found a place in the hearts of some political leaders and statesmen. They are using it to bridge the cultural divide. I believe we can't hold love in our hands, but we can make someone feel it in the heart by just folding our hands and saying namaste. It is a great way of expressing our love, friendship, gratitude and respect to the people we meet.

# Tolerance & acceptance count in polarised times


T the conclusion of his much-publicised meditation at the Vivekananda Rock Memorial in Kanniyakumari recently. Prime Minister Narendra Modi said: "Swami Vivekananda, a leader of spiritual renaissance, has been my ideal, my energy and the source of my spirituality." Modi is only one of the countless Hindus to be inspired by Swamiji since he entered the nation's consciousness in the 1890s, primarily through his impactful speech on the Hindu faith at the Parliament of Religions in Chicago in 1893. His message to the Hindus, and the youth in particular, to be strong but also compassionate, is of everlasting significance. The question is whether Modi's spirituality is on all fours with the ideals that Vivekananda firmly believed in, lived by and espoused.

Vivekananda and his companions established the Ramakrishna Mission to spread the ideas and ideals of their masters, Ramakrishna Paramahansa, and Sarada Maa. The mission has carried blood, destroyed civilisation And, political leaders who

forward their spiritual teachings. It is good that the Prime Minister has rejuvenated himself with this spiritualism as he will begin his third term but, for the first time, leading a full-fledged coalition government.

The core of Vivekananda's

understanding of the Hindu way of life was expressed by him in his address at the inauguration of the Parliament of Religions. Calling Hinduism the "mother of religions", he said: "I am proud to belong to a religion which has taught the world both tolerance and universal acceptance. We believe not only in universal toleration, but we accept all religions as true. I am proud to belong to a nation which has sheltered the persecuted and the refugees of all religions and all nations of the earth... I will quote to you, brethren, a few lines from a hymn which I remember to have repeated from my earliest boyhood, which is everyday repeated by millions of human beings: 'As the different streams having their sources in different paths which men take through different tendencies, various though they appear, crooked or straight, all lead to Thee'." He went on to add: "Sectarianism, bigotry and its horrible descendent, fanaticism, have long possessed this beautiful earth. They have filled the earth with violence, drenched it often and often with human

and sent whole nations to despair. Had it not been for these horrible demons, human society would be far more advanced than it is now." He concluded with the fervent hope that fanaticism and persecution would end.

I have extensively quoted from Swamiji's address because his message on central Hindu beliefs is particularly relevant to our polarised times. If 'tolerance' and "accepting all religions as true" are the essence of the Hindu faith, it logically follows that all Hindus should accept these propositions and live by them without linking them to the beliefs of the adherents of other faiths.

have been inspired by them should demonstrate their commitment to these ideals through the correct implementation of their policies instead of just mouthing slogans. This obviously can never mean that Hindus should meekly accept deliberate contempt or distortion of their great faith.

The election campaign of the BJP, in particular, drifted away, in part, from the path of tolerance and acceptance. The political class should carefully consider how to preserve the values of tolerance and acceptance even during an election campaign. A model/moral code of conduct can only be upheld if these values are not abandoned during campaigning. Yes, the cut and thrust of arguments and forcefully putting forth views which support a party's thinking and programmes are part of politics and electioneering. Yes, campaigns can generate heat through criticism and even sarcasm, but should they go beyond all that? Certainly, Swamiji would have been appalled at the utterances of some of the leaders during the campaign.

In a recent article, Modi wrote that as he continued with his meditation at the rock memorial, "the heated political debates, the attacks and counter-attacks, the voices and words of accusations, they all vanished into a void". The point is that all people are not as spiritually evolved as he is. They cannot forget unkind words. The words remain in memory, gnawing away at their emotions and their sense of self-worth. It can even be asserted that historical wrongs cannot be corrected by causing anguish among large sections of people. Other ways to address them have to be found.

Swamiji denounced sectarianism, bigotry and fanaticism. These characteristics are not the monopoly of any faith. The Constitution, too, mandates that all Indians will be treated equally. It obliges political leaders to make equality the foundational principle of governance. It is insufficient that all sections of the people be Modi's campaign speeches.

given equal access to the advantages of economic schemes for they need the assurance of living their lives without fear and with dignity. They should also have a sense of participation in governance. Some of the political utterances during the campaign sailed close to the characteristics that Vivekananda had denounced.

HE ruling African National Congress (ANC) has recorded its worst poll performance since the end of apartheid in South Africa three decades ago. It has bagged barely 40 per cent of the votes in the recent elections, even as former President Jacob Zuma's newly founded uMkhonto weSizwe(MK) Party secured a vote share of 15 per cent.

South Africa went to the polls on May 29. Voting was held for the formation of Parliament and state Assemblies. The new Parliament will elect the President. Observers have viewed the poll outcome as a sign of the diminishing value of the single-party system. A transition to a coalition government was anticipated, but the scale of the ANC's decline is huge. Will this lead to a more mature polity? Or, like in other African countries, will election outcomes widen fissures? Kenyan President William Ruto, who led the African Union (AU) observer mission, suggested a coali-

tion based on agreement.


Since the end of apartheid in 1994, the ANC has had a majority in both Houses of Parliament. The party's vote share had been in excess of 60 per cent, except in 2019, when it dipped to 57.5 per cent.

Though the ANC still has the largest vote share, it lacks a majority to form the government. It is holding talks with other parties over stitching together a ruling coalition. A 14-day window for government formation is open.

While the White-dominated Democratic Alliance (DA) has improved its vote share from 20.77 per cent to 21.69 per cent, the Economic Freedom Fighters (EFF) has seen its share decline from 10.8 per cent to 9.46 per cent. The good performance delivered by Zuma's MK is the major reason why the ANC has lost ground, mainly in KwaZulu-Natal.

With Cyril Ramaphosa as the President, South Africa tried to play a larger role on the world stage. A stable nation would be able to continue to do so. A coalition government, however, would need to harmonise the

nuances of foreign policy. The MK and the EFF are unlikely to have major differences with the existing foreign policy. Their domestic demands may be stronger. A coalition

including the DA will lead to a balancing act in foreign policy and perhaps push South Africa to a less strident anti-West position. The DA is a centre-right party with an anti-corruption and economic reform agenda, which is preferred by investors.

In the past five years, the salient features of South Africa's policy have included a closer engagement with China and, consequently, with Russia. It has distanced itself somewhat from the Western bloc. After initial criticism of the Russian action against Ukraine, not only did South Africa abstain from voting on UN resolutions pertaining to the conflict, but it also led an African peace initiative to visit both warring countries. This is not in consonance with the position held by the US-led West on Ukraine.

Between 2019 and 2021, South Africa held a non-permanent seat on the UN Security Council and chaired the AU. The challenges posed by the Covid-19 pandemic and the civil war in Ethiopia during that period showed the limitations of South African influence.

During its BRICS chairmanship in 2023, South Africa played a role that was aligned with China's push for rapid expansion of the grouping. It is uncertain if the new members Ethiopia, Saudi Arabia, the

UAE, Iran and Egypt — are beholden to South Africa in any way. If South Africa was trying to project itself as a leader of the Global South, it failed as it couldn't persuade Argentina and Indonesia to join the bloc.

South Africa, which will take over as the G20 president in 2025, will become the fourth country in a row from the South (after Indonesia, India and Brazil) to chair the multilateral body before the US assumes its presidency in 2026. It remains to be seen whether South Africa will play the role of a Global South leader or a Chinese-

influenced president. South Africa has been taking the lead in the World Trade Organisation in conjunction with India in regard to issues of importance in the countries of the Global South. On the West Asian crisis, it has stepped out of the crease to attack Israel through the International Court of Justice, invoking the Genocide Convention.

South Africa is learning to cope with a changing world. Some analysts, who are sceptical of Ramaphosa's foreign policy, blame him for a decline in the nation's global moral standing. Some believe that he focuses on international crises as it diverts attention from domestic issues. The huge blow to the ANC may see Ramaphosa lose his presidency unless the coalition partners value his potential for stability.

A coalition government will test South Africa's ability to push a stronger foreign policy agenda. Even if Ramaphosa survives the electoral disappointment, the churn in the ANC will continue. He will need to project a stronger voice for the Global South. Domestic politics and foreign policy are interrelated. What happens domestically impacts a country's global stature.

Arina Muresan of South Africa's Institute for Global Dialogue stated that in a coalition, the partners' oversight over policy would increase through Parliament. The DA is an investor-friendly party. It will not hedge relations with China and Russia if the business makes progress, but it will seek adjustments with the West and Israel. The DA has questioned the anti-Israel economic policy. Evidently, the coalition partners will need a common minimum programme. This will be a new experience for South Africa.

For India, what matters is that a stable South Africa plays an important role in the next troika of the G20 presidency, including Brazil and the US. India sees South Africa as an important partner in the BRICS and G20 forums and hopes to strengthen the bilateral relationship.

Responding to Parra's remarks, Omar said: "I spent my entire campaign talking about Rashid's release and unlike his campaign, I talked about the release of the 1000s detained since 2019."

Omar said the articles he had

shared on X were not his views but they were a point of view. "I may agree with parts, disagree with parts but they are an opinion. As for Rashid's release, it's a matter for the courts to decide. I didn't agree with Rashid's detention in the first place and I don't agree with it now but that's neither here nor there because it shouldn't be just about one man but about the 1000s in jail, including the anonymous ones outside J&K," Omar added.

Rejecting Omar's assertion, Parra said while the PDP endorsed his plea for the release of all political prisoners, "we must at least find consensus on the return of one such prisoner, Er Rashid, who was also your Assembly colleague". The PDP leader added that

if a mandate was misconstrued as militancy, it would inevitably sow confusion and backlash against the mainstream political forces in J&K. Later, other NC leaders also

joined the debate, asking Para: "If the state allowed you to walk out on bail on the exact same charges, it should also allow Abdul Rashid Sheikh to come out who faces the same charges." NC's spoke sperson Ifra Jan

said: "Your cook continues to be in jail but finds no mention in your speeches." Apni Party leader Hassan Mirsaid: "The NC has survived always because of its stance against Delhi, which it always played as a buffer. Engineer Rashid won because of sympathy as a victim. There is no separatism element in his win. The people are the masters."

### Court seeks NIA responseon jailedleader's interim bail plea

NEW DELHI, JUNE 6 A Delhi court on Thursday directed the NIA to respond by tomorrow to an applica-

tion filed by Engineer Rashid, arrested in a 2016 terror funding case, seeking interim bail to take oath as an MP after the recently concluded General Election. Former J&KMLA Sheikh Abdul Rashid, popularly known as Engineer Rashid, defeated former Chief Minister Omar Abdullah in the 2024 Lok

Sabha poll from Baramulla.

He moved the court seeking interim bail, or custody parole in the alternative, to take oath and perform his parliamentary functions. The application was moved before Additional Sessions Judge Chander Jit Singh on June 4, and had directed the NIA to file its response by today. However, the agency on Thursday sought more time to file the reply. Rashid has been in jail since 2019 after he was charged by the NIA under the UAPA in the alleged terror funding case. - PTI

### 89 of 100 Lok Sabha candidates lost security deposit in 5 J&K seats UP home turf: Omar

Nearly 90 per cent of the candidates vying for the five and Kashmir lost their security deposits, unable to garner one-sixth of the votes polled in their respective constituencies. The voters gave a decisive mandate to the eventual winners on all but one Lok Sabha constituency in the Union Territory, the Election Commission data revealed.

Of the 100 candidates in fray, 89 lost their security deposits, the data showed. Sheikh Abdul Rashid, an Independent contender who defeated political heavyweights — former CM Omar Abdullah and Peoples Conference chief Sajad Gani Lone — in Baramulla Lok Sabha seat, was the sole win-

ning candidate who secured less than 50 per cent of the total votes polled, with a vote ba Mufti from Anantnag, Lok Sabha seats in Jammu share of 45.70 per cent.

> Baramulla is the only constituency in Jammu and Kashmir where the third placed candidate - Sajad Gani Lone —was able to save his security deposit.

Lone had polled 16.76 per cent votes against the requirement of 16.34 per cent for saving the security deposit. While NC leader Aga Ruhullah Mehdi got the highest percentage of votes at 52.85, BJP's Jugal Kishore who made a hat-trick win from Jammu garnered 52.80 per cent of the votes.

In Udhampur, BJP leader and Union Minister Jitendra Singh, who also won for the third time in a row, got 51.28 per cent votes while NC's Mian Altaf Ahmad, who defeated former CM Mehboosecured 50.85 per cent votes.

Ghulam Nabi Azad's DPAP was routed at the hustings as all three of its candidates lost their security deposit. In fact, none of his party candidates managed to secure even four per cent of the votes.

Ghulam Mohammad Saroori, who contested from Udhampur Lok Sabha seat, received 3.56 per cent of the votes, while Mohammad Saleem Parray got 2.49 per cent votes in Anantnag-Rajouri and Aamir Bhat 2.24 per cent votes in Srinagar.

There were seven women in the fray in these five constituencies and only PDP president Mehbooba Mufti managed to save her security deposit. — PTI

negotiators engaged with key allies on non-negotiables with top sources saying both Naidu and Nitish have "placed their trust in the PM, who will finalise the portfolios".

The Lok Sabha Deputy Speaker's position is on the table for friendly parties. Importantly in the outgoing LS, there was no Deputy Speaker. The BJP had wanted to give it to the BJD, but the BJD had not zeroed in on any leader. BJP sources also said all alliance partners would be part of Modi 3.0 Council of Ministers. From the JD(U), former

party president Lalan Singh and Devesh Chandra Thakur, a first-time MP from Sitamarhi and former Bihar Speaker, are among the frontrunners for Cabinet posts. Modi is likely to take oath as the PM for the third time on June 9.

getting a perfect score of 720 out of 720. They also pointed out the same sequence of roll numbers of some of the top rank holders. A majority of these candidates are from same examination centres in different states — Rajasthan (11), Tamil Nadu (8), Maharashtra (7), Haryana (6) and then four each from Andhra

Pradesh and Bihar. In 2019 and 2020, there was one topper each. There were three toppers in 2021, one in 2022, and two last year. Scorecards of students getting 718 and 719 marks were circulated on social media, which educationists claim is impossible to achieve when each NEET question carries four marks and one mark each is given for negative marking. If a student omits a question four marks get deducted and if an answer is wrong five marks are reduced. So a student can either score 716 or 715.

In its defence, the NTA said candidates who experienced time loss during the examination had been granted grace marks. At several centres there was a delay in distribution of question papers, which resulted in loss of time of candidates.

The NTA, in a statement, said it received a few representations from candidates raising concerns over loss of time during the exam held on May 5 and hence grace marks were given. "Such cases/representations were considered by the NTA and the normalisation formula, which has been devised and adopted by the apex court in a judgement from 2018, to address the loss of time faced by candidates. The loss of time was ascertained and such candidates were compensated with grace marks. So their marks can be 718 or 719 too," the NTA said. Although the agency dis-

missed the paper leak claims, the Bihar police arrested 13 persons in connection with it in May. A criminal case was filed against three individuals in Gujarat's Godhra district.



but only 74 of them emerged victorious. West Bengal, which has the only woman Chief Minister in the country. elected the highest 11 women MPs, all of them from the Trinamool Congress.

Uttar Pradesh and Maharashtra, having 80 and 48 seats, respectively, have elected seven woman MPs. Several states, including Kerala, Goa, Manipur, Sikkim, Arunachal Pradesh, Meghalava and Nagaland, which together have 31 seats, did not elect any woman MP.

the National Capital of Delhi have elected one woman MP each of the total 39 seats in these states. The BJP had fielded 69 woman candidates, but only 31 of them won. 
As the contours of the new government will emerge on Tuesday, a series of key tasks would need attention in the Ministry of Defence.

These would include taking forward the military's structural reforms, reducing import of weapons and continuing with policy to tackle China along the Line of Actual Control (LAC). The new government faces

the pending military reforms — creating theatre commands or having an integrated force with all elements such as cyber, space, land, air and sea. These have been given a final shape and a formal proposal from the Department of Military Affairs would be sent to the government for approval. The proposal is in three

demarcated timelines till 2047 by incorporating changes in technology, addressing the changing nature of warfare and integrating the abilities of the three armed forces. This is a task laid out by Narendra Modi government when the Post of Chief of Defence Staff was created in January 2020, now things have reached a decisive stage. Another issue for the new

government is tackling the dichotomy between the export of military equipment and India's continued run as the largest importer of weapons in the world. In the previous fiscal, India's exports of military equipment stood at Rs 21,083 crore. However, despite locally made warships, fighter jet Tejas, nuclear submarine INS Arihant, missiles like Akash and BrahMos, New Delhi keeps on emerging as the top global importers of weapons.

Sweden-based Stockholm International Peace Research Institute (SIPRI) in its report on March 10 this year said Indiamaintained its position as the world's top arms importer. The SIPRI tracks arms sales globally and produces an annual report. India imported 9.8 per cent of all global arms between 2019-2023, it said.

Another pressing issue is China. Four years ago in April 2020, Beijing amassed troops, hundreds of guns, tanks, missiles and long range artillery on its side of LAC in Eastern Ladakh. After April 2020, the Naren-

dra Modi government ramped up troop numbers, added equipment and moved elements to send a message across the LAC. Since then the two sides are locked in a military stand off. The situation has somewhat improved but restoration of status as in April 2020 has not been achieved.

After 21 rounds of military commander-level talks there has been partial success. And importantly all agreements on maintaining peace and tranquillity along the LAC were disregarded by China. Within the security establishment, it is an accepted fact that new agreements are needed.





## 40 killed in Israel's 'targeted' strike on UN school in Gaza

CAIRO/IERUSALEM, IUNE 6 Israel hit a Gaza school on Thursday with what it described as a targeted airstrike on up to 30 Hamas fighters inside. A Hamas official said 40 people, including women and children, were killed as they were taking shelter in the UN site.

Video footage showed Palestinians hauling away bodies after the attack, which took place at a sensitive moment in mediated talks on a ceasefire that would involve releasing hostages held by Hamas and some of the Palestinians held in Israeli jails.

The United States issued a joint statement with other countries on Thursday calling on Israel and Hamas to make whatever compromises were necessary to finalise a deal after eight months of war in the Gaza Strip.

Ismail Al-Thawabta, the director of the Hamas-run government media office, rejected Israel's assertion that the UN school in Nuseirat, in central Gaza, had hidden a Hamas command post.

The US State Department imposed sanctions on Thursday on the Palestinian militant group, Lion's Den, in the Israeli-occupied West Bank, the department said. Department spokesperson Matthew Miller cited attacks by the group on Israelis as well as Palestinians in the West Bank since 2022.

They were elected by a secret ballot in the UN General Assembly. In the two seats for African and Asia-Pacific States, Somalia got 179 votes and Pak-

istan received 182 votes. Among the Latin American and Caribbean States, Panama got 183 votes, while in the Westem Europeanandother States, Denmark got 184 votes and Greece got 182 votes.

# Parting without a gift

India play out goalless draw against Kuwait in Chhetri's last international match

The talismanic Sunil Chhetri stirred up emotions in his final international outing but the Indian football team just could not rise to the occasion as it settled for a goalless draw against Kuwait in its crucial World Cup qualifying match here today, critically hurting its chances of going into the next round.

In a country deprived of major footballing success, it was not the best farewell for a man who had created an alternative universe for the spectators of the beautiful game in this part of the world.

An emotional Chhetri was seen sobbing after the end of the match and when he was given a guard of honour by his teammates he buried his face into head coach Igor Stimac's arms while crying.

A win would have virtually sealed India (five points) a berth in the third round of the World Cup Qualifiers for the first time ever but the draw put them in an extremely difficult situation as they play Asian champions Qatar in their last match on June

If India fail to beat Qatar, then Kuwait -- currently on four points - can make it to the third round of the World Cup qualifiers if they beat Afghanistan on June 11.

"It's been tight against Kuwait in recent times. We didn't open the game enough today, we were not aggressive enough in the middle. It's been happening for too long, not being clinical in front of goal. Today, thank god, Gur-

preet (in goal) was brilliant. When it matters most he's there. But other players were not there enough today. Rahim Ali makes great runs but goals need to come. He could have scored from the chance he had," Stimac said.

The 39-year-old Chhetri ended his glorious 19-year international career as the fourth most prolific scorer in international football with 94 goals, behind Portugal super-



star Cristiano Ronaldo (128). Iran legend Ali Daei (108) and Argentine wizard Lionel Messi (106).

It's an astounding feat for a player from a country like India and FIFA had acknowledged Chhetri's legendary status when he announced his international retirement on May 16.

Chhetri bid an emotional adieu to the international game in front of a jampacked 68000-capacity Salt Lake Stadium, with his parents Kharga and Sushila, wife Sonam Bhattacharya and a host of officials and former players in attendance.

He will, however, continue playing club football for "two more years". He has a contract with the Indian Super League side Bengaluru FC till next year.

Chhetri had scored in his debut match against Pakistan on June 12, 2005, in Quetta in a 1-1 draw. After his 151st match for the country, Chhetri gave a last bow, taking a lap of honour of the packed venue with folded hands as chants of "Sunil, Sunil" echoed the stands.

"For the ones who have followed me in my career, for the ones who have seen me in videos, for the ones who have taken autographs, for the ones who have been my old-time supporters, thanks to everyone. These 19 years would not have been possible without each and every one of you, and I genuinely mean it. For everyone who is here, thank you so much," Chhetri said. — PTI

Unlike in the case of Arshpreet and Servin, the Athletics Federation of India (AFI) is trying to get Suraj's old timings restored by the World Athletics (WA).

AFI president Adille Sumariwalla said that it was too early to conclude about the latest case.

"We will have to wait for the final list of World Athletics. It is premature to discuss at this point when three weeks are still left," Sumariwalla told The Tribune on Thursday.

Each national sports federation can only field a maximum of three athletes in the men's 20km race walk event for the Paris 2024 Olympics. Apart from Akshdeep, Ram Baboo, Paramjeet Singh Bisht and Vikash Singh have so far achieved the qualifying mark. Those who have dropped from the list will now have to compete at the national championships later this month in Panchkula.

## Stoinis runs show as Aussies win

The 22-year-old shot a 242.7 in the eight-man final, leaving behind his nearest competitor Bu Shuaihang of China by 0.2 points as Germany's Robin Walter won bronze. Sarabjot had on Wednesday

shot a top score of 588 to qualify for the decider. The final had in its line-up the reigning world champion Bowen Zhang of China and four-time Olympian Yusuf Dikec of Turkey, besides Bu and Walter.

Under the circumstances, Sarabjot delivered a fine pillar-to-post victory for his second individual World Cup medal, after his breakthrough gold last year in Bhopal.

### Court denies bail to Kejriwal, says he's fine

The extensive campaigning tours and related events undertaken by Delhi Chief Minister Arvind Kejriwal indicate that he does not appear to be suffering from any serious or "life threatening" ailment, a Delhi court has held while denying him interim bail.

In yet another setback to Kejriwal, the court on Wednesday dismissed his application for interim bail on medical grounds in the money laundering case linked to the alleged excise policy scam, as reported by the PTI.

"The extensive campaigning tours and related meetings or events undertaken by Arvind Kejriwal as highlighted during the course of arguments indicate that he does not appear to be suffering from any serious or 'life threatening' ailment so as to entitle him to the benefit," Special Judge Kaveri Baweja said. The judge also extended Kejriwal's judicial custody till June 19. The court is scheduled to take up on June 7 his application seeking default bail in the case.

In the order, the judge further held that grant of interim bail for conducting tests in



## Rural distress costs BJP dear in LS poll

The rural distress coupled with farmers' unrest seems to have played a significant role in the BJP's rout in rural and semi-rural constituencies, preventing the party from getting a simple majority by bringing its tally from 303 to 240.

The decline in the support for the BJP in rural areas can be attributed to several factors - economic strain, failure to double farmers income, slowdown in agricultural growth despite overall economic gains, etc. An analysis of the Lok Sabha election results reveals that of around 300 rural and semirural seats, the BJP-led NDA managed to secure only 221, a notable decline from the 251 seats it won in 2019.

The results indicate a clear shift in rural voter sentiment as the opposition INDIA bloc madethemostoftherural distress and managed to capture 157 of these constituencies. This shift suggests a growing dissatisfaction with the cur-

There has been dissatisfaction with the government's pricing policies and minimum support price (MSP) provisions. These issues were exac-

erbated by the handling of farmer protests, particularly in regions like Punjab and Haryana. Besides losing 29 seats in UP

alone, as its number came down to 33 from 62, the BJP has lost 11 seats in Rajasthan, five seats in Haryana and two in Punjab, facing straight loss

of 47 seats in these four states as compared to 2019.

In additions to this, failure to open its account in Punjab. the BJP faced debacle in the farmer-dominated several constituencies. including Lakhimpur Kheri, Muzaffarnagar, Kairana, Saharanpur of UP, Hisar, Rohtak, Sonepat, Ambala and Sirsa in Harvana and Sikar, Churu, Jhunjhunu and Nagaur in Rajashtan.

As per experts, besides the issues of MSP and loan waiver, the action against Punjab farmers by the Haryana Government united the peasants. The Samyukta Kisan Morcha an umbrella body of nearly 40 farmer associations openly gave a call to oppose the BJP in the LS elections.

Devinder Sharma, an agriculture and food policy expert, said the electoral verdict clearly demonstrates that the farmers' anger had translated into votes against the ruling party. In nearly every two constituencies, the BJP faced defeat, highlighting setbacks in 38 farmerdominated seats.
