Price rise and inflation is increasingly burdening the citizenry who now will have to bear an additional burden when power bills reach their homes next month owing to an aggregate 3.5% hike in tariff which has become effective from this week.

Both high and low tension consumers across all categories -- domestic, commercial, industrial, agriculture and public sector -- will all face increased power consumption bills in July, a senior official of the electricity department said but the hike will be the maximum for the commercial

and industrial users. The most hit will be the manufacturing sector with high tension industrial consumers having to cough up a flat five paise increase per unit irrespective of quantum of consumption. They will

# **NEW DELHI**

Forty-one airports, including in Chennai, Patna and Jaipur, received bomb threat emails on Tuesday, prompting authorities to scramble contingency measures and carry out anti-sabotage checks that lasted hours, and each of them was found to be a hoax, official sources said.

Security was beefed up as agencies swept terminals after emails were received around 12.40 pm from the ID exhumedyou888@gmail.com.

The airports in Chennai, Patna, Nagpur, Jaipur, Vadodara, Coimbatore and Jabalpur were among those that received the threats.

An online group called "KNR" is suspected to be behind these hoax threat emails. The group reportedly issued similar emails to several schools in the Delhi-National Capital Region on May 1, the sources said.

The emails received by the airports carried almost the identical message: "Hello,

# to English-medium schools: NCERT **DIRECTOR SAYS IT IS NO LESS THAN SUICIDE**

#### **NEW DELHI**

NCERT Director D P Saklani has lamented that parents remain fascinated by English-medium schools even though many don't have trained teachers, saying it is "no less than suicide" as government schools now provide quality education.

The chief of National Council for Educational Research and Training said the practice of cramming content in English has led to knowledge loss among kids and distanced them from their culture.



"Parents are obsessed with English-medium schools, they prefer to send their children to such schools even if there are no teachers or they are not trained enough. This is not less than suicide and this

why the new NEP has stressed upon teaching in mother tongue," he said.

"Why should teaching be matrabhasha adharit (based on mother tongue)? Because till then we will not understand our own mother, our roots. And multilingual approach is not like teaching in any language is being ended, the push is to learn multiple

Similarly, the complaint stated that the employees has allegedly committed theft, dishonest misappropriation of public funds and criminal breach of trust by allegedly siphoning the money collected as fees and fines, from the vendors of the Municipal Council to his personal accounts.

"During the preliminary inquiry, it was revealed that the employee used the amount of Rs 17.96 lakh for his personal use and had depositing the amount in his personal bank accounts to clear up his personal outstanding loans. He further issued and affidavit dated June 14 to the Council admitting the fact that an amount of Rs 17.96 lakh is in his custody and he failed to deposit the amount to the Municipal treasury. On the same day, he deposited a sum of Rs three lakh in the Municipal treasury and further requested to grant some time to de-

posit the balance amount in the municipal treasury," the Chief Officer further stated in his complaint.

The complaint added: "After preliminary inquiry with the Municipal inspectors, accounts and taxation officer and the Head Clerk, it is revealed that all the fees and fines collected during the Purumentachem fair was taken into custody by the LDC unauthorizedly and an amount of Rs 17.96 lakh was allegedly fraudulently transferred by the employee to his personal bank account, thereby committing theft, misappropria tion of municipal funds and causing loss to the Municipal exchequer. The LDC has also unauthorisedly directly collected fees from some of the vendors to his personal GPay account, thereby committing criminal breach of trust."

# GCCI voices concern over power tariff hike, offers suggestions

The Goa Chamber of Commerce and Industry (GCCI) has expressed serious concerns regarding the recent hike in power tariffs across all sectors, which is set to significantly impact its members from various industries, including industrial, hospitality, agriculture, and allied activities. The tariff hike is the recommendation of the Joint Electricity Regulatory Commission (JERC).

During the public hearing conducted by JERC before the tariff increase, GCCI had proposed several alternative measures to generate additional revenue without burdening consumers. These suggestions were implementing steps to minimise power transmission losses to improve efficiency and lower costs and switching back from the current KVAH-based billing system to a KWH-based system to make billing more straightforward and cost-effective for consumers. Similarly, identifying high distribution loss areas and focusing on areas with high distribution losses and peak load restrictions to take corrective

er compared to major cities in India. To address these issues, the chamber suggested the installation of automated sectionalisers to enhance power distribution efficiency.

GCCI also recommended the formation of mini grids equipped with Battery Energy Storage Systems (BESS) and the utilisation of waste heat recovery gener ating stations at Amona to en hance the reliability and quality of power supply in the region.

# Peak power problem

To address the peak power shortage in Goa, GCCI urged JERC to direct the Electrici ty Department to explore alternative avenues such as pumped hydroelectric generation, BESS, and open tenders for procuring peak power. These measures, according to GCCI, would alleviate the peak power problem.

Despite repeated requests, GCCI also brought to JERC's notice that no district committee has been formed to review the quality of power supply. This oversight has led to continued dissatisfaction among consumers regarding the power quality.

The increased electricity tariffs for industries in Goa make it challenging for local industries to compete with those in other states, where industrial tariffs are lower This disparity poses a significant threat to the competitiveness and sustainability of Goan industries in the manu facturing sector, said GCCI director, Kiran Ballikar.

Desmond Alvares, an outspoken resident from Assagao, voiced his concerns on social media questioning the prioritisation of rave party promotions over essential traffic signals.

While the revenue from rave parties might benefit the local administration, the adverse impact on traffic safety and the environment cannot be ignored.

The situation calls for stricter regulations and enforcement to balance commercial activities with the community's quality of life.

Moreover, a sustainable approach to tourism and nightlife is essential to preserve the character and livability of the Anjuna-Vagator coastal belt.

The ongoing debate highlights the need for transparent governance and community engagement in decision-making processes. As the panchayat moves to remove the offending hoardings, it remains to be seen whether this action will lead to a more permanent solution to the problem.

# Mapusa brutal assault case victim dies after 18 days

# Family refuse to claim body unless main accused is arrested

Ahmed Devadi (30), a victim of a brutal assault on May 30 in Mapusa, succumbed to his injuries early Tuesday morning at Goa Medical College, Bambolim, after 18 days of treatment.

The Mapusa Police have now registered a case of murder against all suspects involved in the attack.

The assault, which occurred near an overhead water tank at the Housing Board in Mapusa, involved two victims – Ahmed Devadi from Laxminagar, Housing Board, and Sandesh Salkar (28) from Moira.

Both men were viciously attacked with iron rods by four assailants, leaving them with severe head injuries.

Sandesh Salkar is still recovering in the intensive care

Following the death of Ahmed Devadi, his family has refused to claim his body until the prime suspects, Ramkrishna Bhalekar, also known as RK, and his brother Babu Bhalekar, are apprehended.

The Bhalekar brothers remain at large.

On the day of the incident, Mapusa Police apprehended three suspects: Manthan Chiri (24), Sridhar Killedar (26), and Abhishek Pujari (20), all residents of Khorlim, Mapusa.

Subsequently, three more suspects - Sharanbasu Gaikwad (27), Nagaraj Pujari (19), and Boresh Pujari (38) – were also arrested.

Initially, the police had filed charges under Sections 120 (B), 307, 326, 506 (2), and 34 of the Indian Penal Code (IPC).

With Ahmed Devadi's death, the charges have been amended to include Section 302 (murder) of the IPC.

Sources suggest that the victims and their attackers were acquainted and had a personal dispute.

The assault was reportedly triggered by a recent verbal altercation between the victim and RK's brother, Babu, which had already resulted in a police complaint.

Mapusa Police Inspector Nikhil Palekar is leading the ongoing investigation.

The Anjuna Panchayat is poised to submit a compliance report regarding the recent sealing of illegal structures along the Anjuna and Vagator beach belt.

This follows the directives of the High Court of Bombay at Goa, which initially mandated the sealing of 175 unauthorised structures.

The compliance report will detail the actions taken and the current status of these establishments.

Earlier this year, on February 13, 2024, the High Court, while hearing a public interest litigation concerning illegal constructions, ordered the sealing of these commercial establishments.

# Why the silence on issues flagged by artistes on KA?

rotests over Kala Academy works erupted once again. This time, artistes from across the State came together on Monday demanding a white paper on the expenses incurred over renovation works and also sought the resignation of Art and Culture Minister Govind Gaude. The artistes threat-

ened to take to the streets if the structure was not restored to its original state within 15 days.

While artistes took turns pointing at shortcomings of the works and alleged misappropriation of funds, a representative of the Charles Correa Foundation pointed out that drastic changes had been made to the structure taking away the original aesthetics and vibe of the area. The representative stated that the restoration work lacked visual appeal and was of mediocre quality.

Interestingly, the meeting which was an open forum saw Gaude seated among the audience patiently listening to every line that was spoken, but chose not to comment despite him being a direct target of criticism. Gaude, who is an artiste himself, by attending the meeting sent out a message that he was ready to listen, and yes he did. But why has there been a silence or a pause? On the flip side, why is PWD also not held responsible? It is a foregone conclusion that the renovation work has gone bad, and whether one calls it overhead clogging of drainage resulting in leakages or something else, the fact of the matter is that there is something seriously wrong. A cross-section of artistes coming together to take up the issue shows that things are indeed not up to the mark. Lest we forget, Gaude had said that the sound system installed is of professional standard and needs to be tuned to the requirements of artistes. That means that the contractor is liable to take care of any problems that arise in the next two-and-a-half decades. The irony is that the State government is now pumping in another Rs 10.56 crore to repair the renovated structure, and what is more surprising is that this job has also been awarded to the same contractor. The agony of artistes is understandable, but the silence of Gaude and Chief Minister Pramod Sawant, who also holds the PWD portfolio, is baffling. We recall when Sawant issued directions to the PWD Chief Engineer to ensure that all repair work at Kala Academy is to be done on priority so that there are no leakages. Leakages happened even when the State witnessed the first showers in May. By ordering an audit of the renovation work and constituting a three-member technical committee to examine the alleged "corruption", "irregularities" and "illegalities" the government cannot assume that it has done its job. The need of the hour is to hear out the artistes and lay out an action plan. There has to be a white paper released on the expenses incurred on the renovation because accountability in public projects is a must. The assurances of quality work and world-class infrastructure appear hollow given the state of affairs of Kala Academy. It's time Gaude and Sawant view the entire Kala Academy renovation work through the lens of these artistes who are flag bearers of our art and culture.

# Do poll results show that nation is saved?

The traumatised souls of the last ten years are a pragmatic lot. They know that the nation is still not completely out of the woods

The country is saved", is how an elderly friend reacted when I called him up after the election results. I can't call him a left liberal but he is a hardcore political person for whom "country first" has been the leitmotif for life. I have known him for a very long time and can vouch for the honesty of his conviction. He was a worried man. We had had many discussions over the years since the Bharatiya Janata Party formed the government in 2014. As elections neared this time, he told me in one of his friendly but very enlightened chats that if the BJP were to get more than 300 seats, then the country would not be the same again; the Constitution would be changed, Parliamentary democracy would be consigned to the dustbin of history; Parliament and the Constitutional institutions would have no meaning and the country would be proclaimed a Hindu rashtra. No wonder, a large section of intelligentsia, journalists, professionals working in different walks of life, activists with no affiliation to any party, who had been critical of the Congress in pre-2014 era, and even those who were considered to be rightists or supporters of Hindutva philosophy, gravitated towards the Congress. In their opinion, the rise of right-wing fascist politics was due to the decline of the Congress as a robust political force. And if the country had to be saved then the Congress had to be strengthened. After the exit poll results, gloom permeated their hearts and the subsequent tense two days tormented them no end. But by 10am on June 4, once the results trickled in and it was apparent that the BJP was not getting the numbers that the pollsters had predicted, they were overwhelmed by relief and mobile phones started buzzing with congratulatory calls and messages. The nation has finally survived, was the common call. These are brilliant people who have done well in their respective fields, and wear love for the nation on their sleeves; yes they are not fashionably pompous about their patriotism – for them India is a lived reality, a commitment, and not a delusional society's false imagery. For them, nation means pluralism, a free society, freedom to express themselves, where



the voice of dissent is celebrated, not mauled; where minorities live with dignity without fear and persecution, where the state is creative and harmonious and not discriminatory, and liberty is the uncompromising cardinal principle of life.

But the traumatised souls of the last ten years are a pragmatic lot. They know that the nation is still not completely out of the woods. It's only a temporary recovery. The sun has peeped through the dark clouds but the bright sunshine is still far away. The new government has been formed. Unlike the last two, it's not a majority government. Crutches are needed to run it. The prime minister is theoretically weakened but his team is the same. Though, the coming week will unfold the truth about his real demeanour when parliament will be in session. Unlike the last two terms, the Opposition will be more robust, the Congress will be bolder due to its enhanced numbers in the Lok Sabha; one can see better floor coordination as the results have proved that if the Opposition is more cohesive and united then the government can be tamed. But with Modi at the helm, overconfidence can be disastrous. It is true that he has never run a coalition government ever since he became the chief minister of Gujarat. He always had a majority on his own and he was never constrained by mundane things in his party and the government. He was the boss and ran both the institutions like his fiefdom. In fact, he so jealously guards his power that he did not tolerate the RSS, and during his time as chief minister he ensured that none of the RSS pracharaks and officebearers would have any say in the party or in the government, and those who dared challenge his authority were brutally shown the door and could not survive. A similar model has been active in Delhi since 2014. It was his government. Even senior BJP leaders had no

authority, their job was to implement

what was being decided or ordered by the powerful PMO. Through Amit Shah, the prime minister has total control over the party. Now the situation has changed.

Nitish Kumar and Chandrababu Naidu are mavericks. They know how to protect their interests and demand their pound of flesh. Both have worked with the PM in the past and had their skirmishes with him; together they command 28 seats, which is enough to destabilise the government with the support of others. It's a relationship of distrusting partners. The PM knows that if any of their demands is not fulfilled then neither will hesitate to pull the rug under his feet and the two of them are well aware that in his quest to get 272, the prime minister can hijack their MPs too. The election of the Speaker in Parliament will be the first test of the coalition government. If the BJP cedes the Speaker's chair to a coalition partner then it can be argued that the partners have decided to buy peace and Parliament will have some amount of autonomy in its functioning. And if the BJP carries the day with its nominee then uncertainty will continue. The second test will be the appointment of the BJP's party president. RSS chief Mohan Bhagwat's statements are a stiff reminder that the RSS has decided to not mortgage the party like it did earlier. It has not taken lightly the statement of JP Nadda that now the BJP has become self-sufficient and it is not dependent on the RSS to win elections. A senior RSS person told me long back that Modi's priority could be to be the prime minister which is not that of the RSS, whose civilisational project is to unite Hindus. Now is the right time for the RSS to assert itself, when Modi's popularity is declining and he does not have enough numbers. This battle is serious and it will be interesting to see how it unfolds.

# Hand over Kala Academy to the artistes' forum

s the condition of Kala Academy remains unchanged, a group of artistes have reportedly united to demand a white paper giving details of the repairs carried out at the premiere cultural centre and the resignation of the Art and Culture Minister Govind Gaude from his position as chairman of Kala Academy. It may be noted that the iconic structure was renovated over a period of three years by spending crores of rupees. "The government can take up redevelopment of its buildings on its own, if required, through a tender, especially for their own staff accommodation quarters which are in a dilapidated condition," said Khan.

"However, no builder would be willing to demolish and redevelop a private building and also offer the same area to shops and flat owners."


Alemao said a coordinated strategy with INDIA alliance partners will be worked out to corner the government over the issue during the upcoming monsoon session of the Assembly.

**BELAGAVI:** A 20-month-old male child from Belagavi district who born with a rare congenital heart defect known as a 'Coronary cameral fistula', underwent a successful surgery at KLES Dr Prabhakar Kore Hospital, Belagavi.



# Leadership and what's missing..!

here's something amiss in this country: There's somebody who's going round the world pounding his chest and shouting, "Look at me, see I'm back for the third time," and there's the world saying, "I think you've got it wrong, there's a brother and sister, who seem to have more leadership qualities than you!"

I believe, and this is not a political article, that these elections have shown us qualities of true leadership. And let's learn some pointers about leadership from the election's that's happened:

It shows that you are truly invested in making things better, and you will gain a reputation for generating ideas, solving problems and improving processes. Thirdly, treat other people not just the way you would like them to treat you, but go one step farther and treat others the way they want to be treated. Which means investing time and thought to find out and delve into the strengths and weaknesses of others. This is very important as we are not generalising but serving a specific purpose. Focus on what they need and what they care about. Fourthly, learn to ask questions and remain open to new ideas. Yes, from the recent elections we have found that people really don't like know-it-alls. If you go around diminishing others while acting like you have a monopoly on bright ideas, you will be disliked. People will respect you less because they don't feel you value their ideas or expertise. Fifthly, learn to deal with conflict even when it's uncomfortable. When you avoid conflict, you send a message that you are afraid, or that their needs are inferior to yours. Turning a blind eye to a conflict as what happened in Manipur is more the style of Nero playing the fiddle while Rome burned. Finally, allow criticism from others. Never think that only weak people need others. Strong ones have the courage to allow others to provide assistance. When you ask for help, you show your strength. You show that you are indeed confident in your abilities and have the willingness and courage to accept guidance. You show others that you don't believe yourself to be superior to those around you, and you create opportunities for others to contribute to your development. What are the biggest password no-nos?

hy is password security so important? The spike in cyberattacks leading to system breaches and data leaks has compelled a review of access control strategies. The question has shifted from whether cyberattacks will occur to when and how they will happen.

Passwords and usernames remain a key point of vulnerability as they are still used for access and authentication. Too many people use weak and recycled passwords. A report by cybersecurity firm Sophos found that the "number of cyber attacks on businesses in South Africa, Kenya and Zambia increased by 76% in 2023". This comes at a huge cost.

Each year various sources publish lists of the most used passwords. Research by NordPass often highlights predictable choices like "123456", "admin", "12345678" and "password".

These passwords can be cracked in less than a minute by highly skilled hackers and those with basic hacking skills. Confidential information is then exposed to theft, deletion or tampering. Al tools are making hacking easier.

In some organisations, passwords never expire, creating opportunities for unauthorised access. In many instances, compromised passwords result in online identity theft. Nor are password-saving features, such as websites offering

# What can companies do differently?

A password policy and corresponding standards should be developed and implemented to meet the company's cybersecurity objectives. How this is done depends on the organisation and the type of business. For example, financial institutions and credit card companies may find the Payment Card Industry Data Security Standard to be most appropriate. Others might find the guidelines provided by the US National Institute of Standards and Technology or ISO/IEC 27001 security standards useful. These standards are used globally.

Companies must ensure that employees are fully informed about the policies and procedures related to password use and that they understand their responsibilities. They should therefore conduct regular awareness campaigns to promote safe password practices and address potential password threats. Follow best practice security standards for user accounts management and password control.

Incorporate password-strength meters to assist users in generating more secure passwords.

Consider adopting multi-factor authentication, which requires two or more pieces of evidence to nition ensure that the password files are encrypted.

Conduct regular audits to monitor and ensure compliance with password policies and standards.

## What about individuals?

Individuals can enhance their online safety – both at work and in their private life – by remaining vigilant and informed about the latest threats that could compromise password security. In organisational settings you should know and follow organisational policies and standards for safe password use. Participate in awareness and training sessions. Report any suspicious security incident to the ICT help desk or follow your organisation's incident management process.

Keep your login credentials safe and secure. Log out after every session, especially when you're using a shared computer. Use passwords which are strong and unlikely to be guessed by attackers.

Avoid using sequential characters or repetitive phrases for passwords, recycled or easily guessable passwords such as dictionary words.

Check if the chosen password is not already on the list of breached or common passwords.

Change your password whenever a compromise is suspected and use encrypted password manager tools to store passwords safely.

Don't use basic or easily guessable passwords, such as common dictionary words. Users should aim for a password not shorter than 12 characters long, a combination of alpha numeric (letters and numbers) and special characters, and lower and upper cases (small and capital letters) and keep it confidential.

It's also important not to reuse passwords across different accounts.

Don't use auto-fill or save your passwords on websites especially on shared computers.

Avoid sharing passwords or revealing them to others, particularly with colleagues in the workplace. If you have to share a password, ensure that it is authorised by the manager and that the details are documented for auditing purposes. Never give password details over the phone to individuals claiming to be IT technicians without proper verification.

Some of the ways to verify the authenticity of the call are to confirm the ticket number the caller is referencing. Ask the caller to send an official email to your account, especially if you don't have issues accessing a computer.

If an internal telephone number is being used, check the authenticity of the call and request identification details from the caller such as their name, office location, department and reporting lines.

# Assam top official kills himself in hospital after wife's death

GUWAHATI: Assam Home Secretary Siladitya Chetia on Tuesday shot himself dead inside the ICU of a private hospital where his wife passed away moments earlier, police said. Chetia, who had earlier served as SP of Tinsukia and Sonitpur districts, killed himself with his service weapon, they said.

In an unfortunate turn of events, Sri Siladitya Chetia, IPS 2009, Secretary Home and Political took his own life this evening, a few minutes after the attending physician declared the death of his wife who was battling cancer for a long time. Entire Assam Police family is in deep grief, DGP G P Singh said in a post on X.

A team of forensic and CID officials has also been sent to the hospital. Chetia's late father was also a police officer.





# Fitch ups India's FY25 GDP growth forecast by 20 bps

Fitch Ratings on Tuesday raised India's growth forecast for the current fiscal to 7.2 per cent, from 7 per cent projected in March, saying elevated consumer confidence will drive spending, besides increased investments.

In June update to its global economic outlook report, Fitch said it expects inflation to decline to 4.5 per cent by end of this year and RBI to cut policy interest rates by 25 basis points to 6.25 per cent.

"We expect the Indian economy to expand by a strong 7.2 per cent in FY24/25 (an upward revision of 0.2 pp from the March GEO)," Fitch said in its global economic outlook report. Investment will continue to rise but more slowly than in recent quarters, while consumer spending will recover with elevated consumer confidence, it said.

For the fiscal years 2025-26 and 2026-27, Fitch projected growth rates of 6.5 per cent

The net direct tax collection of Rs 4,62,664 crore (as of June 17) includes CIT at Rs 1,80,949 crore and PIT (including Securities Transaction Tax) at Rs 2,81,013 crore, the CBDT said in a statement.

Refunds amounting to Rs 53,322 crore have also been issued in the FY 2024-25 till June 17.

# Certain quarters of PLI beneficiaries have urged the departments for timely disbursement of claims

> Several departments have started accepting applications for disbursements of incentives under the production linked incentive (PLI) schemes on a quarterly basis to fast-track clearance of claims, a senior government official said. The department for promotion of industry and internal trade (DPIIT) has suggested others also follow the same practice.

> "In many departments, we have started accepting quarterly applications. Others also, we are telling them to do except in some cases, where they are finding it difficult to do like food processing, where the numbers are small," the official said. The development assumes



significance as certain quarters of PLI beneficiaries have urged the departments for timely disbursement of claims.

The PLI scheme was announced in 2021 for 14 sectors, including telecommunication, white goods, textiles, manufacturing of medical devices, automobiles, speciality steel, food products, high-efficiency solar PV modules, advanced chemistry cell batteries, drones, and pharma, with an outlay of Rs 1.97 lakh crore. So far, only Rs 9,700 crore has been disbursed to PLI beneficiaries, which is about 5 per cent of the total estimates. In 2023-24, the figure was Rs

6,800 crore, the official said.

Earlier the scheme guidelines stated that applications for incentives can be submitted after the end of the financial year to which the claim pertains. Annual claims can be submitted only once and within nine months of the end of the financial year.

In February, economic think tank GTRI (Global Trade Research Initiative) flagged the slow progress in the disbursement of sops under the schemes and suggested the government to simplify the criteria to expedite the grant of incentives and push domestic manufacturing.



# Budget 2024-25: CII seeks steps to cut cost of business and enhance ease of doing biz

Apex business chamber CII has in its presentation to the government ahead of the Union Budget, requested for the rationalisation of stamp duty on land and phasing out the cross-subsidy on power rates to "reduce the cost of doing business".

The CII presentation suggests that states should be encouraged to rationalise stamp duty. The apex industry chamber has also recommended that cross-subsidisation of power by industry to other user segments should be



phased out as it tends to increase the cost of production and makes Indian industry less competitive than its global rivals.

CII has also suggested that captive power plants (CPPS) should be brought at par with the power sector for coal pricing, allocation, and transportation.

The presentation also makes out a strong case to cut

logistics costs for businesses by phasing out cross-subsidisation of railway passenger fares by freight.

It points out that as highlighted in the National Logistics policy, the government should continue digitisation aiming towards paperless logistics to save significant time and cost.

CII has also suggested petroleum products and electricity should be brought under GST to reduce power and logistics costs.

India has witnessed the fastest jump in alternative remittance share for e-commerce payments in the Asia-Pacific (APAC) region, from 20.4 per

cent in 2018 to 58.1 per cent in 2023, a new report has said. According to the data and analytics company GlobalData, this jump can be attributed to the widespread usage of mobile wallets, largely driven by UPI (Unified Payments Inter-

face), which enables mobile payments in real time simply by scanning QR codes.

The report highlighted that alternative payments are already popular in countries like China and India, and are gaining traction in other APAC markets as well.

"While most Asian markets are traditionally cash-dominated, the adoption of alternative payment methods for both online and in-store payments is growing across many markets in the region, outpac-

"This trend is driven by the rising smartphone and Internet accessibility, increasing convenience of electronic payments, and the proliferation of mobile and QR code-based payment solutions," she added. "Alternative payment solutions account for the lion's share in e-commerce markets







Talking about the need for a global mindset, Mehta added saying "There are two constraints as far as I can see, we haven't cultivated a global mindset and we haven't triggered a global ambition.... Creatively there is nothing wrong with us, we are the most creative civilization the world has seen." He also highlighted the high cost of money and the lack of a sustainable distribution network for such content. Speaking at the engaging panel discussion actor-producer Jackyy Bhagnani emphasised the on differentiation of content today, with theatrical and OTT cum broadcast content being bifurcated and the sort of content being made to cater to each medium.

# Mbappe comes off with busted nose as France sneak 1-0 win

Maximilian Wober's own goal was enough to give France a winning start to its Euro 2024 campaign on Monday as it edged Austria 1-0 in its opening game, but Kylian Mbappe came off late on with a bloodied nose.

Wober diverted Mbappe's cutback into his own net seven minutes before half-time in Duesseldorf to allow the French, one of the leading contenders to win the tournament, to come through a stiff test.

Austria has been much-improved under Ralf Rangnick and its pressing game often made life uncomfortable for the 2022 World Cup runner-up, who saw Mbappe leave the field near the end after being hurt in a collision.

He had earlier failed to convert a glorious chance that would have allowed France to win by a wider margin.

While Les Bleus were not at their best, they will be relieved to have emerged victorious from the game after a build-up overshadowed by talk of politics rather than football.

The result leaves Didier Deschamps' team level on three points in Group D with the Netherlands, who defeated Poland 2-1 in Hamburg on Sunday. France and the Netherlands meet next in Leipzig on Friday, while Austria faces Poland earlier the same day in Berlin. Austria had enjoyed some impressive results coming into the tournament on a seven-game unbeaten run and the team is on familiar ground during these Euros -- its coach Rangnick is from Germany and eight of its starting lineup played in the German Bundesliga last season.

PTI has learned that the incident took place during the league stage matches in Guyana where a former Kenya pacer tried to contact a Ugandan team member multiple times from different numbers.

Following ICC's strict anti-corruption protocol, the player reported the approach to the ACU officials on site.

The development prompted the officials to raise a red flag against the former Kenya player by informing all the associate teams about him.

In the last six matches, the opener's individual scoresheet reads: 1, 8, 0, 4, 1, 7. The 20-year-old will require a substantial score sooner than later to cling on to her spot.

Skipper Harmanpreet Kaur will also like to have a big score under her belt after notching up 14, 9, 5, 3 and 10 in her last five outings.

Top-order batter Jemimah Rodrigues, who returned from a back injury that forced her to sit out of the T20I series against Bangladesh, too failed to impress.

Rodrigues would like to recapture her 2023 form where she made a couple of 8os and came close to scoring her maiden ODI hundred.

All of them, in fact, can take a cue from vice-captain Mandhana, whose sixth ODI hundred stood out for its studiousness.

Of course, the graceful left-hander has been in good touch in ODIs, as her last 20 innings dating back to February 2022 have fetched seven fifties and two centuries and was dismissed below 10 only thrice.
