

Death toll rises to 53 in Kallakurichi Hooch tragedy: The death toll in the Kallakurichi Hooch tragedy has risen from 50 to 53, officials said on Saturday. Kallakurichi District Collector MS Prasanth said that out of the total 193 patients, who consumed illicit liquor, 140 are currently safe. "193 people who have consumed illicit liquor have come to the hospital. Out of the 193, 140 are currently safe, while few of them are on ventilators. Right now, 53 people have passed away," he said. Meanwhile, in the wake of the deaths in Kallakurichi in Tamil Nadu, 250 litres of illicit liquor were seized and disposed off in the state's Tiruchirappalli district (Photo).

Govt sets up panel to reform exam process

▶ The committee, led by former ISRO chairman K Radhakrishnan which also includes Dr. Randeep Guleria, Former Director, AIIMS Delhi, will make recommendations on reform in the mechanism of the examination process, improvement in data security protocols and structure and functioning of NTA.

▶ The committee will analyse the end-to-end examination process and suggest measures to improve the efficiency of the system and to forestall any possible breach. It will also conduct a thorough review of the Standard Operating Procedures (SOPs)/Protocols of the NTA.

New stringent 'anti-paper leak' law comes into effect

Amid the ongoing row over the alleged malpractices in conducting the NEET and UGC-NET examinations, the Centre has notified the Public Examinations (Prevention of Unfair Means) Act, 2024, to prevent paper leaks and cheating.

The Act, passed in February this year, prohibits disclosing exam-related confidential information before time, and unauthorised people from entering exam centres to create disruptions.

According to the new stringent law which came into effect on 21 June, any

person or persons found guilty of leaking a paper or tampering with answer sheets will receive a minimum jail term of three years.

This can be extended to five years with a fine of up to Rs 10 lakh.

"In exercise of the powers conferred by sub-section (2) of section 1 of the Public Examinations (Prevention of Unfair Means) Act, 2024 (1 of 2024), the central government hereby appoints the 21st day of June 2024, as the date on which the provisions of the said Act shall come into force," a gazette notification issued by the Ministry of Personnel, Public Grievances and Pensions said.

Ministry said: "Taking into consideration the recent incidents of allegations regarding the integrity of certain competitive examinations, Ministry of Health has decided to undertake a thorough assessment of the robustness of processes of NEET-PG entrance examination, conducted by the National Board of Examination for medical students."

The NTA is facing criticism over alleged irregularities in this year's National Eligibility-cum-Entrance Test (Undergraduate) exam, even as the UGC-NET exam was cancelled due to apprehensions that its integrity had been compromised. This

India, Bangladesh sign 10 major accords, aim to bolster defence partnership

Prime Minister Narendra Modi on Saturday reassured his Bangladeshi counterpart Sheikh Hasina of India's commitment to realising 'Bangabandhu' Sheikh Mujibur Rahman's vision of a stable, prosperous and progressive Bangladesh as the two neighbouring nations signed ten major accords in diverse fields, including defence.

The two sides also announced the launch of a new train service between Rajshahi and Kolkata and a bus service between Chittagong and Kolkata.

"We had extensive discussions on further strengthening defence cooperation, from defence production to modernisation of armed forces. We have decided to strengthen our engagement on counter-terrorism, de-radicalisation and peaceful management of borders. We share a common vision for the Indo-Pa-cific Oceans Initiative," Mr Modi said at a joint media interaction with Sheikh Hasina after wide-ranging talks between the two leaders. The Bangladesh PM is the first top foreign leader to pay a state visit to India after the formation of a government by Mr Modi for the third successive time.

The Indian leader said the two countries have prepared a futuristic vision for cooperation in new areas. The youth of both countries will benefit from the consensus reached on cooperation in many areas such as Green partnership, Digital Partnership, Blue Economy, Space and Maitri Satellite. Mr Modi said the two countries have decided to start negotiations at the technical level for the renewal of the 1996 Ganga Water Treaty.

He said the two countries also propose to take their economic relations to new heights and have agreed to start negotiations on a Comprehensive Economic Partnership Agreement (CEPA).

Sheikh Hasina, on her part, described India as a major neighbour, trusted friend and regional partner of Bangladesh. "Bangladesh greatly values our relations with India, which were born during our war of liberation in 1971. I pay homage to the brave, fallen heroes of India who sacrificed their lives during our war of liberation in 1971," she said.

Briefing reporters on the meeting between the two leaders, Foreign Secretary Vinay Kwatra said a technical committee has been constituted to look at the Teesta Water restoration Project. The committee's mandate has more to do with the management of water flow than water sharing.

On the decision to enhance defence cooperation between the two countries, Mr Kwatra said India will help Bangladesh's armed forces in modernisation and capacity-building. India will also see how it can fulfil the needs of the Bangladeshi forces. The MoU between the two countries, he said, pertains to cooperation concerning military education in the field of strategic and operational studies.

Mr Kwatra said the two leaders agreed to give an impetus to bilateral and sub-regional cooperation in a vision document that seeks to realise India's vision of a 'Viksit Bharat' by 2047 and Bangladesh's vision of a 'Smart Bangladesh' by 2041. (More on Page 10)

Services provided by Indian Rlys like platform tickets exempted from GST

Services provided by the Indian Railways to common man, sale of platform tickets, facility of retiring rooms and waiting rooms, battery operated car services are being exempted from GST, Union Finance Minister Nirmala Sitharaman said while addressing a press conference after 53rd GST Council meeting on Saturday. Further, intra-railway supplies are also being exempted.

Another key announcement that the minister made is that now hostels which are for students but are not in educational institutions are also getting exempted.

The minister said that the service by way of hostel accommodation is presently not exempted, which are provided to students if they are outside of educational institutions. If they are within the educational institutions, then they are already exempted. Hostels which are for students which are within an educational institutions are also getting exempted.

The Finance Minister further said: "Council recommended to prescribe a uniform rate of 12 per cent on all milk cans meaning steel, iron, aluminium which are irrespective of the use. They are called milk cans but wherever they are used that will be the rate applicable so that no disputes arise out of it."

The council also recommended to prescribe a uniform GST rate of 12 per cent on all carton boxes and cases of both corrugated and non-corrugated paper or paper board.

'Passed without proper debate': Cong backs call to defer implementation of new criminal laws

The Congress on Saturday said the implementation of the three new criminal laws should be deferred and added that they were passed "without" proper debate and discussion in Parliament.

The demand came after Bengal Chief Minister Mamata Banerjee wrote to Prime Minister Narendra Modi urging him to defer the implementation of the three criminal laws - the Bharatiya Nyaya Sanhita, 2023, the Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhiniyam, 2023 which will replace the India Penal Code, 1860, the Code of Criminal Procedure, 1973 and the Indian Evidence Act, 1872 respectively, and will come into effect on 1 July.

Congress General Secretary in-charge of Communications Jairam Ramesh in a post on X wrote: "On December 25, 2023, the President of India had given her assent to the Bharatiya Nyaya Sanhita, 2023, the Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhiniyam, 2023. The three far-reaching Bills had been bulldozed through Parliament without proper debate and discussion, and at a time when 146 MPs had been suspended from the Lok Sabha and the Rajya Sabha."

Mr Ramesh said: "Earlier the Bills had been 'bulldozed' through the Standing Committee on Home Affairs without detailed interactions with stakeholders across the country and completely ignoring the written and very detailed dissent notes of a number of MPs belonging to different political parties, including the Indian National Congress, who were members of the Standing Committee."

"The three new laws are to come into effect from July 1 2024. The Indian National Congress is of the firm opinion that this date should be deferred so as to enable a thorough review and re-examination by the reconstituted Standing Committee on Home Affairs which should have more extensive and meaningful consultations with various legal experts and organisations who have serious concerns on the three laws as they stand - thereafter by the 18th Lok Sabha and Rajya Sabha as well," he said.

New Telecom Act: Central government can take control of telecom networks during emergency

With the partial notification of the Telecommunications Act, 2023, starting from 26 June, the central government will have the authority to control any telecommunication services or networks during emergencies.

The Central government on Friday partially notified the Telecommunications Act, intended to replace century-old colonial laws, making sections 1, 2, 10 to 30, 42 to 44, 46, 47, 50 to 58, 61 and 62 of the new law effective from 26 June. Among other key provisions, Section 20 of the Telecommunications Act 2023 stated that the central government or a state government will be able to take control of any telecommunication services or networks in times of emergency after the implementation of the Act.

On the occurrence of any public emergency, including disaster management, or in the interest of public safety, "the Central Government or a State Government or any officer specially authorised in this behalf by the Central Government or a State Government can take temporary possession of any telecommunication service or telecommunication network from an authorised entity; or provide for appropriate mechanisms to ensure that messages of a user or group of users authorised for response and recovery during a public emergency are routed on priority," according to the Sector 20 of the Act. Any telecom player who wants to establish or operate telecommunication networks, provides services or possess ratio equipment will have to be authorised by the government.

"The Telecommunications Act, 2023 aims to amend and consolidate the law relating to development, expansion and operation of telecommunication services and telecommunication networks; assignment of spectrum and for matters connected therewith," said the Department of Communication (DoT).

The Telecommunications Act, 2023 seeks to repeal existing legislative frameworks like Indian Telegraph Act, 1885 and Indian Wireless Telegraph Act, 1933 owing to huge technical advancements in the telecom sector and technologies. The Act also provides measures for protection of users from unsolicited commercial communication and creates a grievance redressal mechanism.

When it comes to the Right of Way (RoW) framework, public entities shall be obligated to provide right of way except in special circumstances. "The fee for right of way would be subject to a ceiling. The Act provides a complete framework for RoW in respect of private property based on mutual agreement. The Act also provides that the RoW to be granted shall be non-discriminatory and as far as practicable on a non-exclusive basis," said the DoT.

It also provides that telecommunication infrastructure shall be distinct from the property it is installed on. This will help reduce the disputes when property is sold or leased.

BIS introduces new standards to enhance safety of E-vehicles

The Bureau of Indian Standards (BIS) has introduced two new standards, IS 18590:2024 and IS 18606:2024, aimed at enhancing the safety of electric vehicles in the L, M, and N categories.

These standards focus on the critical component of electric vehicles - the powertrain - ensuring it meets stringent safety requirements. Additionally, they emphasize the safety and performance of batteries, ensuring they are both powerful and secure.

However, the shift to electric mobility extends beyond cars and trucks. E-rickshaws and E-Karts are gaining popularity across India. To address this, BIS has introduced IS 18294:2023, which establishes safety standards specifically for these vehicles. These standards cover various aspects, from construction to functionality, ensuring the safety of both drivers and passengers.

With these new standards, BIS has raised the bar, now having a total of 30 Indian Standards dedicated to electric vehicles and their accessories, including charging systems. These standards are crucial in driving the transition to a more sustainable, environmentally friendly, and an efficient transportation system in the country.

Sikkim CM requests FM for extra financial assistance

Tamang joined Sitharaman at Bharat Mandapam in New Delhi on Saturday for a pre-budget event.

The chief minister of Sikkim, Prem Singh Tamang, has emphasized the serious aftermath of the South Lhonak Lake outburst, which resulted in widespread flooding and destruction across the state.

Mr Tamang also called for additional financial assistance to support long-term recovery measures and emphasized the urgent need to repair NH-10, the main highway of Sikkim.

Sikkim CM Tamang joined Union finance minister Nirmala Sitharaman at Bharat Mandapam in New Delhi today for a pre-budget event.



The gathering was also graced by chief ministers, finance ministers and other prominent officials from various states. "During my speech, I

offered my congratulations to the finance minister and emphasized the importance of cooperative federalism. I also highlighted the urgent issues facing Sikkim and requested that they be taken into account when creating the Union Budget for 2024-25," Mr Tamang said.

The Chief Minister, Mr Tamang, emphasized the dangers of excessive rainfall and called for long-term, sustainable solutions.

He also expressed concern over the significant difference in expenses for building and upkeep in Sikkim and urged officials to take this into account when planning rehabilitation initiatives.

In addition, Mr Tamang emphasised to the relevant

authorities the importance of providing compensation for the yearly decrease in revenue caused by the Teesta-III project.

He also urged for a reassessment of the deficit in IJST settlements for 2023-24.

Recognising the beneficial effects of extended interest-free loans for capital expenses, CM Tamang appealed for a greater allotment for Sikkim. Furthermore, he suggested maintaining the borrowing cap for states and boosting aid under the National Social Assistance Programme.

"I have faith that the upcoming budget will tackle these concerns and stimulate progress and well-being in our state," Sikkim CM said.

Central CPM leaders to oversee worker movements in state

With sources indicating that central CPM leaders will now monitor and guide the farmer and worker leadership in Bengal, the party aims to revitalize its movements. They will also provide hands-on training on how to build effective movements.

Despite bringing youth leaders to the forefront, the CPM has not seen significant electoral success, failing to win a single seat or make notable gains in vote share.

To analyze the results of the Lok Sabha elections in the state, the CPM held a two-day state committee meeting at Alimuddin Street, starting Wednesday.

According to sources, in his opening speech, the party's state secretary and politburo member, Mohammad Salim mentioned that despite their best efforts, the results for the Left in the state did not meet expectations.

There was a delay in finalizing the seat arrangement with the Congress, and the alliance with the ISF also fell through at the last moment.

Additionally, there were disputes over seats within the Left Front itself and a lack of coordination.

Salim believes that despite these adversities, the expected results were not achieved.

He has called for an open discussion within the party.

This has led to internal reviews and questions about what went wrong. During a review meeting on Friday, the Democratic Youth Federation of India (DYFI) discussed the reasons behind their loss. Questions arose about the presence and effectiveness of senior farmer and worker leaders.

Some believe that stronger leadership could have prevented such a debacle.

The role of the RSS has also been scrutinized.

At the DYFI meeting, some members expressed frustration, noting not only the failure of farmer and worker movements but also the inability to understand the work of the RSS.

They pointed out that the RSS has been working effectively at the grassroots level,

something that the CPM failed to grasp. In this context, central CPM leaders will now oversee the direction and methods of the farmer and worker movements in Bengal. They will provide direct guidance and training on how to build movements effectively.

It is learned that the extended state committee meeting of the CPM will be conducted at Kalyani in the last week of August from 23 to 25.

The youth wing workers will move door-to-door, seeking public opinion about their general expectations from the party.

Party sources said that another important issue likely to come up for discussion in the extended meeting is that going back to the party's traditional form of politics where there was a distinct line between the dedicated organisational administration and leaders contending electoral battles.

DRM ER inspects Bandel Chandannagar stations

The DRM conducted inspection of ABSS stations in HWH-KWAE-BWN section, inspection of ABSS station at Chandannagar and inspection of yard at Bandel.

Under the ABSS, the selected stations will be upgraded with the latest technology, providing better passenger facilities at par with those at airports.

BSF seizes gold worth ₹ 2.48 cr along Indo-Bangladesh border

The South Bengal Frontier of the Border Security Force (BSF) made a breakthrough on Saturday by apprehending three persons along the Indo-Bangladesh border in West Bengal with 30 gold biscuits weighing 3.4 kg and valued at around Rs 2.48 crore in the Indian market. The gold was being smuggled into India from Bangladesh.

"The operation was carried out under the jurisdiction of the Bomberia Border Outpost in the Nadia district of West Bengal, based on inputs from the Intelligence Department of the BSF. An ambush was laid near the Kulgachhi village. Before long, three persons were spotted on two motorcycles and a three-wheeler van. There was some interaction taking place over the handing over of a consignment. The three were immediately taken into custody and the 30 gold biscuits were seized from them," said A.K. Arya, DIG and spokesperson, BSF, South Bengal Frontier.

The BSF official said that one of the smugglers during interrogation confessed that he has been working for a

kingpin based at Banpur for the last few days. His job was to hand over the gold to couriers for further delivery. He would be paid well for this job.

"The other two admitted that they are couriers and would hand over smuggled gold to an unknown person at Bongaon in the North 24-Parganas district of West Bengal. They said they would receive good payment for this," Arya said.

All three, along with the gold, have been handed over to officials of the Directorate of Revenue Intelligence (DRI) in Kolkata for further legal action.

"This was a commendable performance by our personnel. The BSF is doing whatever it takes to curb crime along the Indo-Bangladesh border. We would urge border residents who wish to live in a crime-free environment to report any information related to gold smuggling to the BSF's 'Seema Sathi' helpline at 14419 or send a message (text or voice) to 9903472227. Those providing concrete information will be suitably rewarded and their identities will remain confidential," Arya said.

Bengal STF arrests suspected terrorist

The Special Task Force (STF) of West Bengal has arrested a suspected terrorist from Mirpara in Kanksha police station area of West Burdwan district.

At around 3 pm today, a team from West Bengal raided a house in Mirpara in Kanksha police station area, under Ansang Durgapur Police Commissionerate and arrested a youth Mohammad Hasibul Sheikh allegedly for his connections with banned Bangladeshi terror outfits.

After his arrest, he was taken to Kanksha police station, where senior cops of ADPC and STF questioned him. Sources said that he will be later taken to Kolkata. Acting on a specific tip-off, the STF jawans zeroed into his house and nabbed him.

The Indian Army base camp is in Panagarh and the area is a high security zone, the arrest of a terror outfit member near the vicinity has created a stir in the region.

It is still not known on what basis he has been arrested and what documents have been seized from his possession after the search operations.

minister, tabled the proposal before Miss Banerjee which the latter had accepted. Mr Chidambaram's meeting with Miss Banerjee also assumed significance since the relationship between Miss Banerjee and the Congress in Bengal had been very frosty in the run-up to and during the Lok Sabha elections.

Students enter class with guns, cause panic

They claimed they did not bring the pistols to school to intimidate anyone

In a shocking incident, two Class X students entered Andulberia High School in Rejinagar police station area with firearms, causing panic among other students. According to school sources, classes had begun as usual after the morning prayers when it was suddenly reported that two Class X students had entered the classroom with pistols and were showing them to their friends.

The head teacher, Jahangir Alam, stated that upon learning about the incident, teachers rushed to the classroom but initially couldn't find the students. Later, they were identified and questioned about bringing pistols to school. The school headmaster and teachers managed to snatch away the gun from the duo. The weapon was a country-made single shot gun, which is locally available among the local miscreants. The students claimed they had found the guns by the

The students claimed they had found the guns by the roadside on their way to school. However, they couldn't explain why they didn't turn the pistols over to the headmaster's office upon arrival.

roadside on their way to school. However, they couldn't explain why they didn't turn the pistols over to the headmaster's office upon arrival. The news of the students carrying weapons to school was quickly relayed and worried parents gathered at the school. The two students were confined to a room and the school authorities informed the police. The situation further escalated with a complaint from school security guard Jahangir

Molla. He reported that two days earlier, the same students were caught stealing a bicycle seat from the school gate, leading to an altercation when he intervened. Molla stated, "They had been threatening to kill me since then, even saying they would shoot me yesterday. I didn't take it seriously, but now that they entered the school with guns, I am very scared." The two students, however, claimed they did not bring the pistols to school to intimidate anyone. Meanwhile, concerned parents blamed the school authorities, citing a lack of strict discipline. They expressed their fear of sending their children to school under such circumstances. The headmaster asserted that it is not feasible to monitor all 2,500 students constantly but assured that future measures would be taken based on this incident.



A group of miscreants, armed with bamboo sticks attacked the office of the Trinamul Congress councillor Pintu Deb Nath on Saturday and damaged furniture and documents. Four persons close to the councillor were injured according to local police. Huge police force from the Narendrapur police station was rushed to the spot, who rescued the injured. They beat up several people who came to meet the councillor seeking his signature on different civic issues. The entire office virtually turned into a battlefield, locals said. Local Trinamul Congress sources said that the councillor didn't entertain some illegal demands of the miscreants and as a result, the latter attacked his office and beat up some persons, who are close to him.

GRSE bags export order for four commercial vessels

KOLKATA, 22 JUNE

The Garden Reach Shipbuilders and Engineers Ltd (GRSE), a defence public sector undertaking (DPSU) which is the only shipyard in the country to have built and delivered 109 warships to the Indian Navy and Indian Coast Guard, has made a foray into the world of commercial vessel export. On Saturday, GRSE signed an agreement with Carsten Rehder Schiffsmakler und Reederei GmbH & Co. KG, Germany, for the construction and delivery of four multi-purpose vessels of 7,500 DWT each, with an option of building another four ships in future. These vessels will be 120 metres long and 17 metres wide with a maximum draft of 6.75 metres. Each of them will carry 7,500 metric tonnes of cargo. The vessels will have a single cargo hold each to accommodate bulk, general and project cargoes. Containers will be carried on hatch covers. The ships have been specifically designed to carry multiple large windmill blades on deck. The agreement was signed by Cdr Shantanu Bose (Retd), Director (shipbuilding), GRSE, and Carsten Thomas Rehder, Managing Director, Carsten Rehder Schiffsmakler, in the presence of Cmde PR. Hari, (Retd), Chairman and Managing Director, GRSE. While GRSE's mainstay has been the construction of warships for India's maritime defence forces, the shipyard has also been a pioneer in the export of ships. The shipyard is also working on six patrol boats and a TSH dredger for the Government of Bangladesh. **AGENCIES**

As paper tussle continues, two newly elected Bengal MLAs await oath ceremony

As confusion continued over the swearing-in ceremony of two newly elected Trinamul Congress MLAs, the office of the Secretary of West Bengal Assembly has forwarded a fresh communique to Raj Bhavan requesting quick approval for the oath ceremony. This is the second such communique from the Assembly Secretary's office to the office of Governor C.V. Ananda Bose. The first communique was issued on June 15. Although 18 days have passed since Trinamul Congress' Reyat Houssen Sarkar and Sayantika Banerjee got elected from Bhagawangola and Baranagar Assembly constituencies in a bypoll, their oath ceremony is caught in the middle of technical



glitches of communication between the state secretary at Nabanna and the Raj Bhavan, sources said. Raj Bhavan insiders pointed out that there is a procedural error in the two consecutive communications received by the office of the Governor since as per protocol such communications regarding the swearing-in ceremony of newly-elected legislators should have come from the office of the Minister of State for Parliamentary Affairs Department and not from the office of the Assembly Secretary. Raj Bhavan insiders further said after receiving the first communique, the office of the Governor, on its part had sent a communique to the Assembly seeking answers to certain queries regarding the present nature of the House like the number of senior-most legislators, number of MLAs coming from Scheduled Caste or Scheduled Tribe communities, among others. However, instead of sending any reply to those queries, the office of the Assembly Secretary has forwarded a fresh communique requesting quick approval for the oath ceremony.

Fire near historic building in BBD Bagh, 2 floors affected

Another fire incident shook the city today. A devastating fire broke out at an old house at 5 Garstin Place in BBD Bagh around 3:30 am today. Six fire engines were pressed into service to control the fire. Locals joined the firefighting efforts. The house is located in a congested area, raising fears of the fire spreading. The entire area was covered in black smoke. Explosions were intermittently heard from the house. Local residents feared the building, which is over 100 years old, might collapse. No casualties were reported. According to sources, it took nearly six hours to bring the fire under control. The fire did not spread to other areas from the house. Local sources reported that around 3:30 am on Saturday, smoke was first seen emanating from the third floor of the building,



gradually spreading to the fourth floor. The fire department was informed. Five fire engines arrived at the scene about an hour later, followed by another engine. A total of six engines were used in the firefighting operations. Due to the area being congested, the fire department had difficulty reaching the site. Local residents were outraged by the delayed response of the fire department, claiming that the fire spread throughout the house due to the delay. They also accused the fire department of lacking necessary equipment. The cause of the fire is still unknown. Fire minister Sujit Bose was surrounded by protesters when he arrived at the scene. "The house is more than 100-year-old. These houses require restoration and repair. I shall speak to the KMC mayor regarding this issue," he said. The residents of the building have been evacuated. According to the residents, the fire spread either due to a cylinder explosion or an AC malfunction. Local sources reported that about 25 families lived in the building. After the fire broke out, they were evacuated. Local residents alleged if the fire department had arrived on time, the building would not

have burned down to such an extent. The third and fourth floors were affected by the fire. Several families live on these floors and fear that the fire will leave them homeless. The Garstin Place area has many old houses. The house that caught fire, housed about 25 families, all of whom have been relocated to safer places. Local resident and Congress councillor Santosh Pathak too arrived at the scene. He alleged that there was a chemical warehouse in the building, which contributed to the spread of the fire. He also accused the fire department of delayed response.

Lord Jagannath gets royal bath at Mahesh

The famous chariot festival of Lord Jagannath usually picks up momentum from the day of *sana yatra* (holy bath of Lord Jagannath). Today being an auspicious day as per the Hindu calendar, the idols of Lord Jagannath, Balaram and Subhadra are bathed in the holy Ganges water, milk and in the essence of vermilion and sandalwood. The celebration of the *sana yatra* in Mahesh, Serampore has stepped into its 628th year. However, the rare planetary alignment of mokha jog, which is taking place after 47

years, has made this year's *sana yatra* different from other years. Usually, after the *sana yatra* of Lord Jagannath, Balaram and Subhadra, the deities are carried back to the temple *garbha griha* (designated place) of the Mahesh Jagannath temple and the main temple door is kept closed for a certain time. After the holy bath the deities are kept on the *sana bedi* (bathing pedestal) for the entire day. All the Vedic religious rituals are performed in full view of the massive gathering. The main shebait (priests devoted towards performing religious rituals) Soumen



Adhikari, Piyal Adhikari and others said that from time immemorial the holy rituals are adhered to. Around 28 pitchers of Ganges water is collected in the Bengali month of Bhadra, 65 litres of fresh milk with the



essence of vermilion and sandalwood is poured on the deities. The historic chariot on the other side is kept waiting for the lord to take his throne within, for a ride to his aunt's place. Piyal Adhikari said after the daylong rituals and *bhog*

offered to Lord Jagannath, Balaram and Subhadra, the deities will be carried back to the main temple *garbha griha* (sanctum sanctorum) today in the evening at 6:30 pm and thereafter the temple doors will be kept closed. On 5 July, the temple doors will be reopened and on 5, 6 Chanadan Utsav and Naba Jouban Utsav will be performed. On 7 July, the historic Ratha Yatra of Lord Jagannath Balaram and Subhadra will begin. The *sana yatra* and the chariot festival have its own divine charm which have brought people of all religion, caste and creed to stand in uniformity.

YSRCP's 'illegal' office at Tadepalli demolished; Jagan cries vendetta

The land belonging to water resources dept had been leased out to YSRCP over the then chief engineer's objections: TDP

The under-construction YSRCP central headquarters at Tadepalli was demolished early Saturday morning by the authorities on the ground that it was illegally built on government land belonging to the irrigation department.

However, YSRCP leader YS Jagan Mohan Reddy termed the move as vendetta politics and accused chief minister N Chandrababu Naidu of being a dictator.

The demolition was reminiscent of the knocking down of Praja Vedika or 'Grievance Hall' built by Naidu by the YS Jagan Mohan Reddy's government soon after assuming office on the grounds that it was illegal.

Significantly, the Greater Visakhapatnam Municipal Corporation (GVMC) has also issued a notice to the under-

construction YSRCP office in Vizag terming it as unauthorized.

Early on Saturday morning in Tadepalli, the Andhra Pradesh Capital Region Development Authority (APCRDA) and Mangalagiri Tadepalli Municipal Corporation (MTMC) brought in bulldozers and excavators to demolish the YSRCP party office.

The YSRCP claimed that the High Court had given a stay order and the same had been conveyed to the APCRDA by the party's legal counsel.

"A dictator bulldozed the nearly completed YSRCP central office at Tadepalli. The order of the High Court was ignored. Law and justice have completely disappeared in the state. Chandrababu who is shedding blood due to violent incidents that are taking place after the elections, has given another violent message

about how this regime will run through this incident," said YS Jagan Mohan Reddy on 'X' while urging all democratic forces of the country to condemn Mr Naidu's "misdeeds".

However, the TDP said that the land belonging to the Water Resources department had been leased out to YSRCP disregarding the objections raised by the then engineer-in-chief. The tehsildar had approved it without seeking clearance from the irrigation department.

It further stated that when YSRCP had approached the High Court it had passed orders to follow due procedure and disposed the petition. Hence, the APCRDA, MTMC and the water resources department today repossessed the land.

The complaint was lodged by TDP's Guntur district secretary Pothineni Srinivasa Rao who demanded action against illegal structures.

TDP's Ayyanna Patrudu elected Andhra Assembly Speaker

Veteran TDP leader Ayyanna Patrudu was today unanimously elected as the new Speaker of the Andhra Pradesh Legislative Assembly.

Chief minister N Chandrababu Naidu, deputy chief minister Pawan Kalyan and BJP minister Y Satya Kumar led him to the Speaker's podium as YSRCP leader YS Jagan Mohan Reddy chose to stay away, travelling to his constituency Pulivendula. Since the only nomination submitted was for Patrudu's candidature he was elected unopposed, declared Proteem Speaker G Butchaiah Chowdhary. Later, in his maiden address Naidu urged his MLAs to utilise the floor of the House to discussing people's problems while ruing that the previous regime under YSRCP had reduced the House to Kaurava Sabha, levelling baseless allegations and passing objectionable comments against the Opposition leaders and targeting their family members.

He recalled how the YSRCP had derided the TDP saying they had won only 23 seats but now it has been reduced to 11 which is the number you get after adding all digits of the 164 (seats won by the NDA). He also recalled how the YSRCP had vowed not to allow Jana Sena to even touch the gates of the Assembly but the party won all the seats it contested with 100 per cent strike rate. Praising his deputy chief minister Naidu said, "Pawan Kalyan knows where to win and where to bow down."

Two booked for 'blackmailing' Prajwal's brother Suraj over 'false' sexual abuse charge

The Karnataka Police have filed an FIR against two persons for "blackmailing" Janata Dal (Secular) MLC Suraj Revanna by threatening him with a "false" case of sexual assault. Suraj Revanna is the grandson of former Prime Minister H.D. Deve Gowda and younger brother of Prajwal Revanna, the prime accused in the sex video scandal.

Suraj Revanna's aide Shivakumar H.L. has filed a case against a JD(S) activist, who alleged that Suraj Revanna abused him sexually, and his kin at the Holenarasipura police station.

The complainant said the accused had gone to the Suraj Revanna's farmhouse on June 16 to request a job. As the

accused did not get a job, he asked Suraj Revanna to give Rs 5 crore to him failing which he would file a sexual abuse case against the leader.

The complainant claimed that the accused later reduced the "extortion" amount to Rs 2.5 crore.

The police have registered a case under IPC Sections 384 (extortion) and 506 (criminal intimidation) and 34 (criminal act by several persons).

However, the accused, talking to mediapersons, said: "Suraj Revanna was impressed with me as I had organised a programme in my village. We shared the mobile numbers and after that, Suraj messaged me for a meeting. I was asked to meet him at his farmhouse, where I was sexually abused."

Karnataka needs to fight legally to cancel NEET: Medical Education Minister

Karnataka Medical Education and Skill Development Minister Sharan Prakash Patil on Friday termed the NEET-UG 2024 a massive 'scam' of the Central government, as he demanded a CBI probe into the matter.

About 24 lakh aspirants appeared for NEET on May 5 for admission to medical colleges. The results were announced before time on June 5 but were marred by allegations of paper leak and awarding of grace marks to over 1,500 candidates.

Addressing mediapersons here, Patil said, "The Tamil Nadu government has already expressed its position... We need to fight this legally."

"It's sad that the Centre is not taking the matter seriously even as students and parents continue to protest across the country. Union Education Minister Dharmendra Pradhan is acting irresponsibly. The CBI should conduct a probe and the guilty must be punished," he added.

The minister also said that the Centre's reluctance to order a probe into the NEET fiasco despite protests across the country raises doubts in the minds of the people.

"Many state governments have demanded a CBI probe into the matter. We don't know if the Centre is trying to shield the culprits. The BJP government at the Centre is playing with the future of 24 lakh students," Patil said.

Expressing the state government's limitations in seeking exemption from NEET, Patil cited a Supreme Court order and the legal restrictions.

Palakkad Assembly bypoll: BJP scouts for candidates after Metro Man Sreedharan backs out

With Metro Man E. Sreedharan, who was a surprise choice of the BJP for the Assembly elections in Palakkad in 2021, now backing out from another contest, the BJP has started searching for a candidate for the soon-to-be-announced by-election. The by-election in Palakkad was necessitated after sitting Congress legislator Shafi Parambil quit his seat after he won the Vadakara Lok Sabha seat. In his debut election in 2021, the now 92-year-old Sreedharan managed to bring down the victory margin of Parambil from 17,483 in 2016 to just 3,859 votes.

The Kerala unit of the BJP is in an upbeat mood after the victory of Suresh Gopi from the Thrissur Lok Sabha constituency with an over 72,000 votes margin. The party that finished in second place in



the Palakkad assembly constituency is confident that it will be able to open its account in the 140-member Kerala assembly too. The names that the BJP is contemplating include that of Sobha Surendran who finished second in 2016 in Palakkad. After that, her status as a firebrand party leader increased hugely when she, though finishing third in the 2019 Lok Sabha polls from Attingal and in the 2024 polls from Alappuzha, garnered sizeable votes.

Another name that has started to get traction is Padmaja Venugopal, daughter of Congress veteran and four-time Chief Minister K. Karunakaran. She joined the BJP from the Congress in March this year and had campaigned for Gopi in Trissur, where her brother and sitting MP, K. Muraleedharan finished third. The Congress and the CPI-M have also started their search for candidates as it is going to be a fight to the finish for all three political fronts.

Transparent, zero-error exams are a commitment: Pradhan

Soon after the announcement of the formation of a high-level committee of experts to make recommendations on reform in the mechanism of the examination process, improvement in data security protocols and functioning of National Testing Agency (NTA), Union Education Minister Dharmendra Pradhan on Saturday asserted that transparent, tamper-free, and zero-error examinations are a commitment.

This comes amid the allegations of irregularities in the National Eligibility-cum-Entrance Test (NEET) Undergraduate examinations, which saw several protests held by candidates across the country.

"Transparent, tamper-free



and zero-error examinations is a commitment", Pradhan said in a post on 'X'.

"Setting up of the high-level committee of experts is the first of a series of steps to improve efficiency of the examination process, put an end to all possible malpractices, strengthen data security protocols and overhaul and reform the NTA. Student inter-

ests and their bright future will always be our govt's top priority", he added.

Earlier today, the Ministry of Education said it has constituted a high-level committee of experts to make recommendations on reform in the mechanism of the examination process, improvement in data security protocols and function-

ing of the National Testing Agency (NTA).

The 7-member committee, led by ISRO Former Chairman Dr K Radhakrishnan, will submit its report to the ministry in the next two months.

"In order to ensure transparent, smooth and fair conduct of examinations through National Testing Agency (NTA), Department of Higher Education, Ministry of Education constituted a High-Level Committee of Experts to make recommendations on Reform in mechanism of examination process improvement in data security protocols and structure and functioning of National Testing Agency," the ministry said. As per the ministry, the committee will look into reforming in mechanism of the examination process by analysing the end-to-end examination process and suggesting measures to improve the efficiency of the system

and to forestall any possible breach.

The committee will also conduct a thorough review of the Standard Operating Procedures (SOPs)/Protocols of the NTA, and suggest measures to strengthen these procedures/protocols along with monitoring mechanisms to ensure compliance at every level.

The committee will also suggest measures to improve data security protocols by evaluating the existing data security processes and protocols of NTA and recommend measures for its improvement.

They will also examine existing security protocols related to the paper-setting and other processes for different examinations and make recommendations to enhance the robustness of the system, the Ministry of Education said in the statement.

Jairam Ramesh says anti-paper leak law is 'damage control'

Lashing out at the Bharatiya Janata Party government over the anti-paper leak law for exams that came into effect on Friday, Congress leader Jairam Ramesh said the bill deals with leaks "after they have occurred" while it is important to prevent the leaks from happening at the first place.

Terming the bill as a "damage control" to deal with controversies that have cropped up in several recent exams, the Rajya Sabha MP said the bill was given an assent by President Murmu in February itself, while it came to force only on June 21.

The Public Examinations (Prevention of Unfair Means) Act, 2024, came into effect on Friday.

Taking to social media platform X, Jairam Ramesh said, "On Feb 13, 2024, the President of India gave her assent to the Public Examinations (Prevention of Unfair Means) Bill, 2024. Finally, just this morning, the nation has been told that this



Act has come into force from yesterday, that is, June 21, 2024. Clearly, this is damage control to deal with the NEET, UGC-NET, CSIR-UGC-NET and other scams."

"This law was needed. But it deals with leaks after they have occurred. More important are laws, systems, processes, and procedures to ensure that leaks don't happen in the first place," he added.

The Public Examinations

(Prevention of Unfair Means) Act, 2024, came into effect on Friday. It aims to prevent unfair means in public examinations and common entrance tests held across the country.

The bill comes amid the massive row over the alleged malpractices in conducting the NEET and UGCNET examinations.

The Bill was passed by the two Houses of Parliament in the Budget session which concluded on February 10. It seeks to prevent the use of "unfair means" in public examinations and bring "greater transparency, fairness and credibility".

The public examinations in the Act refer to examinations conducted by authorities notified by the central government. These include the Union Public Service Commission, Staff Selection Commission, Railway Recruitment Board, National Testing Agency, Institute of Banking Personnel Selection, and Departments of the central government and their attached offices for recruitment.

Job Creation

India stands at a pivotal juncture. Despite its status as the world's fastest-growing major economy, the country grapples with an acute unemployment crisis. The challenge of job creation looms large over the government, demanding immediate and innovative strategies to harness the demographic dividend and ensure inclusive economic growth. The conundrum of high economic growth without corresponding employment gains is a paradox that India must urgently address. The nation, boasting a population of 1.4 billion with a significant proportion of young aspirants, finds itself in a situation where economic expansion does not translate into job creation. The recent electoral setback for the BJP underscores the electorate's frustration with widening inequality, persistent inflation, and a dearth of well-paying jobs. The solution to this complex problem requires a multifaceted approach. As suggested by several development economists, a job-specific strategy is imperative. This involves significantly ramping up public employment in essential sectors such as health, education, nutrition, and sanitation. These sectors not only create immediate employment opportunities but also lay the foundation for long-term economic resilience and social wellbeing. However, the government alone cannot shoulder the burden of job creation. The private sector must play a pivotal role. Historically, India's gross fixed capital formation - a key indicator of private investment - has lagged behind its potential. To stimulate private sector investment, the government must identify and eliminate policy hurdles that stymie business growth. Simplifying regulatory frameworks, ensuring policy stability, and providing incentives for private investments are critical steps that can unlock the entrepreneurial potential of Indian businesses. Education reform is another cornerstone of sustainable job creation. The quality of education in India needs a substantial uplift to equip the workforce with the skills demanded by a dynamic and evolving job market. This entails not just enhancing the curriculum but also investing in teacher training and modern educational infrastructure. A collaborative approach involving both central and state governments can ensure that education reforms are implemented uniformly and effectively across the country. Tax reform is equally crucial. A simplified and fair tax system can boost business confidence and spur investment. Moreover, a progressive tax policy that ensures equitable distribution of resources can help address income inequality, thereby creating a more balanced and just economic landscape. The unorganised sector, which employs a vast majority of India's workforce, presents a unique challenge. Accurate measurement of employment in this sector is difficult, leading to discrepancies in official unemployment data. Recognising and formalising the informal economy can provide more reliable employment statistics and enable targeted policy interventions. Strengthening social security nets for workers in this sector and facilitating their transition to formal employment can also enhance job security and improve living standards. Ultimately, addressing India's employment crisis requires a concerted effort from all stakeholders - government, private sector, and civil society. It is not just an economic imperative but a social one, as well. Creating meaningful employment opportunities is essential to harnessing the potential of India's youth, fostering social stability, and achieving sustainable development.

Pushed into graves

The humanitarian crisis unfolding in Sudan's Darfur region is a tragic testament to the devastating consequences of war. As the conflict between the Sudanese military and the paramilitary Rapid Support Forces (RSF) rages, the victims are ordinary people, particularly children, caught in the crossfire. The rapid expansion of cemeteries, a grim marker of escalating mortality, underscores the dire situation on the ground. This crisis demands urgent attention and action from the international community. The situation in Darfur is not merely a result of natural disasters or economic downturns but is profoundly man-made. The blockade of food and medical aid by combatants has turned a challenging situation into a catastrophic one. The deliberate obstruction of humanitarian assistance is a violation of international law and a moral failing of the highest order. The harrowing stories from displaced persons' camps, where families are forced to survive on one meal a day and children die from preventable diseases, should shock the conscience of the world. The lack of food, medicine, and healthcare has created a lethal environment where the most vulnerable - children and the elderly - are perishing in alarming numbers. This tragedy is compounded by the fact that aid organisations are unable to deliver critical supplies due to security threats and logistical barriers imposed by warring factions. The data on food insecurity is staggering. With an estimated three-quarters of a million people facing catastrophic food shortages and nearly nine million in an emergency food situation, Sudan is on the brink of a famine. This projection should serve as a clarion call for immediate international intervention. Yet, the response from the global community has been tepid at best. The focus must shift from diplomatic platitudes to concrete actions that ensure the delivery of aid to those in desperate need. Moreover, the international community must hold those responsible for obstructing aid accountable. Both the Sudanese military and the RSF bear responsibility for the suffering of civilians. Reports of the RSF looting aid warehouses and the military hindering access to border areas highlight the need for accountability and justice. The world cannot stand by as these atrocities continue with impunity. The impact of this crisis extends beyond immediate hunger and health issues. The breakdown of healthcare systems and the rise in diseases such as measles, malaria, and cholera threaten to create a "deadly cocktail" that could decimate entire communities. The long-term consequences for Sudan's population, particularly its children, are severe. Without urgent intervention, the country risks losing an entire generation to hunger and preventable diseases. As we witness the rapid expansion of graveyards in Darfur, we are reminded of the human cost of this conflict. These graves are not just numbers; they represent individuals - mothers, fathers, children - whose lives were cut short due to a lack of food, medicine, and compassion. The international community must act decisively to end this crisis. Humanitarian corridors must be established, and aid must flow unimpeded to those in need.

Goals for Education ~ I

The NEP launched in the second half of 2020 aimed at overhauling India's education system, but the pandemic situation turned the academic calendar topsy-turvy. It is time to review how far the NEP can be made relevant to the new normal in education. A UNESCO report explained the scenario: 'Education systems responded with distance learning solutions, all of which offered less or more imperfect substitutes for classroom instruction'



Under the NEP-2000, the name of the Ministry of Human Resource Development (MHRD) was changed to Ministry of Education (MoE). There was a serious dimension to this change in nomenclature. The term "human resource" induced the person in charge to look at teachers and academics as part of a labour force and therefore not worthy of too much respect. The renaming of the department could well initiate the process of refashioning the government's attitude to educational institutions and to those who teach in them.

The attitude, as articulated by present Minister Dharmendra Pradhan's predecessors, had been for the government to curtail the autonomy of academic institutions as much as possible on the ground that most universities were fully or partially funded by the government. The presence of the government - often bordering on interference - tended to stifle the pursuit of excellence in bodies of higher learning. It was expected of Mr Pradhan to step back and allow the heads of universities to run the institutions. Admittedly, this would be one of the first steps in the government's gradual withdrawal from the sphere of higher education and to opening it up for private players.

So the task before Mr Pradhan as the minister of education for a second time is to cut the Gordian knot. While the policies of successive governments have failed to live up to the country's much-trumpeted goals in the sector - inclusion, expansion and excellence - electoral politics have always prevented our planners from thinking creatively. Drawing the border between populism and pro-people policies is often forgotten.

Our country's Constitution cannot be faulted. The directive principles of state policy offer great promise. Article 41 says: "The State shall, within the limits of its economic capacity and development, make effective provision for securing the right to work, to education and to public assistance in cases of unemployment, old age, sickness and disablement, and in other cases of undeserved want." However, there is a rider: the State will perform such tasks "within the limits of its econom-

ic capacity".

The ground reality is daunting though. There has been an unmistakable imbalance in the allocations for the different facets of the social sector in the union budgets for decades. One can easily plead that the economics of learning is yet to be calibrated in our country.

A notable trend, particularly in the past three decades, is that private expenditure on education is growing faster than that of the public, which reflects increasing privatization of education in India, and has far-reaching policy implications. Growing demand for education coupled with inadequacy of public expenditure on education has resulted in growing private expenditure. The non-fulfillment of the public education system due to inadequate state funding strained the private pockets in meeting the growing demands. NEP-2020 intends to curb the commercialization, but not privatization.

According to All India Survey on Higher Education (AISHE) report estimates, Gross Enrollment Ratio (GER) in higher education in India was 28.5 per cent in 2021-22. Private educational institutions account for nearly 46 per cent of the total school enrolment and 70 per cent of higher education enrolment. Most of the studies on private expenditure on education infer that education being a public good, public investment in education is a must. Unfortunately such expenditure is found to be insufficient in achieving the educational goals of our country.

Whereas the private expenditure on education (PFCE) increased from Rs 86.5 crore in 1951-52 to Rs. 509961.6 crore in 2018-19 and to Rs 728197.6 crore by 2022-23, public expenditure increased from Rs 64.5 crore to Rs 736581 crore and further to Rs 1098589.4 crore for the same periods. It goes without saying that the government's intent on faster digital integration and creating a high-quality and equi-

table public education system needs to be supported by adequate fund allocation. Though NEP-2000 notes the criticality of enhancing public funding, it is discouraging that the budgetary allocation does not provide proper support to make a convenient roadmap for achieving the target.

While it was expected that some specific allocation would be announced keeping in view the objectives of NEP-2000, much to our dismay a sum of Rs



1.206 lakh crore was allocated to the ministry of education in the interim budget (2024-25) which is a mere 6.8 per cent increase in comparison to FY 2023-24. Of this, Rs 47619.77 crore has been set aside for higher education departments. However, the budgetary allocation for education as a percentage of total expenditure has dropped over the last seven years

from 10.4 per cent to 9.5 per cent, according to the Economic Survey 2022-24. The allocation is not encouraging in view of the NEP 2000 schemes that aim at improving infrastructure and teaching in educational institutions post-Covid 19.

While the government is and should be intent on an overall implementation of the NEP 2000, which aims at universalisation of education from pre-school to the secondary level, the budget for Samagra Shiksha Scheme, the main vehicle for implementing the Right to Education Act is at Rs 37500 crore, slightly higher than Rs 37435.47 crore allocated for 2023-24.

The NEP launched in the second half of 2020 aimed at overhauling India's education system, but the pandemic situation turned the academic calendar topsy-turvy. It is time to review how far the NEP can be made relevant to the new normal in education. A UNESCO report explained the scenario: "Education systems responded with distance learning solutions, all of which offered less or more imperfect substitutes for classroom instruction".

Living in a furnace: Is there any way to beat the heat?

Stepping outside in Dhaka these days feels like venturing into a furnace. A scorching sun beats down on a city choked by concrete, and temperatures routinely surpass 35 degrees Celsius - a far cry from the balmy days many of us remember. This relentless heat isn't just uncomfortable; it's a growing public health crisis. Studies by the International Centre for Diarrhoeal Disease Research, Bangladesh (icddr.b) paint a concerning picture: rising temperatures are linked to a surge in heatstroke and dehydration cases, particularly among vulnerable populations like the elderly and children.

The culprit behind this urban inferno is a well-documented phenomenon known as the "urban heat island (UHI)" effect. Dhaka, like many rapidly urbanising cities around the world, has prioritised development at the expense of green spaces. Lush parks and verdant gardens have been replaced by towering buildings and sprawling infrastructure, all constructed from heat-absorbing materials like concrete and asphalt. This transformation has fundamentally altered Dhaka's microclimate. The city now acts like a giant heat sink, absorbing and trapping solar energy throughout the day. With limited vegetation to provide shade and cool the air through evapotranspiration, these heat-soaked surfaces continue to radiate the energy long after sunset, creating a microclimate significantly warmer than surrounding rural areas. This urban heat island effect not

only exacerbates the discomfort of daily life but is also overburdening our healthcare system due to heat-related illnesses.

Dhaka's predicament is far from unique. Similar stories of scorching cities are unfolding across the globe. A 2019 study published in the journal Environmental Research Letters found that the UHI effect in Beijing, China, could be as high as 8 degrees Celsius warmer than surrounding areas. This extreme heat contributes to a rise in respiratory problems, with a direct correlation between UHI intensity and hospital admissions for asthma and other respiratory illnesses. In Ahmedabad, India, a 2012 study documented how the UHI effect can raise nighttime temperatures by as much as 7 degrees Celsius compared to rural areas. This dramatic rise in nighttime temperatures translates to a significant increase in energy consumption as residents resort to air conditioners for relief. The overburdened power grids struggle to meet this surge in demand, leading to blackouts and further exacerbating the heat crisis.

The crisis isn't limited to just scorching temperatures. The UHI effect also disrupts natural weather patterns. A 2020 study by the Indian Institute of Technology Delhi found that increased heat island intensity in Delhi led to a decrease in monsoon rainfall by up to 10 percent. This translates to water scarcity, impacting not only residents but also agriculture in surrounding regions, further straining food security. Globally, countries are grappling with the consequences of unchecked urban sprawl and diminishing green spaces. The science is clear: the UHI effect is a real and growing threat to our health and well-being.

Fortunately, there's hope. Cities around the world are implementing effective policies to combat UHIs. We in Dhaka can follow suit with a multi-pronged approach, starting with a greening transformation. Singapore, a global leader in urban sustainability, offers a compelling example with its "City in a Garden" programme. This initiative has demonstrably increased the city's green cover from 30 percent to over 50 percent in recent decades, transforming Singapore into a model metropolis.

Is the Constitution being followed in Manipur?

At the height of the turmoil in Manipur last year, the Chief Justice of India had remarked that "apparently the provisions of the Indian Constitution do not seem to apply in Manipur." Thereafter, the apex court had appointed a high-level committee to oversee developments and to monitor steps being taken, including the registration of 6,000 plus FIRs.

On the court's directive, the State had been quick to respond at least in two cases - notably those of the parading naked of two tribal girls by Meitei youth, and the abduction and subsequent killings of two Meitei students - a boy and a girl - by Kukis. The culprits have since been booked; one of them in the latter case from a place as far away as Pune.

But in matters relating to 200-plus deaths, thousands of houses burnt and over 60,000 people displaced, those deviating from the Constitutional path are still active. Here one is not talking about the gun-toting youngsters on either side or the odd men in uniform allowing ethnic affinity to override allegiance sworn to the State and the Constitution, but people in high places duly enjoined to safeguard the Constitution of India.

To start with, we have the Chief Minister, the head of the government of the State who was duly sworn in by the Governor. He is on record stating that Article 355 of the Constitution of India has been invoked in the State. This statement is supported by the fact that Chief Minister N. Biren Singh has been stripped from his position as the Chairman of the Unified Command - the apex body comprising the Army, Para-Military Forces and the



State Police to oversee the law and order situation in the State - and in his place one Kuldiep Singh was appointed as Security Advisor.

Additionally, the Director General of Police was replaced without notice to the Chief Minister. Finding a landing place was Rajeev Singh, a Tripura cadre IPS officer said to be a favourite of Kuldiep Singh. Then we have the Governor of Manipur, Anusuiya Uikey, who stated that Article 355 of the Constitution of India has not been invoked in Manipur, as the law and order situation in her State had not so completely broken that the Central government had to take charge of law and order. She did not bother to explain the circumstances leading to the appointment of the Security Advisor as the Chairman of the Unified

Command and appointment of the Director General of Police without notice to the State Government.

It appears that Article 355 of the Constitution of India had been invoked in Manipur by proxy. Whether the Constitution has such provisions is for the court to examine.

Then came the meeting on 17 June convened by the Union Home Minister Amit Shah at New Delhi's North Block. Present were the Union Home Secretary Ajay Kumar Bhalla, Director of the Intelligence Bureau Tapan Kumar Deka, Chief Secretary Vineet Joshi, Security Advisor Kuldiep Singh, DGP Rajeev Singh of Manipur, the Chief of Staff of the Indian Army General Manoj Pande and others dealing with the law and order situation. And although the meeting was

conveyed to discuss the law and order situation in Manipur, conspicuous by their absence was the Chief Minister of Manipur or any elected representative from Manipur.

Law and Order is a State subject in the Constitution but the Chief Minister of the state, one belonging to the Bharatiya Janata Party, was ignored despite the party having lost both parliamentary seats from the state. These acts suggest that in effect, not just Article 355 but also Article 356 - whereby the elected government is dismissed and President's Rule imposed - has also been invoked by proxy.

The meeting is said to have deliberated upon the developments in Manipur at length and concluded that more troops would be stationed in the state, with orders to take action against anybody using violence, while initiating steps to commence talks between the two warring sides. But on the surface it appears that steps are planned to be taken to disarm the few thousand Meitei youth who had taken away guns from police armouries last year. Ignored for now seems to be any examination of the role of Assam Rifles, accused of bias for the Kukis.

As early as January this year the Chief Minister's office had notified the DGP about the impending attack by Kukis at Jiribam, the district bordering Assam. The input was kept under wraps. Earlier this month, suspected militants beheaded a Meitei farmer and began attacking Meitei villages in the fringe area of the district. The Chief Minister was in New Delhi at that time and was scheduled to visit the district upon his return to Imphal. But his advance security team was ambushed by Kuki militants and the convoy had to turn back. CM Biren upon arrival at Imphal then decided

not to venture to Jiribam for reasons best known to him.

On the peace parleys, there will definitely be hardliners on both sides who would call for complete annihilation of the other as the only solution. But this reminds me of the Track-2 meetings the Meiteis had with the Nagas in 2000. Tension was running high then between the two indigenous communities of Manipur. Present as mediators were Lt. General V K Nayar (Rtd), former Governor of Manipur, Chaman Lal, former DGP of Nagaland and Jayant Madhav, former Chairman of the Assam Finance Corporation. The Nagas of Nagaland were represented by Church leader Wati Aier, Gandhian Niketu Iralu, Rev. Shishak, Principal of Patkai College, while the Nagas from Manipur were represented by PA Thekko, then Editor of Horn Bill Express from Senapati and Naga academic Dr Jina Singham. Representing the Meiteis were writer and author Pradip Phanjoubam, noted social commentator Dhanabir Laishram, Arun Irembam, former Media Advisor to the Chief Minister, this writer and a former editor, now the current Chief Minister of Manipur, N. Biren Singh.

The move initiated by former Consultant Editor of the Statesman, Sanjoy Hazarika, had three rounds of meetings - first at Shillong, then at Barapani and finally at Kaziranga.

Both sides spoke their hearts out and a lot of goodwill was earned. We did not agree on anything but we were able to have a friendly football match at Senapati between the Meiteis and the Nagas. But the process broke the tension between the two sides. The rest is history but we broke the tension between the two sides. I am making this point to show that a start has to be made somewhere, sometime by somebody.

Discovering ignorance

Hearing the question, the teacher took the student to the bank of a river. There they found a clay pitcher lying half buried in the slushy sand. The pitcher had several holes and was full of mud and slush.

The teacher sitting a little away from the river instructed his student, "Fetch water from the river with the help of this pitcher." The student was quite confused by the unreasonable instruction. However, the obedient student could not turn down his teacher's order. He tried to fetch water with the apparently useless pitcher several times, but in vain. At last, the exhausted student said to the teacher, "I am extremely sorry to say that I have failed to execute your order. Please pardon me." However, he could not restrain his inquisitiveness and asked why he had been given such a seemingly unjustified order.

The teacher smiled and said, "No, you have not failed at all. Look inside the broken pitcher. Though the pitcher has failed to hold water, it is now quite clean as all the mud and slush stuck inside have washed away by the force of the water leaking out through the holes. Our brain is like that pitcher with several holes and impure thoughts, evil ideas and superstitions in it. Our brain may fail to remember everything that we read. WEEK-END TRIPS

Clarke was the author of remarkable novel now very scarce called Jasper Tristram, which should have a high place in any anthology of school stories. He married late in life a daughter of General Milman. For all his exuberant sense of the absurd, Clarke was a real diplomat and a man of statesman like mind. Zanzibar had nothing but deficit budgets till he took charge of its affairs in Downing Street. But undoubtedly his greatest contribution to the work of his profession consisted in the personal negotiations which he was called upon to conduct with the late king of the Belgians over the Congo difficulties.

Clarke would leave London on a Friday night with plenipotentiary powers in his pocket, and be back in his office on Monday, having spent the week-end cloistered with the most astute monarch in Europe. The settlement ultimately arrived at was largely Clarke's work.

To wind up with a word as to bigger folk. If the line of British Foreign Secretaries includes no Bismarck or Cavour, the list of permanent heads of the Foreign Office contains the names of a good many people of the first distinction. And the Permanent head one must remember have had their say in shaping our foreign affairs. There was one person who particularly trusted their judgments and that was his late Majesty King Edward VII. He was, indeed, commonly accompanied by the permanent Head of the foreign office on occasions when he was said personally to effect so much in the diplomatic field. One hopes that the present generation may get some enlightenment on these matters. History now clamours to be "up to date" and a public which demands "open diplomacy" whatever that may mean might just as well begin by compiling true records of its immediate past.

Priyanka's foray should boost Congress

Amidst a flurry of speculation and anticipation, the Congress party has made a strategic and significant move by fielding Priyanka Gandhi in the by-election in Wayanad, Kerala. This seat became available after her brother Rahul Gandhi decided to retain Rae Bareilly and step down from Wayanad, after winning both seats. If she succeeds, it could be a game-changer for Priyanka, her party and Indian politics. It has sparked excitement and scepticism among the public and political class.

"I am glad to represent Wayanad and will ensure the people don't feel Rahul Gandhi's absence," she said when her candidacy was announced. "I chose to run in Wayanad to continue my family's political legacy and the Gandhis' presence in the South. My grandmother, Indira Gandhi, had a strong connection with the people of Wayanad, and I hope to build on that."

Rahul and his mother, Sonia, have led the Congress party for many years and served as MPs. The upcoming Wayanad elections will be a critical test for Priyanka, as this will be her first litmus test. The entire nation, including the BJP, will closely observe her performance.

Born into a political family, Priyanka has actively participated in her mother's election campaigns. She also campaigned for her brother when he entered politics in 2004.

In 2024, Priyanka decided not to run for a Lok Sabha seat, focusing on nationwide party campaigning. She held 108 public meetings, participated in roadshows, and campaigned in 16 states and one union territory.

The decision to contest from Wayanad presents a unique set of challenges and opportunities for

Priyanka. On the one hand, she faces attacks from the BJP on the issue of dynastic politics, a hurdle she must navigate with tact and resilience. On the other hand, it gives her a golden opportunity to prove herself and connect with a new constituency, a chance she must seize with determination.

The Wayanad constituency, located in north Kerala, has a voter base of 1.46 million. It has consistently elected Congress MPs in the past four elections, indicating solid support for the party. The constituency also enjoys broad support from the Indian Union Muslim League (IUML), with Muslims and Christians comprising about 60 per cent of the voters. IUML will back Priyanka.

If Priyanka wins, all three members of the Gandhi family will be in Parliament. This could strengthen the family's position within the party but will also invite attacks from opponents.

Overall, Priyanka's candidacy in Kerala is a strategic move by the Congress to strengthen its support base in the South, potentially reshaping its regional dynamics. The party acknowledges the importance of the South and aims to strengthen its presence there. Thus, Rahul will focus on the North, while Priyanka may concentrate on the South. Her win could bolster the party's position in the region.

There is more to it, as Priyanka's husband, Robert Vadra, also wants to join politics. He said Priyanka should be in Parliament before him, and he could follow her at a suitable time.

The CPI plans to contest to ensure non-Congress votes do not go to the BJP.



GST Council waives interest, penalty on notices to taxpayers

As part of several taxpayer-friendly decisions, the GST Council on Saturday recommended the waiving of interest and penalty in cases of tax demand notices that have been sent under Section 73, of the GST Act, Finance Minister Nirmala Sitharaman said after the meeting.

"In the case of demand notices issued for 2017-18, 2018-19, 2019-20, interest and penalty will be waived off, if tax is paid by March 31, 2025," Nirmala Sitharaman said.

The GST Council has also recommended that the time limit to avail input tax credit in respect of any invoice or debit note under section 16(4) of the CGST Act filed up to the 30-11-2021 for the financial years 17-18, 18-19, 19-20 and 20-21 may be deemed to be 2011 to 2021.

So for the same requisite amendment retrospectively with effect from 1 July 2017, the Finance Minister said.

In order to reduce tax litigation which is expected to

benefit both taxpayers and the government, the GST council recommended a minimum limit for filing appeals of Rs 20 lakh for the appellate

tribunal, Rs 1 crore for the High Court and Rs 2 crore for the Supreme Court.

In another taxpayer-friendly measure, the GST Council

has decided to introduce Form GSTR 1A to enable taxpayers to add information they have missed when filing Form GSTR 1.

The new form can also be used to correct mistakes that they have made while filing their particulars in form GSTR 1.

Israeli strikes on tent camps near Rafah kill at least 25 and wound 50

Israel has previously bombed locations in the vicinity of the 'humanitarian zone' in Muwasi

Israeli forces shelled tent camps for displaced Palestinians outside Gaza's southern city of Rafah on Friday, killing at least 25 people and wounding another 50.

This was the latest deadly attack in the Gaza Strip, where hundreds of thousands have fled fighting between Israel and Hamas. It comes less than a month after an Israeli bombing triggered a deadly fire that tore through a camp for displaced Palestinians in southern Gaza.

Witnesses whose relatives died in one of the bombardments near a Red Cross field hospital north of Rafah told The Associated Press that Israeli forces fired a second volley that killed people who came out of their tents.

The International Committee of the Red Cross said the hospital was flooded with casualties, including 22 dead and 45 wounded, and condemned the firing of "high-caliber projectiles" a few meters

(yards) from the facility. Hundreds of people live in tents nearby, including many of the hospital staff, the ICRC said. According to Ahmed Radwan, a spokesperson for Civil Defense first responders in Rafah, witnesses told rescue workers about Friday's shelling at two locations in a coastal area that has become filled with makeshift tents.

The locations of the attacks provided by the Civil Defense and the Red Cross hospital appear to be just outside an Israeli-designated safe zone on the Mediterranean coast, known as Muwasi. The Israeli

military said the episode was under review but that "there is no indication that a strike was carried out by the IDF" inside the safe zone, using an acronym for Israel's armed forces. It did not offer details on the episode or say what the intended targets might have been.

Israel has previously bombed locations in the vicinity of the "humanitarian zone" in Muwasi, a rural area with no water or sewage systems where displaced Palestinians have built tent camps in recent months.

Israel says it is targeting Hamas fighters and infrastructure and that it tries to minimize civilian deaths. It

blames the large number of civilian casualties on militants and says it's because they operate among the population.

With Israel's war against Hamas now in its ninth month, international criticism is growing over the campaign of systematic destruction in Gaza, at a huge cost in civilian lives. The top United Nations court has concluded there is a "plausible risk of genocide" in Gaza — a charge Israel strongly denies.

The attack near the Red Cross hospital began with a munition that only made a loud bang and bright flash, said Mona Ashour, who lost her husband after he went to

investigate what was happening.

"We were in our tent, and they hit with a 'sound bomb' near the Red Cross tents, and then my husband came out at the first sound," Ashour said, holding back tears while clutching a young girl outside Nasser Hospital in nearby Khan Younis.

"And then they hit with the second one, which was a little closer to the entrance of the Red Cross," she said.

Hasan al-Najjar said his sons were killed helping people who panicked after the first strike.

"My two sons went after they heard the women and children screaming," he said at the hospital. "They went to save the women, and they struck with the second projectile, and my sons were martyred. They struck the place twice."

The hospital's location is known to all parties in the conflict and marked with the Red Cross emblem, the ICRC noted on Friday. The 60-bed field hospital was opened in mid-May to provide emergency surgeries, obstetric, pediatric and outpatient care, according to a news release at the time, which shows white tents covering an area about the size of a soccer field.

US aircraft carrier arrives in South Korea as a show of force against nuclear-armed N Korea

A nuclear-powered United States aircraft carrier arrived Saturday in South Korea for a three-way exercise stepping up their military training to cope with North Korean threats that escalated with its alignment with Russia.

The arrival of the USS Theodore Roosevelt strike group in Busan came a day after South Korea summoned the Russian ambassador to protest a pact reached between Russian President Vladimir Putin and North Korean leader Kim Jong Un this week that pledges mutual defense assistance in the event of war. South Korea says the deal poses a threat to its security and warned that it could consider sending arms to Ukraine to help fight off the Russian invasion as a response — a move that would surely ruin its relations with Moscow.

Following a meeting between their defense chiefs in Singapore earlier in June, the United States, South Korea and Japan announced Freedom Edge. The new multidomain exercise is aimed at sharpening the countries' combined response in various areas of operation, including air, sea and cyberspace.

The Theodore Roosevelt strike group will participate in the exercise that is expected to start within June. South Korea's

military didn't immediately confirm specific details of the training.

South Korea's navy said in a statement that the arrival of Theodore Roosevelt demonstrates the strong defense posture of the allies and "stern willingness to respond to advancing North Korean threats." The carrier's visit comes seven months after another U.S. aircraft carrier, the USS Carl Vinson, came to South Korea in a show of strength against the North.

The Theodore Roosevelt strike group also participated in a three-way exercise with South Korea and Japanese naval forces in April in the disputed East China Sea, where worries about China's territorial claims are rising.

In the face of growing North Korean threats, the United States, South Korea and Japan have expanded their combined training and boosted the visibility of strategic U.S. military assets in the region, seeking to intimidate the North.

Russian strikes continue to target Ukrainian energy facilities, say officials

Russia launched a new barrage of missiles and drones in an overnight attack on Ukraine, officials in Kyiv said Saturday morning, damaging energy facilities in the country's southeast and west and injuring at least two energy workers.

In its eighth major attack on Ukrainian power plants since Moscow intensified energy infrastructure attacks three months ago, Russia fired 16 missiles and 13 Shahed drones at energy facilities and critical infrastructure, the Ukrainian air force said.

Ukraine's air defenses intercepted 12 of the 16 missiles and all 13 drones launched by Russia, the air force said.

State-owned power grid operator Ukrenergo said the strikes damaged equipment at facilities in Ukraine's southeastern Zaporizhzhia region and western Lviv region.

Two energy workers were injured in the Zaporizhzhia region when a fire broke out at an energy facility, according to regional Gov. Ivan Fedorov.

With no major changes reported along the 1,000-kilometer (600-mile) front line, where a recent push by the Kremlin's forces in eastern and northeastern Ukraine has made only incremental gains, both sides have taken aim at infrastructure targets, seeking to curb each

other's ability to fight in a war that is now in its third year. Moscow's overnight attack on Zaporizhzhia and Lviv follows Ukraine's military strikes on three oil refineries in southern Russia overnight into Friday, as per reports.

Ukraine is struggling to cope with a new wave of rolling blackouts after relentless Russian attacks took out half the country's power generation capacity, as per reports.

In other developments, the governor of eastern Ukraine's partly occupied Donetsk region said Saturday that Russian attacks had killed five people and wounded a further seven the previous day.

A policeman was killed in the partly occupied region of Kherson as a result of a Russian drone attack on a checkpoint, the Ukrainian National Police said.

In Russia, air defense systems overnight destroyed five drones over the Sea of Azov and the country's western Bryansk and Smolensk regions, the Russian Ministry of Defense said.

Bird flu outbreak at US dairy farms cause public health concerns: The ongoing bird flu outbreak at US dairy farms has heightened concerns among public health experts as more dairy herds have tested positive for the virus in recent months. The influenza A (H5N1) virus, commonly known as bird flu, is widespread in wild birds worldwide and has been circulating in US poultry since 2022, reports Xinhua news agency. However, the situation escalated in late 2023 when the virus is believed to have jumped from birds to dairy cows at a Texas farm. This was followed by a human infection in April linked to exposure to infected cattle. To date, three human cases of infection have been reported, bringing the total number of US H5N1 cases to four, including one case in 2022 linked to poultry exposure, according to the Centers for Disease Control and Prevention (CDC). The virus had been confirmed in at least 115 dairy herds across 12 states as of Thursday, according to the latest tally posted on the US Department of Agriculture's Animal and Plant Health Inspection Service website. The CDC noted that while the current public health risk is low, it is watching the situation carefully and working with states to monitor people with animal exposures.

India will also open a new consulate in Rangpur, Bangladesh to facilitate services for people

AGENCIES NEW DELHI, 22 JUNE

India will start an e-medical visa facility for Bangladesh nationals coming to India for medical treatment, Prime Minister Narendra Modi said on Saturday after the meeting between the two delegations here in the national capital on Saturday.

India will also open a new consulate in Rangpur, Bangladesh to facilitate services for people in the north-west region of the country.

The two Prime Ministers addressed the media after meeting at Hyderabad House on Saturday.

PM Modi emphasised the two leaders have met several



times in last one year, adding that this visit is special because PM Sheikh Hasina is India's first state guest in the third tenure of the NDA government.

"In the last one year, we have met 10 times, but today's meeting is special because PM Hasina is the first state guest of our third government.

Bangladesh is crucial for our Neighbourhood First policy, Act East Policy, Vision SAGAR, and Indo-Pacific vision. We have completed several developmental programmes together in the last year," PM Modi said at the press statement.

"India will start e-medical visas for Bangladesh nation-

als coming to India for medical treatment. India has decided to open a new Assistant High Commission in Rangpur to benefit the people in the north-west part of Bangladesh," he further said.

Ahead of the T20 World Cup Super 8 clash between India and Bangladesh today, PM Modi also gave best wishes to both teams.

"I also give my best wishes to both India and Bangladesh cricket teams for today's match," he said.

Prime Minister Modi further said that India and Bangladesh have started trading in Indian Rupees. He also highlighted the electricity export from Nepal to Bangladesh using the Indian grid.

He added the two countries have decided to start talks at the technical level for the renewal of the Ganga River treaty. A technical team will also travel to Bangladesh to review the protection and management of the Teesta River in Bangladesh.

"The sixth rail link between India and Bangladesh has started between Jakhoda and Agartala has started. Cargo services have been started for our north-eastern states with the Khulna-Mongla Port... Trade in Indian Rupees has started between the two countries. The world's longest river cruise on the Ganges River between India and Bangladesh has been successfully completed," PM Modi said.

BSP convenes crucial meeting today, Akash Anand may rejoin party

The Bahujan Samaj Party (BSP) will hold a crucial meeting in Lucknow on Sunday to review its disastrous performance in the recent Lok Sabha polls. It is also likely that Akash Anand, the nephew of party chief Mayawati, will rejoin the party.

The indications of Akash Anand's return gained momentum after he was designated as a star campaigner for the upcoming Uttarakhand and Punjab assembly by-elections on Saturday. Mayawati herself had appointed him as the party's national coordinator and her political heir in December 2023.

Akash Anand's name was listed second after Mayawati in the star campaigners' lists for Uttarakhand and

Punjab.

The BSP is contesting the assembly by-elections in both states.

A BSP source said that Akash Anand was relieved of party responsibilities by Mayawati during the Lok Sabha elections. However, his inclusion in the star campaigners' lists for two states indicates that his return to the party has now been finalised.

On May 8 last year, during the Lok Sabha campaigning and on the day of the third phase of polling,

Mayawati removed her nephew Akash Anand (29) from the position of BSP national coordinator and as her political successor just five months after his appointment.

Mayawati said she took the decision in the interest of the party and the movement until the time Akash Anand gains "full maturity".

Mayawati had taken action against Akash Anand after an FIR was registered against her nephew and four others on April 28 for allegedly using objectionable language at a poll rally in Sitapur, in violation of the Model Code of Conduct.

Akash Anand had reportedly also made some indecent comments about Azad Samaj Party president Chandrashekhar Azad during campaigning in the Nagina seat, which had irked the Dalit community.

SBSP chief Om Prakash Rajbhar dissolves all units of his party

AGENCIES NEW DELHI, 22 JUNE

After a setback in the recent Lok Sabha election, Om Prakash Rajbhar, the chief of Suheldev Bharatiya Samaj Party (SBSP), on Saturday dissolved all units of the party.

The party's National General Secretary, Arvind Rajbhar, issued a letter stating that all major units, including the Uttar Pradesh executive committee, the Purvanchal, Madhyanchal, Bundelkhand, and Paschimanchal units at the regional, district, Assembly and block levels, along with all the fronts and cells have been dissolved with an immediate effect.

Following the defeat in the



Lok Sabha elections, the party's focus is now on the 2027 Assembly elections.

Notably, SBSP lost the only seat -- Ghosi -- it contested in the recently concluded general elections. Arvind Rajbhar, son of the party chief, contested from this parliamentary constituency but was defeated by Samajwadi Party's Rajeev Rai.

The defeat led the party to review its performance, following which the decision to dissolve all units was made.

Party leaders have stated that after dissolving all executive bodies, a new organisation will be formed with fresh vigour to focus on reestablishing itself for the upcoming 2027 Assembly elections.

Flood crisis continues in Assam, 3.90 lakh people affected: Officials

Over 3.90 lakh people in Assam remain affected due to continued widespread flooding in the state, officials reported on Saturday.

Despite a slight improvement due to receding rainfall, 19 districts in Assam remain heavily impacted by floods, officials stated. The death toll from this year's floods, landslides, and storms in Assam has reached 37, with one person reported missing, officials confirmed. According to Assam State Disaster Management Authority 3,90,491 people across the state have been affected due to the floods. Karimganj district has been the hardest hit, with over 2.40

lakh people affected by the floods.

Key rivers, including Kopili at Kamrup and Dharamtul, Barak at BP Ghat, and Kushiara in Karimganj, were reported to be flowing above the danger level. More than 100 relief camps, sheltering over 15,000 people, are operational, along with 125 relief distribution centres. Houses, cattle sheds, roads, bridges, embankments, and other infrastructure have sustained damage in various districts, according to officials.

Meanwhile, the Assam Higher Education Department has extended the date of admissions to undergraduate courses in colleges as the monsoon flood has impacted the whole process.

Violence in Ferozabad after Dalit youth dies in jail; Mayawati demands action

An irate mob indulged in arson in Ferozabad on Friday night after a Dalit youth died in judicial custody.

According to reports of the incident, Akash, a prisoner who was sent to jail on theft charges, died yesterday after which his family members and supporters created a ruckus. Angry people pelted stones at the police team and burnt a police bike.

Many policemen were injured in stone pelting. Many officers including the CO and City Magistrate had to run for their lives.

BSP supremo Mayawati has issued a statement here

on Saturday on the death of a prisoner in Ferozabad district jail. She has demanded strict action against the guilty policemen. She said that the people who raised their voice against the police atrocities should be released immediately and the cases registered against them should also be withdrawn.

Mayawati said on social

site X that the way a Dalit youth was killed in jail in Ferozabad district of UP is very sad. The government should take strict action against the guilty police personnel and also provide full help to the victim's family. Meanwhile, IG Deepak Kumar has said that the matter will be investigated by the District Level Judicial Officer.

'Project Tiger', 'Project Elephant' will pave way for conservation of tigers, elephants in UP



Very misunderstood person, says Ashwin on Gambhir

Ashwin hailed Gautam Gambhir, one of the frontrunners for the next India head coach's role

India's off-spin stalwart Ravichandran Ashwin hailed Gautam Gambhir, one of the frontrunners for the next India head coach's role as a "very misunderstood person", while opening up about his relationship with the two-time World Cup-winning former India opener on the sidelines of the launch of his book - A Kutti Cricket Story.

Recalling his interaction with Gambhir during his first full Test series for India in 2012, Ashwin revealed that the opening batter was one of the very few from outside his home state of Tamil Nadu to give him a lot of confidence as a newcomer. "I was playing my first full series. I only carried drinks during the first two years before the World Cup in 2011. Gautam gave me a lot of confidence at the beginning of my career. I was not used to someone beyond my state (Tamil Nadu) giving me that sort of confidence," he said.



"Gautam Gambhir is a very misunderstood person. It's all about perception. He is a fighter. The biggest issue with many of us is that we give hero status to someone in our mind and forget about everyone else. This is a sport, not a movie narrative. There are no heroes and villains. Gambhir is a competitor. His desire and hunger to win is unbelievable. I have massive respect for him," he added. Ashwin, who has 744 wickets in international cricket, and two ICC trophies in his cabinet, also shared an interesting incident that helped him get noticed by the legendary

Mahendra Singh Dhoni until he finally got the IPL breakthrough in the 2010 edition with Chennai Super Kings under the charismatic former India skipper. Recollecting the incident that took place during the 2008 Challenger Trophy in Nagpur, Ashwin felt he had done his bit to finally grab the attention of Dhoni.

"It's an evolving relationship. MS didn't even know someone like me existed in 2008. And because of that, I made it my life's goal — from 2009, it was to get the wicket of MS Dhoni. When a person has a goal like this, he will go crazy when an

opportunity to achieve it pops up," he said.

"We were playing the Challenger Trophy, and I bowled an unbelievable spell. MS would struggle through that spell in Nagpur. Once, when he tried to play, the ball went through his gates. I got him out in the final. From then on, I think he saw somebody with skill, and the relationship matured," he said. Ashwin said once a player earned the trust of Dhoni, then he would get ample chances to prove himself.

"One of MS' usual qualities is that, if he decides this horse (a player) is not ready to race, he will not use you. He needs to know you're a horse. But, once he knows you're a horse, only when you feel like giving up, he will look past you. That is MS Dhoni; he believes in you," he added. Ashwin had a limited role to play in India's epochal 2011 World Cup victory, under the leadership of Dhoni but mentioned how then head coach Gary Kirsten and the whole team did not make him feel unwanted.

"After winning (the WC), Gary called me over and said we have not done justice to your talent. You have waited two years, but make no mistake, take it from me — you will achieve far greater things, and I am upset that I will not be a part of it," he reflected. "So, Gary actually resigned (as head coach) with me first before announcing it outside (laughs). It was surprising for me because in all these two years, Gary actually spoke, maybe, 100 lines to me. Gary was a man of few words and an outstanding human being," he added. In fact, Ashwin was used sparingly even in the run-up to that World Cup. He offered a reason for that.

"One of the reasons why MS did not play me leading up to the World Cup (2011) was the novelty factor. But eventually, I figured out that they would play me. "I was about to play the match against Pakistan (2nd semifinal in Mohali). But, they decided to opt for an extra fast bowler because there was heavy dew the previous day there," he concluded.

Sumit Nagal confirms Paris Olympics qualification

India's top-ranked Tennis player Sumit Nagal has officially confirmed his participation in the 2024 Paris Olympics.

"Extremely glad to share that I have officially qualified for the 2024 Paris Olympics. This is a monumental moment for me as the Olympics holds a special place in my heart! One of my career highlights so far was participating in the 2020 Tokyo Olympics. And a big thanks to TOPS and SAI for extending help in the last

few months," read the statement by Sumit Nagal on X (formerly known as Twitter)

This will be Sumit's second appearance at the Olympics after he previously became the first Indian man since Leander Paes to win a singles match at the Tokyo Olympics. Nagal defeated Uzbekistan's Denis Istomin in the first round, but went on to lose against Russia's Daniil Medvedev in the second round. Nagal's meteoric rise over the past year has seen the 26-year-old's ATP ranking jump up to 71, which is the joint-fourth highest ranking achieved by an Indian

men's player since the introduction of the computerized system of rankings in 1973.

His recent impressive performances were the reason behind the massive jump in rankings.

After making his French Open debut at the Roland Garros in which he was eliminated in the first round at the hands of Karen Khachnov, Nagal went on to win the Heilbronn Challenger in Germany before just missing out on a consecutive title win at Perugia challenger in Italy as he lost to Luciano Darderi (6-1, 6-2) in the finals of the tournament.

It is important to note all three tournaments were played on clay courts in Sumit's attempt to prepare for the upcoming Olympics which will also be played at Roland-Garros, the mecca of clay courts.

Before the Olympics, India's highest-ranked star will be fully focussing on the Wimbledon that is scheduled to begin on July 1 where he will be entering the tournament as a part of the main draw for the very first time.

Hope my win will help people know what MMA, UFC is: Puja Tomar after becoming first Indian to win UFC fight

Puja Tomar became the first Indian fighter to win a fight in the Ultimate Fighting Championship on June 9 when she went on to beat Rayanne Dos Santos of Brazil in the Women's 52 Kg weight category also known as Women's Strawweight.

"After this victory, many people got to know what MMA fighting because in the place where I come from there being a girl is a very difficult thing. After this win I think people will now know be it girl or boy what UFC is," said Puja Tomar while speaking to ANI.

Her dedication and relentless training led her to excel in Wushu, a martial art known for its complex techniques, earning her several national

championships and international recognition. And finally, she made it to Ultimate Fighting Championship.

"I was aware that I am the first Indian fighter to win a match in UFC. I was also aware that winning this fight is also very important for me and hope this win changes a lot of things," added Puja Tomar.

Puja Tomar became the first Indian female MMA fighter to sign a contract with UFC and she was aware that her fight would open doors for many fighters in the country.

"The moment I was getting ready for the fight and walking inside with India's national flag then only one thing was running in my mind that I have to win this fight and the only thing was in my mind was that I have to win because in India no one



knows what MMA is. So, it was very important for me," said the UFC fighter.

The moment Puja won her bout she was very emotional as she has come from a very humble background and had to fight all the odds to get to where she is. Born in Muzaffarnagar, Uttar Pradesh, in a family of a farmer and two sisters. The fact that Puja was a third child - it had a quite big impact on her parents, whose

responsibilities multiplied. "That thing I can never forget. It was an amazing thing for me. I was very emotional and it was a huge moment for me," she said.

Puja's childhood was not so fascinating. She said that she likened herself to boys by using their style of haircuts or clothing. Street fights were also a usual thing for her.

"The journey is very long and I hated boys since my childhood. Sorry to say this but it is like this (laughs) but in my family, everyone wanted a boy even my grandmother but not my mother. She was the only one who supported me and loved me. My father too wanted a boy. So, whenever I used to see boys I used to feel that they should not come anywhere close to me. So, since then it was all about watching Jackie Chan's

movie and whenever there used to be a fight anywhere I used to feel like I have to beat them up. It is then I got to know about Ronda Rousey, MMA fighter. There were a lot of financial problems but I still went to martial arts. After that it was my dream to compete in UFC and win it," explained Puja Tomar.

Puja Tomar's inspiration was none other than UFC legend from the United States of America Ronda Rousey. It was her fights that inspired her to get into martial arts.

'England have to adapt to playing on slower pitches'

Former captain Nasser Hussain believes defending champions England need to address issues in adapting to playing on slower pitches after losing to South Africa by seven runs in their second Super Eight stage game of the ICC Men's T20 World Cup 2024.

At the Daren Sammy National Cricket Stadium on Friday, England did well in restricting South Africa to 163/6. But in their chase, England struggled to get going against South Africa's slower balls and were reduced to 61/4.

Harry Brook played a calculated 53 and shared a sensational 78-run partnership off 42 balls for the fifth wicket with Liam Livingstone, who smashed a 17-ball 33, as the

duo capitalised on South Africa's bowlers' bowling pace-on deliveries.

England needed 25 runs from 18 balls to win the match, but South Africa corrected their mistakes and gave away only 17 runs in the last three overs to seal a thrilling win and be now on top of Group 2.

"No batter likes it when the ball stops in the pitch a bit, but my one concern about England is that their players really like facing balls with pace on as we saw against West Indies earlier in the week."

"This was not a minefield, just a slower pitch and if you look at where England have played their best cricket in this tournament, it has been Antigua when there was pace and bounce and here in St Lucia when there was pace and bounce against the West Indies." "If Jos Buttler's team defeats

the United States on Sunday to get into the semifinals, they could end up facing India in Guyana, for example, and they will need to address how to play on the kind of surface they were dealt here."

"Harry Brook and Liam Livingstone showed they can cope with coming in during the middle overs and put the foot down straightaway, but despite England playing good cricket, they failed to get over the line," wrote Hussain in his column for Daily Mail.

Hussain also applauded South Africa's wicketkeeper-opener Quinton de Kock for smashing 49 runs off 20 balls in the power-play, which included him hitting relentless boundaries off Moeen Ali, Jofra Archer, and Sam Curran. His blitz ensured South Africa's power-play score was 63/0, which bettered England's 41/2.

Indian compound women's team secures hat-trick of gold medals at Archery WC

Indian Compound Women's Team secures historic hat-trick gold at Archery World Cup.

This victory marks a historic hat-trick of gold medals for the Indian team in the 2024

Archery World Cup series, having previously secured top honours in the stages held in Shanghai and Yecheon earlier this year.

At Stage 3 in Antalya, the Indian women's team began their campaign with a first-round bye in a field of just 10 countries. They then showcased their skill and determination by defeating El Salvador 235-227 and the host nation, Turkey, 234-227, to secure their place in the final. Against Estonia, the Indian archers maintained their composure and accuracy, sealing their third consecutive gold medal.

In contrast, the top-ranked

Indian men's compound team, comprising Priyansh, Abhishek Verma, and Prathamesh Fuge, faced a more challenging journey. They narrowly missed out on a place in the final after a dramatic semifinal shoot-off against Turkey. Both teams were tied at 236, but Turkey edged out India by shooting closer to the center in the shoot-off (30"-30").

Despite the setback, the Indian men's team put up a valiant fight in the bronze medal match against France. In a closely fought contest, India fell short by a single point, losing 236-235, and finishing fourth in the tournament.

Babar Azam likely to take legal action against former players, YouTubers for 'targetting' him during T20 WC

Sources informed Geo News that during Pakistan's campaign, a social media campaign

It was also reported that evidence related to statements made by YouTubers and former cricketers is being collected by the Pakistan Cricket Board's legal department.

Babar, along with Imad Wasim, Haris Rauf, Shadab Khan, and Azam Khan, are expected to depart on Saturday. After featuring in the finals against England in the last edition of the competition, Pakistan crashed out of the ongoing World Cup in the group stage.

Pakistan ended their campaign with a three-wicket win over Ireland in Florida on Sun-

day, a dead rubber after India and the USA, from Group A, advanced to the Super 8 stage.

Placed in Group A, Pakistan endured back-to-back defeats against the co-hosts, the USA, and then their bitter rival, India.

They bounced back with two wins on the trot, but it wasn't enough to turn their woeful campaign around and secure a spot in the Super 8.

Pakistan's next white-ball series will be against Australia in November. The Men in Green will engage in a three-match ODI series, which will kick off on November 4.

Gautam Gambhir tight-lipped on prospects of being coach

Former India opener Gautam Gambhir, who is widely speculated to take over from Rahul Dravid as the next Indian men's cricket team's head coach after the latter's role ends post the ongoing T20 World Cup, preferred to remain tight-lipped on his prospects even though he revealed that his mantra has always been based on a team-first philosophy.

Earlier on Tuesday, Gambhir, who recently inspired Kolkata Knight Riders (KKR) to their third IPL title haul as a mentor, was interviewed by Cricket Advisory Committee (CAC) members Ashok Malhotra, Jatin Paranjape and Sulakshana Naik. Gambhir, however, faces stiff competition from veteran cricketer WV Raman, who was reportedly more impressive in the virtual interview with the CAC members.

At an Indian Chamber of Commerce event in Kolkata on Saturday, Gambhir, when asked about his chances of succeeding Dravid for the top post, chose to remain noncommittal, adding to the mystery surrounding the potential coaching change.



"I don't see that far ahead. You are grilling me, asking me all tough questions. It is difficult to answer right now. All I can say is that I'm happy being here, just finished a brilliant journey (and) let's enjoy that. I'm in a very happy space right now," Gambhir said at a 'Rise To Leadership' seminar.

The two-time World Cup winner, however, stated that coaching philosophy is pure-

ly based on the "team first ideology". "If you have the intent of keeping your team ahead of any individual, things will fall in place. If not today, tomorrow, if not tomorrow, someday it will fall in place. But if you start thinking on that, or if you know that you need to help one or two individuals perform, then your team will only suffer," he said.

"For me, the guru mantra

is team first philosophy. I think team-first ideology, team-first philosophy is the most important ideology in any team sport," he added.

The KKR job was Gambhir's second stint in a coaching role after spending a couple of seasons (2022 and 2023) as mentor at Lucknow Super Giants, helping the team qualify for the playoffs both times.

Gambhir had sought time

to take a final call during the IPL, but speaking at an event in Abu Dhabi on June 1, he had expressed his desire to coach India. "Look, I would love to coach the Indian team. There is no bigger honour. There is no bigger honour than coaching your national team. You are representing 140 crore Indians. And more across the globe as well. And when you represent India, how can it get bigger than that?," he had said.

The BCCI is likely to make an official announcement of the appointment by the end of the month, largely depending on India's campaign at the ongoing T20 World Cup in the Americas.

It has been reliably learnt that even if Gambhir is picked for the role, he will take over the role from the tour of Sri Lanka after the conclusion of the Zimbabwe tour that begins July 5. National Cricket Academy chief VVS Laxman is most likely to accompany the team for the Zimbabwe tour that comprises five T20 Internationals.

The new head coach will be assigned for the next three years, which will include three major ICC tournaments across different formats, starting with the ICC Champions Trophy early 2025.

Eyeing successive Olympic podium-finish, lifter Mirabai hopes to remain injury-free

Mirabai Chanu is a medal away from becoming the first Indian weightlifter to win two Olympic medals. The Tokyo 2020 silver medallist says success at Paris Olympics will depend on how well she manages to keep herself injury free and improve technical nitty-gritties because "competition in the 49 kg division is going to be very tough this time."

The Manipuri lifter, who is the lone Indian in fray at Paris 2024, said the period between now and August 7, the day when the weightlifting competition will start at the Olympics, will be dedicated to "managing all the muscles in my body" and "improving technique to lift at least 90 kg in snatch."

Mirabai's personal best in snatch is 88 kgs, an effort that helped her win the 2022 Commonwealth Games gold in Birmingham with a combined lift of 201 kg that included a 113 kg in clean and jerk.

Paris 2024 will be Mirabai Chanu's third Olympics.

After a horror debut at Rio 2016, Mirabai, pushing 30, made impressive comebacks with sterling shows at global competitions. She became the first lifter in 22 years to become a world champion in 2017. The gold at Commonwealth Games in 2018 in Gold Coast followed and after narrowly missing a medal at the 2019 world championship, Mirabai created history at the 2020 Asian championships in China by hoisting a world record of 119 kgs at Ningbo,



China.

Injuries have often derailed Mirabai's career. Post the historic silver medal at the Tokyo Olympics, she has been afflicted by multiple injuries. The hip injury at the Hangzhou Asian Games sidelined Mirabai for five months.

Managing injuries with her trusted American physio Dr Aaron Horschig and coach Vijay Sharma, has been her biggest challenge. With Paris 2024 on the anvil, Mirabai has been very choosy about her competitions this year.

In 2024, she took part in only one mandatory competition—the World Cup—and with a combined lift of 184 kilos, finished 12th. However, it was enough to secure a spot at Paris.

"After the Asian Games injury, the World Cup was my first competition. I was certainly apprehensive about picking up another injury. I didn't want to spoil my Paris chances. So, yes, that injury fear was there. For me, injury management and staying stress free will be important. I have to do the things that helped me recover," she said.

"Injuries and pain are

companions for us. You never know when they will strike. We have to conquer them and Paris Olympics will tell me how well I have managed these aspects of the sport," tells Mirabai.

Mirabai and her team will be off to Le Ferte-Milon in France in the first week of July and will have almost a month to "acclimatize" ahead of the Summer Games. She says there is a direct relation between fitness and technique and every muscle plays a part in lifting weights.

"Weightlifting is a sum of many parts. Lot of gym exercises are required as every body part plays its role. Certain muscles like the back, knee and shoulder have to be in perfect condition. Muscle strength matters a lot to lift weights over 200 kgs (that's four times Mirabai's body weight). And more importantly, I can't skip training. If I leave training for a day, it will take a week for me to recover and bring my muscles to perfect state."

"If there is no strength or endurance, one can't lift weights. It's a tough process and one can't afford to relax.

Let's say to lift 85 kg in snatch, one has to lift 50 kgs at least 100 times and then gradually scale up," said Mirabai, while explaining her training schedule at the world-class facility in Patiala.

Injuries have made Mirabai more determined. The star weightlifter, for whom the sports ministry, through the Target Olympic Podium Scheme and other athlete funding programmes, has spent over Rs 2.7 crores for her training in the Paris cycle, laments for not having an Asian Games medal in her cabinet. Five months away from weightlifting has actually made her more combative. Winning another Olympic medal remains her only target.

"An Asian Games medal seems to be jinxed, I definitely want to win one and I was just one lift away from getting one in Hangzhou when the injury came. Even after so much preparation, I got injured. That hurts for sure but at the same time, injuries make me determined to come back stronger for India. So never had negative thoughts to quit."

"For any weightlifter to take part in two Olympics is a big thing. To compete at the world level is tough. Like Tokyo, I will again count on the prayers of all Indians and of course, it's going to be God's wish on that day in Paris. It will be a dream for me and my family to win a second Olympic medal but I also know that even the best of preparation can fail. So, let's hope for the best," she said before signing off.

'It is very easy to coach Cristiano Ronaldo'

The sound of sleep

It is a rain-lashed night in a village in the deep jungles. Through flashes of lightning, one can see a tiny wooden cottage, its windows lit up by the glow of golden light emanating from inside. It could be a lamp or a candle. Or it could be the flames from a burner or stove. Someone seems to be cooking. What is he or she making or baking? Hot soup or stew, perhaps? Or fresh bread to be had with delectable butter, maybe? A chimney above the tiled terrace emits a steady stream of smoke. This storybook image, set somewhere in an imaginary countryside somewhere in the world, is generated through artificial intelligence (AI) and is accompanied by the sound of incessant rain pounding the rooftops, the narrow hamlet roads, and the grassy green grounds.

It was on an insomniac moonlit midnight that I discovered this virtual village on a YouTube channel while doing a search on "fall sleep," not really expecting to find anything of value. I serendipitously stumbled upon this video, followed by dozens of other such videos, which proposed to help induce "peaceful sleep" in those suffering from sleeplessness. The videos were enchanting, usually with a fixed image depicting a cosy, comforting scene ranging from a warm bed strewn with blankets and pillows by a fire on a clear cold night to a scene of domestic bliss like a couple sipping steaming tea in the kitchen of a cottage nestled beside a stream of a hill. The sounds ranged from simulated rain like the above to flowing water as though a gushing rivulet or a gurgling brook. Yet others evoked the sound of wind whispering through the leaves of trees in a forest. Some simulated steady sounds of birds chirping or leaves rustling. The idea was to create an ambience where the viewer-listener would be transported to a peaceful place—read: a lap of nature—so that he or she could fall asleep.

The audio part of the technology used to create these AI-generated audio-visuals is called "white noise" or "white sound" in laypersons' terms, and it is essentially the technique of infusing a wide spectrum of sound frequencies in order to produce the effect of a steady sound simulating the

drone of falling rain, say, or flowing water or the buzz of a bee or other insects or even a whirring fan or a running vacuum cleaner.

While white noise is widely believed to help in inducing sleep by blocking out other background noises and has even been used by physicians and psychiatrists in the treatment of insomnia, they also point to the dangers of addiction and the risk of harmful exposure to blue light radiation as emitted through computer screens or cell phones. Indeed, it is an irony that the supposed sleep-inducing sounds need to be emitted through a technology that emits radiation and radio frequency energy, even if at low levels, which have the potential to stimulate the same brain that one is trying to calm down. "It is never advisable to depend for prolonged periods of time on artificial ways of inducing sleep," says a doctor who says he does not prescribe sleeping pills to his patients for long durations.

It occurred to me that in today's world, we prefer to depend on the artificial in order to get what we already have access to in nature. After a few days and nights of listening to the AI-generated rain in the vain hope of sleep, it was only when real rain fell on the window sill and I threw open the glass panes to let it in that I fell deeply asleep. It was the sound of sleep.

Sure, nature is no longer as generous with her gifts as she once used to be. We humans, it has been long established, have caused the earth to heat up so horribly that we have changed the way weather works. No, it does not rain as much as it once used to, but when it does, it totally drowns out the sound of any AI-generated rain.

It is a rain-lashed hamlet in a jungle in Bengal, and a humble hut is lit up by flashes of lightning. Through the rumble of thunder and the sound of rain, one can hear voices from within. A soft glow is emanating from within. It could be a clay lamp (*pradip* or *diya*) or flames from the open fire of an earthen stove. Through the tiny window, one can see cooking going on. Hot rice and fried potatoes perhaps? Or handmade roti to be had with *ghee*?

This is a real hut in a real hamlet, and the sound of rain I hear is real.

Mangrove forests: Guard of biodiversity & coastal stability

Mangrove forests, a unique and vital ecosystem, line India's 7,500-kilometre coastline, offering immense ecological, economic and environmental benefits. These forests, found in the intertidal regions where freshwater and saltwater mix, are characterised by salt-tolerant plants capable of thriving in harsh conditions. India's mangroves, particularly the Sundarbans, play a critical role in stabilising coastlines, supporting diverse species and mitigating climate change effects.

Mangroves are crucial for coastal protection. Their dense root systems stabilise shorelines, preventing erosion caused by waves and tides. These roots also act as natural barriers, reducing the impact of storm surges and tsunamis. This protective function is especially vital for densely populated coastal regions, safeguarding lives and property during extreme weather events.

Beyond physical protection, mangroves enhance water quality. Their intricate root systems filter pollutants, including nitrates and phosphates, from the water, thus maintaining healthier coastal and marine ecosystems. Additionally, mangroves are significant carbon sinks, capturing and storing large amounts of carbon dioxide, termed "blue carbon", which is essential in the fight against climate change.

Mangroves are biodiversity hotspots, providing essential habitats for various species, including fish, crustaceans, birds, and mammals. The Sundarbans, for instance, host the iconic Bengal tiger, estuarine crocodiles, and Gangetic dolphins. These forests are also critical breeding grounds for many marine species. Juvenile fish, shrimp, and crabs find refuge among mangrove roots, which support the livelihoods of coastal fishing communities by sustaining fish stocks.

Bird species such as egrets, herons, and kingfishers rely on mangroves for nesting and roosting. Endangered species, including the smalltooth sawfish and hawksbill sea turtle, also depend on these habitats.

Different types of mangroves exist, including red, black, and white varieties. Red mangroves are typically found along coastlines, while black mangroves are identified by their dark bark and better access to oxygen. White mangroves, on the other hand, tend to grow at higher elevations compared to red and black mangroves. In India, major mangrove areas include the Sundarban Mangroves, Mahanadi Mangroves, Mangroves of Gujarat, Ratnagiri Mangroves, Goa Mangroves, Cauvery Deltaic Mangroves, Krishna-Godavari Mangroves and Andaman Nicobar Mangroves.

Despite their significance, mangrove forests face numerous threats. Human activities such as

coastal development, aquaculture and deforestation have led to significant habitat loss. In India, urbanisation and industrial activities encroach on mangrove areas, disrupting these ecosystems. The conversion of mangroves into shrimp farms is a major issue, contributing to approximately 35 per cent of global mangrove loss.

Pollution, such as oil spills and plastic waste, worsens mangrove habitats. Climate change, with rising sea levels and stronger storms, adds to their challenges. Mangroves struggle to adapt fast, urging urgent conservation.

Essential measures include reforestation, community-based programmes engaging locals, and awareness campaigns. Legal protections are vital, designating mangroves as protected zones and fostering international cooperation for shared areas like the Sundarbans.

Mangrove forests are indispensable to India's coastal ecology, offering protection, supporting biodiversity, and combating climate change. Effective conservation is crucial for coastal well-being, emphasising mangroves' significance as more than just trees but vital coastal lifelines deserving the utmost care.

'Women are capable of excelling in engineering' Day for women engineers



On 23 June, International Women in Engineering Day celebrates the ongoing contributions of women in a profession that spans multiple sectors and continues to shape the future.

Sivapriya Mothilal Bhagavathy, lead R&D engineer at the power networks demonstration centre at the University of Strathclyde, Glasgow, United Kingdom, talks to The Statesman about her journey throughout the years.

Following are the excerpts:

Q. Please tell us a bit about your background and what inspired you to pursue a career in engineering.

Growing up, I was always fascinated by mathematics and its applications. This interest naturally led me to pursue a degree in engineering. I completed my bachelor's in electrical and electronics engineering at the College of Engineering, Trivandrum. In my third year, I took the Graduate Aptitude Test in Engineering and scored an all-India rank of 250, which opened doors to pursue my master's in energy systems at IIT Bombay. After IIT, I joined Reliance Industries Limited as a system design manager for their solar PV group. My goal was to understand the industry and then pursue a doctoral degree based on industry challenges. After four years at Reliance, I started applying for PhD scholarships and landed a fully funded position at Northumbria University, where I researched barriers to solar PV systems in the UK.

Q. What led you to specialise in power networks, and what do you find most exciting about this field?

During my undergrad days, I stumbled upon the harsh realities of climate change and its devastating impacts. That's when I knew I had to do my part in mitigating its effects. I became obsessed with renewable power generation and how it could transform our electricity networks.

The crazy-fast evolution of low-carbon technology has created a whole new world of challenges and opportunities for innovation. What really gets me excited is figuring out how all these new technologies interact and can be integrated seamlessly without disrupting the whole system. That's what drove me to specialise in this sector, and honestly, it still blows my mind.

Q. Please describe your current role as the lead R&D engineer at the power network demonstration centre at the University of Strathclyde.

As the lead R&D engineer at the power networks demonstration centre at the University of Strathclyde, I lead technology research in the whole energy system, including technology scouting, identifying, and prioritising ground-breaking innovation and business model concepts in the low-carbon energy sector. I'm also the project lead for the Whole Energy System Accelerator (WESA), a £5 million investment from the Scottish Government and the University of Strathclyde. As part of WESA, I'm designing and developing an infrastructure facility to demonstrate low-carbon heating technologies and hydrogen systems in 'real-world' conditions.

Q. Can you share a professional accomplishment that you are particularly proud of and explain why it holds special significance for you?

I'm particularly proud of achieving chartered engineer status from the IET. This recognition demonstrates my high level of competence in technical, people management, and project management skills, as well as my commitment to continuous professional development (CPD). It's a testament to my hard work and dedication to staying at the forefront of my field, and it's a great feeling to know that my expertise is recognised by industry leaders.

Q. Were there any challenges you faced in your career, and how did you overcome them?

One of the biggest challenges I faced was time management during my PhD days. As a mother, I had to balance research with raising my daughter, who was only four at the time. I had to be extremely strict about how I spent my time and regularly monitor my progress to ensure I completed my research within the funded duration of three years. I successfully defended my thesis within 3.5 years of starting the research.

Q. What are a few emerging areas in engineering that you believe hold great potential for innovation and development?

I'm excited about the potential in several areas. The three top ones that come to mind are as follows: First is power electron-

ics, crucial as we move towards a low-carbon economy, helping with renewable energy integration, energy storage, and electric transportation. Second is the application of artificial intelligence (AI) and machine learning (ML), as they can help optimise energy distribution, predict demand, and identify improvement areas, making the system more efficient. Last, but not least, is cyber-security, which is essential as our energy systems become more connected and the risk of cyber threats grows. Developing robust cyber-security measures is crucial to maintaining the reliability of our energy supply.

Q. What are a few common misconceptions about the engineering profession, particularly for women, that you would like to address?

One common misconception is that engineering is only about technical skills. While technical skills are essential, so are soft skills like communication, collaboration, and problem-solving. Another misconception is that women aren't interested in or capable of excelling in engineering fields. This outdated stereotype can discourage young women from pursuing engineering careers and undermine their confidence. Lastly, some think the engineering field is inhospitable to work-life balance, especially for women with family responsibilities. While engineering can be demanding, many organisations now offer flexible work arrangements, parental leave, and supportive programmes to accommodate employees' diverse needs. By addressing these misconceptions, we can create a more inclusive and supportive environment.

Q. What advice would you give to young women and girls who are considering a career in engineering?

My advice to young women and girls considering a career in engineering is to believe in themselves and not let anyone, including themselves, doubt their abilities. Don't be afraid to ask for help, and seek out mentors, teachers, or online resources when needed.

Q. How can educational institutions and workplaces better support women pursuing careers in engineering and technology?


Educational institutions and workplaces can better support women by providing bias training, mentorship programmes, flexible work arrangements, and fostering a work culture where asking for help is encouraged. Creating an inclusive environment where women's contributions are valued and recognised is key to encouraging more women to pursue and thrive in engineering and technology careers.

Your *Maa* hollers your *daak naam* (pet name), urging you to hurry up and take a bath. You know that after savouring some *shorshe diye ilish*, you'll be rewarded with a delightful *bhaat ghum*, cuddled up with your beloved *kolbalish* or *pashbalish* (cylindrical pillow or bolster). And who knows, maybe later you'll indulge in a Satyajit Ray classic! So unfolds the archetypal *Bangali* (Bengali) life, or *Bangaliyana*, in all its winsome glory.



in Mumbai, Banerjee is a *probashi*, meaning, he was brought up outside his linguistic community of West Bengal. The book's pulse is humour, brought to life by a whimsical mix of doodles and cartoons. For the past decade, the author, (a self-taught cartoonist, a former journalist and a successful corporate communications leader) spent most weekends sketching, creating a

treasure trove of cartoons. Banerjee's passion for cartooning ignited at the tender age of six as he watched his father craft witty cartoons in a small black diary. His primary learning source thereafter was studying the works of renowned cartoonists like R.K. Laxman, Mario Miranda and Ajit Ninan. His deep dive into Bengalis and *Bangaliyana* filled a sketchbook to the brim, planting the seed for this book.

naam that often makes more sense to the heart than to the head. The author humorously recounts how his entire neighbourhood knew him only by his pet name. When outsiders asked for his address using his formal name, the neighbours were left scratching their heads in bewilderment, having no clue who that was.

"*Maacher jhol* and *bhaat* (fish curry and rice) is synonymous with Bengalis but imagine the horror on the faces when I announce, '*Ami maach khai na*' (I do not eat fish)," writes Banerjee in the chapter titled *Tumi Maach Khao Na?* He humorously narrates his trips to the Mumbai fish market, where the sellers blatantly ignore him, instinctively knowing he's no fish connoisseur. The *kakimas*, *pishimas*, *kakus* and *dadus* (aunties, uncles and grandfathers) are the prized clientele and command all the attention. "Most fishmongers have, over the years, picked up a smattering of Bengali phrases too add to their sales pitch, '*Aasun, kakima, ilish nao, khub bhalo*' (Welcome, aunty, there are some good hilsa for sale)," Banerjee writes in his book.

The book boasts chapters like *Sunday Breakfast, Lunch and Ghoom, Kol Baleesh, Bhaat, Aloo Bhaja, and Muchmuche*. In these, Banerjee hilariously reminisces about staging epic battlefield scenes with his *kol balish* as the star, savouring elaborate Sunday feasts, and Bengalis' undying love affair with *muchmuche aloo bhaja* (crispy fried potatoes).

And then there's *Boroline*, the green tube of wonder ointment. Got a cut? *Boroline*. Chapped lips? *Boroline*. World ending? Well, *Boroline* might not fix that, but it will certainly make you feel better. "I distinctly recollect a mother admonishing her child aloud for not applying *Boroline*, inside the train compartment," Banerjee writes in the chapter titled *Boroline*.

There are plenty of delightful scents in the world, but then there are the prototypical fragrances of incense sticks, *dhuno* and *bhog proshad* including *khichuri*. One whiff and you

know '*Maa eshe gehen*'. Banerjee dives into the essence of this festival in the chapters, capturing the true pujo vibe through chapters titled *Pujo Pujo Bhaab, Bhog Prasad at the Durga Pandal, Pujor Chhuti* and *Durga Puja Chanda and Sponsorship*.


I first encountered the term 'wanderlust' (which translates to *bhromon er nasha*, meaning a strong desire to travel) around the age of seven or eight. I discovered it through Satyajit Ray's film *Agantuk*, where the maternal uncle, Manmohan Mitra, mentioned how his wanderlust compelled him to leave home and explore the world. It was then that I also learned the word has German origins.

In *Bangaliyana*, Banerjee discusses the Bengali fondness for travel, particularly their enthusiasm for pilgrimage to Puri, Odisha, and their adoration for hill stations such as Darjeeling, Kalimpong and Gangtok. "A Bengali family holidaying in the hills is a sight... There is a sweater, a muffler, a shawl and a mankey tupi (monkey cap)..." he writes in the chapter titled *Wanderlust*.

Jana Aranya by Satyajit Ray holds a particularly special place in my heart. More than just a film, it serves as a cynical social commentary. The film vividly portrays the depths of debasement within society. Banerjee, in the chapter titled *Satyajit Ray*, highlights my favourite scene where Utpal Dutt (Bishu Da) instructs Pradip Mukherjee (Somnath) in the ways of conducting business. Dutt's condescending tone when Somnath hesitates at the idea of engaging in trade is striking, particularly his remark, "You can beg on the streets, but you won't sell *chanachur* (snacks)."

Bangaliyana scoffs at the idea of fitting neatly into a single genre. It's part memoir, part short story, and one hundred per cent humour. Think of it as a treasure hunt through the author's memory bank, unearthing stories that will strike a chord with *probashi* Bengalis everywhere. The book is not about critiquing Bengali

culture; it's a heartfelt love letter to the true-blue Bengali spirit. Whether you're a *probashi* or just someone intrigued by the Bengali way of life, this book promises to tickle your funny bone and tug at your heartstrings. From the quirky anecdotes to the hilarious doodles, it's a riot of laughter, nostalgia and a celebration of everything that makes Bengali culture wonderfully unique.

The unpredictable nature of human intimacy

This is not the first book in which writer and academic Saikat Majumdar has looked at what he likes to call "non-normative" relationships between two human beings, irrespective of gender.

Even if there is fluidity in this concept, how it really plays out in our real lives is the subject of his various books that deal with, among other subjects, sexuality, homelands, religion and race in an immediate environment, which could be Kolkata, Delhi, or North America. More recently, his time spent at the Stellenbosch Institute for Advanced Study as a fellow pushed this, his latest novel, *The Remains of the Body*, to the finishing line. Something that is not easy at all. He acknowledges: "It has been a year of flight and mooring, through the burnt-orange twilight of the haunting South African sky, which will never leave my dreams." It provoked and disciplined him.

Available in hardcover, this book is more of a novella (the cover reminds one of Picasso's cubic painting *The Kiss*) and reads quick of two men, one married but whose marriage is already crumbling, who meet again to perhaps get another stab at rekindling the sparks of their childhood and adolescent years spent together as they discovered their bodies and each other. This theme of natural attraction with the same sex is also the theme of one of his earlier novels, *The Scent of God*, where two boys are drawn to each other, as it often happens in a same-sex boarding school, usually monastic.

Two male friends, one married but with the marriage breaking, resurfaced in North America as seasoned professionals. They negotiate their

own lives through academia and research in a country in which immigrants try to fit in but often feel sad and isolated. This is not always because of the quietness and sterile surroundings, but due to traces of racial tension beneath the surface. At the weekend parties in well-appointed homes where goat curry and wine are abundantly served, the *body* I feel becomes the metaphor for *home*.

There is bonding between not just two but three friends, as desire is like "secret coils of energy. Unfurled, they could light a flame in the water."

The novel looks into human desire. It is complex. Like shapeless water, it can take on the shape of whatever vehicle it is carried in. Round, square, or triangle—whatever happens in the novel can happen in life, but circumstances vary. The smaller details are against the larger picture of what the daily grind of living is and the stoicism we choose to suppress it with.

In a novel, the writer can give wings to the story to fly so that the reader can re-imagine it in the best ways possible, and that is the beauty of this piece of work. The prose is evocative and reflects the war that often takes place in the theatre of our minds, when not spilling over in terms of crisis. The book compels us to look at the unpredictable nature of human desire, intimacy and passion while they last (in our bodies) in kinder and more humane ways. The role of the opposite sex is no less here, and it entwines in ways that the author wishes to surprise us with.

Is it love, or is it the body? And can the two be segmented? These are questions raised, but there is a deep bonding between the two individuals that remains. It may not always be overtly sexual, but a certain erotic charge in our relationships, whoever

it may be with, is what makes life beautiful, if not painful.

Excerpts from an interview with the author who launched *The Remains of the Body* in Kolkata recently:

Q. You have positioned your book in the LGBTQIA+ genre. Can we expect more from you in this category?

As a novelist, I don't think I have much control over what I write about. Compelling moments and questions take hold of you and demand that you make novels of them. But I feel that disruptive forms of desire, including forbidden ones, have become a primal imaginative force for me. That is how I understand queerness—any desire that lies outside socially normative reproductive activity but also beyond the binary of gay and straight. Transgressive desire is a narrative energy of its own, as nothing pushes narrative like unfulfillment; such desires rarely come to fruition. Sometimes, they can be destructive, in small and large ways, and that destruction, too, is artistically fascinating. Their moments of happiness are also tiny acts of rebellion, almost always transient. I have the stirrings of a similar narrative, but it's too early for me to even fully imagine it. But it feels like it will require me to return to Calcutta, the original milieu of my fiction.

Q. Who are some of the Indian writers who have already dealt with this? Any favourite international writers?

The obvious names in Indian English writing are Vikram Seth and Hoshang Merchant in poetry and essays; R. Raja Rao, Sandip Roy and Hansda


Sowvendra Sekhar in fiction; Akhil Katyal in poetry; and Ruth Vanita in poetry and fiction. But there are writers in the Indian languages who have dealt with more subterranean forms of desire, sometimes radically and clearly queer, but often more grey and undefined. Niladri Chatterjee has been translating the queer fiction of Bengali writers like Krishnagopal Mullick and Shibram Chakraborty. But there are stories of strange and unclassifiable tremors, such as Saadat Hasan Manto's story *Peerun* or the moment in U.R. Ananthamurthy's story *A Horse for the Sun*, where a man gets a head massage from an old friend, a man who is seen as a village idiot.

Of international writers, my classic favourites are those by writers such as D.H. Lawrence and Vladimir Nabokov. I also enjoyed the Irish writer Sally Rooney's first two novels and the work of the Māori writer Witi Ihimaera.

Q. How much of you is in the book?

All fiction, as P.D. James had said, is autobiographical, and all autobiographies are lies. In other words, all fiction has something of the author in them. But it's hard to say what of the author. A limb, a memory, a wisp of laughter, a belief, a question? It's unpredictable. Factual things, like places are easy—I write about places I've known myself. Otherwise, I cannot make them come alive. As for characters, it's more complicated. Many Indians may recognise the kind of chaddi-buddy friendship Avik and Kaustav share in the novel. Kaustav's question—why doesn't the intensely physical dimension of this friendship become erotic?—might be a twist in that tale. I have asked myself that question: Why are we not pansexual?

Why is it that all of us don't get attracted to multiple genders? But it's a question that has come to me intellectually, though in an intensely personal way. But for Kaustav, this is not just an intellectual question; it is a bodily one too. The embodiment of an intellectual question is the fiction that I've tried to shape.

Jagged daggers of history warriors

Browsing the news and social media this week, I noticed a recurring theme of ethnic and cultural rifts. (1) A school district tries to increase racial integration, which often spurs affluent white parents to take their kids out of the public school system and opt for more exclusive private education. (2) The harrowing assault of a young girl turns into fodder for the immigration debate because the suspected perpetrator is an Ecuadorian, feeding the narrative that "these people" are inherently vicious and a grave threat to Americans, even though violent crimes by immigrants are statistically very rare, except for gang and cartel-related incidents having little impact on anyone outside the illegal drug trade. (3) An exposé about hiring or promotion practices at Disney alleges that the company blatantly discriminates against white applicants. (4) An Indian man is charged with attempting to murder an Indian American man, allegedly because of the latter's advocacy of an ethno-religious separatist movement in India, which, by definition, is undergirded by cultural hostilities, real or perceived. (5) A clash between two top stars in women's professional basketball is immediately interpreted by thousands of social media users as being motivated by anti-white racial sentiment on the part of a black athlete, which is ironic given that a quick

scan of their timelines shows these same commentators routinely dismiss such suggestions as "woke" and oversensitive ("snowflake") when the races of the purported aggressor and aggrieved are reversed.

To those of us who came of age at the end of the 20th century, the current era's fever pitch of racial and ethnic tension feels false and anachronistic, and frankly, shocking. We were raised to value tolerance, colour blindness, unity and multiculturalism.

But now, tribalism is ascendant. And it's not limited to the rough and tumble of current affairs. The trend is to recast ALL human history through factious and unapologetically biased lenses.

On one side, there is a new mythology whose chief antagonist is "whiteness"; which condemns anything perceived to be "western" as inherently "colonial" and oppressive; which makes exaggerated—and sometimes utterly unfounded—claims about the achievements of non-western civilisations, and overlooks any imperialism, violence, or cruelty by those perceived to be "people of colour." The preachers of this mythology demand collective retribution for and against entire races for offences committed by and against long-dead people. Some of it is downright petty. For example, there is a dinner-discussion series called "Race to Dinner" conducted by a duo of activists, an Indian American woman (from a highly privileged background) and an African American woman. This entails groups of white women paying these two ladies (and one white woman hosting the event in her home) to yell at them for being white and therefore inherently, inescapably, unconsciously (yet still culpably) "racist".

On the flip side, the reaction to this upsurge of anti-whiteness has been the resurrection of the most pernicious western colonial propaganda—downplaying the achievements of eastern civilisations, exaggerating any cruel cultural practices, falsely claiming credit for "civilising" the world, etc.

These myths had been largely debunked in the mid-late 20th century by scholars working with integrity towards objective discovery, something that's dismissed as naïve and misguided by today's "activist" academics. It's especially astonishing that the proponents of western exceptionalism would uncritically accept centuries-old, unverifiable imperial claims, given that many of them tend to be highly suspicious of any government or otherwise "official" narrative encountered in their own era. I don't fault them for their scepticism, but I do fault them for failing to apply the same standards to the one-sided "historical" accounts, almost certainly motivated by glaring imperial political interests.

Perhaps the most striking feature of this kind of revisionism is how much cherry-picking goes into these tortured readings of history. For example, if you're a proponent of Western exceptionalism, what cultural roots do you claim? Can you square your ethnic chauvinism with the rationalist and universal values of the Enlightenment age? Would your scientific accomplishments exist without the mathematics that originated in India and Arabia? Can you divorce European art and culture of the High Middle Ages and Renaissance (or ANY time in the last 1,500 years) from Christianity, imported from the Middle East? If you want to bypass all that and harken back to classical Greece and Rome, do you realise that Greeks and Romans were part of a cross-pollinating regional civilisation that included North Africa, Egypt, Mesopotamia, Anatolia and Persia? And that ancient Greeks and Romans would have seen most other Europeans as savages? Also, did you know that written language, astronomical observations, public water and sanitation systems existed in parts of India some millennia before they did in Europe? Have you heard of the bard Kalidas, who lived a thousand years before Shakespeare? Can you tell us exactly what period of history it was that you're invoking—that glorious golden age when Europeans were minding their own business

and creating their miraculous civilisation (not living as nomadic hordes or rough villagers) but NOT yet influenced by non-Europeans and NOT dealing with non-Europeans (by trade or conquest)? You can't, because no such era ever existed. Yes, western civilisation rose to spectacular heights. No, it didn't do so in isolation. Indeed, insular societies NEVER create "civilization"; only outgoing ones do. A society can engage with others in battle and conquest, or it can engage in peaceful trade and cultural exchange. But it must engage. Otherwise, it doesn't grow beyond a point.

But this reality is not acceptable to western exceptionalists. They need to parse the history and geography of Europe and "white people" in different ways for different purposes, as needed for their entire worldview to hold.

I call this "historical gerrymandering" (after the practice of redrawing an electoral district in such a way that it strengthens a favoured party's voter block and dilutes that of an opposing party. The term "gerrymander" is a portmanteau of "Gerry" and "Salamander", referring to the jagged, highly irregular, salamander-like shapes of the maps of these manipulated districts and the 19th-century politician Elbridge Gerry, the earliest official to be associated with this practice).

On the other side of the rift, if you're among those still trying to avenge European colonialism over the last half-millennium, can you show me any mature civilisation that does NOT have any history of imperialism? Are your ancestral lines completely free of any imperial taint? In fact, can you say confidently that you don't share substantial ancestry with the people you are charging as the descendants of your ancestors' oppressors? It should be noted, despite my framing of these questions the way I have, that this "side" is currently dominant in academia and the media (and is espoused by most white liberals, not just people of colour). In academia, it is reportedly common to be pressured to publicly

avow "anti-racist" sentiments and policies and even sign specific declarations. I've read strangely forced statements in nonfiction books and scientific papers that sound like ritual affirmations.

Much of what passes for historical literature now is an incessant battle of competing tribal mythologies and revisionism. For those who are still committed to truth and good-faith communication, there are now some additional hurdles. To confront either side of the problem, one must now devote considerable time and energy to dispelling the perception that one is shilling for the other camp.

The coffee-cartoonist of Kolkata

At my March, in the novel *Little Women*, sketched a cartoon of her teacher, Mr Davis, while she battled boredom in the classroom. Enola Holmes drew cartoons of Mycroft Holmes and Miss Harrison to mock them and their conventional beliefs when she was sent to boarding school. Even the film maestro, Satyajit Ray, often entertained

himself with doodling. Cartoons, as an art form, offer a unique blend of humour, calm and composure, which may effortlessly wipe away the pressures and frustrations of societal responsibilities, corporate work demands, politics and even mere school homework. A laugh is a necessity, and those who ease the burden of such minds weighed down by stress must be considered society's saviours, as they

dig ways to load off those burdened minds and recycle them to think fresh.

This week we came across one such saviour, providing solace to the people of Kolkata from the fast-paced and hectic metropolitan lifestyle by offering them the magical combination of coffee and cartoons.

Nestled beside the Tollygunge Metro station, Kolkata Coffee, which covers no more than 3 ft by 5 ft of pavement space, is the brainchild and single-handed creation of Shyama Prasad Dey. This little shop is no less than a museum itself. Along with 4 to 5 seating arrangements, every corner of this blue-coloured shop is plastered with black and white whimsical cartoons and intricate sketches, including calligraphic quotes.

Initially, Dey assisted and finally took over his father's book-selling business in 1993, and then shifted it near the Tollygunge metro station. The previous shop unfortunately reached its expiration date during the onset of the Covid pandemic, with reading mostly becoming digital.

Therefore, as someone from the working class of the nation, hope and idleness were never options. As soon as the global pandemic hit its last days, he established his coffee shop, just outside the Tollygunge metro station.

Dey speaks of his origin of interest: "I used to doodle during my early days in the book shop. Gradually, I came up with the idea of drawing some of those on greeting cards and initially showcasing some for sale. To my astonishment, those items were swiftly purchased, prompting me to create more in response to the escalating demand. Hence, I dived deep into the world of art. After discovering my area of interest, it was up until the year 2016 that I eventually took part in different exhibitions and fairs, as after that I became severely sick from taking long bus journeys from my home to attend such events."

Even though he visits his coffee shop every day at 6 p.m., his entire day remains packed. His day starts at 4 a.m., when he sets off

for the Baghajatin fish market to sell tea, and he only returns around 10 a.m. after securing the day's earnings. He says, "I sell tea to the fish sellers who cannot move around to buy tea now and then. Fishermen, as they engage in strenuous physical labour since the break of dawn, mostly rely on sips of tea to stir them up for work."

There is stiff competition among tea sellers; hence, for his shop in the Tollygunge area, he made the rule of selling coffee only in order to segregate himself from the other hawkers in the same area and also not to bother anyone else's business. He even caricatured a few boards with writing on them that say, "Ekane cha paben na", meaning one won't get tea here.

Dey's pseudonym, 'Dhopeswar Maharaj' is because he not only draws individuals in cartoons but also adds witty one- or two-liners as captions. Often, people get surprised by reading these captions that match their current mood, thoughts or personalities.

"The idea to draw on coffee cups was from my daughter's, who told me of coffee shops that write customers' names on their coffee cups. Therefore, along with serving coffee, I can draw cartoonish profiles



of people who visit my shop, instantly, for a very nominal price," he adds.

Dey handles his clients quite decently. While offering his customers their cups of coffee, he himself sips one too, to set a comfortable and relaxed atmosphere, hence allowing the former to gulp and digest their mundane work pressure along with his coffee.



Jangipur College in Murshidabad: The only general degree college in Jangipur city

The Bhagirathi River bisects the town of Jangipur, a subdivision of the historic Murshidabad district. Although Jangipur municipality was established in 1869, until 2001, ferries were the main means of communication between the two sides. A bridge was built over the Bhagirathi River in 2001, fulfilling the long-standing expectations of the people of the area. The history and cultural heritage of Jangipur are ancient. People of Bengal and India know this subdivision as the city of Dadathakur Sarachandra Pandit. The first weekly newspaper, "Jangipur Sangbad" was published in Jangipur in 1939 under the editorship of Dadathakur. His "Vidushak" and "Botol Purana" are brilliant additions to Bengali satirical literature. The famous kabiyal Guman Dewan (1302-1380 Bengali era) lived in Jindighi village in Jangipur. In memory of the kabiyal, the state Kabiyal Mela has been held in Jindighi village for the past ten years. The legendary Alkap artist Dhananjay Mandal was born in Dhanpat Nagar village, on the outskirts of Jangipur College. Jhanku took the folk drama Alkap industry to the pinnacle of excellence.

It was from Jangipur that India's famous politician Bharat Ratna, the late Pranab Mukherjee, was elected to the Lok Sabha for the first time in his life, held important ministries in the Government of India, and was the only Bengali to become the President of India. Today we are focusing on Jangipur College, the only general degree college in Jangipur city.

Jangipur College is located in a beautiful natural environment on the eastern bank of the Bhagirathi River, which runs through the middle of Jangipur city. Jangipur College was established as a government-sponsored college in 1950 due to the efforts of some educated people in the area. At that time, this college was under Calcutta University. In 1999, along with other colleges in Nadia and Murshidabad, Jan-

gipur College also came under the affiliation of Kalyani University. The college is QMS and EMS, ISO-certified by an IAF-accredited body with a B++ in NAAC assessment 2nd cycle.

There is a boys' hostel with 60 beds. The hostel, which is under construction with a special grant from the central government, is not yet completed. The principal of the college, Prarthita Biswas, said, "A utilisation certificate has been sent after completing the first installment of the girls' hostel. Once the money for the second installment arrives, it will be completed very soon."

Jangipur College is one of the addresses for getting higher education for the students of about 14 higher secondary schools around Jangipur College. Even though Jangipur is quite an old city, the main livelihood of the common people of the area is farming, bead tying, and masonry work. At one time, the silk industry was flourishing in the area. There was fur and bronze work. All that is in the past now.

Now, Jangipur is known throughout the country for its skilled bidi workers and masons. Naturally, the students at this college come mainly from these families. The current number of students in this college is around 9,000, including those in the science, arts and commerce streams. About 55 per cent of the students are from minority families; 30 per cent belong to Scheduled Castes; and about five per cent belong to Scheduled Tribes. About 30 per cent of students are first-generation learners. The number of female students is significantly higher among the total students at the college. Overall, this college has been playing an important role in the development of education in the area for a long period of 74 years.

At present, the number of professors at this college (including the principal and the librarian) is 69. The total number of permanent and casual non-teaching staff is 32. There are six science subjects taught in the college, including physics, chemistry, mathematics, botany, biology and environmental science. Honours, or major and minor subjects, are taught in these six subjects of science as per NEP 2020. In Bengali, English, history, political science, philosophy, economics, geography and Sanskrit are eight subjects in the arts stream taught as honours, majors, and minors as per NEP 2020, and education and Arabic are two general and minor subjects. In the department of commerce, only accounting is

taught as an honours or major/minor subject.

For those who cannot take entry into university for various reasons after completing their undergraduate studies, there is an opportunity to study MA in Bengali, English, history and education at this college through the distance education department of Kalyani University. There are several subjects of science and arts taught as undergraduate and postgraduate subjects under the aegis of Netaji Subhas Open University.

Jangipur College has separate modern laboratories for lab-based subjects. There are two computer labs with a total of eighty computers. Many classrooms in the college have audio-visual facilities and two smart classrooms. This college has an herb garden under the supervision of the Department of Botany. The Central Library has a collection of around fifty thousand books and e-books, which is rare compared to other colleges in West Bengal. The library has newspapers, journals and e-magazines on various subjects. There is a reading room for students and professors. Every floor of Jangipur College has clean toilets for male and female students. There is a sanitary napkin vending machine and a disposal machine in the girls' common room. There is a daycare centre too.

The college has a modern canteen. The college has a large, environment-friendly playground protected by boundary walls. Students regularly play sports here. Also, the training classes of the NCC unit of the college are held in the playground. A number of students from the NCC unit of this college have participated in the Republic Day Parade in Delhi. Their success in various competitions held among colleges affiliated with Kalyani University is notable.

The NSS unit of the college is very old. Their service programmes run throughout the year, in close proximity to the college and beyond. Every year, they adopt two to three nearby villages and help in the overall development of the villages. Their regular programmes include student health check-ups, blood donation camps, thalassaemia awareness camps, health awareness camps, breast cancer awareness camps, napkin distribution, Ganga and environmental pollution awareness, plantation programmes, etc. NSS programme officer Prof. Biplob Das said, "This year before the monsoons, a programme has been undertaken to plant thousands of trees at various

places in the area, including college premises, playgrounds and Bhagirathi banks."

With the unstinted support and cooperation of the Management Committee of this college, the encouragement of the principal, and the leadership of the Internal Quality Assurance Cell (IQAC), various sub-committees of the college undertake programmes in their respective fields outside of the syllabus-oriented curriculum unrelentingly. For example, various committees like the cultural sub-committee, seminar sub-committee, women's cell, equal opportunity centre, publication sub-committee, icc (internal complaints committee), career guidance cell, etc. organise regular cultural programmes, workshops, seminars, awareness camps, and publish magazines.

The auspicious days are celebrated with great fervour and aplomb. Professor Krishnendu Palchoudhuri of the department of economics is an accomplished musician himself. As he is the convenor of the cultural subcommittee, the cultural programmes of the college are of very high quality. The career guidance cell of the college helps the students in their careers in its limited capacity. Basudeb Chakrabarti, coordinator, IQAC, and head, department of English, said, "Though the college is in a remote area of West Bengal, our main strength is the resources. The college has highly qualified professors in every department, including the principal and the librarian. This might be the scenario in most colleges, but our additional strength is that during working days, 90 per cent of professors working here stay back. As a result, beyond the specified time, a great talent pool can work for the improvement of the college."

The students of the departments of zoology, botany and geography at the college have excursions on a regular basis. Other departments also organise educational trips and picnics at regular intervals. Through these programmes, sincere relationships are developed between students and professors. The Jangipur College Alumni Association is a very strong organisation of alumni of Jangipur College. Reunions are held every two years under its initiative.

The president of this association is Rezaul Karim, a successful businessman in the area who said, "The joy of being associated with Jangipur College is one of the greatest joys of our lives. Therefore, if we have any role in the development of the college, we eagerly look forward to it. We have grand celebratory plans for the 75th anniversary of the college next year."

Nurul Mortoza, senior professor of the department of Bengali, said, "Sri Bhajan Kumar Sarkar is the architect of the transformation of the college in the recent past. Sri Sarkar was the president of the management committee from 2012 to 2017. Bhajan Babu's administrative experience and indomitable desire to do good, combined with the efforts of the members of the governing body, literally transformed the college's get-up into a modern one. The honourable members of the current management association, including the principal, are trying hard to continue that trend."

At the end of this year, the visit of the NAAC peer team for assessment of the 3rd cycle at this college is on the horizon. This year, the college will be 75 years old. Overall, the atmosphere at the college is beautiful. Based on that, professor Tarak Mondal, secretary in the teachers' council, said that, "Despite the scorching heat of summer this year, we did not take a vacation. On the advice of the principal, I have been cooperating in facilitating administrative and academic work, and in this regard, I have received the full support of the teaching staff, including the professors of the college."



The story of a young artist

This year, a young illustrator and artist, Kuhoo Mitra's one-day solo exhibition was exhibited at Calcutta Rowing Club on Sunday, 16th June. Mitra is a student of the bachelor of fine arts in illustration at the School of Visual Arts, New York City, and will begin her final year in the coming fall.

"I used to read a lot of children's books and would love to draw my own characters and scenes passionately since childhood, and my parents have supported and encouraged me a lot in this field," she said.

Mitra decided to pursue her career as a freelance illustrator at an early age, and immensely admired iconic painters and illustrators like Satyajit Ray, Nandalal Bose and Bikash Bhattacharya.

In this exhibition, she displayed 21 paintings and five illustrated, hand-bound books done by herself.

She has been illustrating and publishing books since her school days. Her first illustrated book of Bengali poems, Somoyer Chokhe, was written by Subhanu Mitra and published by Bani Sansad Publishing House in Kolkata in 2018. One of her best illustrated books covers Bengali short stories titled Oder Golpo, written by Shreya Ghosh and published by Parampara Prakashan in Kolkata in 2020. A fifteen-page illustrated book written in Bengali and depicting through pictures the various rituals and events that take place is titled Durga Puja. The writing, typography, design, screen-printing and binding were all done by Kuhoo herself. She used the Japanese stab-binding method for this book, which was made in New York in 2023. She has illustrated

a few accordion books, Creature of the Deep Sea and Cracking India in 2023.

Kuhoo has been experimenting in different mediums, sizes, styles and subject matter, though in this exhibition she focused on water colour, gouache and coloured pencils. Kuhoo has expertise in mediums like water colours, acrylics, pen and ink, graphite and charcoal.

"I was highly enchanted by the Western illustrators and writers at the age of 3-4 years. I got the primary idea of illustration and storyboard drawings from them and their illustrated picture books and magazines," she says.

This was Kuhoo Mitra's first solo exhibition, where she expressed a strong commitment to creating illustrated books in Bengali. She observed that despite the growing diversity in the picture book industry, Bengali culture remains underrepresented in English-language picture books. Consequently, Kuhoo aims to produce more illustrated books featuring Bengali protagonists, exploring unique aspects of Bengali culture. Her upcoming works will address themes like breaking stereotypes

about Bengalis, celebrating Bengali customs, food and culture, and delving into the history of Bengal and the Indian subcontinent.


