

NDA ally NPP withdraws support to BJP government in Manipur

nion Home Minister Amit Shah on Sunday convened a high-level meeting with senior officials in the national capital to assess the security situation in Manipur.

Sources indicated that the Home Minister planned to hold a detailed review meeting on Monday to discuss the concerns and strategies surrounding the fragile security scenario in Manipur.

The development comes after a curfew was imposed in the valley districts in Manipur and internet services were suspended as fresh protests erupted against the killing of six people, whose bodies were found in Jiribam and neighbouring after they were allegedly kidnapped by Kuki militants.

Amid the protests, and civil society organisations demanding the resignation of elected legislators over the government's failure to protect civilians and end the Kuki-Meitei conflict, now in its 18th month,

review meeting after he returned to his residence in Delhi, postponing his planned visit to Vidarbha, where he was expected to attend a series of rallies ahead of the Maharashtra Assembly polls on 20 November. Three women and three

children who were staying in a relief camp went missing after a gunfight between security forces and militants in Jiribam district on 11 November, with Meitei organisations alleging that they were kidnapped by militants. Protests erupted in the Imphal valley since Saturday morning following news that the lifeless bodies of the kidnapped civilians, including an infant, have been found in a mutilated state. Protesters attacked the homes of several state ministers and MLAs and

clashed with security forces,

leading to injuries.

Following the developments, the Ministry of Home Affairs had said on Saturday that all security forces have been directed to take necessary steps to restore order and peace in Manipur. In light of continued tensions, the Director General of the Central Reserve Police Force (CRPF) Anish Dayal Singh also reached Manipur on Sunday.

Meanwhile, the Conrad Sangma-led National People's Party (NPP) has withdrawed its support to the BJP-led N Biren Singh government, alleging that it has completely failed to control the ethnic violence in the state and restore normality. The NPP has seven MLAs in the Manipur Legislative Assembly, while the BJP has 37 MLAs and enjoys the support of the Naga People's Front (NPF) with five MLAs, one JD(U) MLA and three Independents.

The Coordinating Committee on Manipur Integrity (COCOMI), an apex body of the Meitei community, has given a 24hour ultimatum to the Centre and the state government to take "decisive action" against armed groups or face public anger, as violent protests continued in the valley districts and the houses of several ministers and MLAs were attacked by mobs. A group of 13 civil society organisations also called for the resignations of all 50 Meitei MLAs in Manipur, including Chief Minister Singh, citing a lack of political will and warning of a potential public uprising.

PEOPLE'S PARLIAMENT, ALWAYS IN SESSION

Prime Minister Narendra Modi and Nigerian President Bola Ahmed Tinubu on Sunday reaffirmed their commitment to jointly fight terrorism, piracy

and radicalisation.

Mr Modi is on a State Visit to Nigeria from 17-18 November. He held official talks with Nigerian President Bola Ahmed

Tinubu in Abuja on Sunday. Earlier in the day, Nigeria conferred its second-highest national award, the Grand Commander of the Order of the Niger (GCON), on Prime Minister Narendra Modi during his first official visit to the country.

This made PM Modi the second foreign dignitary to receive this honour after Great Britain's Queen Elizabeth II, who received the award in 1969.

Mr Modi and Mr Tinubu had a restricted meeting followed by delegation-level talks at Abuja's Aso Rock Villa, which serves as the office and residence of the Nigerian Presidency.

PM Modi recalled his warm meeting with President Tinubu at the G-20 Summit in New Delhi. He noted that the two countries enjoy special bonds of friendship defined by a shared past, common democratic values and strong people-to-people ties.

The Prime Minister conveyed his sympathies to Pres-

ident Tinubu for the destruction caused by the recent floods in the country. President Tinubu thanked

the Prime Minister for India's timely assistance with relief material and medicines. The two leaders reviewed

the ongoing bilateral cooperation and discussed ways to further strengthen India-Nigeria Strategic Partnership. Expressing satisfaction at

the progress of ties, they agreed that there was immense potential for collaboration in the fields of trade, investment, education, energy, health, culture, and people-to-people ties.

Mr Modi offered India's experience in agriculture, transportation, affordable medicine, renewable energy, and digital transformation to Nigeria.

President Tinubu appre-

ciated the development cooperation partnership offered by India and its meaningful impact in creating local capacities, skills, and professional expertise.

"The two leaders also dis-

cussed enhancing defence and security cooperation. They reaffirmed their commitment to jointly fighting terrorism, piracy and radicalisation," a statement issued by the Prime Minister's Office (PMO) said.

Mr Modi and Mr Tinubu also discussed global and regional issues. President Tinubu acknowledged India's efforts to amplify the concerns of developing countries through the Voice of the Global South Summits.

The two leaders agreed to work together to meet the development aspirations of the Global South.

I-Tultimatum to taxpayers: Disclose assets held abroad, or face penalty of ₹10 lakh

Failure to disclose assets held abroad or income earned on foreign shores in the ITR can attract a penalty of Rs 10 lakh under the anti-black money law, the Income-Tax (I-T) Department cautioned taxpayers on Sunday.

The department issued a public advisory as part of a compliance-cum-awareness campaign launched recently by it on Saturday to ensure that such information is reported by the assessee in their Income Tax Return (ITR) for assessment year (AY) 2024-25.

The advisory specified that foreign asset, for a tax resident of India in the previous year, includes bank accounts, cash value insurance contracts or annuity contracts, financial interest

in any entity or business, immovable property, custodial accounts, equity and debt interest, trusts in which a person is a trustee, beneficiary of settlor, accounts with singing authority, any capital asset, etc., held abroad.

"Failure to disclose foreign asset/income in the ITR can attract a penalty of Rs 10 lakh under the Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act, 2015," the advisory stated.

The I-T department said taxpayers falling under this criteria must mandatorily fill the foreign asset (FA) or foreign source income (FSI) schedule in their ITR even if their income is below the taxable limit or the asset abroad was acquired from disclosed sources. The Central Board of Direct

Taxes (CBDT) has also launched a Compliance-**Cum-Awareness Campaign** for Assessment Year (AY) 2024-25 to assist taxpayers in accurately completing Schedule Foreign Assets (Schedule FA) and reporting income from foreign sources (Schedule FSI) in their income tax returns (ITR).

In a statement, CBDT said informational messages will be sent via SMS and email to resident taxpayers who have already submitted their ITRs for AY 2024-25.

Despite an unsuccessful meeting with tea garden owners yesterday, Mr. Ghatak assured trade union leaders of another meeting within 15 days.

Tea workers in the Hills are demanding a 20 per cent bonus, while the state government has recommended a 16 per cent bonus. Workers are pressing for an additional 4 per cent. This comes after a series of inconclusive bipartite and tripartite meetings. The Consultative Committee



of Plantation Associations (CCPA) has agreed to pay a 16 per cent bonus for workers in the Terai and Dooars

by the Labour Department on 6 November in Kolkata also ended without a resolution due to the absence of several tea garden own-

Trade unions representing workers in the Darjeeling and Kalimpong Hills have demanded that the state government ensure the participation of tea garden own-

ers in future discussions.

lution. Some tea garden owners expressed their inability to pay more than a 13 per cent bonus, citing the absence of key representatives from their association.

The Minister requested the owners to consult their colleagues and provide feedback within 15 days.

Trade union leaders urged the Minister to expedite the resolution process to alleviate the distress of tea workers. Saman Pathak, a trade union spokesperson, emphasised the need for a swift resolution and the importance of addressing other pressing issues within the tea gardens.

Bengal lottery scam: Lucky draws on unsold tickets, ED unearths fraud

The Enforcement Directorate (ED) officials probing the alleged financial fraud and money laundering through lottery tickets in West Bengal are probing three particular angles in the alleged scam.

The first angle is how the lottery entity under scanner had been doing the forgery with common people where lucky draws were drawn on the unsold tickets and not the sold ones, sources said.

Subsequently, fake winners were projected through advertisements through multiple mediums alluring people to purchase tickets. Sources said people often got trapped by such advertisements and purchased those tickets unaware of the fact that lucky draws would be drawn on the tickets purchased by them.

In this process, sources

added, this particular entity and its agents mainly targeted people from weaker financial backgrounds who did not have any sort of formal education.

The second angle is that even the fake winner projected by the lottery entity just received a small portion, generally five per cent of the winning amount and the remaining was retained by the management of the lottery entity concerned, which comes under the typical case of money launder-

The third angle, sources said, which is being probed by the ED officials, is the related areas where the said lottery entity invested their proceeds both within India as well as abroad.

Through these investments, the said entity converted its unaccounted money into account one, said the sources.

It is learnt that in June 2019 for the first time, a complaint was filed against the said lottery entity at a police station in south Kolkata. The complaint was the same lucky draws were

drawn on unsold tickets. At that time the city police started an investigation. A couple of persons were arrested and some bank accounts were also frozen. However, the investigation finally did not lead to a logical conclusion.

Last week, the ED officials conducted marathon raid and search operations at some locations in and around Kolkata, which included a lottery-printing press in the northern outskirts of Kolkata.

In this connection, the ED officials also confiscated unaccounted cash worth Rs 3 crore from the residencecum-office of an agent of the said lottery entity at Lake Market in South Kolkata.

Darjeeling Himalayan Railway resumes toy train service on NJP-Darjeeling route



Husbandwon't allow hospital delivery, woman dies in childbirth

A woman tragically died in Basirhat last night after her husband defied government directives and chose to deliver their child at home. The incident occurred in Malipota, under the jurisdiction of the Bagda Police Station.

According to family sources, Sumana, a resident of Basirhat, had been married to Nani Debnath for about a decade. The couple already had an eight-year-old daughter. Locals reported that Nani, who is known to live an ascetic lifestyle, frequently abused his wife and had forced her to undergo multiple abortions against her will.

On Friday night, Sumana went into labour. Instead of taking her to a hospital, her husband insisted on a home birth. As her condition deteriorated, she was rushed to Bagda Hospital and later transferred to Bongaon Hospital. After giving birth to a baby girl, Sumana succumbed

to her injuries. The newborn is currently in the SNCU

Locals reported that the woman had delivered the baby at home and was brought to the hospital in a critical condition. Sumana's brother arrived from Basirhat upon learning of her death. While locals are reportedly pursuing legal action, the victim's family has yet to file a formal complaint. Police have stated that no complaint has been lodged by the family, hindering any legal proceedings.

Human rights activist Krishnendu Goswami emphasised the need for legal action to prevent similar incidents and their societal impact. Dr. Kisun Singh, the national general secretary of the Rural Doctors Association of India (RDAI), highlighted the dangers of home births and the need for public awareness campaigns to discourage such practices. He expressed the association's willingness to support the health department in this endeavour.

Later, after the temple was abandoned for some years, the present aatchala temple was built by Nayanchand Mullick in 1764. The temple, along with the naatmandir, is quite large. Within the temple premises, there is also a rasmancha.

The main festival here is Rashyatra, which is normally held in November every year. An octagonal rasmancha dedicated to Radhaballavji is situated a little away from the temple, by the side of the Ganges. The rasmancha is placed on a higher pedestal. There are eight domes on

the eight walls. It is said that Rudraram Pandit of Chatra used to worship at Ballavpur, which is about two kilometres from Serampore. At that time, the area was covered with forests. Lord Krishna was pleased with Rudraram's worship and appeared to him in the form

of an ascetic, asking him to bring a stone from the Sultan of Gaur and carve an idol of him.

The stone was a touchstone, and three Krishna idols were made from it ~ Radhaballav, worshipped in Serampore (the place is named Ballavpur after Radhaballav); Shyamsundar, worshipped in Khardah and Nandadulal,

worshipped in Saibon. Old places of worship in the district, carrying the history, culture, rituals, faith, and beliefs of Bengal, had been neglected over time. However, West Bengal Chief Minister Mamata Banerjee has taken an initiative to pre-

serve these ancient places of worship, buildings, and monuments, and to promote them on the world tourism map. Many of these ancient constructions and buildings have been declared heritage sites by the state heritage commission. Prodesh Chakraborty, the

president of the Radhaballav Temple Trust Board and a descendant of Rudraram Pandit, said that Chief Minister Mamata Banerjee has sanctioned over 5 crore rupees for the complete renovation of the four-century-old temple, the construction of a pilgrim's rest house, and the beautification of the surrounding

Late-night car accident in Howrah: Two dead, three injured

A late-night car accident in Howrah has resulted in two fatalities, including the driver. The incident occurred around 1 a.m. last night on Foreshore Road in Shibpur. The car crashed into a stationary trailer parked on the road-

side. Two people died, and three others were injured and hospitalised. The car involved in the accident bore the plaque carrying the name of Giasuddin Mollah, MLA of Magrahat West in South 24 Parganas. However, the MLA denied any connection to the car.

Mustaq Khan (25), a resident of Watgunge, was driving the car with four others when the accident occurred. The speeding car lost control and collided with the rear of the stationary trailer. The impact was so severe that the front of the car ended up under the trailer, trapping the occupants inside.

Police from the Shibpur police station arrived at the scene and rescued the passengers from the wreckage. Mustaq and another person were declared dead at Howrah District Hospital. The remaining three injured passengers are undergoing treatment.

Mustaq's father, Mohammed Mukhtar, confirmed that his son was driving the car and had been working for MLA Giasuddin. However, the MLA denied any involvement in the accident.

Police are investigating the cause of the accident and are reviewing CCTV footage from the area.

State government to launch drive to promote safer helmets for two-wheeler riders

In an effort to prevent loss of life in road mishaps involving two-wheelers, the state government will introduce a stateof-the-art helmet.

This comes after it was discovered that many motorcyclists are using poor-quality helmets that would not protect their heads in the event of an accident.

The West Bengal Motor Vehicle Association will launch a massive campaign across the state from 23 November, urging motorcyclists to use IS 4151:2015 helmets approved by the Bureau of Indian Standards.

This decision was taken at a high-level meeting held in the Transport Department. The drive will be part of the

This comes after it was discovered that many motorcyclists are using poor-quality helmets that would not protect their heads in the event of an accident.

Safe Drive Save Life initiative launched by Chief Minister Mamata Banerjee.

The meeting was chaired by Mr Snehasis Chakraborty, the state's Transport Minis-

It has been decided that city police and their district counterparts will conduct extensive drives to inspect the quality of helmets.

Initially, riders will be advised to use proper quality helmets,

failing which they will be fined. A senior officer from the

state Transport Department said the state government is determined to reduce road accidents. "We aim to make the state accident-free, and the state government will leave no stone unturned to achieve this," the officer said.

The officer explained that the new type of helmet approved by the Bureau of Indian Standards will prevent head injuries for motorcyclists in accidents. He noted that many two-wheeler riders often

do not use proper helmets. "Many two-wheeler riders believe that wearing a helmet is a casual affair. So they buy poor-quality helmets and use them. These helmets crack during road accidents and cannot prevent head injuries," he said.

However, some motorcyclists, especially those who go on long-distance rides, use proper helmets, gloves, elbow pads, and knee pads. These accessories are manufactured by two-wheeler manufactur-

City police have already launched a massive drive against two-wheeler riders who are not wearing helmets. Offenders are fined Rs 1,000. The rider is also fined if the pillion rider is not wearing a

helmet. "The drive, which was launched before Kali Puja, has been very effective, and twowheeler riders in areas where many were previously seen without helmets have now started using them," the officer said. "The drive will continue and is expected to yield even better results," he added.

Jhansi Hospital fire: Toll rises to 11, negligence suspected

The tragedy unfolded late Friday night when a short circuit sparked a fire in the NICU, claiming the lives of 10 newborns initially; later the DM confirmed the death of another child, making it 11 infants

The death toll from the devastating fire in the Neonatal Intensive Care Unit (NICU) of Jhansi Medical College has risen to 11, officials confirmed on Sunday.

The tragedy unfolded late Friday night when a short circuit sparked a fire in the NICU, claiming the lives of 10 newborns initially.

On Sunday, District Magistrate Avinash Kumar reported the death of another child during treatment, bringing the total fatalities to 11. At the time of the incident,

the SNCU housed 49 new-

borns, out of which 39 were

rescued. However, the cause of the fire remains unclear. While the hospital administration attributes the fire to a short circuit, officials have yet to provide details

about how the electrical

failure occurred. Preliminary investigations



suggest that the short circuit was caused by an overload of medical equipment in the SNCU.

The resulting sparks report-

edly ignited the oxygen concentrator, escalating the blaze beyond control. Police are continuing to probe other potential causes of the fire.

The SNCU primarily cares for newborns suffering from conditions like jaundice and pneumonia.

Experts highlighted that

the ward was accommodating three times its intended capacity at the time of the incident.

Consequently, critical equipment like warmers and monitoring devices had to operate continuously, causing them to overheat.

Hospital administration allegedly failed to regulate the use of this equipment on Friday night, leading to extreme overheating, a short circuit, and eventual oxygen leakage. The leaked oxygen fueled the flames, which rapidly engulfed the ward.

Chief Fire Officer Rajkishore Rai confirmed the overload as the likely trigger for the short circuit and stated that other aspects of the incident are under investigation.

The incident has raised serious concerns about overcrowding, infrastructure safety, and administrative negligence at the hospital. Authorities have promised a thorough investigation to determine accountability.

Fire safety verification to start in UP hospitals from Monday

In the wake of the death of 11 newborns in a fire that broke out in the Maharani Lakshmibai Medical College in Jhansi, the Uttar Pradesh government has decided to launch safety checks in every hospital in the state afresh.

A Fire Department team will start conducting verification of every government and private hospital and medical college from Monday.

In view of the incidence of fire in hospitals in the state, the Union Health Ministry had already given instructions to investigate the mishaps. Sources claimed here on

Sunday that the Directorate of Electrical Safety carried out inspections at government and non-government hospitals of the state in June 2024. During the inspection of around 524 hospitals, many shortcomings were found in the SGPGI and the Maharani Lakshmibai Medical College, Jhansi. Following the inspections, instructions were issued to the college administration to take steps to improve and avoid such mishaps.

After the incident in Ihansi. the Directorate has decided to run the campaign from Monday all over again. In the fresh campaign, it will be confirmed whether the deficiencies in the hospitals have been rectified after the issuance of the instructions to do so. If

There are a total of 906 government and private hospitals and nursing homes operating in the state capital, of them only 301 have NOC.

According to Chief Fire Officer (CFO) Mangesh Kumar, more than two hundred hospitals running in Lucknow are not meeting the fire safety standards.

Campaigning to end Monday evening in 9 Assembly bypolls in UP

Similarly there is a lot of pressure on Samajwadi Party President Akhilesh Yadav in these bypolls to repeat his feat like the Lok Sabha polls.

In all the nine seats, there is a direct contest between the BJP and the SP, but the Mayawati-led BSP is contesting in all the seats, and that could impact the results for both SP and the BJP as the BSP could dent the dalit votes in the state.

Chief Minister Yogi Adityanath has single handedly led the campaign for the BJP and had already visited each assembly segment at least twice along with holding roadshows to woo the voters. THe CM has been

On the other hand, SP President Akhilesh Yadav spearheaded the campaigning and visited the constituencies. Out of nine seats, four were held by the Samajwadi Party, three by the BJP, one each by BJP ally Nishad Party and the SP's former ally Rashtriya Sabha polls. Eight of these seats, except Sisamau, fell vacant after their MLAs were elected as MPs in the Lok Sabha polls. In Sisamau, the bypoll is being held due to the disqualification of SP MLA Irfan Solanki, who was convicted in a criminal case.

Karhal and Katehari seats are important seats in this bypolls which were held by the SP but this time BJP has put all its pressure to wrest

ongress President Mallikarjun Kharge on Sunday slammed the BJP-led NDA governments for "simmering violence" in Manipur, saying that "neither Manipur is united nor it is safe under BJP's double engine governments."

Hitting out at the Bharatiya Janata Party, Kharge accused the BJP of "divisive politics", saying "BJP deliberately wants Manipur to burn, for it serves its hateful divisive politics."

Taking it to a social media post on X, Kharge wrote, "@narendramodi ji, Under your double engine governments, "Na Manipur ek hai, na Manipur Safe hai" Since May 2023, it is undergoing unimaginable pain, division and simmering violence, which has destroyed the future of its people. We are saying it with utmost responsibility that it looks that the BJP deliberately wants



Manipur to burn, for it serves its hateful divisive politics."

Attacking further, Kharge said that both governments have "failed in the beautiful border state" and people of the Manipur will "never forgive or forget" them for their situation.

The tweet added, "At least 17 people have lost their lives since November 7. New districts are being

added to the list of strifetorn regions and the fire is spilling over to bordering NE states. You have failed Manipur -- a beautiful border state. Even if you visit Manipur in future, people of the state will never forgive or forget that you left them to fend for themselves, and never set foot in their state to heal

their miseries and find a

Meanwhile, Manipur police officials have arrested 23 individuals who were part of the mob involved in the alleged "ransacking and arson of the houses," said Manipur Police on Sunday.

These individuals were arrested from Imphal East, Imphal West, and Bishnupur districts of the state. Additionally, the police officials have recovered one .32 pistol, seven rounds of SBBL, and eight mobile phones from their possession, the police said. Amid the escalation in the state, a total curfew has been imposed in Imphal until further orders. Following this, the government immediately suspended Internet and mobile data services for two days. Following this incident, heavy security forces including the Army and Assam Rifles were deployed in Imphal. In a post on X, Manipur Police wrote, "On 16.11.2024, irate mobs have targeted various houses and properties of public repre-

sentatives including Ministers and MLAs of the State in Imphal. Police have resorted to firing tear gas shells etc. to disperse the mob. Security forces including Army and Assam Rifles have been deployed in Imphal to strengthen the security in the town area. Flag marches have been conducted. 08 (eight) persons have been injured in the process of mob dispersal."

In a post on X, Rahul Gandhi described the events as "deeply disturbing".

"The recent string of violent clashes and continuing bloodshed in Manipur is deeply disturbing. After more than a year of division and suffering, every Indian hoped that the Central and state governments would have made every effort at reconciliation and found a solution," he said. "I urge the PM once again to visit Manipur and work towards restoring peace and healing in the region," Gandhi added.

AICC General Secretary Priyanka Gandhi alleged that under the Bharatiya Janata Party rule, "no women, farmers, youth or workers are feeling safe" and it's only the businessman friends of Prime Minister Narendra Modi who are secure.

Addressing a massive rally in the Maoist-affected Gadchiroli district and later holding a huge road show in Nagpur, she targeted the BJP regime for indulging in 'politics of discrimination' on the question of developmental works in the country.

"India's first PM Jawaharlal Nehru set up many big educational institutions, factories, ports, dams, and hospitals across all states considering the overall interests of the country. The Congress governments in the past never practised favouritism in progress and development, like the BJP government's policies of discrimination in

the past 10 years," said Priyanka Gandhi.

She cited how the BJP has always been unfair against Maharashtra by diverting several mega-projects to Gujarat or other states.

As a result, unemployment has shot up hugely, 2.50 lakh government posts remain vacant with no recruitments, jobs are being filled on a contract basis leading to frustration among the youngsters, and maximum suicides among youth are happening in Maharashtra, said Priyanka Gandhi.

She reiterated how the agriculturists are in deep

distress without proper remuneration prices for their produce, which is driving many farmers to end their lives in despair, particularly in the Vidarbha region.

Besides, she referred to the growing costs of cultivation with the imposition of GST on agricultural inputs that has further added to the woes of the tillers in the

"The Congress had enacted the PESA Act to safeguard the rights of Adivasis, but today they are at the receiving end under the BJP... Chhattisgarh's Tribal Welfare Minister, Ramvichar Netam, has ignited a political storm by declaring Prime Minister Narendra Modia "divine incarnation" and the "God of the tribal community."

Speaking at a program in Raipur to mark Tribal Pride Day, Netam praised Modi as an unparalleled leader who has transformed the lives of tribal communities across

"No leader ever listened to our problems before," Netam stated.

"Blessed is the land that gave birth to an avatar like Narendra Modi. He is deeply concerned about the tribal community and has launched several schemes for our upliftment. The 'Dhartii Aaba Tribal Village Upliftment Campaign,'



initiated by the Prime Minister, will ensure the holistic development of 6,500 villages and their residents in Chhattisgarh."

Netam's remarks have provoked fierce backlash from the Congress party, which accused him of sycophancy and disrespecting tribal traditions.

"By equating Modi to a God instead of honoring Budhadev, our traditional deity, Ramvichar Netam has insulted tribal beliefs. The BJP has no right to place its leaders above our gods and faith," a Congress spokesperson retorted.

The comments are being viewed as part of a broader strategy to consolidate BJP influence in tribal-dominated regions. Under Modi's leadership, the BJP has championed initiatives aimed at improving education, healthcare, and infrastructure for tribal communities. However, critics argue that the party is leveraging religious symbolism to secure electoral gains.

For the Congress, the controversy presents an opportunity to position itself as the guardian of tribal heritage. Analysts predict the issue could escalate into a key electoral battleground in Jharkhand and Chhattisgarh, where tribal votes often determine out-

Observers note that Netam's controversial statement reflects a calculated risk by the BJP. By portraying Modi as a savior-like figure, the party seeks to reinforce its commitment to marginalized communities.

However, such rhetoric may alienate traditional tribal voters who perceive the deification of political leaders as a challenge to their cultural identity.

The BJP faces the challenge of navigating this delicate terrain in the electoral battle. For the Congress, the task lies in countering the BJP's narrative without appearing dismissive of development schemes that have benefited many tribal communities.

The debate over Ramvichar Netam's remarks has brought tribal concerns and political strategies to the forefront. While the BJP highlights its developmental initiatives, critics question the blending of religious symbolism with governance.

FBI-wanted Vikash Yadav seeks court exemption, cites grave security threat to his life

NEW DELHI, 17 NOVEMBER

Vikash Yadav, accused of attempting to murder Khalistani terrorist Gurpatwant Singh Pannun (*photo*) in the United States, has filed an application before a Delhi court requesting exemption from attending his case hearing.

Yadav claims that his personal details have been made public, putting his life at risk. He has asked the court to grant him relief from being present for the hearing due to the ongoing security threat.

The plea stated that false and baseless allegations have been made against the applicant (Vikas Yadav) and that his personal details--such as his address, background, and photographs--have been widely circulated globally, thereby exposing him to a serious threat to his life from malicious elements.

The plea further stated



that the applicant is being relentlessly monitored by hostile elements, who are attempting to track him at all possible locations, leaving him with no option but to remain confined for his safe-

It was also argued that the threat to the applicant's life is immediate, grave, and imminent and that his physical presence in court could provide an opportunity for these elements to harm him.

Given these circumstances, the plea emphasized that even appearing via video conference would be highly unsafe, as the applicant's location could potentially be traced using electronic technology, thereby reinforcing the request for exemption. Noting the submissions, the Delhi court granted the applicant exemption from attending the hearing on Saturday and directed him to appear on 3 February.

Engineers in MP suspended for disrespect to Scindia's statue

A video of the statue being shifted with the help of an earthmoving machine with a noose tied around the structure's neck surfaced on social media, and Madhva Pradesh Chief Minister Dr. Mohan Yadav issued strict directives on Saturday to take stringent

action against those responsible.

MP BJP Chief V D Sharma

and others had also expressed strong objection to the removal of the bust of Madhavrao Scindia, father of union telecom minister Jyotiraditya Scindia who had joined the ruling BJP after quitting from the Congress in 2020. Pursuing Justice

ndia's decision to seek the extradition of alleged Khalistani separatist Arshdeep Singh Gill, also known as Arsh ■Dalla, from Canada represents a significant step in its efforts to combat transnational terrorism and organised crime. Accused of masterminding numerous criminal and terrorist activities, Dalla's arrest in Canada presents both an opportunity and a challenge for India as it seeks justice for over 50 alleged crimes ranging from murder to terror financing. The extradition process is rarely straightforward, particularly when geopolitics and legal complexities intersect. India has faced hurdles in securing the extradition of individuals involved in criminal activities abroad, especially from countries like Canada, where diplomatic ties have been strained over the Khalistan movement. Despite this, Dalla's arrest is an opening for India to push for stronger collaboration on international crime. While the arrest may appear as a breakthrough, securing Dalla's extradition is far from guaranteed.

Extradition treaties require both countries to adhere to rigorous legal procedures, ensuring the suspect's human rights are not compromised and that sufficient evidence of wrongdoing exists. Canada's earlier reluctance to act on India's requests for provisional arrests suggests that the road ahead could be long and fraught with legal manoeuvring. Adding to the challenge are the political undercurrents between the two nations. Canada has often been criticised for its leniency toward elements that advocate Khalistani separatism, a stance that has complicated bilateral ties. Any delay or perceived lack of commitment to extradition could further strain relations, especially as India remains resolute in its stance against secessionist threats.

Despite these challenges, the situation also presents a critical opportunity. By demonstrating transparency and providing robust evidence, India can reinforce its credibility in seeking international legal cooperation. Evidence of Dalla's financial transactions, properties, and links to terror activities has already been shared with Canadian authorities, signaling India's preparedness to meet the standards of international law. If Canada reciprocates by approving the extradition, it could set a precedent for addressing such cases more efficiently in the future. This would not only serve justice but also affirm both nations' commitment to fighting global terrorism and organised crime, transcending political differences. Successfully extraditing Dalla would be a watershed moment for India. It would bring a notorious criminal to justice, dismantling part of the Khalistan Tiger Force's operational framework and deterring others from following similar paths. Additionally, it would strengthen public confidence in India's ability to address international threats that impact domestic security. Arsh Dalla's extradition case is more than a legal pursuit; it is a litmus test of India's resolve to counter terrorism and hold perpetrators accountable, no matter where they operate. Success in this endeavour could redefine how India navigates the complexities of transnational crime and enhance its global standing as a nation committed to justice and security. But, first, there is the little matter of a Canadian Prime Minister to deal with.

Sri Lanka's Reset


ri Lanka has taken a decisive step toward reshaping its political and economic trajectory. The resounding victory of President Anura Kumara Dissanayake's Marxist-leaning National People's Power (NPP) coalition in this week's general election signals a clear rejection of entrenched family dynasties and a hunger for transformative governance. With a two-thirds parliamentary majority, the NPP now faces the dual challenge of meeting the high expectations of the people while steering the country through a precarious economic recovery. This election represents a dramatic shift in Sri Lanka's political culture. Voters from across the island, including minority Tamil regions historically sceptical of centralised power, have rallied behind Mr Dissanayake's message of equity, poverty alleviation, and systemic reform. The election results are not just a mandate for change but a demand for tangible action to address deep-seated issues like corruption, inequality, and a high cost of living.

The sweeping rejection of political dynasties ~ most notably the Rajapaksa and Wickremesinghe families ~ reflects a collective demand for clean governance and accountability. The Rajapaksa family, which dominated Sri Lanka for over a decade with multiple members holding power, saw their party reduced to just three parliamentary seats. Similarly, the coalition backed by former President Ranil Wickremesinghe managed a meagre five seats. This marks a definitive end to their dominance and an embrace of fresh leadership under Mr Dissanayake. The President's promises to cut taxes, boost welfare spending, and support local businesses resonate with citizens still grappling with the fallout of a devastating economic crisis. However, these goals come with significant risks. The country's economic recovery is tethered to an International Monetary Fund (IMF) bailout programme that requires stringent fiscal discipline. Altering the terms of this agreement, as suggested by the new administration, could jeopardise future funding and stall progress toward financial stability. Balancing populist promises with the realities of fiscal management will be the government's defining challenge.

Beyond economic policy, the new government's inexperience in governance poses another hurdle. With many coalition members untested in legislative and executive roles, translating electoral momentum into effective policy execution will require strategic planning and capacity building. The absence of seasoned administrators could slow reforms at a time when swift and decisive action is critical. The decisive rejection of political dynasties underscores a voter desire for systemic reform. While structural changes like abolishing the executive presidency ~ often linked to abuse of power ~ are not immediate priorities, they could further align governance with democratic ideals over time. The road ahead for Sri Lanka is fraught with complexity. Economic recovery, while underway, remains fragile, and political missteps could erode the trust that voters have placed in this new government. Yet, the unprecedented mandate offers a unique opportunity to redefine the nation's path. If Mr Dissanayake and his coalition can deliver on their promises without undermining economic stability, they could set a transformative precedent for South Asia. This election marks more than a shift in leadership ~ it is a moment of reckoning.

Indian concepts

Management curriculums in Indian B-schools are based on Western thoughts, concepts and corporate experiences. Today's students become managers of tomorrow. Thriving on Western management concepts, they come across the problems of 'Indianizing' their knowledge. Ignoring Indian sentiments and culture makes management students confused in actual work situations



ndian civilization is one of the most ancient in the world. It has a unique cultural and spiritual fragrance gifted by great seers, saints, kings, acharyas, and visionaries. Their timeless advice is enshrined in the ancient Indian scriptures. Ancient Indians knew the art and science of management and Indian scriptures are a testimony to this.

Scriptures such as the *Bha*gavad Gita, the Upanishads, and the *Mahabharata* speak volumes about the management excellence of Lord Krishna. King Janaka, Arjuna, Vidura, Bhishma, and the list is only indicative. They were front runners in the management of affairs of their times. Their management styles showed enough poignancy to complement and supplement the present-day management concepts.

Indian scriptures are a treasure house of philosophy and offer vital guidelines on psychology, sociology, political science, social psychology, human behaviour and modern-day management concepts. Resurging focus on spirituality, yoga and meditation in management has made the scriptural knowledge all the more relevant for modern-day managers. Add to it, deteriorating ethics and degrading values in society and the time is ripe for Indian managers to imbibe management concepts from these scriptures.

The Indian style of functioning is different from the Western style, and that makes it imperative for managers to provide 'Indian uniqueness' to management. Admittedly, Western and Japanese management styles are not irrelevant for Indian managers but these can at best serve as nutritional supplements. The 'basic food' should come from Indian scriptures ~ experiences, culled from Indian sentiments and sensitivities rooted in these scriptures.

Present day managers are well versed in technicalities of Western management concepts. They have modern infrastructure to support them but equally important is the 'Knowledge of Self-Management'.

Arjuna was adamant, confused, fragmented, disjuncted and collapsed exactly when he was supposed to perform. Although he was a highly qualified warrior (his area of specialisation) and equipped with the best weapons (infrastructure in a modern context), yet he emotionally involved himself with the consequences of war (attachment with results) which did not speak well of a person of

Scriptures label an emotionally immature person who refuses to perform when the time comes as a Tamasic and indolent personality (Tamasic mentality). Arjuna felt deluded and confused because of poor self-management. A modern manager suffering from the Arjuna Syndrome would behave like Arjuna. He has premier educational degrees and infrastructure at work to support him. Nevertheless, his inner self stays turbulent and does not let him concentrate on work. Further, he works with an eye on rewards (Rajasic work efforts, Tamasic Mentality and attachment to rewards).

Results are neither encouraging for the manager nor fruitful for the organisation. He suffers from poor physical and mental health. His work potential is grossly underutilised. He loses confidence in himself and trust in others. Interpersonal relationships at work suffer. Business imperatives of glob-

alisation and the quickening pace of obsolescence call for a fluid, horizontal de-structured organisation which eastern thinking with its emphasis on internal resources facilitates. The root of Indian management is the Pantheism concept ~ the oneness of God and the Universe. The universe, and all in it, is interconnected. While Western management has taken notice

of the Law of *Karma*, the principle of detachment, yoga and meditation from Indian scriptures, the Indian management fraternity is

Management curriculums in Indian B-schools are based on Western thoughts, concepts and corporate experiences. Today's students become managers of tomorrow. Ignoring Indian sentiments and culture makes management students confused in actual work situations where they have to deal with employees and coming to work with Indianized work habits such as late coming, false commitments, gossiping, wasting time at the workplace, nepotism, and other questionable work ethics.

Management in action is a holistic process. Nowhere in our education, least of all in our management training, is it taught as a holistic process. We are told to be rational and to concentrate on analysis. This fragmentation of the mind into analysis or rationality and emotions creates a gap in our values. In the words of Lord Curzon, 'Though educated in a Western curriculum, you should remain Indians, true to your own beliefs, your own traditions, and your own people.'

The need of the hour is to develop a 'India-centric management style'. For this to happen, scriptures need to be explored for Indianized management wisdom.

To justify the relevance of Indian management, Swami Someswarananda, then President of Vivekananda Centre for Indian Management, Indore, along with his team conducted experiments in different public and private sector companies. Through their studies, team could convince that a new approach is needed in industries and organisations to come out with desirable results.

Studies and experiments were conducted with company workers both in public and private sector undertakings. And in places like Pune, Trivandrum, Delhi, Baroda and Chennai the responses were very encouraging.

> It would be prudent to share here some of their findings. It was found that at the workers' level there was lack of self-confidence and self-respect. There was a dearth of autonomy. There were not many contributions from unions. In the public sector, to give importance to concern for workers, customer-centric issues were neglected. While the

powerful union members created stubbornness and arrogance, they could not inculcate self-respect. Equally important to point out is that autonomy was never practised as it is the leaders, not workers, who had a voice in management.

The Vedanta gospel of "Aham Brahmasmi" (I am full of immense potential) played a pivotal role in their studies and experiments. Workers told the team they thought of themselves as ordinary human beings ~ a smelter, a fitter, a driver, a crane operator etc. It was equally disheartening to note that their supervisors and bosses did not want them to use their brain or heart.

When they were made to realise that each and every one of them had infinite potential, it worked miracles. The purpose was to develop in them self-respect. It is indeed unfortunate that in the present system an extraordinary human being is made ordinary.

An area of management known as Job enrichment is a debatable concept. Can I always get a job of my liking? Shall I always depend on external stimuli to get myself motivated from time to time? While Transactional Analysis has its own justifications do I always require positive strokes? If I have to depend on positive strokes, it will make me psychologically dependent. This is where Vedanta comes in and talks about "mind enrichment". The million-dollar question is "can I make any job, whatever I do, interesting? And that is *karma yoga*.

Another area that draws attention is the modern-day corporate training programme. Majority of the training initiatives revolve around preparing a performanceoriented employee and manager.

The issue is that in all these Management Development Programmes the participants are considered as Managers and Executives only. The facilitator rarely understands that the participant is also a parent, a friend, a relative and above all a citizen.

If a training programme is to be unified, systematic, comprehensive and integrated, then there is a need for all these aspects to be integrated. Else it will remain one sided. From the teachings of Vedanta we learn about the concept of 'advaita' that asks us to see the person in totality.

Emotional Intelligence of late has gained popularity. The idea is to give importance not only to the intellect but also to the emotions, values, beliefs and actions. The roots can be traced through Vedanta that suggests the path of *jnana, bhakti* and *karma*. To be successful one needs to coordinate the intellect (*jnana*), emotions (bhakti) and action (karma). Thus training programmes must involve participants in discussions (this helps them to grow intellectually and be creative). The next step is to adopt techniques of meditation to remove mental blocks. Finally, the action takes place. Thus, when all these three are integrated ~ *jnana, bhakti* and *karma* ~ the learning generates impactful results.

One burning issue is job hopping. Employers complain that employees are not committed to their organisations. This is because money is the sole criteria and a job is considered as a means to earn money. Unless a philosophy does not guide people, the trend will continue. Vedanta has an answer to this. Its teachings state that work is a means to grow. In *Karma yoga*, Lord Krishna preached that unless there is a deeper meaning to work, efforts are in vain.

Vivekananda also chronicles the same through his lectures and discourses. Indian management thus suggests an alternative to Western concepts. According to the Indian ethos, effective supervision is to supervise the growth of people. More autonomy and creative opportunities will not only make them more productive but motivated and committed.

Insights gained through concepts of Indian management go to the roots of holistic development of the tremendous human potential that lies untapped. They give us intellectual conviction that the ultimate aim of work is perfection and autonomy, and not merely monetary benefits and profits. If we can inculcate Indian values and ethos in our executives, managers and corporate captains, unselfishness will become the path to achieve the goal.



Dangerous ties

he main opposition Democratic Party of Korea held a rally in Seoul on Saturday, substantially calling for President Yoon Suk Yeol to step down. The party was going to hold a rally in Daejeon after the first one near Seoul Station on Nov. 2, calling for a special counsel probe of first lady Kim Keon Hee's alleged illegal intervention in state affairs. It changed locations by holding its rally near a separate rally by civic groups including the Korean Confederation of Trade Unions, which has over 1.2 million workers as members.

"The Headquarters of the Movement for the Resignation of President Yoon Suk Yeol," comprising 43 groups including the KCTU, held their first rally to launch the movement and also to commemorate Jeon Tae-il, the sewing worker and labor activist who died protesting inhumane working conditions in Korea, near the gate of Deoksugung on Saturday afternoon.

The party, alongside four other opposition parties, rallied near Sungnyemun, not far from the palace, in the evening. The Democratic Party mentioned the impeachment of Yoon indirectly, while the other parties did so directly. The party argues that its protest to demand a special counsel probe is different from one by civic groups to demand Yoon's resignation or impeachment, but that assertion seems close to wordplay. The Democratic Party plans to hold its third rally on Nov. 16, possibly near the site of a rally by the movement headquarters around the same time. It is likely that their rallies will eventually

combine. On Nov. 6, a court sentenced a former senior KCTU staff member who headed the organizing and industrial action to 15 years in prison on charges of spying for North Korea, and two other former high-ranking officials of its affiliated unions to seven and five years behind bars, respectively, on the same charges. Organizing and industrial action are key KCTU activities.

The court ruled that they had contacted North Korean spies abroad, received directions from them, organized anti-government struggles and reported to Pyongyang. They received directions on 89 occasions and even signed an assurance of loyalty to North Korea.

The KCTU made no apology, however, before rallying for Yoon's resignation. Some claim the organization, one of the country's two major umbrella unions, could be a pro-North Korean group. It

must prove that it acts for workers' rights. Its current leader is a former member of the Gyeonggi Dongbu (Eastern Gyeonggi) Union, a network of progressive activists belonging to the National Liberation faction that emerged from the 1980s student and democratization movement. National Liberation argues for cooperation with North Korea moving towards unification, through anti-US imperialism including the withdrawal of

US forces from South Korea. Lee Suk-ki, a former lawmaker of the Unified Progressive Party, was a central figure of the Gyeonggi Dongbu Union, too. The Constitutional Court disbanded the Unified Progressive Party in December 2014 for inciting sedition and violating the National Security Act. Lee lost his seat as a lawmaker and was sentenced to

Former members and supporters of the disbanded party reportedly formed the Progressive Party in 2017, which won three National Assembly seats in the last general election on April 10. Two of its candidates became lawmakers thanks to the Democratic Party's nomination of them as proportional representation candidates of its satellite party.

One candidate was elected in a local constituency also thanks to the Democratic Party unifying its candidacy with the Progressive Party in the electorate. Later, the satellite party expelled the two lawmakers back to their original Progressive Party. Some on the right have claimed that the Democratic Party was used by a "pro-North Korean political

force" trying to enter the Assembly. The rallies on Saturday took place six days ahead of the court's first-trial ruling on Lee's charges of allegedly violating election law. He and his party may want the rallies to put political pressure on the court.

Can AI help decolonise knowledge production?


rtificial Intelligence (AI) is emerging as a critical technology that has applications Lin myriad domains like microeconomics, biotech, and Internet-of-things (IoT). It is not just a buzzword but one of the huge breakthroughs of the modern era that aims to alter the way we interact with everyday objects.

This generative AI accessibility means that, for the first time ever, anyone in an organisation can use advanced technology to innovate their workflows and this unlocks entirely new possibilities at an individual or organisational level. Every aspect of intelligence and every structure of the learning process can be described very precisely in a way that teaches a machine how to simulate it, at which point Artificial Intelligence (AI) was established as a new field of study and research and generated extraordinary expectations.

AI is the ability of a machine to imitate human functions such as reasoning, learning, planning and creativity. AI systems are able to adapt their behaviour to some extent by analysing the effects of previous actions and operating autonomously. Some AI technologies have been around for over 50 years, but increased computing power, the availability of enormous amounts of data, and new algorithms have led to major advances in AI in recent years.

Artificial intelligence is considered a central element of the digital transformation of society. But, artificial intelligence also represents an opportunity for our societies to become more socially and environmentally fair and sustainable through regulatory systems of public scrutiny and control. The key question raised here is: "will AI be of help to create an equal society?"

Higher education and knowledge production globally continue to be highly unequal, with the Euro-American epistemic hegemony and domination rooted in colonialism and white supremacy being presented as the real



same time, 'other' worldviews, largely from the Global South, continue to be side-lined and presented as something of lesser value and relevance.

Researchers at the University of Copenhagen have found that Chat-GPT, currently one of the most popular generative AI platforms, "is heavily biased when it comes to cultural values". It promotes American norms and values and often presents them as 'universal' when asked to provide responses about concepts

and other countries and cultures. This way, the researchers argue, ChatGPT acts as a "cultural imperialist tool that the United States, through its companies, uses to promote its values". If that be so, AI will only perpetuate the division, not pre-

As the journalist and New York University academic Professor Meredith Broussard points out, 'better data' is not the solution as long as the world remains riddled with systemic racism, sexism, ableism, patriarchy and other bigotries and social ills. Without systemic and structural societal change in the real world, would cleaning up the data that is fed into the AI platforms solve the problems?

A recent UNESCO paper on AI and education highlights that "education is – and should remain – a deeply human act, rooted in social interaction". Every other aspect of intelligence and every structure of the learning process can be described very precisely in a way that teaches a machine how to simulate it.

The question that arises is what makes knowledge production different? We can forget about human intelligence and critical thinking if we rely on AI to give us summaries of texts and materials. The purpose of education cannot be learning to write prompts and then reading summaries given to us by chatbots.

Thanks to this work, the greatest city in the world, with no hygienic advantage of site, is also one of the healthiest if not the healthiest of all. A review of its vital statistics shows that the improvement has been progressive, and the effect is illustrated graphically by the statement that during the last eighty years the average lifetime of Londoners has been extended by 19.2 years for men and by 20.8 years for women. Calcutta cannot expect to boast of such results as those in London; nevertheless this city has its lessons to teach as well learn in sanitary progress. It has still less hygienic advantage of site than the British metropolis; yet it is one of the healthiest cities in India; and for this thanks must be given to its health department and sanitary administration.

COLOMBO TEA SALES STRONG AND ACTIVE DEMAND

NURSE CAVELL'S BETRAYER SENTENCED

When people choose wrong

'n 1947 the British were finally driven out of India after 200 years of rapacious colonial rule: steady ■ pilferage of raw materials, wrecking of local industry, neglect of education and healthcare, indifference to economic growth. I wasn't yet ten but I was astounded to hear some people say, "We were better off under the British rule." Some Indians, whatever the havoc they saw around them, craved for the little island of security they imagined themselves to be in under the majestic rule of the British empire.

Forty years later, I saw Ferdinand and Imelda Marcos flee from the Philippines after 20 years of misrule – 14 years as dictator – with rampant corruption, torture and extrajudicial killing, when people finally rose in fury. Then I was aghast to hear some Filipinos say, "We were better off under Marcos." These were the poor and middle-class people the Marcoses had most robbed and oppressed, but they still imagined themselves somehow secured under their thieving autocracy. They admired Ferdinand's gilded Malacañang Palace and adored, possibly envied, Imelda's ornate 6,000 pairs of shoes.

Less dramatically but more poignantly and recently, I hear some Peruanos say, "Peru was better off under Fujimori." Fujimori ruled Peru only for a decade and in that time he stopped the runaway inflation and stabilized the economy, attracting international business and drawing IMF support. Also, he crushed the Sendero Luminoso and Tupac Amanu terrorist movements which had killed 12,000 people, including hundreds of

offiicials, and ruled over a quarter of the country's territory. But these achievements came at a terrible price. Fujimori abrogated the judicial system, assumed autocratic powers flouting the constitution, used corruption as a common political device and killed hundreds with death squads. Some people remember only the relative security, economic stability and a more orderly life.

In Nepal, royalty has been abolished and I hear some Nepalis say, "We were better under the king." Some politicians even espouse a return of royal rule. Let alone the huge waste and pathetic misrule of several kings, people seem to forget the utter recidivism of an undemocratic heritage system which brings no relief to ordinary people.

I mention these countries where I was and felt a personal sense of outrage: how could people be so insensible as to express a preference for the clearly unscrupulous and evil? I felt deeply upset that, on some petty consideration, some people should be partial to wrongdoing. How could they make such an abhorrent choice?

They could and they would. People, in different countries and at different times, make such hateful choices. They choose, on petty, trivial, most mundane grounds, a regime of hate, acrimony and violence, thinking it will give them some little advantage. It does not matter if a colleague or two, a few neighbors, some marginal community, some odd religious group or some fringe political activists are detained, arrested or, God forbid, even killed. That is a price to be paid for the progress of the country. One is never sure when a few dozen activists, or even a few hundred, are shot down, if they were real miscreants or the authorities overacted a bit to prevent greater mischief, and surely the authorities, trying hard to maintain order, must be given

some leeway. This is the central meaning when you hear it said, during an election time, that what really matters at the end is 'the economy, stupid.' The thing that vot-


ers most care about is how well their bread is buttered. To be sure, humans live by bread, but one would have thought that by now many of us are well-off enough to care about a few other things. We might care about our political system, given that it determines the quality of how we live, relate to one another, choose who take big decisions for us; we might care about our work, our earnings, our holidays, our security; we might care for our society, how we educate, entertain, socialize, build our mutual relations, organize for purposes we value. How come then, that when it comes to the crunch, the most that we can argue about is the economy? That is what matters most and decides an election. In other words, what matters most is

our preoccupation with our bread; everything else – even if they eventually determine not just our bread but our

very life – comes much later. It is not just the poor countries that are falling prey to populist nationalism and jingoism. Germany, which has suffered grievously in the past, is seeing the upsurge of virulent Alternative to Democracy gaining 13 per cent support; Austria, with a similar history has the militant Freedom Party with 26 per cent support. Switzerland, Denmark and Belgium, always the most advanced democratic countries, all have toxic nationalistic groups that command more than 20 per cent of votes. These resurgent groups are harping typically on identity, power and abhorrence of alien groups.

Countries don't live by bread alone, nor by identity politics. But that is the false gospel that is being increasingly drummed into people. In the election politics of the US, the dominant themes have been the economy and immigration, and an ex-President exploited the themes with hyperbole and mendacity. Truth and clarity are the principal victims. No surprise, some people's choice is what is the very worst for them. As Justice Learned Hand said in a famous speech, in the last days of WWII, when liberty dies in the hearts of men, no law or constitution can save it.

Kerala Governor defends Centre's stance on Wayanad landslide relief funding

Kerala Governor Arif Mohammed Khan on Sunday defended the central government's position on the delay in releasing relief for the victims of the Wayanad landslides, stating that assistance would be provided once the state submits proper accounts to the Centre.

Speaking to media persons in Kochi, Governor Khan said that the state's argument regarding a lack of funds was invalid and emphasised that financial assistance would be provided if the state submits proper accounts to the Centre. He slammed the state government for its unwillingness to utilise the funds it currently holds.

The Governor expressed confidence in Prime Minister Narendra Modi's assurances on Wayanad's rehabilitation, stating that he trusted the Prime Minister's commitment more than anyone else. The Governor's comments come

amid criticism from the state government over the Centre's stance on the relief fund. The ruling CPI-M-led LDF and the Congress-led UDF opposition in Kerala have called for a hartal in Wayanad district on Tuesday to protest the Centre's refusal to declare the Wayanad landslides a national disaster and the denial of financial assistance to those affected. Earlier this week, the central government informed Kerala that there is no provision to declare any calamity a 'national disaster'. This clarification came from Union Minister of State for Home Affairs Nityanand Rai in response to a request from

seeking the national disaster declaration.

In his reply, the Union Minister explained that the current SDRF and NDRF norms do not allow for a calamity to be declared a national disaster. Rai emphasised that the primary responsibility for managing disaster-related matters lies with the state government. He also pointed out that flash floods are already listed as one of the 12 notified disasters under the State Disaster Response Fund (SDRF) guidelines, which place the onus of financial

support on the state. The Union government, he noted, has already allocated Rs 388 crore to Kerala for SDRF operations in the current financial year. Of this, Rs 291 crore has been provided by the Union government, with the first instalment of Rs 145 crore disbursed on August 31. Additionally, the state's SDRF fund will have a balance of Rs 394 crore by April 1, 2024, providing Kerala with sufficient resources to manage the ongoing disaster response.

Holy Devmali set to emerge as a hot tourism destination in Rajasthan

Devmali – an 1100-year-old village in Rajasthan's newly carved out Beawar district that preserves spiritual faith, life chores, culture, and customs in the absolute medieval rural ambiance - will soon emerge as a hot tourist destination.

The Rajasthan government has resolved to evolve this winner of the Best Tourism Village of India Award 2024 village as a popular destination for domestic and international tourists, Deputy Chief Diya Kumari said on Saturday.

The dusty but unique village in the Masuda subdivision, about 60 km from here, follows its centuries-old lifestyle, customs, and even commitments made to the village deity Bhagwan Devnarain, the folk-lore divine figure (& an incarnation of lord Vishnu).

According to folklore, Lord Devnarain visited this place



nestled in Aravalli hill spanning around 3000 bigha, about 1100 years ago, in the Vikram Samvat 999, and sought a place to reside in.

Locals there faithfully dedicated the entire 3000 bighas of land to the divine and made a cow-dung-made home with a thatched roof. Since then, they have been residing in their homes on lord's land without their ownership.

Happy with the service and faithful gestures of locals,

Bhagwan Devnarain asked the villagers to seek a boon for themselves but the villagers politely declined. The Lord had then blessed all of them with ever-lasting peace and tranquility and also advised them to reside in nature-

thatched roofs. In view of the (folk) deity's word and also the type of thatched home they provided to their lord, they never constructed pucca houses using concrete, cement, lime, iron/

friendly mud homes with

metal rods, and frames. Even today they reside in mud made thatched-roofed homes.

There is no concrete structure in the entire village except the state government offices and the temple of lord Devnarain on the hilltop. Moreover, no one in the

village eats non-vegetarian food or consumes alcohol. Also, there is a complete ban on the burning of kerosene and neem wood. Villagers also conveyed

that none of the village homes puts locks on their doors. There has not been any case of theft or robbery for the last many decades. All these characteristics of the Devmali and its

denizens that give a clear reflection on spiritual faith and firm resolve for the environment, cultural discipline, and social tranquility have obviously attracted the Centre which has launched the best tourism village competition since 2023 to promote tourism to the Soul of India (India's

villages) and this Devmali has been declared winner in the Community based Tourism category for the current year.

Devmali is among 36 villages of the country that have been chosen as winners in eight categories from amongst 991 entries received this year for the competition from 30 states.

The award was announced in about a couple of months by the government in New Delhi and will be presented to the winners on November 27 later this month.

Consequently, the Rajasthan government has also acknowledged the historic spiritual and environmental significance of Devmali and resolved to make efforts to protect its legacy and evolve it appropriately as a hot tourist destination by strengthening infrastructure facilities like connectivity, accessibility, and spiritual and environmental characteristics.

Indian govt launches major operation to track down 'Lord of Drugs' Haji Salim

In a significant move, the Narcotics Control Bureau (NCB) of India launched a massive operation under 'Operation Sagar Manthan' to dismantle the large-scale drug cartel activities of wanted smuggler Haji Salim, also

known as "Lord of Drugs." According to officials, the operation was launched on the directions of Union Home Minister Amit Shah to track down Haji Salim aka Haji Baloch and his trafficking syndicate spread worldwide. As part of this operation, authorities have seized nearly 4,000 kilograms of illicit drugs linked directly to Salim's cartel, with several Pakistani nationals arrested in connection with the haul.

The criminal network of Haji Salim is suspected to be responsible for a massive drug pipeline spanning mul-



tiple countries, from Pakistan to India and beyond, officials said.

Speaking to ANI, Deputy Director General of Narcotics Control Bureau, Gyaneshwar Singh, said, "Haji Salim is one of the biggest drug traffickers in the world, who supplies large shipments of heroin, methamphetamine, and other illegal narcotics through a complex network that spans across Asia, Africa, and the West. He has a very big network. He has been on our radar for a long time but in this case, I would not like to

comment on Haji Salim's

name or anyone else's name because the investigation is still at a very initial stage."

Salim is allegedly the leader of a massive smuggling syndicate responsible for trafficking large quantities of narcotics across several countries, including India, Mauritius, Sri Lanka, and the Maldives. Multiple international law enforcement agencies including those in the United States, Malaysia, Iran, Sri Lanka, Mauritius, New Zealand, and Afghanistan are on the lookout for him.

"He is one of the most wanted drug kingpins in the Indian Ocean region. His operations are vast, and the scale of his trafficking syndicate is unparalleled," he said.

"Salim's network is linked to narco-terrorism activities that destabilize the region. His drugs are not only a menace to society but also fund terror operations across borders," added Singh.

'n a major setback to the Aam Aadmi Party (AAP) ahead of the upcoming Assembly elections in the national capital, senior party leader and minister Kailash Gahlot resigned from the cabinet as well as the party on Sunday.

Gahlot, in his resignation letter to AAP convenor Arvind Kejriwal, mentioned the party's political ambitions taking over from the commitment towards the people of Delhi that according to him, left many promises unfulfilled, as the reason for his move.

In the resignation letter, he also mentioned the sorry state of the river Yamuna. He said the AAP had promised to transform it into a clean river, but never got around to doing it. "Now, the Yamuna



River is perhaps even more polluted than ever before," the letter read.

Gahlot also cited controversies like the 'Sheeshmahal' that he said created doubts in people's minds over AAP's common man image as the reasons for his resignation.

The resignation letter shared by the politician shared on social media platform X a major portion of its time fighting with the Centre."

"I had started my political journey with the commitment to serve the people of Delhi and I want to continue doing that. Which is why, I find myself left with no option but to step away from AAP and hence I resign from primary membership of Aam Aadmi Party," he wrote.

Other than his resignation letter to Kejriwal, Gahlot also wrote to CM Atishi, stating, "I hereby tender my resignation from the Council of Ministers GNTCD.'

Israeli overnight airstrikes kills twelve in Gaza Strip

Israeli police arrested 3 suspects after flares were fired at PM Netanyahu's private residence

sraeli strikes in the Gaza Strip overnight killed 12 people, Palestinian med-**L**ical officials said Sunday. Israeli police meanwhile arrested three suspects after flares were fired at Prime Minister Benjamin Netanyahu's private residence in the coastal city of Cae-

sarea. In Lebanon, Israeli warplanes pounded the southern suburbs of Beirut after the military warned people to evacuate from at least seven buildings. The Hezbollah militant group has a strong presence in the area, known as the Dahiyeh, and the strikes came as Lebanese officials are considering a United States-brokered cease-fire proposal.

Netanyahu and his family were not at the residence when two flares were fired at it overnight, and there were no injuries, authorities said. A drone launched by Hezbollah struck the residence last month, also when Netanyahu and his family were away.

The police did not provide details about the suspects behind the flares, but officials pointed to domestic political critics of Netanyahu. Israel's largely ceremonial president, Isaac Herzog, condemned the incident and warned against "an escalation of the violence in the public sphere."

Netanyahu has faced months of mass protests over his handling of the hostage crisis unleashed by Hamas' Oct. 7, 2023 attack into Israel, which ignited the ongoing war in Gaza.

Critics blame Netanyahu

for the security and intelligence failures that allowed the attack to happen and for not reaching a deal with Hamas to release scores of hostages still held inside Gaza. Israelis rallied again in Tel Aviv on Saturday night to demand a cease-fire

deal to return them. Justice Minister Yariv Levin meanwhile seized on the flare attack to call for a revival of his plans to overhaul the Israeli judiciary, which had sparked months of mass protests before the war.

"The time has come to provide full support for the restoration of the justice system and the law enforcement systems, and to put an end to anarchy, rampage,

refusal, and attempts to harm the Prime Minister," he said in a statement.

Supporters said the judiciary changes aim to strengthen democracy by circumscribing the authority of unelected judges and turning over more powers to elected officials. Opponents see the overhaul as a power grab by Netanyahu, who is on trial for corruption charges, and an assault on a key watch-

Opposition Leader Yair Lapid said in a post on X that he "strongly condemns" the firing of flares at Netanyahu's home while blasting Levin's

"Levin should go home with rest of this irresponsible government," Lapid wrote. "We will not let him turn Israel into an undemocratic state."

Trump names fossil fuel executive Chris Wright as energy secretary

President-elect Donald Trump has selected Chris Wright, a campaign donor and fossil fuel executive, to serve as energy secretary in his upcoming, second administration.

CEO of Denver-based Liberty Energy, Wright is a vocal advocate of oil and gas development, including fracking, a key pillar of Trump's quest to achieve U.S. "energy dominance" in the global market. Wright has been one of

the industry's loudest voices against efforts to fight climate change, and could give fossil fuels a boost, including quick action to end a year-long pause on natural gas export approvals by the Biden administration.

Frequently criticizing what he calls a "top-down' approach to climate by liberal and left-wing groups, Wright has argued that the climate



movement around the world is "collapsing under its own weight." He has never served in government, but has written that more fossil fuel production is needed around the globe to lift people out of poverty.

Consideration of Wright to head the administration's energy department won support from influential conservatives, including oil and gas tycoon Harold Hamm.

Hamm, executive chairman of Oklahoma-based Continental Resources, a major shale oil company, is a longtime Trump sup-

porter and adviser who played a key role on energy issues in Trump's first term. Hamm helped organize an event at Trump's Mar-a-Lago resort in April where Trump reportedly asked industry leaders and lobbyists to donate \$1 billion to Trump's campaign, with the expectation that Trump would curtail environmental regulations if reelected.

Mike Sommers, president of the American Petroleum Institute, the oil and gas industry's top lobbying group, said Wright's experience in the energy sector "gives him an important perspective that will inform his leadership" of the Energy

Department.

"We look forward to working with him once confirmed to bolster American geopolitical strength by lifting DOE's pause on LNG export permits and ensuring the open access of American energy for our allies around the world," Sommers said.

Russia launches one of the fiercest missile and drone attacks at Ukraine's intrastructure

Russia on Sunday launched

a massive drone and missile attack on Ukraine, described by officials as the largest over the past months, targeting energy infrastructure and killing civilians.

The attack came as fears are mounting about Moscow's intentions to devastate Ukraine's power generation capacity ahead of the cold winter.

President Volodymyr Zelenskyy said that Russia had launched a total of 120 missiles and 90 drones in a large-scale attack across Ukraine. Various types of drones were deployed, he said, including Iranian-made Shaheds as well as cruise, ballistic and aircraft-launched ballistic missiles.

Ukrainian defenses shot down 140 air targets, Zelenskyy said in a statement on the Telegram messaging

"The enemy's target was our energy infrastructure throughout Ukraine. Unfortunately, there is damage to objects from hits and falling debris. In Mykolaiv, as a result of a drone attack, two people were killed and six others were injured, including two children," Zelenskyy said.

Two others were killed in the Odesa region, where the attack damaged energy infrastructure and disrupted power and water supplies, said local Gov. Oleh Kiper.

Russia grinds deeper into Ukraine after 1,000 days of gruelling war

When Russian tanks rolled into Ukraine in February 2022, the conventional wisdom was that the capital, Kyiv, would soon fall and the rest of the country wouldn't last long against a much larger enemy.

Instead, it was that nar-

rative that quickly collapsed. The Ukrainian army proved it could slow the advance of Russia's forces and, if not drive them out completely, then – with enough support from the West-at least forestall defeat.

But nearly three years later, the outlook is again grim. Russia is expending huge amounts of weaponry



and human life to make smallbut-steady territorial gains to the nearly one-fifth of Ukraine it already controls. Ukraine, meanwhile, is struggling to minimize losses, maintain morale and convince allies that, with more military aid, it can turn the tide.

As this brutal war of attrition grinds toward its 1,000th day, neither side seems eager to negotiate. President-elect Donald Trump has said he

could quickly end the war, though it is unclear how or in whose favor he might tip the scales.

This backdrop appears to be driving Russia's strategy in eastern Ukraine, according to Phillips O'Brien, a professor of strategic studies at the University of St. Andrews, Scotland. Trump could try to force an end to the war by halting the supply of weapons to Ukraine, he said.

"If Trump cuts aid to Ukraine and a cease-fire leads to a frozen conflict, Russia wants to secure as much territory as it can now," O'Brien

After the war's first year, Russia and Ukraine essentially came to a standstill on the frontlines as the war rolled

into its third year. Then in February 2024, the town of Avdiivka fell to the Russians. With Ukraine low on ammunition, relentless Russian airstrikes created a major breach in Ukraine's defenses in the Donetsk region. After fending off Moscow's offensive in the eastern Kharkiv region, Ukraine launched a surprise incursion into Russia's Kursk region giving Kyiv leverage in potential cease-fire negotiations as it still holds onto

For Ukraine, the key to any cease-fire would be guarantees from the West that it won't allow Russia to reinvade in the future. Otherwise, O'Brien said, "a ceasefire is a recipe for constant instability in Europe."

Counterintelligence expert Kash Patel, close to Trump, under consideration to head FBI

Counterintelligence expert Kash Patel, who is close to US President-Elect Donald Trump, is reportedly under consideration for appointment to head the Federal Bureau of Investigation (FBI) after having been passed over for the leadership of the Central Intelligence Agency (CIA).

If he gets the job, he will likely be the highest-ranking Indian American in the administration even though it is not a Cabinet post and no names from the community have emerged as of Saturday for the remaining Cabinet-level jobs.



Media reports say that several Trump loyalists are pushing the appointment of Patel, who has called for "drastic measures" to reshape the FBI.

Patel had close ties with Trump who considered him one of his policy specialists, and they both share the view that Trump had won the 2020 election but was unlawfully deprived of the presidency and that there should be ret-

ribution for those they consider responsible.

During his campaign, Trump endorsed Patel's proposals to reshape government in his book, 'Government of Gangsters', a title that reflects both their views that a cabal of "Deep State" operatives was running the country behind the scenes.

Patel had served as the Deputy Assistant to the President and Senior Director for Counterterrorism (CT) at the National Security Council (NSC), before becoming the chief of staff to the then Acting Secretary of Defence Christopher Miller, his final job in the first Trump administra-

The 'superyear' of elections has been super bad for incumbents as voters punish them in droves

Whether on the left or the right, regardless of how long they've been in power, sitting governments around the world have been drubbed this year by disgruntled voters in what has been called the "super year" for elections.

Donald Trump's victory in the U.S. presidential election was just the latest in a long line of losses for incumbent parties in 2024, with people in some 70 countries accounting for about half the world's population going to the polls.

Issues driving voter discontent have varied widely, though there has been almost universal malaise since the COVID-19 pandemic as people and businesses struggle to get back on their feet while facing stubbornly high prices, cash-strapped governments and a surge in migration.

"There's an overall sense of frustration with political elites, viewing them as out of touch, that cuts across ideological lines," said Richard Wike, director of global attitudes research at the Pew Research Center.

He noted that a Pew poll of 24 countries found that the appeal of democracy itself was slipping as voters reported increasing economic distress and a sense that no political faction truly represents them.

"Lots of factors are driving this," Wike said, "but certainly feelings about the economy and inflation are a big fac-

Since the pandemic hit in 2020, incumbents have been removed from office in 40 of 54 elections in Western democracies, said Steven Levitsky, a political scientist at Harvard University, revealing "a huge incumbent disadvantage."

In Britain, the right-ofcenter Conservatives suffered their worst result since 1832 in July's election, which returned the center-left Labour Party to power after

But just across the English Channel, the far right rocked the governing parties of France and Germany, the European Union's biggest and most powerful members,



in June elections for the parliament of the 27-nation bloc.

The results pushed French President Emmanuel Macron to call a parliamentary election in hope of stemming a far-right surge at home. The anti-immigration National Rally party won the first round, but alliances and tactical voting knocked it down to third place in the second round, producing a fragile government atop a

divided legislature. In Asia, a group of South Korean liberal opposition parties, led by the Democratic Party, defeated the ruling conservative People Power Party in April's parliamentary

elections.

meanwhile, had been widely expected to easily sweep to a third straight term in June but instead voters turned away from his Hindu nationalist Bharatiya Janata Party in droves, costing it its majority in parliament, though it was able to remain in power with the help of allies. Likewise, Japanese voters

in October punished the Liberal Democratic Party, which has governed the country nearly without interruption since 1955.

Japanese Prime Minister Shigeru Ishiba will stay in power, but the greater-thanexpected loss ended the LDP's one-sided rule, giving the opposition a chance to

achieve policy changes long

opposed by the conserva-

"If you were to ask me to explain Japan in a vacuum, that's not too difficult," said Paul Nadeau, an adjunct assistant professor at Temple University's Japan campus

in Tokyo. "Voters were punishing an incumbent party for a corruption scandal, and this gave them a chance to express a lot more frustra-

tions that they already had." Globally, however, it's

harder to draw conclusions. "This is pretty consistent across different situations, different countries, different elections—incumbents are getting a crack on the shins," he said. "And I don't have any good big picture expla-

nations for why that is.'





fter two days of meetings in Lima that rarely ventured beyond platitudes in discussing the strategies of the region's major economies, the Asia-Pacific Economic Cooperation forum wrapped up on Saturday with a spirit of detente that many fear the summit may not see again for four years.

The 21 leaders from economies bordering the Pacific, including President Joe Biden and Chinese President Xi Jinping, had descended on Peru for the annual gathering at a time when America's President-elect Donald Trump has vowed to withdraw the United States from its leadership of a global free trade agenda.

Few could help noting that Biden's late entrance on Saturday for the traditional APEC family photo lent itself to political metaphor, as the rest of the leaders prepared



to pose onstage before looking around to find Biden miss-

They tittered for five awkward minutes before a seemingly dazed Biden emerged and took his place in the far back corner, standing between Thailand's 38-year-old Prime Minister Paetongtarn Shinawatra and Vietnam President Luong Cuong. Biden briefly reached for Shinawatra's hand to steady himself.

Chinese President Xi scored the best spot in the

house, front and center beside the host, Peruvian President

Dina Boluarte. Xi had draped himself in the banner of globalization this week, inaugurating a massive \$1.3 billion megaport in Peru that promises to become South America's biggest shipping hub and using his speeches to reject protectionism.

In Xi's summit address, delivered by one of his ministers, the Chinese leader urged APEC members to "tear

down the walls impeding the flow of trade," and criticized tariffs—which Trump threatens to levy on Chinese imports — as "going back in histo-

For the annual photo-op, leaders all wore bark-hued wool scarves from Peru in the APEC tradition of posing in some garb representative of the host country. While conference organizers typically position leaders in alphabetical order for the family photo, arrangements have varied over the years.

Reporters shouted questions as Biden left the stage Friday, asking how he felt about this being his last APEC summit — and one of his last major global events as president.

Biden had hoped that APEC—along with the Group of 20 summit in Rio de Janeiro, where he heads Sunday would have capped his decades-long political career with a flurry of productive diplomacy and swaggering proclamations of America's force on the world stage.

But with his party's stinging defeat in the U.S. election and the future of the U.S.-China rivalry uncertain, there was little he could accomplish in Lima.

Biden sought to cement alliances that could be upended by a Trump administration. He expressed concern to the leaders of South Korea and Japan about what he called "dangerous and destabilizing cooperation" between North Korea and Russia. After nearly four years of

record stability in the Japan-U.S. alliance—a partnership crucial for regional security — Japanese Prime Minister

Shigeru Ishiba is now struggling to arrange a high-stakes meeting with Trump.

He told reporters in Lima on Saturday that his hopedfor meeting with Trump on his way home from next week's G-20 summit in Brazil would not happen—explaining that Trump's team had invoked U.S. legal restrictions to refuse his requests.

Latest typhoon lashes the Philippines displacing massive numbers of people

A powerful typhoon wrecked houses, caused towering tidal surges and forced hundreds of thousands of people to flee to emergency shelters as it cut across the northern Philippines on Sunday in the sixth major storm to hit the country in less than a month.

Typhoon Man-yi slammed into the eastern island province of Catanduanes on Saturday night with sustained winds of up to 195 kilometers (125 miles) per hour and gusts of up to 240 kph (149 mph). The country's weather agency warned of a "potentially catastrophic and lifethreatening situation" in provinces along its path.

There were no immediate reports of casualties from the typhoon, which was forecast to blow northwestward on Sunday across northern Luzon, the archipelago's most populous region. The capital region of metropolitan Manila would likely be spared from



a direct hit but was placed, along with outlying regions, under storm alerts and warned of dangerous coastal storm surges.

"The rain was minimal, but the wind was very strong and had this eerie howling sound," Roberto Monterola, a disaster-mitigation officer in Catanduanes, told The Associated Press by telephone. "Along a main boulevard here, the tidal surges went up to more than 7 meters (23 feet) near the seaside houses. It looked really scary."

The entire province of Catanduanes had no power after the typhoon knocked down trees and electricity posts, and disaster-response

teams were checking how many more houses were damaged in addition to those impacted by previous storms, he said.

"We need tin roofs and other construction materials, aside from food. Villagers tell us here that they still haven't gotten up from the past storm and were pinned down again by this typhoon," Monterola said. Nearly half of the island province's 80,000 people were sheltering in evacuation centers.

Catanduanes officials were so concerned as the typhoon approached that they threatened vulnerable villagers with arrest if they did not follow orders to evacuate to safer grounds. More than 750,000 people took refuge in emergency shelters, including churches and a shopping mall, due to Man-yi and two previous storms mostly in the northern Philippines, Assistant Secretary Cesar Idio of the Official of Civil Defense and other provincial officials said.

Iranian Defence Minister visits Syria to enhance security cooperation



DAMASCUS, 17 NOVEMBER

Iran's Defence Minister Aziz Nasirzadeh arrived in Syria to strengthen defence and security ties between the two countries, according to Syria's Al-Watan online news-

'Everyone knows the important position of the Syrian Arab Republic in Iranforeign policy," ian

Nasirzadeh told reporters upon his arrival, Xinhua news agency reported.

"We came to Damascus based on an invitation from the Syrian Defence Minister, and we will have meetings with political and military officials to discuss several common issues between the two countries, especially in the field of defence and security, aiming to expand cooperation and exchange expertise between the two sides," he was quoted as saying by Al-Watan.

Nasirzadeh praised Syria's experience in combating terrorism and its role in the regional "axis of resistance," an anti-Israel bloc, which also includes Iran, Hezbollah, Hamas, and militant groups in Iraq and Syria, among others.

Senegal votes in election that will decide if president can carry out the reforms he promised

Polls opened in Senegal on Sunday for a parliamentary election that is set to determine if the country's newly elected president can carry out ambitious reforms.

More than 7 million registered voters in the West African country are choosing 165 lawmakers in the national assembly, where the party of President Bassirou Diomaye Faye currently does not hold a majority.

Faye, who was elected in March on an anti-establishment platform, says that has blocked him from executing the reforms he pledged during his campaign, including fighting corruption, reviewing fishing permits for foreign companies and securing a bigger

share from the country's natural resources for the popu-

In September, he dissolved the opposition-led parliament, paving the way for a snap legislative election. His party is facing the Takku Wallu opposition platform led by former President Macky Sall, alongside 39 other registered parties and coalitions.

Polls will close at 6 p.m (1800 GMT). The first provisional results are expected to be known by Monday morning, but the final count will only be published later during the week.

Faye's political party, PASTEF, needs at least 83 seats in order to gain a majority in the assembly. Analysts say it has a high chance of securing that, given its popularity and Faye's margin of victory in



the March presidential elec-

Faye, 44, was elected with 54% in the first round, becoming Africa's youngest elected leader, less than two weeks after he was released from prison. His rise has reflected widespread frustration among Senegal's youth with the country's direction — a common sentiment across Africa, which has the world's youngest population and a number of leaders accused of clinging

Over 60% of Senegalese are under 25 and 90% work in informal jobs. Senegal has been hit by skyrocketing inflation in recent years, making it difficult for them to get by.

to power for decades.

The country is also a major source of irregular migration to Europe, with thousands leaving every year on rickety, artisanal fishing boats in search of economic opportunities.

The campaign for the legislative election was marked by sporadic clashes between supporters of different parties. The headquarters of an opposition party were set on fire in the capital, Dakar, and clashes have erupted between supporters in central Senegal in recent weeks, the interior

ministry said Monday. On Tuesday, Ousmane

Sonko, the country's prime minister who helped catapult Faye to victory, denounced attacks against supporters of PASTEF in Dakar and other

"May each patriot they have attacked and injured be proportionally avenged. We will exercise our legitimate right to respond," he wrote on X, before back-pedalling and asking his supporters to remain peaceful in a speech later that day.

Last month, Sonko's vehicle was attacked with stones as clashes broke out between his supporters and unidentified attackers while he was campaigning in Koungueul, in the center of the country. The leader of an allied party, former minister Malick Gackou, had his arm broken in the incident, according to local media.

Reports of violence against minorities 'completely exaggerated', says Yunus; to seek Hasina's extradition

Bangladesh's interim leader, Chief Adviser Prof Muhammad Yunus said today that reports on violence against religious minorities in the country were "completely exaggerated".

US health officials report first case of new form of mpox in a traveller

Health officials said Saturday they have confirmed the first U.S. case of a new form of mpox that was first seen in eastern Congo.

The person had traveled to eastern Africa and was treated in Northern California upon return, according to the California Department of Public Health. Symptoms are improving and the risk to the public is low.

The individual was isolating at home and health workers are reaching out to close contacts as a precaution, the state health department

Mpox is a rare disease caused by infection with a virus that's in the same family as the one that causes small-



pox. It is endemic in parts of Africa, where people have been infected through bites from rodents or small animals. Milder symptoms can include fever, chills and body aches. In more serious cases, people can develop lesions on the face, hands, chest and genitals.

Earlier this year, scientists reported the emergence of a new form of mpox in Africa that was spread through close contact including through sex. It was widely transmitted in eastern and central Africa.

But in cases that were identified in travelers outside of the continent, spread has been very limited, according to the U.S. Centers for Disease Control and Prevention.

More than 3,100 confirmed cases have been reported just since late September, according to the World Health Organization. The vast majority of them have been in three African countries — Burundi, Uganda, and the Democratic Republic of the Congo.

Since then, cases of travelers with the new mpox form have been reported in Germany, India, Kenya, Sweden, Thailand, Zimbabwe, and the United Kingdom. Health officials earlier this





"Today, the growth of the Indian economy presents a picture of stability and strength," Das said while addressing an event at the launch of the Kochi International Foundation here.

The country's external sector is also strong and the current account deficit (CAD) has remained within manageable limits as it presently stands at 1.1 per cent of GDP. Earlier, in 2010 and 2011, it was in the range of six to

seven per cent, he added. The central bank chief



also pointed out that India has one of the largest foreign exchange reserves in the world at about \$675 billion.

He further stated that the country's inflation was expected to be moderate despite periodic humps.

India's inflation rose to 6.2 per cent in October from 5.5 per cent in September because of food inflation, he

Referring to inflation as an elephant in the room, Das remarked: "Now the elephant has gone out of the room for a walk, then it will go back to the forest."

He also pointed out that when the Ukraine war started, inflation went up but the RBI followed the right monetary policy, unlike some other

countries, and succeeded in keeping the price spiral in check.

"What we did not do in India is also important. RBI did not print notes because if we start printing notes the problems we are trying to resolve will expand and go beyond handling. In many countries the inflation was deep-rooted but ours is moderating," he added.

"We kept our interest rate 4 per cent, therefore making our recovery much easier,' he pointed out.

Das also highlighted how the RBI is bringing about a transformational change in credit delivery, especially to small entrepreneurs and farmers, through the Unified Payments Interface (UPI) and the Unified Lending Interface (ULI) launched recently.

Driven by investments in liquid schemes, the debt-oriented mutual funds witnessed a strong recovery in October attracting a net inflow of Rs 1.57 trillion after huge redemptions in the previous month.

The data suggested that the debt mutual funds attracted inflows of Rs 1.57 trillion in October, marking a sharp reversal from the outflows of Rs 1.14 trillion recorded

Foreign investors pull out ₹22,420 crore from Indian market in Nov

So far in November, the foreign investors have pulled out Rs 22,420 crore from the Indian equity market. This is owing to high domestic stock valuations, increasing allocations to China, and the rising US dollar as well as Treasury yields.

With this sell-off, Foreign Portfolio Investors (FPIs) have recorded a total outflow of Rs 15,827 crore in 2024 so far. Notably, the withdrawals

are concentrated in the secondary market, with FPIs offloading Rs 32,351 crore through exchanges this month, while still investing selectively in the primary



market to the tune of Rs 9,931 crore.

October also has proven to be a challenging month for the Indian stock market. The sell-off by FPIs in the Indian stock market raised concerns among investors. According to NSDL, as of October 22, 2024, equities saw outflows amounting to Rs 72,136 crore.

Earlier in September 2024, foreign investors made

a nine-month high investment of Rs 57,724 crore. Before this, FPIs withdrew Rs 61,973 crore from

equities in March 2020. On the other hand, FPIs invested Rs 42 crore in the debt general limit and Rs 362 crore in the debt voluntary retention route (VRR) in November so far.

So far this year, FPIs invested Rs 1.06 lakh crore in the debt market.

The FPI selling since October are majorly driven by high valuations in India, concerns regarding the earnings downgrade and the Trump trade.

India clocks 12 pc rise in deal volume in Jan-Oct, China sees 23 per cent decline

Indiasaw 11.9 per cent increase in deal volume (year-on-year) in the January-October period, bucking the overall trend in the Asia-Pacific region, a new report has said.

On the other hand, China experienced YoY decline in deal volume by 22.9 per cent during the period, according to GlobalData, a leading data and analytics company.

Atotal of 11,808 deals (mergers and acquisitions, private equity and venture financing deals) were announced in the Asia-Pacific (APAC) region during January to October 2024, which was a year-on-year (YoY)

An analysis revealed that during January-October, the number of private equity and venture financing deals declined by 16.3 per cent and 10 per cent, respectively. Meanwhile, the M&A deals volume experienced a marginal YoY improvement during the review period.

According to Aurojyoti Bose, lead analyst at Global Data, the decline in deal activity in APAC was in line with the global trend wherein all the regions experienced fall in deal volume. However, the APAC region showcased relatively better

decline of 4.8 per cent, compared performance and experienced only single digit decline whereas most of the other regions experienced double-digit declines, Bose mentioned.

> "This could be attributed to the improvement in deal activity experienced in some of the APAC countries, like India," the report said, adding that this has helped in minimising the impact of decline experienced in other countries within the region.

The top three movies in October 2024 were Tamil



and Telugu films, followed by a Hollywood movie, Venom: The Last Dance. Vicky Vidya Ka Woh Wala *Video*, starring Rajkummar Rao, secured the fifth posi-

In October, Tamil films came to the rescue of lacklustre box office collections as Sivakarthikeyan led *Ama*ran and Vettaiyan saved the day for the industry as films released in October grossed Rs 994 crore in the domestic box office, the report said.

Tamil cinema was the highest contributor, with almost 50 per cent of the month's collections coming from Tamil films, including their dubbed versions. Amaran became the highest-grossing movie in October 2024, with a gross domestic box office collection of Rs 269 crore across all language versions, and also entered the list of the top 10 releases for this year. Vettaiyan grossed Rs 173 crore in October.

The report said for the January-October period in 2024, Hindi-language films accounted for 34 per cent of gross domestic box office collections, down from 41 per cent in the same period last year. This year saw cinema exhibitors introduce several initiatives to boost audience footfall, such as re-releasing movies and offering attractive prices on food and beverages, it highlighted.

Price of tomato declining: Centre

The Centre on Sunday claimed that the retail prices of tomatoes are on the decline with the fall in mandi prices.

The all-India average retail prices as on 14th November 2024 was Rs.52.35 per kg, which is 22.4% lower than Rs.67.50 per kg on 14th October 2024. During the same period, the modal prices at Azadpur mandi declined by almost 50%, from Rs.5,883 per quintal to Rs.2,969 per quintal with the increase in tomato arrivals. Similar declines in mandi prices are reported from benchmark markets such as Pimpalgaon,

Madanapalle and Kolar. The total annual production of tomatoes, as per the third advance estimate of the Department of Agriculture, is 213.20 lakh tonnes in 2023-24; a 4% increase over 204.25 lakh tonnes in 2022-23. Even though tomatoes are produced throughout the year, there is seasonality in the producing areas and the quantum of production.

Adverse weather conditions and slight logistics disruptions have a significant impact on prices due to the high susceptibility of tomato

crops and the high perishability of the fruit. The surge in tomato prices during October 2024 was on account of excessive and prolonged rains in Andhra Pradesh and Karnataka.

The general seasonality in tomato production across various regions of India showed that October and November are the main sowing periods in major producing states. Continuous availability of tomatoes in the market, however, is ensured because of the short

duration for cultivation of

the crop and multiple picking of the fruits.

Even though the arrivals have subsided at major tomato centres in Madanapalle and Kolar, prices have come down on account of seasonal arrivals from pockets in states like Maharashtra, Madhya Pradesh and Gujarat that have been filling the gaps in supply across the nation. As of date, the weather has also been favourable for the crop and also for maintaining a good flow across the supply chain from the fields to the consumers.



Sanamahi, the supreme God of Meiteis and other indigenous tribes

he story of Sanamahi in Meitei lore parallels the themes of creation seen in scientific theories, such as the Big Bang (Thille Pokaiba), that describe the origin of the universe. Sanamahi is revered as the divine force behind all creation, responsible for bringing every living creature into existence. Sanamahi's role as the creator and sustainer of life embodies a profound reverence for the interconnectedness of all beings and the natural world. In the indigenous belief system of Sanamahism, central to the Meitei people of Manipur, Sanamahi is indeed regarded as the focal point (Asuppa) of the universe's creation. In Sanamahism, the focal point of the universe, Sanamahi, is not only the central source of creation but also embodies light in its purest and most divine form, known as 'Yel-

The concept of a small unknown creation in liquid form, when there was no cloud or air, reflects the primordial state of the universe in Sanamahism. This idea is linked to the very beginning of creation when the universe was still in its earliest, of elements like air, water, or even we cover our ears with our hands. light. This unknown creation can be seen as a representation of the chaotic, formless potential from which all things would eventually emerge, guided by the will of Sanamahi. He embodies the ultimate source of life, energy, and order, and is seen as both the creator and sustainer of the direction and corners (Maikei and

cosmos. Sanamahi is believed to have emerged from the divine essence, the eternal, formless, and infinite being who existed before time and space. This act of creation signifies that Sanamahi is not only a god but the essence through which the universe itself is formed. The concept of a central focal point is essential to the structure and direction of the universe.

Sanamahi, as the primordial and supreme God, is believed to provide this central point, giving direction, balance, and order to existence. Without this focal point, the universe would lack structure, coherence, and purpose. The process of creation begins from a central, divine focal point, Sanamahi. From this point, the energy that forms the universe starts to coalesce, pulling together and gathering matter, life, and spirit. This gathering is imagined as a powerful, resonant act, where the energy of creation doesn't just flow outward silently but instead emerges with a sound (ung), a cosmic resonance or vibration. This sound is often symbolic in mythologies around the world, representing the force, intention, and rhythm behind creation. The sound of creation, as envisioned in Sanamahism, is likened to the subtle, unformed state before the introduction resonant hum we experience when

Sanamahi is often referred to as the "Asuppa Laie Ningthou", a title that highlights his supreme and central role in the creation and maintenance of the universe. Sanamahi holds the supreme authority to shape not only the core of the universe but also its

Sungtai), essentially defining its structure, balance, and movement. Thille Ungleire is believed to be the centre or focal point of the entire universe. Sanamahism describes the creation of the universe as emerging from a primordial state of formlessness, where the universe began from a single divine point, Thille Ungleire. The scripts in Sanamahism hold the divine truth about the creation of the universe. These ancient texts not only tell the story of the origin of the universe but also emphasise that Sanamahi's will shaped both the material and spiritual aspects of creation. These texts describe the formation of space, the emergence of light, the creation of elements, and the coming together of life—all from the divine Center of Thille Ungleire.

Atingkok Guru Sidaba and Sidabi are considered the first creators of Sanamahism. The first god created everything; Sanamahi himself is the ultimate creator who formed Atingkok Guru Sidaba and Sidabi. This makes Sanamahi a god who exists beyond the very first beings and the divine origin of the cosmos. Sanamahi, after the creation of the universe and the world, created these two divine beings, Atingkok Guru Sidaba and Sidabi. This signifies that Sanamahi is the supreme God, existing before even the first creators. His role in creation is portrayed as pre-existent, meaning he was there from the beginning and beyond all creation. After cre-

ating the universe,

Sanamahi

instructs

Atingkok Guru Sidaba and Sidabi to become his devotees, revealing his divine presence in a pot and avatar as their son. The pot symbolises the vessel of Sanamahi's essence, and his instruction for them to come and pray indicates that divine connection and devotion are central to understanding and accessing the higher realms of existence. The higher will of Sanamahi underscores the belief that Sanamahi is the greatest and most powerful God in the universe.

Atingkok Guru Sidaba and Sidabi, the first creators, instructed Sanamahi and Pakhangba to take seven rounds around the world to prove their worthiness to become the king of the world, or Kanglei (Dry Land). The seven rounds are symbolic of a journey of completion, power, and divine maturation. Sanamahi, as the supreme God, follows the command and completes the journey of seven rounds. Pakhangba's inability to complete the seven rounds leads to the intervention of his mother, who tells him to take the round of your father instead. This

suggests that Pakhangba's role is different from that of Sanamahi. When Sanamahi returns after completing the seven rounds and finds Pakhangba already seated, he becomes angry. Sanamahi is the supreme God, and the idea of another taking the throne or a different path in the creation might have shaken his sense of order. In response to this perceived injustice, Sanamahi begins to destroy the world. This act symbolises his power over creation, and the divine disturbance he causes can be interpreted as a reaction to the imbalance he feels. It is said that the world was once a single piece, but after this destruction, it became diverse and fragmented, representing the diversity of existence that we see today. This transformation may reflect how divine conflict or imbalance can cause cosmic changes, shifting unity into multiplicity. The mother's explanation brings balance and harmony back to the cosmic order. Pakhangba is granted kingship over the world/Kanglei, signifying his role as the ruler of Kanglei, the earth,

or the physical realm. Sanamahi is

individual homes, hearts, and souls of beings in the world. Sanamahism is a spiritual belief system and philosophy that is based on a deep connection to the land, the divine, and ancestral traditions. The idea is that Sanamahism can be followed by anyone, with no boundaries, speaking to the universal aspects of its teachings and the openness of its spiritual worldview and respect to nature. Sanamahism is a belief system that teaches profound truths about the creation of the universe, the nature of the divine, the purpose of life, and symbiotic relations of all living beings in the cosmos. Sanamahi, as the Supreme God, is the ultimate creator and protector of all life and existence. Followers of Sanamahism are taught to embrace these truths and live in harmony with the divine order, which brings blessings and spiritual fulfilment.



Smith reveals plans for facing Ashwin during upcoming Border-Gavaskar Trophy

MELBOURNE, 17 NOVEMBER

Australian batter Steve Smith opened up on his battles with Indian ace spinner Ravichandran Ashwin over the years and revealed how he would face him during the upcoming Border-Gavaskar Trophy against India at home.

With the ICC World Test Championship (WTC) final chances of both sides at stake, both teams will be starting with the first Test at Perth from November 22 onwards. For Australia, it would be important that their most premier batter Smith is in his best form and his battles with spinner Ashwin would surely be interesting. With Ashwin and Smith both having suffered form dips as of late, the imminent clash between both becomes even more interesting.

Speaking on Sydney Morning Herald, Smith said that he and Ashwin have had

great battles over the years. "When you have five matches, if someone gets on top of another player, they could have 10 innings against them.

So you are facing those mental challenges each game, and if it goes one way early, they will feel under pressure against that player. There is



nowhere to hide in five games like there are in a two-game series. Ashwin and I have had some good battles over the years," he said.

Smith has a career average of 54.2 against Ashwin, being dismissed by him eight times. During the last BGT in India, he could score only 22 runs off him and was dismissed twice.

In Australia, where Ashwin has a mediocre average of around 42 as compared to his excellent average of around 21 at home, Smith thrives against Ashwin, averaging 80.3 despite being dismissed thrice and scoring just 64 runs against him in the 2020-21 BGT series at home. During the 2017 series in India, Smith scored 132 off 215 balls against Ashwin and only gave him

his wicket twice. Reminiscing on his dismissals in the 2020-21 series,

Smith said that he would now be looking to be proactive against Ashwin and not let him settle.

"Ashwin nicked me off in the first innings in Adelaide and then got me at leg slip at the MCG on a tacky wicket. I do not like getting out to off-spin in Australia. I feel as though it should be, particularly for a right-handed batter, relatively easy to face. But he is also a very good bowler and he came in with some decent plans," said

Smith. "There were a couple of occasions where he got on top of me, then I got on top of him at the SCG when I was a bit more proactive [Smith made 131 and 81]. So that is key for me. Just be proactive against him and not let him settle and bowl the way he wants to," he

added.
