## MAHA KUMBH NUMBED Modi, Shah monitoring

stampede-like situation at the Maha Kumbh Mela in Prayagraj on Wednesday claimed dozens of lives and left many more injured. A senior doctor at a hospital tending the injured told *The Pioneer* that most of the deceased were from Karnataka, and their bodies have been handed over to their families after postmortem examinations.

Despite the tragedy, the spiritual fervor remained intact as over six crore devotees took a holy dip at the Sangam on Mauni Amavasya The Akhara Parishad, which had initially called off the Amrit Snan, later participated in the ritual, albeit without its usual grandeur.

There was, however, a variance in the statements of Prime Minister Narendra Modi and Chief Minister Yogi Adityanath regarding the incident. PM Modi expressed his deepest condolences calling the tragedy "extremely saddening." In a post on X, he assured that the local administration is providing all possible help and wished a speedy recovery to the injured. "I have been speaking to Chief Minister Yogi ji and am in constant touch with the state government," he said. In contrast, CM Yogi

Adityanath avoided confirming any fatalities. His official statement only mentioned the injured, saying, "Some people have serious injuries," sidestepping reports of deaths. The Maha Kumbh Mela control room remains operational, but no dedicated helpline has been issued yet for affected

devotees, further adding to the frustration of those searching for missing family members.

chaos that unfolded in the early hours. "We were waiting near the Sangam since last night," said Rajesh Tiwari, a devotee from Varanasi. 'People had been sleeping there to secure a good spot for the Mahurat bath at 3 am. But around 2 am, the crowd surged forward, unaware of those lying on the ground. That's when the pushing started, and everything went out of control."

Rekha Devi, a devotee from Bihar, described the horror of the moment. "It all happened in seconds. Whoever fell could not get up. People were running in all directions, but some got trampled," she said.

## Timeline of major stampedes at religious gatherings

JULY 2, 2024: More than 100 people, including women and children, were killed after a stampede broke out at a 'satsang' (prayer meeting) organised by a self-styled godman, Bhole Baba aka Narayan Saakar Hari, in Uttar Pradesh's Hathras.

JANUARY 1, 2022: At least 12 people died and over a dozen were injured in a stampede at the famous Mata Vaishno Devi shrine in Jammu and Kashmir triggered by a heavy rush of devotees OCTOBER 13, 2013: 115 people were killed

and over 100 injured in a stampede during the Navratri festivities near Ratangarh temple in Madhya Pradesh's Datia district. The stampede was triggered by rumours that a river bridge the devotees were crossing was about to collapse

FEBRUARY 10, 2013: More than 36 people lost their lives at the Prayagraj Junction, which was packed with pilgrims for the 2013 Kumbh Mela, following a panic on the foot

overbridge leading to platform 6, triggering a stampede. Dozens sustained severe injuries, requiring prolonged hospitalisation. The victims were devotees from Uttar Pradesh Bihar, Delhi, Maharashtra, Madhya Pradesh and other states

NOVEMBER 19, 2012: Around 20 people were killed and many others injured as a makeshift bridge caved in, triggering a stampede during the Chhath Puja at Adalat Ghat on the bank of river Ganga in Patna. NOVEMBER 8. 2011: At least 20 people were killed in a stampede in Haridwar at Har-ki-Pauri ghat on the banks of the Ganga river.

JANUARY 14. 2011: At least 104 Sabarimala devotees were killed and over 40 were injured in a stampede when a jeep crashed into homebound pilgrims at Pulmedu in Kerala's Idukki district.

MARCH 4, 2010: About 63 people were killed in a stampede at Ram Janki Temple of Kripalu Maharaj in Uttar Pradesh's Pratapgarh district as people gathered to collect free clothes and food from the self-styled godman

SEPTEMBER 30, 2008: Nearly 250 devotees were killed and over 60 injured in a stampede triggered by rumours of a bomb going off at Chamunda Devi temple in Rajasthan's Jodhpur city.

AUGUST 3, 2008: 162 dead, 47 injured in a stampede triggered by rumours of rockslides at Naina Devi temple in Himachal Pradesh's Bilaspur district.

JANUARY 25, 2005: Over 340 devotees were trampled to death and hundreds injured during an annual pilgrimage at Mandhardevi temple in Maharashtra's Satara district. The accident occurred when some people fell down on the steps made slippery by the devotees breaking coconuts

AUGUST 27, 2003: 39 people were killed and around 140 injured in a stampede during the holy bath at the Kumbh Mela in Maharashtra's

I express my condolences to the families of the injured devotees and pray to God that all the injured devotees recover soon, President Murmu said in a social media post in Hindi. Vice President Jagdeep Dhankhar expressed grief at the stampede and prayed for the speedy recovery of the

> injured. Modi spoke to Uttar Pradesh Chief Minister Yogi Adityanath four time in three hours following the tragic stampede at the Maha Kumbh, where over two dozen people were injured and many were feared dead. The Prime Minister reviewed the situation, called for immediate support measures,



and assured continuous monitoring of developments. Union Home Minister Amit Shah also reached out to Adityanath and assured all possible assistance from the Central government. Centre stands with Uttar Pradesh in this hour of crisis and will provide all necessary support," Shah said.

Union Health Minister JP Nadda, who is also national president of Bharatiya Janata Party, spoke to the Uttar Pradesh Chief Minister and assured that the Centre would ensure all necessary medical aid for the injured. He also conveyed that BJP workers were prepared to assist the administration in managing the situation. In response, Adityanath informed Nadda that the district administration had brought the situation under control.

Uttar Pradesh Governor Anandiben Patel enquired about the prevailing situation and spoke to Chief Minister Yogi Adityanath twice.

## **No entry for** vehicles to **Prayagraj**

Uttar government directed district police chiefs to temporarily halt vehicles carrying devotees to the Maha Kumbh Mela in Prayagraj following stampede-like situation during the Second Shahi Snan on Mauni Amavasya early Wednesday. Uttar Pradesh

Minister Yogi Adityanath also appealed to people to take a dip in the Ganga at their nearest ghats and not try to reach the Sangam Nose, according to an official statement. "All ghats hold equal spiritual significance and reaching the main confluence point should not be a priority," the statement quoted the chief

minister as saying. The move is aimed at preventing overcrowding at the religious gathering, where millions of pilgrims converge to take a holy dip at the confluence of the Ganga and Yamuna rivers.

In Rae Bareli, Circle Officer (City) Amit Singh confirmed that around 40-50 vehicles, including 10 large buses, have been stopped from proceeding to Prayagraj.



## **SC** bans mannual scavenging in 6 cities including Delhi, Mumbai

The Supreme Court on Wednesday passed passed directions banning manual scavenging and manual sewer cleaning in six metropolitan cities - Delhi, Mumbai, Chennai, Kolkata, Bengaluru and Hyderabad- in a writ seeking petition eradication of manual scavenging in India. In its order, it stated that in the

comprehensive affidavit filed

by the Union, there is "no

clarity" on the eradication of

manual scavenging and sewer

cleaning. "Therefore, we hereby order manual sewer cleaning and manual scavenging shall be stopped in all top metropolitan cities as follows: Metropolitan city of Delhi, Mumbai, Chennai, Kolkata, Bengaluru, and Hyderabad," the order passed by Justices

Sudhanshu Dhulia and Aravind Kumar.

The top court also directed the Chief executive officer (whatever name they are called in the respective cities) of each metropolitan city shall file a precise affidavit apprising as to how and when manual scavenging and sewer cleaning is stopped in the city. The affidavit shall be filed latest by February 13.

The Public Interest Litigation filed by Dr. Balram Singh raised the issues that pertinent provisions of the Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act. 1993 as well as the Prohibition of Employment as Manual Scavengers and Their Rehabilitation Act, 2013, unimplemented despite the mandate of the

The Bench expressed orally that it is "fed up" with passing

orders seeking compliance which remains "academic" in nature as there is no compliance. It said: "Can we say it today that manual scavenging from today onwards is banned?...We are fed up of order. We are directing. Either do it or face

consequences."

Earlier, bench of Justices Sudhanshu Dhulia and Aravind Kumar on December 11, last year, directed the Union Government to call a meeting of the Central Monitoring Committee along with the respective States stakeholders within 2 weeks to assess to what extent the compliance has been made to the main order dated October 20, 2023. Based on the October 20 order, the Union was to file a status report. However, the Court noted the report was "not encouraging

## Delhi Police seize ₹1.87 Crore ahead of polls

The Delhi Police have seized more than ₹1.87 crore in cash in three different operations ahead of the assembly polls in the national

Police said that the Railway Northwest, and Southwest district police have collectively seized the money in separate operations.

The cash, suspected to be linked to illicit activities, was recovered during routine and surveillance, according to a statement from the Delhi

Commissioner of Police (Railway) KPS Malhotra said that the railway unit team seized ₹32.61 lakh from Sabzi Mandi Railway Station. "On January 28 at Sabzi Mandi

Railway Station, the police apprehended Jaswinder Pal (48), a resident of Ropar, Punjab, who was in possession

of ₹32.61 lakh in unaccounted The suspect was intercepted while carrying a black backpack containing 6,282 notes of ₹500, 601 notes of ₹200, and smaller denominations," said the DCP. Upon questioning, Pal told police that he had traveled from Punjab to Delhi by Jan Shatabdi Express and claimed that he had been sent by his brother-in-law to collect the cash-filled bag. However, he

was unable to provide any valid

documentation or proof of

cash ownership.

The DCP said that the Income Tax Department and the concerned Election Cell were immediately informed for further investigation into the source and purpose of the cash. The Income Tax Department took custody of the suspect and the seized cash for further proceedings.

In another operation, a team from the Northwest district seized ₹1.50 crore ahead of the

assembly polls. "Our teams seized ₹1.50 crore in unaccounted cash from six people during enforcement measures ahead of the elections. The seizure was made as part of efforts to curb electoral malpractices," Deputy Commissioner of Police (Northwest) Bhisham Singh

He added that the police intercepted suspects carrying large sums of cash without valid proof, leading to the confiscation of the amount. The suspects were taken into custody, and the investigation is ongoing. In the third operation, the Southwest Police seized ₹3.98 lakh at a picket.

'A team from the Palam area seized ₹3.98 lakh from three people during vehicle checks at Nasirpur Road, Manglapuri. The suspects were identified as Aajam (27), Md Maroof (38), and Sakir Raja (31), residents of Uttar Pradesh.

Stage 3 also bans non-essential diesel-operated medium goods vehicles with BS-IV or older standards in Delhi.

It also said this is in addition to the actions under Stages I &II of the extant schedule of GRAP already in-force in NCR. Various agencies responsible for implementing measures under GRAP including Pollution Control Boards (PCBs) of NCR and DPCC have also been addressed to ensure strict implementation of actions under Stage-III of the extant schedule of GRAP in addition to actions under Stages I &II of GRAP during this period.

The decision to invoke stage three was taken after Delhi's Air Quality Index(AQI) on Wednesday clocked 365 i.e. 'Very Poor' Category (AQI ranging between 301-400), CAQM said. ## JPC adopts amended Waqf bill as Opposition slams provisions

Aparliamentary panel examining the Want Wednesday adopted by a majority vote its report that contained changes suggested by ruling BJP members, prompting the Opposition to dub the exercise as an attempt to destroy the Waqf boards.

The Joint Committee of Parliament (JPC) on the Waqf (Amendment) bill, chaired by BJP member Jagdambika Pal, adopted the report on the draft legislation by a 15-11 majority vote. Opposition members were submitting dissent notes

Opposition members objected to the proposed omission of the 'waqf by user' clause in the Waqf Amendment Bill, contending that the provision existed since time immemorial.

In a dissent note to the report, AIMIM chief Asaduddin Owaisi said the last-minute inclusion of the proviso to the clause omitting waqf by user' was "wholly unhelpful" as the

cases where the property is placed 'in dispute', in which case the proviso will not apply. BJP members insisted that the bill, introduced in Lok Sabha in August last year, seeks to bring modernity, transparency and accountability in the management of Waqf properties, while the Opposition termed it as an attack on the constitutional rights of the Muslim community and interference in the functioning of the Waqf boards. Speaking to reporters after the 38th sitting of the committee, Pal said the report will be presented to Lok Sabha Speaker Om Birla on Thursday and tabled in both Houses of Parliament during the Budget Session beginning Friday. A key concern of the

Opposition was the appointment of non-Muslims on the Waqf Board, which they claimed was violative of Article 26 of the Constitution that granted citizens freedom to manage their religious affairs, including establishment and maintenance of institutions for religious and charitable pur-

granted under Article 26 of the Constitution. You talked about Uniform Civil Code, but there are Hindu Endowment Board, Sikh Boards, Christian boards, which do not have non-Hindus, non-Sikhs, and non-Christians as members. But why does this not extend to Muslims? This is an attempt to destroy the Waqf Boards," Congress member Imran Masood told reporters.

At its meeting on Monday, the committee had adopted 14 amendments to the bill, all proposed by BJP members and rejected every change suggested by the opposition members, including the Congress, the DMK, the TMC, the AAP, the Shiv Sena-UBT and the AIMIM. Trinamool leader Kalyan Banerjee claimed the observations and recommendations of the committee were 'wholly perverse".

BJP members contended that the amendments suggested by the Opposition were intended to uphold the 1995 law and negate the spirit of the Waqf



Amendment bill-2024.

"All these amendments are not in the interest of the Waqf. These will destroy the Waqf board and increase interference of the Central government in their functioning," AIMIM leader Asaduddin Owaisi said. He said the evacuee properties could also be taken over by the government. "This will not be acceptable to the masses, especially the Muslim community. We reject this Waqf amendment. Muslims will lose their masjids," Owaisi said. According to the amendments

## **SC** seeks details of FIRs against men who invoked triple talaq

The Supreme Court on Wednesday directed the Centre to furnish data on FIRs and chargesheets against men who invoked instant triple talaq to divorce their wives in violation of the Muslim Women (Protection of Rights in Marriage) Act, 2019. A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar was hearing about 12 petitions filed by various Muslim individuals and organisations challenging the constitutional validity of the 2019 Act that criminalises the practice of instant triple talaq.

"The respondent (Centre) shall file the total number of FIRs and chargesheets pending under Section 3 and 4 of Muslim Women (Protection of Rights of Marriage) Act 2019. The parties to also file written submissions not exceeding three pages in support of their contention," the bench said. It asked the Centre and other parties to file written submissions to the pleas while the posting the matter for final

hearing in the week commencing March 17. Referring to the legal position, the bench said as triple talaq was held invalid, there was no dissolution of marriage and the point now was the criminalisation of the pronouncement. "If the divorce itself is not recognised, the relationship then continues and no separation. But now you have penalised the very act of pronouncing it....We want the list of cases all over India where FIRs are led, now in all states FIRs are centralised, just give us a list of that," the CJI said. "In no civilised section, such a practice is there," said solicitor general Tushar Mehta. The bench said the petitioners were not arguing for making triple talaq valid but opposed its criminalisation. "I am sure none of the lawyers here are saying that the practice is correct, but what they are saying is whether it can be criminalised when the practice is banned and no divorce can take place by uttering talag three times at once," the CII said.

The bench said as triple talaq was legally void, the law effectively penalised mere pro-

"talaq" thrice - the bone of contention in the ongoing legal challenge. Mehta defended the legislation saying penalising an activity fell within the domain of legisla-

He opposed the argument that the Act imposed disproportionate punishment, saying the maximum sentence under the law was three years, lower than penalties in other laws protecting women's Petitioner's counsel Nizam

Pasha said the law unjustly criminalised the mere utterance of words, talaq, equating it with punishable offenses. He said no other community faced similar legal consequences for marital abandonment. Senior advocate M R Shamshad said existing domestic violence laws sufficiently addressed issues arising out of marital disputes, making the separate criminal law unnecessary. "In matrimonial cases, even if a wife is physically assaulted, it takes months to register an FIR. Here, an FIR is lodged for mere pronouncement," he

Mehta argued the law aligned

with the broader principles of legal accountability, citing Section 506 of IPC, which penalised certain forms of verbal threats. He said the criminalisation of triple talaq served a necessary deterrent purpose.

The bench said even after pronouncing triple talaq, a Muslim husband and wife remain legally married, as the practice did not constitute a valid divorce. "If the divorce itself is not recognised, the relationship continues.

But now, you have penalised the very act of pronouncing it," the CJI said as he referred to petitioners' concerns about the law's necessity.

Section 3 of the Act declares triple talaq as void and illegal whereas Section 4 prescribes a punishment of up to three years' imprisonment for a Muslim husband who pronounces it. In a landmark verdict, the apex court on August 22, 2017 held as invalid the 1,400-year-old practice of "triple talaq" among Muslims while setting it aside on several grounds, including it was against the basic tenets of Quran and violated the Islamic law Shariat.

## SC directs hospitals to regularise doctors' absence during RG Kar protests

The Supreme Court on Wednesday directed hospitals, including AIIMS New Delhi, to regularise the unauthorised absence of doctors who were part of protests against the rape and murder of a doctor at RG Kar Hospital, Kolkata. On Wednesday, a bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar took note of the submissions of a doctors' body that some hospitals had regularised the absence of the doctors following its August 22, 2024 order whereas a few others, including AIIMS Delhi, decided to treat the period as leave of absence.

"We deem it appropriate to clarify that if protesting workers had joined work post the Supreme Court order then their absence shall be regularised and not be treated as absence from duty. This is issued in peculiar facts and circumstances of the cases and is not laying down any precedent," the CJI said. The lawyer appearing for the body said the decision to treat the



protest period as leave could create trouble for some of the medical PG students. Solicitor General Tushar Mehta,

representing the Centre, said as the case was non-adversarial, the hospitals would abide by the top court's directions. Mehta said AIIMS, Delhi, decided to treat the period as leave of absence availed by the doctors. "By an earlier order, it was stated that no coercive step would be taken against the protesting doctors for protests till the date of the order. Pursuant to this some of the AIIMS such as Kalyani and Gorakhpur and the PGI the absence. However some other institutes have treated the said period as if doctors were on leave," the bench said.

On August 22, last year, the bench made an impassioned appeal to the protesting doctors across the country, asking them to resume work. Observing "justice and medicine" couldn't be stopped, it directed no coercive action would be taken against doctors once they resumed work. ## Sirens pierce the night, chaos unfolds at hospital

The first ambulance siren sliced through the quiet night. Then another. And another. Within minutes, the wails of sirens filled the air, signaling something catastrophic Something big had happened. catastrophic. Reports of a stampede at Sangam Nose during the Mauni Amavasya 'Amrit Snan' started trickling in. Without wasting a moment, we rushed to Central Hospital in Sector 2, where ambulances were arriving one after another. The sight that awaited us confirmed our worst fears. Outside the emergency ward, a wave of panic and despair had already taken over. Stretchers with bloodied bodies were being rushed in, relatives ding for

public and media from entering. Determined to find out what

was happening, I posed as a relative searching for someone and managed to slip inside. The moment I stepped through the doors, the scale of the disaster became clear. Over ten lifeless bodies lay lined up on the floor, waiting to be

identified. The injured-some unconscious, others moaning in pain-were scattered across stretchers and makeshift beds, as doctors and nurses worked frantically to save them. 'We are doing our best, but

there are too many injured," a doctor said, barely looking up as he bandaged a man's bloodied forehead. Women, elderly, and even

children lay on stretchers, some updates, and police had sealed gasping for breath after being haunted by one of the darkest off the area, preventing the crushed in the suffocating

crowd. Whenever a patient stabilized, they were quickly moved to make space for more critical cases.

As the chaos unfolded inside, bodies were quietly being moved out through the emergency exit. Some covered in sheets, others still waiting for identification. Ambulances continued to ferry in more injured and lifeless bodies for over three hours.

With beds filling up, several critical patients were transferred to Swarooprani Hospital, where more facilities were available.

Outside, grief and confusion gripped the families waiting for news. Many had lost their loved ones in the crush; others were desperately searching for missing relatives.

Back at Sangam Ghat, where the stampede occurred, police cordoned off the area, but survivors were still seen searching through heaps of abandoned belongingschappals without their pairs, torn bags, scattered blankets, and even packets of food left behind in packets of food left behind in the panic.

"I lost everything-our money, train tickets, even my husband's shawl," sobbed Shanti Devi, a pilgrim from Bihar, rummaging through the pile of discarded items. As dawn broke over Prayagraj, the sirens began to nights of the Maha Kumbh.

The chaos erupted suddenly-one moment, devotees were waiting patiently for their sacred dip; the next, screams filled the air as bodies collapsed under the crushing weight of the surging

crowd. "For a moment, I thought I was dead," said Alpona Sen, a devotee from Kolkata, from devotee recounting the harrowing stampede that unfolded near pillar number 157 in the Kumbh area.

The stampede began around 2 a.m. when lakhs of devotees surged toward Sangam Nose, unaware that many had been



sleeping overnight at the site to secure a prime spot for the Mahurat bath at 3 a.m.

We had been waiting since last night," said Rajesh Tiwari from Varanasi. "Some of us were resting, while others were changing clothes after an early

dip.
Suddenly, people started pushing forward, not realizing people lying down. there were people lying down. That's when the chaos started." The sudden movement triggered panic, and within moments, barricades collapsed as people tripped and fell.

"It all happened so fast. Whoever fell down couldn't get up," said Rekha Devi from Bihar. "People were screaming,

running, pushing. Some got trampled. It was terrifying." At the emergency ward of Central Hospital, distraught

families searched for missing loved ones. Ramesh Kumar, a resident of Kanpur, moved frantically between wards. "I have been

looking for my nephew for hours. We got separated when the crowd surged. His phone is switched off, and I have no idea where he is. I just

hope he is safe," he said, his voice trembling.
A woman cradling her injured

child outside the hospital described the mercilessness of the stampede. "There was nowhere to go.

Some people who pushed us were laughing while we begged them for kindness toward the children," she said, tears streaming down her face. "We Were Trapped"-Survivors

The stampede occurred amid a sea of tightly packed pilgrims along the 12-km stretch of riverbanks designated for Maha Kumbh bathing. Sarojini from Karnataka, still in

shock, wept outside the hospital. "We came in a batch of 60 people in two buses. In our group of nine, we suddenly found ourselves trapped. There was pushing, and we fell down.

The crowd was uncontrollable."

## Chaos at Sangam as devotees search for lost items

heap of colourful clothes, Alone slippers without their pairs, torn bags, and hastily abandoned blankets lay strewn across the ground at Sangam Nose, a grim reminder of the chaos that unfolded in the early hours of the morning. Among the debris, a packet of roti-left untouched-spoke of pilgrims who had arrived with hope and devotion but left in panic.

A stampede broke out around 1 am, as millions of devotees surged forward for the 'Amrit Snan' on Mauni Amavasya, one of the holiest days of the six-week-long Maha Kumbh. More than 30 people were injured, and several others are feared dead in the crush near the sacred confluence of the Ganga, Yamuna, and the mythical Saraswati rivers.

off the area, anxious devotees could still be seen searching through the abandoned belongings. Sunita Devi, a pilgrim from Chhattisgarh, frantically sifted through the pile of clothes. "My husband's shawl was here... we lost our bag in the rush. It had our money, our train tickets. What will we do now?" she said, her

voice breaking. Nearby, Biplab Bhattacharya, who had traveled from Kolkata, looked around helplessly. "My sister had a small bundle with her-a warm blanket and some food. I do not know where she is, and I can't even find her things," he said.

Eyewitnesses described scenes of panic and desperation, with devotees stepping scattered belongings as they tried to escape. Some even climbed barriers Even as the police cordoned pontoons in the chaos.

"People were screaming, running. I saw slippers flying, bags being trampled. bags being trampled. Someone fell right in front of me, and there was no space to pick them up," said Mohan Yadav, a devotee from Varanasi. The stampede occurred between 1 am and 2 am when some devotees attempted to cross barricades at Akhara Marg, Uttar Pradesh Chief Minister Yogi

Adityanath confirmed. "At the Akhara route, where arrangements were made for the Amrit Snan, some devotees broke through the barricades. Several were critically injured and were rushed to hospitals," he said after a high-level meeting in

Lucknow. The Significance of Sangam Nose

Sangam Nose, named for its distinctive shape, is considered the most sacred

bathing spot at the Kumbh Saints, sages, and thousands of devotees prioritize bathing here, believing it grants spiritual liberation. According to initial reports,

the stampede occurred as thousands surged forward to reach this particular spot. The pressure of the crowd became unmanageable, leading to a sudden crush.

The administration quickly launched relief and rescue operations, diverting crowds and opening additional routes to bring the situation under control. Despite warnings, some devotees still attempted to re-enter the area, searching for missing relatives and belongings.

Rescue teams remain at the site, and authorities have urged devotees to remain calm and follow security protocols to prevent further incidents.

remember a senior colleague reminiscing about ■his earlier years in the job. His daughters were small. He was a workaholic and the children would be long asleep when he returned. They would be gone to school by the time he surfaced the next morning. One of the children left a note on her pillow that there would come a time when she might not have time for him. I was talking to a young lady. Her father retired from the services.

He felt lost with more than enough free time on hand. The organisation had taught him to work hard. There were no training manuals to lead a retired life. I met a relative at a wedding. He will superannuate from a senior position in a few months. He sounded uncertain about the future.

He is a scientist and had no hesitation in accepting that he had considered science as a hobby his entire life. Now he was not so certain. In the same function, I caught snatches of conversation between a few gentlemen. An evening, that could have been spent talking about things other than business,

had turned into an extension of the workplace. They might not agree with me now. They

derive joy from such conversations when still in active service. Will they feel the same after retirement in a few years? I flew with a young IT professional many years ago. He was on the verge of quitting a well-paying senior-level private sector job to join a government company at the mid-management level. I was confounded till he explained. He was working in a software company with the majority of clients from America. His Indian job required him to work Indian

hours. His American clients

calls when they woke up. He

could at least sleep in the

night in his new job. I do not

know if he found peace. It does not matter if one works in the private sector or with the government.

The first lesson drilled into us when I joined the railway services was that a railway officer is always on duty, 24x7. It sounded glamorous in the heady euphoria of youth. I started believing that stress brought out the best in me. Till it was too late. I developed hypertension, and then diabetes. I also had meltdowns. I have transitioned from being a technocrat manager to exploring creativity.

I write fiction novels, short articles, and stories, and guide others to pursue passions from a bucket list that they could not take up, lost in the quest to earn a living. Many are not so fortunate. They do

not even realise that they need to strike a balance or that they need help. Recent statements by a couple of respected business leaders raise issues beyond chuckles and memes. A professional typically spends almost four decades working.
This is 2/3rds of his total life

at the time of retirement. Unfortunately, this is the only life he has seen. He has not even been prepared to lead a different later life. It is tougher for women. They are expected to take care of the children also, and sooner rather than later, the birds fly out of the nest. As we grow older, we start equating productivity with longer working hours. We also start believing that health and mental wellbeing, whether working or after retirement, is not important. How wrong we are! Melissa Steginus, mindfulness teacher and productivity coach, reminds us, "Remember that work and life coexist. Wellness at work follows you

## Beyond the 70-hour workweek: Redefining productivity



Fostering efficacy, accountability and a strong sense of ownership plays a big role in cultivating a productive and innovative workforce

ecent statements by prominent Indian business leaders advocating for extended work hours have sparked significant debate across the industries and political sphere. Infosys founder Narayana Murthy suggested a 70-hour workweek for the younger generation, while Larsen & Toubro chairperson S N Subrahmanyan pushed the idea further, proposing a 90-hour workweek, including Sundays. While their intent-to encourage competitiveness and efficiency—is commendable, the emphasis on extended work hours misses a crucial point: the number of hours worked is not the primary determinant of success. Efficacy, accountability, trust and a spirit of ownership are far more vital in creating a productive and competitive workforce.

The Fallacy of "More Hours Equals More Productivity" Globally, data and research have consistently shown that longer working hours do not directly correlate with increased productivity. According to a study by the Organisation for Economic Co-operation and Development (OECD), countries with shorter average work hours often rank higher in productivity. For instance, Germany-known for its robust industrial base—averages 34.6 hours of work per week and boasts one of the highest productivity levels in the world. In contrast, countries like Mexico, where workweeks stretch beyond 42 hours, report significantly lower productivity rates. The human brain has a finite capacity for sustained focus and creative thinking. Prolonged hours often lead to diminishing returns, increased burnout, and higher rates of errors. Studies by the World Health Organization (WHO) have also highlighted the adverse health effects of excessive work hours, linking them to cardiovascular diseases and mental health dis-

Moreover, the concept of presenteeism being physically present but mentally disengaged—is an often-overlooked consequence of extended work hours. Overworked employees may appear productive but are less likely to deliver highquality output. This underscores the importance of optimising work hours for maximum efficacy rather than simply extending them. What Truly Drives Productivity? Instead of focusing on quantity, business leaders should shift the discourse to quality. Productivity is not about the time spent at a desk or shop floor but what is achieved during that time. Three key factors contribute to this:

1. Efficacy: Efficacy emphasises doing things right rather than simply doing more. This involves leveraging technology, optimising workflows, and fostering a culture of continuous improvement. ## Trump's power grab sparks crisis

ust a little over a week into his second term, President Donald Trump is taking steps to maximise his power, sparking chaos and what critics contend is a constitutional crisis as he challenges the separation of powers that have defined American government for more than 200 years.

The new administration's most provocative move came this week, as it announced it would temporarily halt federal pay ments to ensure they complied with Trump's orders barring diversity programmes.

The technical-sounding directive had enormous immediate impact before it was blocked by a federal judge, potentially pulling trillions of dollars from police departments, domestic violence shelters, nutrition services and disaster relief programmes that rely on federal grants. Though the Republican administration denied Medicaid was affected, it acknowledged the online portal allowing states to file for reimbursement from the program was shut down for part of Tuesday in what it insisted was an error.Legal experts noted the president is explicitly forbidden from cutting off spending for programs that Congress has approved. The US Constitution grants Congress the power to appropriate money and requires the executive to pay it out. A 50year-old law known as the Impoundment Control Act makes that explicit by prohibiting the president from halting payments on grants or other programs approved by

Congress. "The thing that prevents the president from being an absolute monarch is Congress controls the power of the purse strings," said Josh Chafetz, a law professor at Georgetown University, adding that even a temporary freeze violates the law. "It's what guarantees there's a check on the presidency." Democrats and other critics

said the move was blatantly

unconstitutional.

"What happened last night is the most direct assault on the authority of Congress, I believe, in the history of the United States," Sen. Angus King, an independent from Maine, said Tuesday. While some Republicans were critical, most

Trump eases up on China after tough campaign rhetoric

Washington (PTI): On the end the war in Ukraine and campaign trail last year, President Donald Trump talked tough about imposing tariffs as high as 60 per cent on Chinese goods and threatened to renew the trade war with China that he launched during his first term.

But now that he's back in the White House, Trump appears to be seeking a more nuanced relationship with the country that both Republicans and Democrats have come to see as the gravest foreign policy chal-

lenge to the US China is also a major trading partner and an economic powerhouse, and it has one of the world's largest military forces. 'We look forward to doing very well with China and getting along with China," Trump said on Thursday at the World Economic Forum in Davos, Switzerland, in comments that suggested Beijing could help

## **Brazil to set up deportee centre** after controversial US flight

Brazilian government Tuesday said it will create a reception centre for deported migrants from the United States following controversy over conditions on a recent deportation flight. President Luiz Inácio Lula da Silva gave the green light to establish a humanitarian reception post at Confins, a municipality in Minas Gerais state, Brazil's Minister of Human Rights and Citizenship Macaé Evaristo told journalists in the capital Brasilia.

That decision was made because of the possibility that more flights will follow the arrival of an initial flight to Brazil under the new Trump administration with 88 deportees on board this weekend. That followed dozens of flights during the Biden administration. Local media reported that government officials were

Brazilians were kept handcuffed after an unscheduled stop in the Amazon's biggest city, Manaus, prompted by technical problems with the plane. A Brazilian military plane brought them to their destination, the city of Belo Horizonte in Minas Gerais, on Saturday afternoon. The next day, Brazil's Foreign Ministry said in a statement that it was seeking answers from Washington regarding the "degrading treatment" of nationals during the recent flight. It cited "the use of handcuffs and chains, the poor condition of the aircraft, with a broken air conditioning system, among other problems." The US Embassy declined to comment and the US Immigration and Customs Enforcement agency didn't

comment. It was unclear whether the 88 Brazilian deportees were taken into custody during the tenure of President Donald Trump, who took office January 20, or former President Joe Biden. There have been almost four dozen deportation flights from the US to Brazil over the past three years.

## Kim inspects N- facility as Pyongyang pressures Trump administration

Seoul (pti): North Korean leader Kim Jong Un inspected a facility that produces nuclear material and called for bolstering the country's nuclear fighting capability, state media reported on Wednesday, as the North looks to increase pressure on the United States following the inauguration of President Donald Trump.

Kim's visit suggests a continued emphasis on an expansion of North Korea's nuclear arsenal, though Trump has said he's willing to talk to Kim again to revive diplomacy. Many analysts view North Korean weapons moves as part of a strategy to win sanctions relief and political concessions from the United States.

The official Korean Central News Agency reported that Kim visited the nuclear-material production base and the Nuclear Weapons Institute. It didn't say where those facilities are located, but North Korean photos of Kim's visit indicated that he likely visited a uraniumenrichment facility that he went to last September.

That visit was North Korea's first disclosure of a uraniumenrichment facility since it showed one to visiting American scholars in 2010. During the latest visit, Kim said North Korea reported "amazing" results in its production of nuclear material last year and underlined the need to exceed this year's production goal to strengthen "the nuclear shield

of the country", according to

invariable noble task" to cope

with intensifying challenges posed by "hostile forces", an apparent reference to the US

and South Korea. The start of Trump's second term raises prospects for the resumption of diplomacy between the United States and North Korea, as Trump met Kim three times during his first term. The Trump-Kim diplomacy in 2018-19 fell apart due to wrangling over US-led economic sanctions on North Korea, and Kim has since significantly dialled up weapons testing activities.

During a Fox News interview broadcast on Thursday, Trump called Kim "a smart guy" and "not a religious zealot

Asked whether he will reach out to Kim again, Trump replied, "I will, yeah." North Korea hasn't yet directly responded to Trump's overture as it continues its belligerent rhetoric against the US along with weapons testing activities Many experts say Kim could eventually sit down for talks with Trump and would likely think he now has greater leverage than before because of his enlarged nuclear arsenal and deepening military ties with

Russia. On Sunday, North Korea said it tested a cruise missile system, its third known weapons display this year, and vowed "the toughest" response to what it called the escalation of US-South Korean military drills. North Korea views US military training with South Korea as invasion rehearsals, though Washington and Seoul have repeatedly said their drills are defensive in nature.

## Western officials warn Ukraine Scholz's challenger presents tough over weapons dispute

Western officials have warned Ukraine that an escalating rift between the defence minister and procurement chief may jeopardise trust in the country and urged the government to resolve the situation quickly so as not to disrupt weapons supplies.

The conflict began last week when the Defence Procurement Agency's board unanimously voted to extend director Maryna Bezrukova's contract for another year. However, Defence Minister

Rustem Umerov overruled the decision, refusing to renew her contract. He accused her of poor performance and failing to deliver weapons and ammunition to front-line troops

The decision provoked an outcry from lawmakers and anticorruption watchdogs who said the minister's move was illegal because Bezrukova had her contract extended by the agency's supervisory board in January. They also came to Bezrukova's defence, saying she has been instrumental in creating greater transparency and reforms within the DPA, which has long faced corruption alle-

Under Ukrainian law, Umerov's decision to go ahead with her dismissal is illegal. The incident comes at a politically sensitive

Merz put migration in the focus of the campaign following a knife attack a week ago in the Bavarian city of Aschaffenburg by a rejected asylum-seeker, which left a man and a 2-year-old boy dead. Germans will vote for a new parliament on February 23 after Scholz's three-party governing coalition collapsed. Polls show Merz's mainstream centre-right Union bloc in the lead with around 30 per cent support, the far-right Alternative for Germany second with about 20 per cent, and Scholz's center-left Social Democrats and the environmentalist Greens further back. Migration was already a significant election issue alongside Germany's struggling economy. Merz's aim appears to be to make the Union look decisive in seeking a tougher approach, which also has been a central call of Alternative for Germany,

or AfD, while making Scholz and the Greens look weak. It's uncertain whether the move will bolster his position.

Merz said last week that if he becomes chancellor, he would order the Interior Ministry immediately to control all Germany's borders permanently and "turn back all attempts at illegal entry without exception", including by asylumseekers

He said that people who are supposed to leave the country must no longer be let go if picked up by police. The conservative leader, who mav well have to form a coalition with

centre-left parties to become chancellor, insisted that "compromises are no longer possi-

He then announced that he would bring motions including those pledges to parliament this week, "independently of who approves them" — in other words, regardless of whether they need AfD's support to gain a majority. Wednesday's expected votes

are on non-binding motions, which would send a political signal, but not change German law. On Friday, proposed legislation from the Union on less drastic changes to migration rules is set to go to a vote. The Social Democrats and Greens, the parties in the remaining minority government, argue that Merz's calls to turn back people at the border on a large scale are incompatible with German and European Union law.They plan to oppose his motions Wednesday, but they could pass with support from a combination of opposition parties, including AfD. They accuse Merz of breakt page. standing promises not to work directly or indirectly with AfD, which has long urged other parties to abandon their "firewall" against it. Merz insists that his position remains unchanged - his party won't approve any AfD motion, go into government or work with it, or nego-

tiate on any motions with it. And he argues that his aim is to gain support in the political center. The Aschaffenburg attack followed knife attacks in Mannheim and in Solingen last year in which the suspects were immigrants from Afghanistan and Syria, respectively — in the latter case, also a rejected asylum-seeker who was supposed to have been sent to Bulgaria, where he first entered the EU.In last month's Christmas market attack in Magdeburg, the suspect is a Saudi doctor who had come to various regional authorities' attention in the past.Merz says Germany has had a "misguided asylum and immigration policy" for a decade - since Angela Merkel, a chancellor from his own party, allowed large numbers of migrants into the country. The outgoing government says much changed already. It instituted temporary controls on all of Germany's borders. It says it has tightened many laws, for instance to ease deportations, and points to a yet-to-be-implemented agreement on revamped EU migration rules. Authorities say 229,751 people applied for asylum in Germany last year, a 30 per cent decrease from the previous year. There were 18,384 deportations in the year's first 11 months, compared with

A senior Pakistani official confirmed the development on Tuesday but emphasised the move was too little to address the country's long-standing concerns, the Express Tribune newspaper reported.

It is believed that the latest move by the Afghan Taliban came after the United Arab Emirates (UAE) nudged the Kabul administration to address Pakistan's concerns over the terrorist hideouts, the paper said.

Taliban's acting interior minister, Sirajuddin Haqqani, along with the Taliban intelligence chief recently travelled to the UAE and held talks with the Gulf country's leadership. Ahead of their visit, a Pakistani delegation also visited the Gulf country as part of efforts to address the issue of TTP, the paper said. There was no official confirmation from either side about the development and potential role being played

Besides, another 20,000 family members have taken refugees across the border. In view of this large number, the relocation of a few hundred family members of the TTP was not the answer to Pakistan's demand, according to another official.

The decision was taken at a meeting of the Cabinet Committee on Economic Affairs (CCEA) chaired by Prime Minister Narendra





## Smith scores his 10,000th test run

Oteve Smith scored his 310,000th test run to put him in elite cricket company and Australia was 145-2 after winning the toss and batting Wednesday in the first test against Sri Lanka.

Smith needed only one run Wednesday to achieve the milestone, and he was 2 not out at lunch along with opener Usman Khawaja, who was unbeaten on 65. Smith was on 9.999 career test runs when he was dismissed in the fifth Australia-India test in Sydney earlier this month.

Smith became the 15th player in test cricket, and fourth Australian, to score 10,000 runs in a career. He brought up the milestone on his first delivery, skipping down the wicket and punching a single to mid-on. Ricky Ponting (13,378), Allan Border (11,174), and Steve Waugh (10,927) are the other Australian batters to have scored 10,000 runs in a test career. Sachin Tendulkar is the leading all-time test scorer with 15,921 runs.

in local competitions. Amiri and Nahida Sapan, who will captain the Afghanistan Women's XI, thanked the Australian government and Cricket Australia for their support in promoting women's sport.

"It's very special for all of us to get back together after three years, leaving everything and losing everything back home in Afghanistan and come together again," Amiri said this week.

Amiri was forced to flee her home country when the Taliban took control. She and her family first traveled to Pakistan and then were evacuated to Australia.

"I also want to express deepest gratitude for everyone who support us. Your support means the world to us," Sapan

"Together we are said. building not just a team. We are building a movement for change and improvement.

"This is a very historic moment for all of Afghan women. This match can open doors for Afghan women for education, sport and our future." Sapan told the BBC in 2023

## Tilak Varma rises to second spot in ICC T201 Rankings

◀alented India batter Tilak Varma climbed one spot to second, while mystery spinner Varun Chakravarthy made a massive leap of 25 places to break into the top five in the latest ICC men's T20I rankings released on Wednesday.

Varma now sits just behind Travis Head in the batters' list, with the Australian maintaining a 23-point

lead at the top.
The young Indian left-hander has been in sublime form, posting scores of 19 not out, 72 not out, and 18 in India's ongoing T20I series against England.

With two matches remaining in the series, Varma has a chance to overtake Head and become the youngest-ever player to top the rankings -- a record currently held by Babar Azam, who reached No. 1 at the age of 23 years and 105 days. Varma's current rating of 832 points is the fourth-highest ever achieved by an Indian batter in T20I history, behind only Suryakumar Yadav, Virat Kohli, and KL Rahul.

India's Abhishek Sharma also made



places to 40th, while England's Liam Livingstone (up five spots to 32nd)

and Ben Duckett (up 28 places to Chakravarthy's rise 68th) were the biggest gainers from the visiting team.

Chakravarthy's magical 5/24 in India's 26-run loss in the third T20I propelled him to top five in the T20I bowling rankings.

Meanwhile, fellow spinner Axar Patel moved up five places to 11th, just outside the top 10.



## Jerry Holness joins as Indian women's 400m relay coach

 $R^{\text{enowned}}_{\text{athletics coach Jerry Lee}} \ \, \text{Jamaican}$ Holness, who has mentored the likes of multiple Olympics and World Championships gold medallist sprinters Elaine Thompson and Nesta Carter, has taken charge of the Indian women's 400m team ahead of some high-profile events coming up this year.

Holness, a highly-experienced and much travelled coach, joined the National Centre of Excellence (NCoE) at the Lakshmibai National College of Physical

Thiruvananthapuram, Kerala, on Monday.

"Holness has joined at NCoE Thiruvananthapuram. He is a highly experienced World Athletics Level 5 coach. He has coached some of the best in Jamaica including Olympic and World Championships medallists," Indian athletics chief coach Radhakrishnan Nair told PTI.

"He will take charge of the Indian women's 400m and 400m hurdles team which is currently based Thiruvananthapuram," added.

Holness' tenure will be up to 2026 initially and can be extended after an evaluation of his performance.

He will be coaching the likes of Hima Das, Subha Venkatesan Rupal, Kiran Pahal and Vithya Ramraj at Thiruvananthapuram.

The 65-year-old Jamaican replaced Stashuk Valerii who was Indian women's 400m and 400m hurdles coach till the Paris Olympics.

"Since the Indian women's 400 team did not do well in the Paris Olympics, SAI did not want to renew his contract. Valerii has left after the Paris Olympics, so SAI wanted a new coach," Nair said from Thiruvananthapuram. important have
