Women's participation in Indian stock markets is rising since year 2022 (CY22), says a report by the National Stock Exchange (NSE).

The report indicates that women's share in new individual investor registrations has been gradually increasing, reaching just below 25 per cent as of December 2024. It said "Female participa-

tion in individual investor registrations has shown a gradual increase since CY22. to slightly shy of a quarter as of December 2024".

Among major states, the report noted that Delhi (30 per cent) has the highest female representation in stock market participation, followed by Maharashtra (28 per cent) and Tamil Nadu (27.7



per cent). These states have a higher share of female investors than the national average of 24.1 per cent in CY24.

However, some states still lag in terms of women's participation. Bihar (15.6 per cent), Uttar Pradesh (18.4 per cent), and Odisha (19.7 per cent) recorded a female investor base below 20 per cent of

total individual registrations in their respective regions.

Despite these regional differences, the overall trend suggests that more women are stepping into the financial markets, improving gender inclusivity in India's stock market ecosystem.

India's services growth hits 26-month low in January, but hiring rises

India's services sector expanded at its slowest pace in over two years in January 2025, as new business growth weakened and demand momentum softened, according to the HSBC India Services PMI data released on Wednesday.

However, job creation saw a notable uptick and business sentiment remained positive despite heightened cost pressures.

But, despite the slowdown, the HSBC Services PMI data suggests that India's services sector remains resilient, with solid job creation, strong export growth, and steady business confidence. However, inflationary pressures and rising competition could act as headwinds in the coming

Pranjul Bhandari, Chief India Economist at HSBC, said, "India's services sector lost growth momentum in January, although the PMI remained well above the 50-breakeven level. The business activity and new business PMI indices eased to their lowest levels since November 2022 and November 2023 respectively."

Bhandari added, "That said, new export business partly countered the downtrend and continued to rebound from a dip in late-2024, in line with official data which showed India's services exports shinning in December and capturing a larger share of global trade."

With domestic demand still holding up and global services



trade rebounding, analysts expect the sector to maintain healthy, if somewhat moderated, expansion in the near term.

The seasonally adjusted HSBC India Services PMI Business Activity Index fell to 56.5 in January, down from 59.3 in December, marking its lowest level since November 2022

While this indicated a loss of momentum, the index remained well above the 50-breakeven level, signalling continued growth in

The slowdown was driven by softer increases in sales and output, with new business inflows expanding at their weakest pace in 14 months.

Some companies attributed output growth to strong demand, new client wins, and investments in technology, while others noted that customer numbers had declined due to competitive pres-

Despite the moderation in domestic orders, international sales rose at the fastest pace in five months, with demand strengthening from Asia, Europe, the Middle East, and the Americas.

Inflationary pressures persisted, with rising staff costs and higher food prices pushing up expenses for service providers.

However, cost inflation remained broadly unchanged from December. Companies passed on higher costs to consumers, resulting in a sharper increase in output

However, India's services sector saw a positive acceleration in job creation, as companies responded to sustained demand and increasing workloads. The hiring rate was among the fastest recorded since data collection began in December 2005.

Outstanding business volumes grew for the 37th consecutive month, hitting the highest level since May 2024, indicating that demand conditions remained fundamentally strong.

Service providers remained optimistic about business prospects over the next 12 months, citing

2,500-Year-Old negev burial site reveals ancient trade routes

Archaeologists uncovered a 2,500-year-old burial site in the Negev Highlands, shedding light on ancient trade routes that connected cultures from Yemen, Phoenicia, Egypt, and beyond, the Israel Antiquities Authority announced on Wednesday.

The site, south of Beer-Sheva, contains dozens of tombs believed to belong to individuals from caravans that passed through the region, highlights the Negev's role as an international crossroads during the 7th to 5th centuries BCE.

Archaeologists found copper and silver jewelry, alabaster items used for incense preparation, amulets, beads, and vessels likely used to transport incense resins.

"The discovery is unique and it points to wide-reaching cultural interchange between southern and northern Arabia, Phoenicia, Egypt and southern Europe," said excavation director Martin David Pasternak.

They also found arrowheads made of flint, a material associated with ancient trade from Yemen and Oman, with traces of ochre.



"The presence of ochre on these arrowheads may indicate their religious or cultic significance as having special value," explained Jacob Vardi, an Antiquities Authority specialist in flint

The tombs raise intriguing questions about their purpose and the nature of the trade caravans that used the route.

Pasternak said the tombs could have served as a longterm burial site for caravans passing through the area, or they may mark the mass burial of a caravan that came under attack. Despite their location at a remote junction in the desert, the site's strategic position along key trade routes makes it a plausible resting place for travelers engaged in long and perilous journeys across difficult terrain. These traders were likely involved in the transport of valuable goods such as frankincense and myrrh, prized commodities from southern Arabia

The UAE also continues to explore closer engagement with South American countries, including Argentina, through direct discussions with Mercosur, the South American trade bloc, to enhance market access and trade flows across

Another key observation from the report is the growing dominance of young investors in the Indian stock market. The proportion of investors aged below 30 years has risen

significantly from 22.7 per cent in 2018 to 39.9 per cent in 2024, making them the largest investor group.

This increasing participation of young individuals has changed the demographic pattern of the stock market. The share of mid-aged investors (40-49 years) has dropped from 20.1 per cent in 2018 to 15.6 per cent in 2024. Similarly, the percentage of investors over 50 years has declined from 26.2 per cent to 15 per cent in the same period.

Even the 31-39 age group has seen a decline, though less significant compared to older age groups.

The findings of the NSE report suggest that India's stock market is becoming more inclusive, both in terms of gender participation and age diversity. More young people are taking an interest in financial markets, and women are steadily increasing their participation, contributing to a more diverse and balanced investment environment



DOMESTIC ABUSE: NEED TO PROTECT MALE VICTIMS

ustice consists not in being neutral between right and wrong, but in finding out the right and upholding it, wherever found, against the wrong.". This pursuit of true justice demands that we examine our legal frameworks and societal structures to ensure they serve all members of society, regardless of gender. The alarming rise in male suicides in India, often health issues and the feeling of being trapped in abusive situations without legal recourse, compels us to confront a silent crisis.

National Crime Records Bu-

reau (NCRB) data reveals a disturbing trend: suicide rates in India are alarming, with men disproportionately affected. In 2022, approximately 72% of suicide victims were men, roughly 342 men each day. This escalating trend reflects lives lost, families devastated, and a failure to address the unique pressures men face. Traditional expectations of men play a significant role. Men are often pressured to be providers, strong, and stoic. Showing emotion is perceived as weakness, and seeking help is considered a sign of failure. This toxic enlinked to untreated mental vironment discourages men

from expressing emotional pain, leading to silent suffering that can culminate in suicide. Men facing mental health issues like depression and anxiety often encounter judgment and ridicule instead of support. They are told to «toughen up» instead of receiving necessary help. This pressure is frequently compounded by financial worries, relationship problems, and job stress.

While various factors contribute to suicide, the gender aspect cannot be ignored. Societal expectations for men, coupled with a lack of accessible mental health support, create a dangerous situation. Legal frameworks, while often wellintentioned, can overlook men>s struggles, particularly with domestic abuse. While laws rightly protect women, men can also be victims of physical, emotional, and psychological abuse. Current laws often fail to recognize this, leaving male victims without recourse. This lack of legal protection can amplify feelings of helplessness and despair, contributing to high suicide rates. Furthermore, its often seen that even relatives of the husband, who don>t even reside in the shared household, are implicated in cases of harassment. This misuse of the law further complicates matters. Therefore, gender-neutral

Enacting these laws is only the first step. Effective implementation and enforcement are crucial. BIG CATS, BIGGER COMEBACK

Established in 2025 with its secretariat in India, the International Big Cat Alliance fosters global collaboration to protect and restore big cat populations.

🗖 n 1967, a 19-year-old Ullas Karanth wandered Lthrough the forests of southern India, his senses assaulted by the cacophony of gunshots and the stark sight of decimated woodlands. The tiger, India's regal predator, was teetering on the brink of extinction. Fast forward to today, and India's tiger population has witnessed a remarkable resurgence, climbing from approximately 2,000 to nearly 3,000 individuals. This resurgence is not merely a tale of numbers but a testament to relentless conservation efforts, scientific innovation, and the indomitable spirit of individuals like Karanth.

THE GENESIS OF A **CONSERVATIONIST**

Originally trained as an engineer, Karanth's journey into wildlife conservation was unconventional. He even ventured into farming before his passion for wildlife led him to the forests. Mentored by the legendary Dr. George Schaller in the United States, Karanth transformed into a leading tiger researcher and conservation zoologist. He pioneered reliable tiger population estimation techniques in India and became a role model for many young, conservation-oriented minds.

INNOVATIONS IN TI-GER RESEARCH

In 1988, Karanth embarked on rigorous fieldwork in the Western Ghats, a biodiversity hotspot in India. By 1990, he was radio-tracking five tigers and three leopards, delving deep into their secretive lives. Later, he introduced camera traps to census tiger populations, deavors and spearheading Thursday found. subsequent conservation efforts. His work provided unprecedented insights into tiger behavior, ecology, and population dynamics.

Karanth's studies revealed that a single tiger kills about 50 prey animals annually, necessitating a prev base of 500 to sustain one tiger.

This finding underscored the critical importance of preserving prey populations and their habitats. He also documented that female tigers hold territories of about 20 km², reach reproductive age at 3–4 years, and can bear 10–15 cubs over their lifetime. However, with a 20% annual mortality rate among adults, maintaining a stable population requires meticulous management.

India doubled its tiger population in a little over a decade by protecting the big cats from poaching and habitat loss, ensuring they have enough prey, reducing human-wildlife conflict, and increasing communities' living standards near tileading the way in both enger areas, a study published

> The number of tigers grew from an estimated 1.706 in 2010 to around 3,682 in 2022, according to estimates by the National Tiger Conservation Authority, making India home to roughly 75% of the global tiger population. The study found that some local com

munities near tiger habitats have also benefited from the increase in tigers because of the foot traffic and revenues brought in by ecotourism.

The study in the journal Science says India's success "offers important lessons for tiger-range countries" that conservation efforts can benefit both biodiversity and nearby communities. "The common belief is that



He once remarked on the "near mystical feeling of anticipating a tiger while soaking up myriad other sounds, smells and sensations," capturing the profound allure that kept him tethered to his mission.

conservation extends beyond individual animals. He emphasizes the need for reserves with minimal human presence, advocating for the relocation of communities to create inviolate spaces for wildlife. Over the past two decades, he has worked with other dedicated conservationists to make impressive strides in human relocations. He has also taken on big business. contributing to the removal of a large mining operation from one reserve, and influenced government policy, such as in methods of tiger censusing.

Karanth also underscores the importance of economic incentives, suggesting that land-use change could favor habitat restoration to advance tourism, thereby benefiting both local communities and wildlife. He notes, "When given the real chance to escape their forced coexistence with tigers to reach towards modernity, people grab it."

INDIA'S CONSERVA-TION MILESTONES

India's commitment to big cat conservation has yielded significant successes:

Asiatic Lions: Once teetering on the brink of extinction, the Asiatic lion ed to 674 individuals as of 2020, marking a 28.87% increase from the previous

Tigers: Through initiatives like Project Tiger, India's wild tiger population has risen to 3,682 as of 2022, accounting for nearly 75% of the global wild tiger population.

Cheetahs: In a historic move, cheetahs have been reintroduced to India after being declared extinct in 1952. The reintroduction began in 2023, with individuals imported from Namibia and South Africa to Madhya Pradesh's Kuno National Park.

Leopards: The Indian leopard population has shown a positive trend, with numbers increasing from 12,852 in 2018 to 13,874 in 2022.

Snow Leopards: The elusive snow leopard, residing in India's high-altitude regions, has an estimated population of 718 individuals, accounting for 10-15% of the global population.







INDEFINITELY WITHOLD VOLUNTARY RETIREMENT WITHHOLD VALID GROUNDS

he Delhi High Court in the case Sandeep Gupta v. Union of India & Ors observed and has ruled that an employer cannot indefinitely withhold voluntary retirement under Rule 56(k) of the Fundamental Rules

The court in the case held that pending vigilance clearance or mere potential inquiries are not valid grounds for withholding retirement.

Further, the court clarified that the employer must communicate any rejection before the notice period expires; else, it would amount to deemed acceptance.

The Division bench comprising of Justice Navin Chawla and Justice Shalinder Kaur was hearing the present matter.

Background of the Case: Sandeep Gupta joined the General Reserve Engineer Force with BRO in the year 1995 as an Assistant Executive Engineer and was promoted to Superintending Engineer in 2017. After nearly three decades of service, he sought voluntary retirement citing health issues and family responsibilities.



Sandeep Gupta applied for it under Rule 48 of the Central Civil Services (Pension) Rules, 1972, the CCS Pension Rules and Rule 56(k) of the Fundamental Rules FRs. However, his request was not processed despite multiple reminders

Aggrieved with the same, Sandeep Gupta filed a writ petition, wherein he argued that his voluntary retirement should be made effective on the expiry of the mandatory notice period. However, the union argued that the Legal Department has to first conduct a 'vigilance clearance', and that pending inquiries against him justified withholding his retirement request.

Arguments before the

Sandeep Gupta argued before the court that he had satisfied all conditions under Rule 56(k) of the FRs.

Sandeep Gupta submitted before the court that under the rule, an employee's right to retire can only be withheld in specific circumstances

(such as being under suspen-

sion or facing a charge sheet). Sandeep Gupta also argued that none of these circumstances applied to his case. Further, citing State of Arunachal Pradesh v. Tai Nikio, and State of Haryana v. S.K. Singhal, wherein he argued that once the notice period ends without the employer's objection, retirement takes effect automatically.

On the other hand, the Union argued that voluntary retirement required 'vigilance clearance' from their Legal Department. They stated that Gupta had been a defense witness in an inquiry against another officer and was also subject to corruption allegations that

could lead to a departmental

inquiry. Thus, a Court of Inquiry, COI had been initiated regarding irregularities in his House Rent Allowance, HRA claims. They argued that until these issues were resolved, processing the retirement request was not

Court Findings:

The court in the case explained that Rule 56(k) of the FRs allows a government employee to retire after giving three months' notice. It noted that the rule permits withholding retirement only if the employee is under suspension, facing a charge sheet, or involved in judicial proceedings for grave misconduct. The court in the case ruled that none of these conditions applied to Gupta.

It has been held by the court that pending vigilance clearance or a potential inquiry does not automatically justify withholding voluntary retirement.

Further, the court noted that an employer must communicate any decision to withhold retirement before the notice period expires.

The court while referring to the case Tai Nikio held that a failure to issue a formal rejection within the notice period

results in deemed acceptance.

The court also reiterated that if an employer intends to withhold permission, it must issue a written order before the expiry of the notice period. Since this was not done, the court ruled that Sandeep Gupta's voluntary retirement had already taken effect.

It has also been held by the court that the union's reliance on pending inquiries was misplaced. The court noted that the Court of Inquiry, HRA irregularities, and corruption allegations were not grounds under Rule 56(k) to withhold retirement. It clarified that the absence of a charge sheet meant that Gupta could not be denied his right to retire. The court while considering the facts and circumstances of the case observed and has directed the union to release Sandeep Gupta's pensionary and retiral benefits within two months.

Accordingly, the court allowed the writ petition.

v State of Kerala expressed concern over the exponential rise in cases relating to outraging a woman's mod-

The bench headed by Justice A. Badharudeen in the case stated that though the law has been strengthened in the matter of sexual offences, the effective implementation of the same should be ensured.

The court stated that, 'The legislature has taken steps to strengthen laws against sexual offences, with stricter deterrents for rape and sexual assault. However, the offences against women continue to be a major problem in India and efforts are still needed to ensure that laws are effectively imple-

Adding to it, the court stated that the Indian Society places greater emphasis on modesty of women and any act that seems to insult the modesty is a matter of serious concern.

The court also stated that

modesty of woman is not limited to physical acts of violence but also includes verbal or non - verbal conduct that is intended within the ambit of assault or crimi-

modesty, says it includes her 'moral

and psychological' modesty

The court in the case stated that these acts takes a toll on the women and causes them mental and physical agony. Thus, it went on to describe that modesty is not just physical, but there are moral and psychological attributes of it. The sense of bashfulness or shame a woman feels when she is subjected to an act that outrages her modesty is moral modesty. The psychological modesty is her innate sense of self-respect and dignity.

The petitioner in the case were convicted under Section 354 (assault or criminal force to women with the intent to outrage her modesty) read with Section 34 (acts done by several person in furtherance of common intention) of the Indian Penal Code, IPC and was sentenced to 6 months of rigorous imprisonment. The allegations were that the petitioners got into the autorickshaw in which the victim and her kid was offence of outraging the travelling. In the auto while travelling, one of the accused pressed on her left breast and other caught her belly. While the victim was screaming, she got a call from her mother. She pressed the call button and her mother heard her cry.

The petitioner appealed the verdict and their sentence before the Appeal Court.

The Appeal Court affirmed the order of the trial court The petitioners subsequently approached the High Court.

The main argument of the petitioner was that the conviction was based mainly on the evidence given by the victim and her mother.

The petitioner submitted before the court that there were no independent wit-

The court rejected the said argument by saving that the testimony of an injured witness, if wholly reliable, can be accepted and the absence of an independent witness is not fatal to prosecution.

The court while considering the facts and circumstances of the case observed that the victim's version was consistent and was not shaken during cross-exami-

Delhi High Court upholds dismissal of Pay Clerk (CRPF) charged with financial misconduct and forgery

The Delhi High Court in the case Sunil Kumar Singh v. Union of India observed and has upheld the dismissal of a Pay Clerk (Central Reserve Police Force) who was charged with financial misconduct and forgery.

The court in the case found that tampering with government records and misappropriation of funds constituted grave offenses that warranted his dismissal from service.

The court rejected the petition filed for compassionate allowance under Rule 41 of CCS (Pension) Rules, 1972, wherein it is held that acts involving moral turpitude disqualified the employee from such benefits.

The Division bench comprising of Justice Navin Chawla and Justice Shalinder Kaur was hearing the present mat-

Background of the Case: Sunil Kumar Singh was a Pay Clerk in the 103rd Battalion of the Rapid Action Force, Cen-



was initially recruited as an Assistant Sub-Inspector in 1994, he worked at several locations before being posted in the 103rd Battalion in 2004. Therefore, he had faced disciplinary action multiple times in his service.

In 2006, he was suspended and was subjected to an inquiry for alleged misconduct, but the charges were dropped. However, in 2009, he was charged again for financial irregularities and misuse of official authority. six charges were leveled against him, which includes misappropriation of funds, tampering with government records, falsifying muster rolls, etc. This

Therefore, he also applied for compassionate allowance under Rule 41 of the Central Civil Services (Pension) Rules, 1972. This request was denied due to his dismissal on the grounds of moral turpitude. Aggrieved with the same, he filed a writ petition seeking reinstatement and compas-

It has also been argued by him before the court that the as it ignored his long service

The court referred to the case State of Jharkhand v. Iitendra Kumar Srivastava. wherein he argued that he is entitled to compassionate allowance despite dismissal. On the other hand, the Union of India argued that Sunil Kumar Singh had committed severe financial misconduct, that included misappropriation of funds and tampering with official records.

The Union of India also submitted that the inquiry was conducted fairly, and followed the principles of

State of Punjab and another observed and has stated that to establish the offence of mischief under Section 425 of Indian Penal Code, IPC there must be an intention to cause damage to propin diminishing its value. The bench headed by Jus-

tice Manisha Batra in the case stated that, 'It being clear that the main ingredient of offence of mischief is that there must be intent to cause wrongful loss or damage to the property and with that intent, destruction and damage should be caused resulting in diminishing the value or utility of some property. therefore, the mere causing of loss is not enough and criminal intention to cause such loss should also be established. In the instant case,

however, there are bald al-



legations in the complaint damaging a paddy field by erty and that should result that the petitioner had set setting stubble on fire. the paddy waste or stubble on fire without producing any material on record to show so.'

Adding to it, the court stated that, 'The mere causing of loss is not enough and criminal intention to cause such loss should also be established.'

The court in the case noted that the alleged victim's plight due to delay by

Police in registration her FIR. Adding to it, it has been stated that the victim being a minor girl of 13 years, who was victimized by the accused. Despite the fact that on the basis of serious allegations FIR has been registered and statement of the victim was recorded yet no action is being taken by the police to apprehend the accused. The police in a status report has submitted before the court that the investigation is being conducted, non-bailable warrant is issued and proceeding for issuing Look Out Circular has been initi-

ated against the accused. The court stated that, 'Perusal of both the status reports shows that the police has failed to take effective steps after the registration of FIR on July 26, 2024.' The court in the case observed and has found that the procedure provided under Section 193(2) of the BNSS, 2023, which mandates that investigation in relation to an offence under Section 64, Section 65, Section 66, Section 67, Section 68, Section 70, Section 71 of the Bharatiya Nyaya Sanhita, 2023 or Section 4, Section 6, Section 8 or Section 10 of the Protection of Children from Sexual Offences Act. 2012 shall be completed within two months, has not been complied with by the police, since the investigation has not been completed within stipulated period of two months and till date the accused has also not been apprehended. Adding to it, the court stated that reluctant conduct of police in the investiga-

tion and apprehending arrest of the ac-

cused, leads the Court to infer that the

jurisdictional police authorities and senior officers of the police are shying away to perform their duties to ensure arrest of the accused, who has committed a heinous crime against a minor girl of 13 years and the society at large.

The court also noted that 'no tangible efforts have been made to ensure arrest of the accused, since the status report dated January 16, 2025 reflects that after presentment of the Challan before the trial court on January 16, 2025", the Court said that "writing a letter to the passport authorities on January 23, 2025 and fetching Bank Account details of the accused just to cover the irregularities in the investigation, whereas, such steps, which have now been taken at this fag end, should have been taken at initial stage of investigation to ensure arrest of the accused and not after presentation of Challan. stated that, 'The subject matter

Communist Party of India (Marxist) leaders Brinda Karat and Prakash Karat on Wednesday cast their votes in the Delhi Assembly polls.

Speaking to ANI, citing her concern about the city's governance, Brinda Karat emphasised the need to protect Delhi from what she called a "double-engine disaster," implying the BJP's central and state governments. "We need to keep Delhi safe from the double-engine disaster and we have voted keeping that in mind," she said.

Her husband, Prakash Karat, echoed similar sentiments, stating that the only issue in Delhi is that the elected government is not allowed to function due to interference from the central government and the Lieutenant Governor. He asserted that the elected government should have the right to function without hin-



"There was only issue that the elected government in Delhi was not allowed to function. We have voted against the centre's and the LG's interference... The elected government should have the right to function," he said.

Polling for 70 assembly seats of Delhi and by-polls for two seats, one each of Tamil Nadu and Uttar Pradesh began on Wednesday morning. Voting commenced at 7.00 am today.

A voter turnout of 19.95 per cent was recorded till 11 am on Wednesday in the single-phase Delhi assembly elections, as per the Election Commission of India.

According to the ECI, the highest turnout was recorded in the North East district with 24.87 per cent among all districts of the national capital followed by the Shahdara district with 23.30 per cent while the Central district recorded the lowest turnout of 16.46 per cent

A total of 699 candidates are in the electoral fray on the 70 assembly constituency seats of the national capital.

In Delhi, the prominent contested constituencies include New Delhi, Jangpura, Kalkaji, Ohkla, Mustafabad, Bijwasan, Kasturba Nagar, Greater Kailash, Patpargani, etc.

These elections are highstakes elections for AAP, BJP and Congress, as, AAP is hoping to retain its power for the next term while the BIP is eyeing to regain power after almost 27 years.

'Most disturbing statistic': Jairam Ramesh on faculty vacancies at AIIMS

Congress MP Jairam Ramesh raised alarm over the reported significant faculty shortages at AIIMS institutions across India, pointing out that the vacancies were "staggering." In a post on social media

platform X, Ramesh highlighted the figures revealed in a recent response to a question asked in the Rajya Sabha.

"Yesterday, an answer to a question asked in the Rajya Sabha of the Minister of Health & Family Welfare revealed a most disturbing statistic relating to the seven fully operational AIIMS institutions in the country," Ramesh said, listing the vacancy rates



for AIIMS New Delhi, Bhopal, Bhubaneswar, Jodhpur, Raipur, Patna, and Rishikesh, all ranging from 24% to 39%.

Ramesh also noted the faculty shortages in twelve cities with partially operational AI-IMS-type institutions, listing vacancy percentages as high as 59.5% in Rajkot and 54% in Bilaspur. He pointed out that these numbers not only highlight the challenges in faculty

recruitment but also question the quality of faculty at these institutions

Ramesh emphasized that while concerns about faculty quality persist, the sheer extent of these vacancies demands immediate government attention.

He wrote, "Quality of faculty apart - although questions have been raised about it - the extent of vacancies in faculty positions is staggering. What is most surprising is the position in the most prestigious AIIMS New Delhi itself, which in many ways is the mother institution. The health minister must give this the highest priority without diluting standards.

The Ministry of Health &

Family Welfare, in its response, had stated that creation and recruitment is a "continuous Process".

The response states, "In order to expeditiously fill vacant sanctioned positions in various AIIMS, steps have been taken by the Government."

These include conducting the Centralized Nursing Officer Recruitment Common Eligibility Test (NORCET), the Common Recruitment Examination (CRE) for Group B and C non-faculty positions, and the Institute of National Importance Combined Entrance Test (INI-CET) and Super Speciality (INI-SS) exams to recruit Junior and Senior Residents across AIIMS.

Bomb threat emails spark panic in Noida schools, police confirm hoax
