Union Finance Minister Nirmala Sitharaman has said that Goods and Services Tax (GST) rates will be reduced further as the process of rationalising tax slabs is nearing completion.

Mrs Sitharaman said that the revenue neutral rate (RNR), which was 15.8 per cent when GST was introduced in July 2017, has now come down to 11.4 per cent in 2023 and will decrease further.

Darjeeling Police arrest key suspect in 2017 cop killing case linked to Gorkhaland agitation

In a major breakthrough, **Darjeeling Police arrested** Prakash Gurung, a key suspect in the 2017 murder case of police officer Amitabha Mallick. The killing occurred during a volatile phase when the Gorkha Jana Mukti Morcha (GJMM), led by Bimal Gurung, had reignited its demand for a separate Gorkhaland state.

Prakash Gurung, currently associated with the Indian Gorkha Janshakti Front (IGJF) led by Ajoy Edwards, was apprehended on Saturday and produced before the court today. The court has remanded him to 14 days of judicial custody.

The murder case, which sent shockwaves through the region, saw Darjeeling

The superintendent of the hospital, Dr Abrojit Mukherjee, said that with the installation of the new equipment, the Serampore ESI hospital has become one of the most upgraded hospitals in the district. Patients can now avail themselves of advanced surgeries, treatments and tests completely free of charge.

The installation of a microtome will aid in conducting histopathology, allowing patients to have biopsies performed here. Laparoscopic surgery is now available, and vasectomies and gall bladder operations can be conducted within a short timeframe. The C-arm machine, used mainly in surgical procedures including orthopaedic, cardiac and vascular surgeries, now allows patients to get knee and hip replacements.

Dr Mukherjee added that an emergency observation ward has been set up to keep patients under observation to ascertain the nature of treatment required. A dialysis unit will also be established soon.

Swarming of jellyfish along Digha coastline sparks concern

A zoologist has expressed concern about the recent appearance of large numbers of jellyfish along the Digha coastline, suggesting it may indicate a significant anomaly in the deeper ocean.



ulations in Digha and the eastern coastal regions, stated: "In Digha, such swarming is not a regular occurrence. My team and I patrolled the Shankarpur and Digha areas during a survey last week but did not observe any swarms." Ms Purushothaman added: "We will, however, investigate this report of a swarm." Regarding the role of jellyfish as bio-indicators, she told The Statesman: "Some species do indicate anomalies in the sea. In the Digha coastline, they are sometimes found between November and February." After a preliminary observation, she suggested: "The current specimens appear to be Acromitus Flagellatus jellyfish." In 2002, scientists identified numerous Crambionella Annandalei, a scyphozoan jellyfish, caught in local fishermen's drag nets. In 1993, a cluster of dead jellyfish was found on the beach in Old Digha. Some experts suggest that their swarming potential increases as they find Digha and the Sunderbans suitable breeding grounds. "As they are saline water inhabitants, they sometimes enter estuarine areas with the intrusion seawater," of Ms Purushothaman explained.

"My initial thought was that the creatures had been carried to the shore by ocean currents, particularly during storms or tides, which might have pushed them towards the coastline near the Science Centre," said Subhas Chandra Dutta, headmaster of Kanchannagar D N Das Institu-

Jellyfish are unable to resist tidal currents and typically die quickly after being washed ashore. Mr Dutta stated, "They are considered bio-indicators, and their swarming on beaches strongly suggests disturbances in the sea, such as water heating, microplastic pollution, marine ecosystem degradation, anthropogenic disturbances, or even signs of an impending earthquake.'

He added: "The day after we observed them, Digha recorded a 5.3 magnitude earthquake on the Richter Scale in the early morning, with the epicentre located 23 km deep in the Bay of

Bengal." Notably, jellyfish are essential components of the delicate underwater ecosystem and provide numerous benefits to other marine life.

The Digha coastline has long experienced jellyfish swarms, especially during winter and hot summer days. These swarms often hinder the local fishing community during their harvest. Nepal Chandra Ghosh, former Deputy Director of the Zoological Survey of India, authored a 1984 research paper titled "Swarming of jellyfish affecting Fishery in Sunderban areas."


Mr Ghosh told The Statesman: "My observations in

the Sunderbans revealed that these creatures clogged fishing nets, weighed them down with their mass, and frequently tore the expensive nets." Like Mr Dutta, Mr

Ghosh also noted: "Ninety per cent of jellyfish are venomous, with venom stored in the stinging cells (cnidoblasts) located at the base of their tentacles."

However, the question remains ~ why do jellyfish swarm towards the coastline? Is it a result of unusual oceanic developments or a natural occurrence? Jasmine Purushothaman, Senior Protozoologist with the ZSI, Kolkata, who conducts ongoing research on jellyfish pop-



First body recovered in Srisailam Left Bank Canal tunnel accident

Body of one of the workers was found trapped in TBM; three more suspected to be buried nearby

n a breakthrough, the body of one of the eight trapped workers was found trapped in the tunnel boring machine (TBM) at the accident site of the Srisailam Left Bank Canal (SLBC) tunnel in Nagarkurnool district of Telangana, 16 days after the roof collapsed, leaving it waterlogged and filled with slush. The cadaver dogs of the Kerala police were brought in once again today, and the body was found with their assistance.

Rescuers late in the night out the body and sent it for postmortem examination at Nagarkurnool hospital. The body is suspected to be of Gurpreet Singh, the tunnel

Family members of the trapped workers are anxiously waiting at Achampet, a nearby town in the Nagarkurnool district.

Three more workers are suspected to be buried nearby, as indicated by the cadaver dogs as well as the images from the ground penetrating radar.

However, digging out the remains poses tough challenges not only because of the advanced state of decomposition of the bodies but also because the last 50 metres of the tunnel is quite unstable due to the seepage of water. The scientists from the Geological Survey of India warned the rescue team about the risk posed by the tunnel. The metal debris, slush, and lack of oxygen

made rescue difficult.

Rat miners and workers of the Singareni Colliery were engaged in the task of retrieving the bodies buried under slush and metal debris of the TBM machine. Two engineers and six workers were trapped when the accident occurred on 22 February inside the 14-km-long tunnel.

Two cadaver sniffer dogs, Maya and Murphy, of the Belgian Malinois breed, along with 157 rescue team workers and technical experts, went into the tunnel this morning. The dogs were flown in on an army helicopter on 7 March from Kerala after all efforts to trace the trapped workers proved futile since they can sniff out decayed remains buried deep under the earth.

Karnataka govt to step up security at tourist spots after gang rape of foreign tourist

LAKSHMANA VENKAT KUCHI **BENGALURU, 9 MARCH**

Aware of the adverse impact of the horrific rape of a foreign national and a domestic homestay owner in Koppal on tourism, Karnataka Home Minister G Parameshwara on Sunday said security will be stepped up at all tourist attractions in the state. The government will also be coming out with a detailed advisory for the tourists, containing the dos and don'ts to help them stay safer.

The ghastly incident, in which three inebriated youth, attacked a group of domestic and foreign tourists stargazing on the banks of Tungabhadra left bank canal—attacking three men and throwing into the canal before raping two women, an Israeli tourist and a domestic homestay owner has left people shocked.

The murder and rape took place on Thursday night on the road to Jangli village, near

Sanapura Lake—a tourist destination in Gangavathi taluk-adjacent to Tungabhadra's left bank canal, located some 350 km from Bengaluru.

While the American and Maharashtrian tourists climbed out of the canal, another tourist, Bidash, could not be found and later his body was recovered.

The incident has not only shaken up the people at large, but has also damaged the image of Karnataka as one of the peaceful tourism destinations in the country.

Disturbed by the incident and its negative impact, the government reacted swiftly. State Home Minister Parameshara told media persons that the government has taken the matter seriously and decided to increase security at all tourist spots in the state.


"The state will reassess security measures and strengthen them at tourist places like Hampi. Moving forward, tourists visiting Karnataka will be briefed on the dos and don'ts to ensure their safety," Parameshwara said. Violent crime undoubtedly

has an adverse impact on tourism, the minister said. "On the one hand, we are trying to attract tourists from across the world, while on the other, incidents like this deter them from visiting our country," Parameshwara said.



Affairs wrote: "In the face of another Mandir desecration, this time in Chino Hills, CA, the Hindu community stands steadfast against hate. Together with the community in Chino Hills and Southern California,



Market Reckoning

he Indian middle class has witnessed a financial revolution in recent years. Encouraged by a booming stock market, low-cost digital platforms, and aggressive financial influencers, millions of households have moved their savings from traditional bank deposits to equities. But the recent stock market downturn ~ wiping out nearly a trillion dollars in investor value ~ has exposed the risks of this shift. For many first-time investors, the dream of high returns has turned into an uneasy reality of losses and uncertainty. This market correction is not just a temporary dip; it reflects deeper structural issues. Foreign investors have pulled back, valuations have been stretched, and corporate earnings have been weaker than expected. The shifting global economic climate ~ marked by geopolitical instability, shifting trade policies, and capital outflows ~ has only compounded the problem. Unlike previous market crashes that had clear recovery paths, today's uncertainty makes the middle-class investor particularly vulnerable. At the heart of the crisis is a fundamental misunderstanding of risk. India's middle class has historically relied on conservative savings methods ~ fixed deposits, provident funds, and gold. The rapid adoption of stock market investments, driven by the rise of Systematic Investment Plans (SIPs) and social media influencers, has exposed many investors to volatility without adequate knowledge of how markets function. For years, stocks delivered strong returns, reinforcing the belief that equities were a guaranteed path to wealth. But markets do not move in a straight line. Many new investors, lured by the excitement of financial influencers and WhatsApp stock tips, entered the market without fully understanding the risks involved. Some even borrowed money to invest, chasing short-term gains. Now, as stocks decline, they face painful choices ~ either exit at a loss or wait in hope of a recovery that may take years. For those who have staked their retirement savings or their children's education funds on the market, this downturn has been a rude shock. India's economic challenges have further aggravated the impact of this correction. Middle-class incomes have been under pressure due to slow wage growth and rising inflation. White-collar job opportunities are not expanding fast enough and private investment remains sluggish. In such a scenario, stock market losses are harder to absorb. Unlike wealthier investors who can ride out the volatility, the middle class does not have a financial cushion. This crisis should serve as a lesson in financial literacy. Stock markets are not a shortcut to riches; they require longterm discipline and risk management. Investors must understand that equity investments should only involve surplus funds that are not needed in the short term. Regulatory bodies must step up efforts to curb reckless financial advice on digital platforms that promote high-risk investments to inexperienced investors. Despite the turmoil, there is hope. Market cycles are natural, and corrections eventually give way to recoveries. But for India's middle-class investors, this moment should prompt a more cautious and informed approach to wealth-building. The focus must shift from speculation to security.

apitalism, the 'saviour of the free world,' was touted as an economic paradigm that incentivised effort, encouraged barter and most crucially, brought power back into the deserving hands of the masses of regular, hard-working people. Sadly, many of these objectives have not been achieved. Moreover, capitalism has generated some popular narratives and engendered ways of living and thinking that bear significant reexamination.

Power has once again become concentrated in fewer hands than ever before. A handful of corporate megaliths use their economic clout to stifle competition, effectively discouraging diversity. Additionally, the nonlevel playing field thus created even blunts the pace of their own research, turning innovators into mere mass producers.

For example, a well-known chip manufacturer, once admired for dynamically improving computer processing speeds, lazily plateaued into monotonously releasing slightly better versions of the same chip every year once they gained a sizable monopoly. Some tech mega brands that dominate the market coast comfortably every quarter more on the class consciousness of their loyal users rather than genuine upgrades of their products over time. Even revolutionary technology like the large language models of AI was deeply influenced by market forces. A small cartel controlled the research which was as expensive as it was exclusive. It took a small start-up from China to shake things up. By providing a version that was a fraction of the cost and freely available to everyone, they totally changed the narrative.

Similarly, nowadays, discussions in corporate hospital monthly meetings are as much about the revenues generated by various specialities such as car-

sable when the company happens to downsize and the people who they have neglected at home for years are not exactly waiting for them with open arms. Capitalism persuades you that you must keep putting the details of your life out there on social media, to build your personal brand.

The bigger the 'influencer' you become, the more wealth you could attract. Slowly and surely, rather than products, it is humans who have become the advertisement. We have been persuaded to change our perspective from 'I think, therefore I am' (cogito ergo sum) ~ to 'I influence therefore I am.'

Focus on money/profits contributes to severe lapses of judgement:

Recent news carried stories of immigrants from third world countries deported back from the US. Amongst these were fellow Indians who sold valuable land, gave staggering sums of money to unscrupulous agents, got into debt, risked getting arrested or killed ~ all in the belief that it would improve their monetary prospects in the future in the US. Such is the illusion of success created by capitalism that in makes people leave the priceless comfort of home, family, and friends, and take a difficult gamble on making it big in a foreign land ~ likely after years of more sacrifice and struggle. What is not clearly thought out, is that if the same vast sums of money were invested in the home country itself, the immigrant would have a likely chance of economic success here itself, in some form or another, while simultaneously being on more predictable and familiar territory along with the benefit of familial support. It is a similar desperation for profit that has often brought out the inhumane side of supervisors in charge of factory or agricultural workers. In Beed Maharashtra, for example, you may have read of the harrowing tales of women workers forced by their contractors to undergo hysterectomies (often in unhygienic, unsafe conditions) just so that they do not have to take a day or two off from work during their periods. Rather than promote true merit as envisioned, capitalism has instead somehow spawned an environment where the act of generating profits (by hook or by crook) is itself deemed excellence. There seems to be no end goal with capitalism. Considering the failings of capitalism, it is important to question some of its entrenched narratives. At an individual level, we can surely try and lead our lives on a much broader scale than that envisioned through the narrow pecuniary confines of Capitalism. As far as governments are concerned, they must put humans before banknotes. Much like the land ceilings which got rid of the Zamindari system, regulatory adjustments can put healthy limits on mega capitalism (e.g. no single entity can own more than 10 per cent market share) to encourage other players and strictly monitor monopolies and restrictive trade practices. Not getting unduly influenced by the profit-oriented outlook of capitalism is what will truly enrich mankind.

n the United States in 2011, the US Centers for Disease Control and Prevention issued an instructional guide for how to prepare for a "zombie apocalypse." Coincidentally in April 2011, the US Defense Department issued a "secret" document titled CONOP 8888 otherwise known as "Counter-Zombie Dominance" that provided strategic instructions for how to survive a zombie attack.

You might think that these were produced for fun, but it turns out that preparing for a zombie attack is remarkably similar to preparing for other natural and human-caused disasters. Given the rise in natural disasters due to climate change, continued conflict between North and South Korea and the destabilization of the political climate in the US and globally, it's a good time to review these recommendations.

In terms of the military document, according to a 2011 article in the news publication Foreign Policy, planners in the US Strategic Command in Omaha, Nebraska, wanted to produce a guide for the military to protect civilians in the event of any type of attack.

However, for fear of offending any existing nation or group, they decided to avoid any hypothetical situations involving real entities and opted for planning for a zombie attack. The only risk is that zombies might get mad at the US military. Six phases of military actions are listed. The zero phase is

Tariff Chaos

he recent back-and-forth on tariffs imposed by the US on Canadian and Mexican goods underscores the unpredictability of President Donald Trump's trade policies. Within days of enforcing sweeping duties, the administration has rolled back significant portions, offering targeted exemptions. While this move provides temporary relief for businesses struggling with supply chain disruptions, the strategy remains chaotic, raising concerns about long-term economic stability. At the heart of the issue is Mr Trump's belief that tariffs serve as a tool to protect American industries and bolster domestic manufacturing. However, history has shown that protectionist policies rarely produce intended results. Instead of revitalising local production, tariffs often lead to higher costs for businesses and consumers alike. With complex supply chains crisscrossing North America, duties on raw materials and finished goods inevitably raise prices, making American industries less competitive rather than more resilient. The exemptions granted under the US-Mexico-Canada Agreement (USMCA) reflect an implicit acknowledgment of this economic reality. Critical imports such as automobiles, agricultural products, and potash have been spared from the harshest tariff measures, likely in response to lobbying from industry leaders. Yet, this selective approach does little to dispel the uncertainty surrounding US trade policy. If businesses cannot predict whether tariffs will be imposed or lifted at a moment's notice, planning for the future becomes nearly impossible. Canada and Mexico have responded differently to Mr Trump's maneuvering. Canadian leaders have signaled frustration, with Prime Minister Justin Trudeau warning of a prolonged trade conflict. Mexico, under President Sheinbaum, has taken a more diplomatic stance, opting to engage in negotiations while addressing shared security concerns. These contrasting approaches reveal how Mr Trump's tariff policies are reshaping diplomatic relations in North America. While the US retains economic leverage, its erratic decision-making weakens trust and could push its neighbours to seek alternative trade alliances. The economic consequences of these policies are already visible. Trade volumes between the three nations remain high, but businesses are adjusting their strategies to minimise exposure to sudden tariff hikes. Some firms are accelerating import shipments ahead of anticipated restrictions, while others are exploring ways to claim duty-free exemptions under USMCA. In the long run, these disruptions could incentivise companies to diversify supply chains away from the US, reducing American economic influence rather than strengthening it. Beyond North America, Mr Trump's tariff strategy signals a broader return to economic nationalism. His administration has hinted at expanding trade barriers beyond Canada and Mexico, with promises of "reciprocal" duties on other nations. If this pattern continues, it risks triggering wider retaliatory measures, ultimately harming the very industries tariffs are meant to protect. In the short term, businesses may welcome the recent exemptions as a reprieve from economic turmoil. However, the fundamental problem remains ~ trade policy driven by political calculation rather than economic logic creates instability. As the US moves ahead with its agenda, it must recognise global economic leadership is built on trust and consistency.

Capitalism justifies its own ideas and actions, while blaming others:

The key ingredient to a fruitful business idea, as many executives will say, is 'solving a common problem.' Capitalism sometimes can create a problem, partially solve it to feign progress, and generate a new problem along the way. We notice how big firms in developed nations outsource production to third world countries, availing cheap labour rates and thus increasing their profits. They are welcomed by the official dom in these countries on the premise that jobs are being created locally. However, these jobs are quite basic and often exploitative (underage workers, unsatisfactory working conditions etc.).

Ironically, these profithungry megaliths are not accused of taking away valuable jobs from their own country by outsourcing. Rather, the spotlight falls on foreign immigrants to their country ~ these are blamed for usurping local jobs. In fact, much of the employment taken up by these immigrants is that which local people shy away from doing.

The lenses and metrics capitalism chooses to view overall

Capitalism has somehow normalised the discrepancy between senior managers of companies on business trips being put up at five-star hotels after journeying by business class and masons and bricklayers not getting even a decent dormitory to sleep in when they cross state boundaries to work.

The narratives spawned by

the big fish portray themselves in glowing terms while being a little derogatory about the smaller players. Robust small size enterprises are pejoratively termed 'mom and pop' shops. On the other hand, big conglomerates confer on themselves epithets like 'unicorns,' when they co-

uld well be labelled

'King Kong' enterprises (that destroy others in their path) for example. Likewise, NGOs sourcing funds (to help others) are dismissively deemed to be 'begging' for funds yet regular business companies pitching for funds (for their personal growth and profits) are painted as brave warriors who tamed the 'sharks.'

Capitalism weaves itself into processes and subverts healthy trends:

Capitalism is slowly seeping into various professional ecosystems and modifying them in ways that could be unsuitable. Take the world of medicine for example. Rather than concentrating mainly on professional excellence and service with a smile, corporate hospitals are increasingly focusing on going deluxe. The outcome of hospitals simulating destination resorts comes at the cost of raised tariffs, out of the reach of many.

The content of medical literature is also changing, with the incorporation of heavy amounts of (to my mind) unnecessary economic data. When we were young medical students, the articles written focused chiefly on the disease entity itself. Nowadays, there seems to be a requirement to write about the economic implications of diseases and interventions. Is this necessary? Is the impact on the GDP an appropriate focus for students reading journals to learn the medical nuances of diseases?

Capitalism insists that the financial net worth of an individual overrides everything else:

Well-wishers and professional psychologists alike tell us of the overriding importance of investing time and effort in nourishing our souls, minds, bodies and becoming self-aware. Then along comes capitalism and persuades you that your bank balance overrides everything else. Many companies have a ruthless professional ethos that dictates employees must first and foremost be robust cogs in the professional wheel ~ and family, life, health, and liberty are lower on the rung of importance, firmly below corpo-

"Shape," where the military learns about zombies and supports civil authorities. Phase 1, which is actually the second phase, is "Deter." Phase 2 is "Seize Initiative." Phase 3 is "Dominate." Phase 4 is "Stabilize." Finally, Phase 5 is "Restore Civil Authority." Each of these phases have sections that offer an offensive strategy, defensive strategy and support to civil authorities.

Another might be one that is in your neighborhood. An evacuation plan is also important and multiple routes out of danger are even better. My tip would be to keep your car with a full tank of gas or full battery.

Of course, sometimes the safest place is inside your house. Certainly, we've learned this from movies where the victims lock themselves in a house ("Night of the Living Dead," 1968), missile silo ("Day of the Dead," 1985), shopping mall ("Dawn of the Dead," 2004), apartment building ("Happiness," 2021 or "Sweet Home," 2020), or school ("All of Us are Dead," 2022). Trade with Pakistan can help achieve 2047 goal

rime Minister Narendra Modi wants India to become an advanced nation by 2047, exactly a hundred years after Independence. He came to power in 2014 promising double-digit economic growth in India, which is what he had achieved when he was the chief minister of Gujarat. Ironically, it was the previous government of Manmohan Singh, which over its tenure of 10 years had achieved a 10 per cent average annual growth rate.

But the Singh government dissolved into a miasma of scams and corruption. Growth in 2014, its last year in office, was only about 6 per cent. This is about the average annual growth rate that Modi has been able to achieve in his own 10 years in office.

For the purposes of our analysis, the benchmark advanced country is presumed to be the United States. The United States current nominal GDP per capita (taken as an average of IMF and World Bank figures) is about \$90,000. Because the US economy is utilized as the basis to calculate PPP (purchasing power parity, which takes into account cost of living), its PPP GDP per capita is also \$90,000. It is assumed for this analysis that the US GDP per capita will stay the same, i.e. \$90,000 in 2047. India's current nominal GDP per capita is \$2,500, and its PPP GDP per capita is \$11,000. If India grows at its current growth rate of 6.5 per cent, then its nominal GDP per capita in 2047 will be approximately \$10,000. Its PPP GDP per capita will be nearly \$44,000.

Therefore, at an 8 per cent growth rate, India is getting there.

At a 10 per cent growth rate, India's nominal GDP per capita in 2047 jumps to just above \$20,000 while its PPP GDP per capita balloons to approximately \$90,000, catapulting it into the big leagues.

One will note that even a one or two percentage point change in the growth rate has a tremendous effect on the GDP per capita (both nominal as well as PPP). According to various reports, if India fully resumed trade with Pakistan, it could potentially add a significant amount to India's GDP, with estimates ranging from a one to two per cent boost due to increased job creation, reduced costs, and enhanced trade potential, potentially reaching a bilateral trade volume of up to \$37 billion between the two nations, according to the World Bank.

The current level of trade between the two countries is \$1.35 billion, which is minimal when compared to its true potential. We have in effect frozen trade ties between the two countries. The US and Canada are today erecting trade barriers. Canadian Prime Minister Justin Trudeau has pleaded with the American people that Canadians love them.





100 YEARS AGO OCCASIONAL NOTE

ON all personal grounds there could be no more popular appointment as temporary Governor of Bengal than that of Sir John Kerr, who is so well known to the province. But presumably the Governor of Assam's leave of absence in England was accorded to him for serious reasons, and in any case his presence in England would have been an advantage both to the Viceroy and the Secretary of State at the time when we are told that the Cabinet will be devoting special con-sideration to India. There will, therefore, be general surprise that it should have been thought necessary to cancel His Excellency's leave in order that he should act temporarily as the Governor of Bengal. Bengal is not a service Governor's province, and the normal procedure would have been for the Senior Member of the Executive Council to act as Governor at Darjeeling during Lord Lytton's short absence at Simla. As the Senior Member of the Executive Council is an Indian, the Government must be aware that the departure from routine will be deeply felt. On behalf of the European community of Calcutta we think it may be said at once that if this exceptional course has been taken with some idea of meeting its wishes, there is no justification for such a belief. Political leaders of the European community in Calcutta are certainly amongst the staunchest defenders in India of European interests, but they do not like privilege at the expense of an Indian loyalist. It is not by their wish that Sir Abdur Rahim has been ignored. But we must end as we began by saying that Sir John Kerr is an ideal appointment.

Clearly, a 6.5 per cent growth rate is not enough to catapult India into the league of an advanced nation such as the United States.

At an 8 per cent growth rate, India's nominal GDP per capita in 2047 is about \$14,000 and its PPP GDP per capita is about \$60,000.

That is being economical with the truth. I have lived in Canada, and almost to a man (and woman), I have heard Canadians express their utter disdain for Americans. Yes, Canadians and Americans do not sow terror in each other's territories, nor do they have nukes pointed at each other.

India and Pakistan share a likehate (as opposed to love-hate) relationship. There is much liking for people on both sides of the border, especially in the two Punjabs, but there is intense hatred between the people as well. We have fought wars, have nukes pointed at each other, and Pakistan instigates terror in India. Pakistan claims that India does the same in Pakistan without giving substantive proof.



If India resumes trade fully with Pakistan, then it should increase its growth rate to about 8 per cent. Of course, Pakistan must ensure that there will be no more 26/11s or Pulwamas. Trade will benefit Pakistan a lot. Cost of living will go down substantially, and Pakistanis will gain access to the vast market that is India. It should also defang the hawks in Pakistan who want to destroy India. Both countries should focus purely on the bottom line. China and India are at loggerheads, yet they trade with each other. Trade has kept tensions at bay.

As noted earlier, Modi has only been able to achieve a 6 per cent growth in office as prime minister. Gujaratis are relentless entrepreneurs, focused only on the bottom line. With the right guidance from Modi, they were able to achieve double-digit growth rates. But much of the rest of India is a contented lot, believing firmly in karma. Modi should completely overhaul his government, including the politicians as well as the bureaucrats, if he wants to achieve a 10 per cent growth rate and thereby make India an advanced country.

Much of the effect of the economic reforms established by Narasimha Rao and Manmohan Singh has been stunted by creeping over-regulation. Modi must ensure that he gets the best people in positions that concern the economy. If he can leave power by attaining doubledigit growth, his legacy in Indian history would be cemented.

favourite uncle was a country doctor who lived in a large house next to his clinic. He had a large brood of rambunctious children. He also had a large orchard not far from his home that supplied us with an ample harvest of fruits, apples and peaches, oranges and pears – and mangoes. Mangoes! Delicious, divine mangoes, large and small, yellow and orange and red, the food of gods.

My uncle also had a chef who presided over a big kitchen. Aziz was tall and goodlooking, with graving temples. He shaved irregularly, looking rugged and handsome with a twoday growth. I built a good rapport with him. When I visited him in the kitchen, I was rewarded with a sample of whatever he was cooking. To my disappointment, however, he would never let me try the water-pipe he smoked every evening. His unbending dogma: kids and smoking don't go together.

remember most are the afternoons Aziz would unravel from a large crate that arrived from the orchard a profusion of orange-red mangoes. I and my many cousins would sit around on the floor on mats – not to mess with the dining table – and would be served a snack of three to four mangoes, with the assurance of replenishment the moment we had consumed our share. Invariably, I asked and got more. No words can adequately capture the joy of eating those sweet, succulent mangoes, with the benign assurance that one could have more just by waving a hand.

I have gone round the world eating all kinds of fruits. From apples and apricots, grapes and guavas to pears and peaches, tangerines to watermelon. Even the exotic ones I hadn't tasted in my salad days, cherimoya to canary melon, loganberry to loquat, mamoncillo to minneola, pommelo to pulasan, satsuma to soursop, tamarillo to tangelo. But I must confess to my tribal bias: I am yet to find a fruit that can hold a candle to a trueblue mango.

Admittedly, there are mangoes and mangoes. I am told that mangoes, magnifera indica as it is technically called, is of two broad types, the Indian type and Southeast Asian type. I am no one to talk knowledgeably I loved Aziz's kabobs but what I about their typology, but my inclination is strongly in favor of the Indian variety produced in West Bengal and Bihar in India and Bangladesh. I remember spirited debates with my World Bank colleague, Tom Pereira, who insisted that Alfonso mangoes from his Goan homeland were the best in the world – many agree with him and there are popular ice-cream

brands named after the fruit – but I find its taste initially tempting but cloyingly sweet in the end. My loyalty was reserved for Langra mangoes from eastern India which have a delicious touch of tanginess along with their sweet allure. These golden delicacies were reportedly blessed by a famous priest who was walking-disabled and came to be called Langra, which in Indian languages means a person who cannot amble. My friend Tom claimed that my choice was 'lame' because I chose a fruit with a distinctly inferior taste.

In any event, my dream of Langra mangoes remained a pipe dream for thirty years since no grocery store in Washington, where I lived, had ever heard of decent mangoes. The first time I saw a decent-looking mango in an elite Georgetown store and quickly bought two specimens. I tasted the first slice with great anticipation, then quickly consigned both mangoes to the trash can, so abhorrent was their taste. I had mentioned my longing to a Bangladesh police chief while we were working together in Haiti in the nineties. Ten years later I was returning home to the US from Singapore, but during the stopover in Dhaka four security officers entered our plane and started a search. When I heard my name, I surrendered and was quickly escorted to the airport security office.

There I found the same police chief inviting me with a broad smile.

"When I saw your name in the flight manifest, I remembered your love for Langra. I had a bunch of the best in my office refrigerator, and I felt I must give you a taste the best that Bangladesh has to offer. Don't worry, my staff will reach you back to your plane in time for your flight to Washington."

On a plate in front of me were four shiny golden mangoes, carefully sliced and artfully arranged. They were indeed divine.

HIGHEST PATRIOTISM NOT TO DIE BUT TO **LIVE FOR ONE'S COUNTRY**

Continuing, His Excellency said: — "The young men who are doing work of the kind referred to in this and other reports, are learning the lessons of the highest patriotism, which is to serve. They are laying the firmest foundation on which to build a nation, that is selfreliance. In the literature of all countries in the past, to die for one's country has been represented as the highest patriotism, but there is a higher which has yet to be learnt, and that is to live for one's country. To give health and happiness and life to others may be both more difficult and more honourable than to surrender one's own. A nation cannot be composed exclusively of leaders, for leaders without followers can accomplish nothing. The practical application of this obvious truth must be learnt at school and at college if it is to be learnt at all. What India needs above all to-day is a widespread knowledge of what the nation needs for its health and happiness, and a plentiful supply of men competent to minister to those needs without waiting for direction from above.

"Since I had the pleasure of conferring with the members of your organizations last year, I have myself become more intimately acquainted with two valuable movements which are having a most far-reaching effect upon the public health of the districts in which they operate. The first is the admirable work of the anti-malarial cooperative health societies organized throughout the Province under the inspiration and direction of Rai Gopal Chandra Chatterjee, and the other is the equally remarkable work of the Asansol Mines Board of Health under the direction of Dr. Tomb. I commend these two move-ments to the special notice of your social service students. If you will study their methods, and learn all you can of the remarkable results which they have achieved, you will, I am sure, derive, as I did, both great enlightenment, and immense encouragement.

"I am tempted here to develop somewhat the topic which I dealt with in my convocation address at Calcutta a fortnight ago. I said then that the University would not be doing its duty to the nation to the full, unless the urge of its stimulus reached right down through the school to the villages, and I pointed out that the nationhood of Bengal could not be built on a foundation of widespread illiteracy. I should like to elaborate my meaning here. Is there one person in Bengal who, honestly facing the facts, can believe that, on the present scale of local and provincial taxation, any real advance in either primary or secondary education is possible? I doubt whether any complete system of education, primary, secondary and university, can be introduced at a much less cost than a sum approaching Rs. 300,00,000 per annum, and, even then, it will be far below the level of the advanced countries of the West, or of Japan.

I must say that, in a fast-evolving society like the US, tastes are evolving forever and fast. Now that I live in the gastronomically less-adventurous south, I was amazed to find in a pop-

Tensions escalate in Manipur amid shutdown in Kuki-dominated areas

The unrest followed clashes between protesters and security forces that left one dead and over 40 injured

iolence continued in Manipur for the second day in a row with Kuki-dominated regions of the state witnessing widespread disruptions on Sunday as protesters enforced an indefinite shutdown.

The unrest, particularly intense in Kangpokpi district, followed violent clashes between demonstrators and security forces on Saturday that left one protester dead and over 40 injured.

Demonstrators blocked key roads in Churachandpur and Tengnoupal districts by burning tyres and placing boulders, forcing security personnel to intervene and clear obstructions.

The shutdown left marketplaces deserted, businesses shuttered, and residents confined to their homes as agitators called

for complete participation in the protest.

Additional security forces were deployed in Gamgiphai and along NH-2 (Imphal-Dimapur Road) to prevent further violence.

The protests were fuelled by discontent over Union Home Minister Amit Shah's recent directive asking the state authorities and security forces to ensure unrestricted movement across Manipur, including regions affected by the ongoing ethnic conflict between the Meitei and Kuki communities.

Protesters argue that the directive endangers the safetv of Kuki-dominated areas, and claim it could escalate hostilities rather than ease tensions.

The situation took a violent turn on Saturday with security forces and demonstrators clashing after the latter attacked a state government bus heading from Imphal towards Senapati

Security officials reported incidence of stone-pelting, catapult attacks, and even gunfire from among the protesters, leading to injuries to 27 personnel, including

two critically wounded. In response, authorities resorted to tear gas and other crowd-control tactics, intensifying the chaos.

The Indigenous Tribal Leaders' Forum (ITLF) has voiced strong support for the shutdown, backing the

Kuki-Zo Council in condemning the government's handling of the crisis. It accused security forces of using excessive force to suppress what they described as "legitimate dissent."

The broader ethnic conflict in Manipur that erupted in May 2023 has so far claimed over 260 lives and displaced thousands. The imposition of President's Rule in February was aimed at stabilising the region, yet the violence persists, driven by deep-seated divisions over territorial integrity, resource distribution, and security concerns.

In a bid to curb escalating violence, Governor Ajay Kumar Bhalla had extended the deadline for surrendering looted arms until 6 March. The move was part of broader efforts to foster reconciliation, but with tensions running high, achieving lasting peace remains an uphill battle.

Union home secy reviews security in J&K, LG orders enquiry after killing of 3 civilians by terrorists

In a bid to formulate the strategy to counter the new wave of terrorism in the Jammu region of the union territory of J&K, the Union Home Secretary Govind Mohan chaired high-level meetings with security forces officers here on Sunday.

In a meeting with the top brass of security forces, paramilitary forces and intelligence agencies, he assessed the security situation particularly in the Kathua district that has witnessed a series of terror strikes and civilian killings in recent times.

Kathua district was declared terrorism free a few years ago and revival of militant activities was causing concern among the people and the government.

The Home Secretary's visit follows yesterday's killing of a minor and his two uncles after reportedly being abducted by terrorists from a marriage function in the upper reaches of Bani-Billawar.

On the other hand, Lt. Governor Manoj Sinha ordered a thorough and transparent investigation into the brutal killing of Varun Singh (14) and his uncles Yogesh Singh and

Darshan Singh. "Justice will be ensured and accountability fixed," he wrote on social media platform X.

The Resistance Front, which is an offshoot of the Pakistan based Lashkar-e-Tayaba (LeT) outfit, has reportedly claimed responsibility for the killings.

A complete shutdown was observed today in Bani, Billawar and other adjoining areas of Kathua where the security situation has deteriorated in recent months amid reports that a group of Pakistani terrorists was operating in the higher reaches of the Kathua, Udhampur and Doda districts.

Angry youths on Saturday heckled the independent MLA of Bani, Rameshwar Singh who went to meet the bereaved families at the hospital in Billawar.

This was Home Secretary Govind Mohan's first visit here after taking charge of the Home department. He held two rounds of meetings with the security and intelligence officers engaged in anti-terror operations in J&K.

MUMBAI, 9 MARCH

The Maharashtra government on Sunday categorically rejected the Mumbai Press Club's characterisation of its media monitoring initiative as a "regime of surveillance" or an attack on press freedom.

The government in its response to the Mumbai Press Club's statement has clarified that this initiative is neither about monitoring journalists nor suppressing criticism, but about systematically identifying and correcting misinformation that undermines public understanding.

The government said that the media monitoring centre would analyse news content, not journalists. Its purpose is to identify factual inaccuracies about government activities, not to monitor per-



sonal communications or target media houses.

"When we refer to "negative" reporting, we mean content that is factually incorrect, misleading, or intentionally distorted. Constructive criticism based on facts will never be categorised as negative. Our classification system has clear guidelines based on verifiable facts, not subjective interpretation. Also, the infor-

It further added: "We regularly prepare detailed responses to correct factual inaccuracies in media reports, yet many outlets simply ignore these corrections. This initiative formalises our existing efforts to ensure accurate information reaches the public, regardless of media outlets' willingness to publish corrections."





Two days of clashes, revenge killings in Syria leave over 1,000 people dead

The clashes marked a major escalation in the challenge to the new government in Damascus

BEIRUT, 9 MARCH

The death toll from two days of clashes between Syrian security forces and loyalists of ousted President Bashar Assad and revenge killings that followed has risen to more than 1,000, a war monitoring group said Saturday, making it one of the deadliest acts of violence since Syria's conflict began 14 years ago.

The Britain-based Syrian **Observatory for Human Rights** said in addition to 745 civilians killed, mostly in shootings from close distance, 125 government security force members and 148 militants with armed groups affiliated with Assad were killed. It added that electricity and drinking water were cut off in large

areas around the city of Latakia. The clashes, which erupted Thursday, marked a major

escalation in the challenge to the new government in Damascus, three months after insurgents took authority after removing Assad from power.

The government has said that they were responding to attacks from remnants of Assad's forces and blamed "individual actions" for the rampant violence.

The revenge killings that started Friday by Sunni Muslim gunmen loyal to the government against members of Assad's minority Alawite sect are a major blow to Hayat Tahrir al-Sham, the faction that led the overthrow of the former government. Alawites made up a large part of Assad's

support base for decades. Residents of Alawite villages and towns spoke to The Associated Press about killings during which gunmen shot Alawites, the majority of them men, in the streets



or at the gates of their homes. Many homes of Alawites were looted and then set on fire in different areas, two residents of Syria's coastal region told the AP from their hideouts.

They asked that their names not be made public out of fear of being killed by gunmen, adding that thousands of people have fled to nearby mountains for safety.

Ali Sheha, a 57-year-old resident of Baniyas who fled with his family and neighbors hours after the violence broke out Friday, said that at least 20 of his neighbours and colleagues in one neighbourhood of Baniyas where Alawites lived, were killed, some of them in their shops, or in their homes.

Sheha called the attacks "revenge killings" of the Alawite minority for the crimes committed by Assad's government. Other residents said the gunmen included foreign fighters, and militants from neighboring villages and towns.

"It was very very bad. Bodies were on the streets," as he was fleeing, Sheha said, speaking by phone from nearly 20 kilometers (12 miles) away from the city. He said the gunmen were gathering less than 100 meters from

his apartment building, firing randomly at homes and residents and in at least one incident he knows of, asked residents for their IDs to check their religion and their sect before killing them. He said the gunmen also burned some homes and stole cars and robbed homes.

The Observatory's chief Rami Abdurrahman said that revenge killings stopped early Saturday.

"This was one of the biggest massacres during the Syrian conflict," Abdurrahman said about the killings of Alawite civilians. The previous figure given by the group was more than 600 dead. No official figures have been released. A funeral was held Saturday afternoon for four Syrian security force members in the northwestern village of Al-Janoudiya after they were killed in the clashes along Syria's coast.





The Government has extended the duty-free import of yellow peas by three months till the end of May and clamped a duty of 10 per cent duty on imports of lentils (masur) with immediate effect, according to an official notification.

The government has imposed a 10 per cent import duty on lentils (mosur) and extended the duty-free import of yellow peas by three months till 31 May this year to increase domestic availability of the pulses and keep prices in check.

Khadi products achieve record 12 cr sales at Mahakumbh-2025

The Khadi and Village Industries Commission (KVIC), under the Ministry of Micro, Small & Medium Enterprises (MSME), organized a national-level exhibition during the Mahakumbh from 14 January to 27 February, 2025.

The exhibition recorded historic sales of Khadi products worth 12.02 crore. Manoj Kumar, Chairman

of KVIC, stated that the exhibition featured 98 Khadi stalls and 54 village industry stalls, generating sales of 9.76 crore in Khadi products and 2.26 crore in village industry products.

As part of the 'New Khadi for New India' movement. Kumar distributed 2,050 bee boxes, honey colonies, and



toolkits to 205 beekeepers across six states via video conference from KVIC's Rajghat office in Delhi.

KVIC Chairman Kumar emphasised that, in line with Prime Minister Narendra Modi's vision of expanding the 'Sweet Revolution' across rural India, the 'Honey Mis-

KVIC introduced the 'Honey Mission' in 2017, under which over 20,000 beneficiaries have received two lakh bee boxes and bee colonies to date.

Highlighting the achievements of the Khadi sector over the past decade, Kumar stated that sales of Khadi and village industry products have grown fivefold, from 31,000 crore to 1,55,000 crore.

Khadi garment sales alone have surged sixfold, from 1,081 crore to 6,496 crore, while 10.17 lakh new jobs were created in the last financial year.

He also noted that the income of Khadi artisans has increased by 213 per cent over the past decade, with over 80 per cent of employment in the sector being generated for women.



he National Institute of Technology (NIT), Imphal is one of the 32 such institutes in India. It was established in 2010. The NITs came into being under an Act of Parliament. The NITs, although primarily engineering institutes, offer job-oriented courses and have 50 per cent of the seats reserved for the host states. Initially attached to the campus of the State Government Polytechnic, the NIT Manipur soon set up its own campus at Lamphelpat. But over time, the powers to be controlling the affairs of the NIT, Manipur, began adopting an ad-hoc-ish policy towards recruitment of its staff both in the teaching and non-teaching sections. For instance, 30 faculty members have been employed for more than 10 years in a row. There have been no moves to absorb them through a policy decision, but rather adopted a "we don't care'

attitude and have asked them to appear as fresh candidates, the only relaxation being given that of upper age relaxation.

But again recently when the NIT advertised for the post of assistant professor, it clubbed management and economics together where the questions were divided 50:50. But management and economics are two different disciplines, although there may be sections that overlap each other. However such lapses cannot be condoned since many different faculty members exist in the institute, and how the post was advertised as economics/management is something that the NIT authorities would have to explain. At the moment, there are a total of 30 faculty members functioning on a contractual basis at the NIT. 15 of these teachers have gone to seek solace from the High Court citing rulings of the Supreme Court inter alia regularisation of contractual employees after prolonged

service on ad-hoc basis.

Speaking to The Statesman, one of the contractual teachers said that after having spent 10 years at the NIT and in the process, she has also completed her Ph.D, if she is to be treated as a fresher when it comes to regular appointments, then where is the justice? Also speaking to The Statesman Prof. Tomba Singh, Registrar of the NIT, said that decisions about appointments and recruitments are vested in the hands of the authorities in the Centre and that the panel of selectors includes top echelons of the NIT and from the IITs also meaning that there can be no room for any discrepancies in the selection process. He also added that at the moment there are eight disciplines at the NIT, Manipur, and has a total of 1,500 students on rolls. He also added that there were 800 applicants for 13 posts which were advertised and as such had to resort to a written test followed by a

presentation before the selection board.

When asked if there is any interference from the non-state actors who are active in Manipur and have their fingers in the running of all educational establishments, he said that since construction work ended in 2015, there have not been many disturbances but they do come once in a while to dictate their point of views. The good news is that the NIT, Manipur unlike other centrally run educational institutions in Manipur has not become a den of corruption inviting CBI cases but is failing in its recruitment of its staff both academics as well nonteaching staff many of them who have been languishing for many years and it would be a cardinal crime if the NIT would just throw them into the dustbin.

Saffron blooms in the north-east: Anew dawn for farmers

or years, saffron cultivation in India has been synonymous with the Kashmir Valley, but the North East Centre for Technology Application and Reach (NECTAR) has changed the narrative. Through innovative technology, scientific planning and farmer training, NECTAR has successfully cultivated saffron in the northeast, opening new doors of opportunity for local farmers.

NECTAR's journey into saffron cultivation began in 2021-22 with a pilot project spanning Arunachal Pradesh, Meghalaya, Mizoram and Sikkim.

Using geospatial technology, NECTAR identified 17 potential cultivation sites where saffron could thrive. The initiative, which trained farmers in optimum cultivation practices, has now scaled up to larger projects in Menchukha (Arunachal Pradesh) and Yuksom (Sikkim), where the high-altitude, cold climate closely mimics the traditional saffron-growing conditions of Kashmir.

"Through satellite imaging, we have found many patches in the north-east where saffron can be grown. We started a few pilot projects, and they were successful. Now, per kilogram of saffron is priced at Rs 3 lakh in the international market," said Dr Arun Sharma, director general of NECTAR, in an interview with The Statesman.

Why is the north-east ideal for saf-

for farmers in the region. "NECTAR is helping farmers with value addition to their crops and devising innovative methods to maximise their returns," Dr Sharma added.

Waste to wealth: Banana and pineapple fibre extraction

Beyond saffron, NECTAR has also initiated a project titled "Waste to Wealth – Pineapple and Banana Fiber Extraction", aimed at transforming agricultural waste into valuable resources. Launched officially on 8 September 2022, the project seeks to extract ecofriendly and biodegradable fibers from harvested banana and pineapple plants, reducing environmental impact and providing employment opportunities.

"With NECTAR's technological intervention, we have successfully extracted fibres of standard quality from banana and pineapple plants, which are now being used to weave attractive pieces of clothing, rugs, sarees and more. Additionally, banana water, a by-product of the process, is used as an organic fertiliser," Dr Sharma explained.

This initiative has already provided direct employment to around 40 individuals and indirectly benefited nearly 250 people, including local artisans and entrepreneurs engaged in the value chain. By encouraging eco-friendly fiber production, the project also minimises deforestation caused by industries reliant on wood and cellulose-based materials.

NECTAR's initiatives highlight the immense agricultural potential of the north-east. From saffron cultivation to waste-to-wealth projects, these programmes empower farmers with new income streams, boost India's selfreliance in high-value crops and promote environmental sustainability. With continued research, innovation, and investment, the Northeast could soon emerge as India's newest hub for premium saffron and eco-friendly textile fibers. As Dr Sharma rightly puts it, "We are not just cultivating crops; we are cultivating futures."

Unwanted controversy embraces a city press club

nviting a minister for a cultural programme by Gauhati Press Club (earlier Guwahati Press L Club) seemingly touched the wrong chord, as the issue has gone out of proportion, where a sizable number of social media users questioned the press club committee why the particular minister was invited even though he is not in charge of IPR or cultural ministry? Moreover, why did the GPC delegation approach the concerned minister at his residence in the evening hours (but not in the Secretariat) and what was the problem in approaching him at the premise of the state legislative assembly, where the budget session (17 February to 25 March 2025) was going on?

The controversy erupted following a social media post by a television journalist, associated with the news channel owned by the state government chief's family, where the scribe claimed that the Assam health and family welfare minister disrespected a delegation from GPC, which went to invite Singhal for a forthcoming Bhaona performance in the city. During the brief interaction, the minister allegedly questioned the necessity of a press club to organise a Bhaona. Moreover, he termed the native traditional performing art form as not being secular in nature. The issue suddenly went viral as many individuals, outfits, media outlets and opposition political leaders started making a hue and cry demanding an apology from the minister. Some even termed Singhal as a 'non-Assamese' who has no idea about the religious performing art form (Ankiya Bhaona), developed by the sixteenth-century Vaishnavite saint, scholar and philosopher Mahapurush Srimanta Sankardev and his prime disciple Madhavdev to enact plays primarily with mythological characters. The excitement, however, lasted for a short period, as the state chief minister Himanta Biswa Sarma opined that he did not believe his cabinet colleague Singhal could make such an immature comment. Sarma also stated that if invited he would also enjoy the show (thus he cleverly indicated that till then CM was not invited). It was followed by a formal clarification from Singhal denying the allegation that he made such derogatory remarks regarding the Bhaona. In a social media post, Singhal stated that it was completely 'false and fabricated' after acknowledging that a group of scribes visited

him to invite him to the cultural programme, which is scheduled for 15 March 2025 at Shilpagram premises in the city. Singhal expressed his annoyance that a fictitious story was generated and made public by a particular journalist.

"We are devoted followers of Sankardev and always embrace Gurujona's creations with deep reverence. Needless to mention, Sankardev's immense contributions and creations continue enriching the great Assamese society," said Singhal, adding that the journalist involved with the episode should tender an apology to the people of Assam. He even threatened to take legal action against the journalist and GPC.

The GPC, however, hit back and asserted that Singhal actually made those negative comments. So it wanted the minister to change his mindset regarding Sankardev or Bhaona. Finally, Singhal made another social media post stating that he sought an apology if anyone's sentiment was hurt by the controversy. Singhal, however, stuck to his stand that he never made any derogatory remark about Bhaona, but a section of media outlets reported misleading stories over the issue. "I don't want any unnecessary debate over the matter and hence I apologize if it hurts anyone's emotion," stated Singhal.

Seemingly happy with the apology of Singhal, the GPC has not made any further statement even though it was half-hearted. Meanwhile, a volley of questions was poured on the city press club as to why a minister would make derogatory comments just to receive an invitation letter for any event. Was there any instigation and it was none other than a demand for some hefty donations from the minister, but somehow it was materialised? A senior television journalist, while speaking publicly, asked the GPC to clarify its stand as the Bhaona titled 'Gandharir Abhishap' was supported by the NEZCC and if needed to apologise to the media fraternity.

The media club, currently functioning from an important archaeological site, claims that it has nearly one thousand members, but many city-based senior scribes publicly stated that they are not associated with the GPC. Many of them were denied general membership (who can vote in the polls unlike associate and patron members) and some intentionally opted to disassociate with the press club, which celebrated the golden jubilee year of its existence. Nonetheless, the press club organised the inaugural function of the yearlong celebration, with CM Sarma as chief patron, at the end of 2022, but the GPC is yet to organise the closing function till date (which was due by the end of 2023).

Days back, the Journalists' Forum Assam (JFA) urged the government to allot an alternative plot so that the rich Ambari archaeological site could be accommodated for necessary preservation and research works. Situated in the heart of Kamrup (metro) district, the site has been excavated several times since 1968 to find more archaeological remains. The archaeology department claims that the ruins of Ambari reflect the period of the Sunga-Kushana dynasty. The JFA also appealed to every conscious citizen to come forward, making the Ambari site (which attracts visitors from different parts of India every day) an encroachment-free area as early as possible.

Sunday's final phase of Khelo India Winter Games 2025 is set to deliver electrifying performances and further elevate the status of winter sports in India.

Khelo India Winter Games (KIWG) are the national-level multidisciplinary grassroots winter games of India. Events include skiing, alpine skiing, nordic skiing, snow rugby, Ice stock sport, snow baseball, mountaineering, snowshoe running, ice hockey, figure skating and speed skating.



It was decided to hold the first Khelo India Winter Games of Ladakh emerge as the overall leader securing seven in 2020 after the success of multiple editions of the Khelo medals, including four golds. India Youth Games. Tamil Nadu followed with The first leg of the KIWG-

five medals, including three golds, while Maharashtra won a total of 10 medals, but with only two golds finishing third. Now, with the final leg set
