

Tariff *Par* **Tariff: Global** trade war escalates

he second stage trade war started by the United States might impact the jobs of more than 5 million Americans due to the retaliatory tariffs from China and Canada, as per a report. Brookings Institution analysis found that a few sectors are most at risk from these tariffs, such as agriculture, manufacturing, and energy industries, according to the Washington Post.

China has retaliated against US tariffs with increase in import tax covering \$21 Billion worth of US agricultural and food products. The moves of the world's top two economies are pushing the global economy a step closer towards an allout trade war.

China also restricted exports and investments on 25 American companies, on grounds of national security, but, unlike when it retaliated against the Trump administration's February 4 tariffs, this time it avoided punishing any household names.

The Chinese tariffs will include a levy of 15 per cent on American products such as chicken, wheat and corn, as well as 10 per cent on products like soybeans, pork, beef and fruit. It clarifiet that goods, which had already been shipped before Monday and imported by April 12 would not be subject to the new tariffs.

President Donald Trump has added 20 per cent tariffs to the roughly \$440 Billion worth of Chinese goods that the US imports annually. The average American tariff on affected Chinese goods now stands at 39 per cent.

The showdown extended to the G7 where, China on Saturday has lashed out at accusations it is endangering maritime safety made by top diplomats from the Group of 7 industrialised democracies in a joint statement, saying the G7 members are "filled with arrogance, prejudice and malicious intentions.

diplomatic language, the statement issued Saturday was unusually vitriolic, although it did not threaten any retaliation.

In the Friday statement that sparked the Chinese response, the G7 said, "We condemn China's illicit, provocative, coercive and dangerous actions that seek unilaterally to alter the status quo in such a way as to risk undermining the stability of regions, including through land reclaimations, and building of outposts, as well as their use for military purpose.

"We reaffirm that our basic policies on Taiwan remain unchanged and emphasise the importance of peace and stability across the Taiwan Strait as indispensable to international security and prosperity," the statement said, referring to the crucial waterway separating China from the selfgoverning island republic it claims as its own territory.

In the response issued through its embassy in Canada, where the two-day G7 meeting was held in La Malbaie, Quebec, China said the statement "repeated the same old rhetoric, ignored facts and

Even for China's generally overheated China's solemn position, grossly interfered in China's internal affairs, and blatantly smeared China.

> "The statements are filled with arrogance, prejudice and malicious intentions to suppress and attack China. China strongly deplores and opposes this and has lodged solemn representations with the Canadian side," the statement said.

China claims virtually the entire South China Sea, through which passes around \$5 trillion in global trade. It has dismissed and occasionally clashed with other countries that claim parts of the sea, especially the Philippines, a US treaty partner.

China is not a member of the G7 but closely follows all comments and references to its international status made by international organisations or in foreign countries, responding to criticism with caustic language. China has firmly rejected a UN-affiliated court's ruling that invalidated most of its claims to the South China Sea and says its claim to Taiwan is non-negotiable, even if China has to use force against the island.

EPIC Aadhaar link on cards

mid allegations of fudging of electoral rolls data, Chief Election Commissioner (CEC) Gyanesh Kumar has convened a meeting of the Home Secretary, Legislative Department Secretary, and Chief Executive Officer of UIDAI on Tuesday to discuss the issue of linking voter identity cards with Aadhaar.

The meeting comes at a time when the Trinamool Congress has raised the issue of electors in West Bengal and other states having the same Electors Photo Identity Card (EPIC) number, leading the Election Commission of India (ECI) to acknowledge that some state chief electoral officers had used the wrong alpha-numeric series when issuing EPIC numbers.

Sources said CEC Gyanesh Kumar, Election Commissioner Sukhbir Singh Sandhu, and Election Commissioner Vivek Joshi are set to meet Union Home Secretary Govind Mohan, Legislative Department Secretary Rajiv Mani and UIDAI CEO Bhuvnesh Kumar on March 18 to discuss the linking of Aadhaar with EPIC numbers.

At present, the Representation of the People Act, 1951 allows the seeding of electoral rolls with the Aadhaar database, but on a voluntary basis only. After an amendment to the Act in 2021 enabled Aadhaar linking with EPIC, the ECI began collecting Aadhaar numbers from electors on a voluntary basis.

So far, however, the ECI is yet to link the two databases. The exercise was meant to aid the ECI in detecting duplicate registrations to clean up the electoral rolls. However, linking of Aadhaar was not mandatory.

Sagarika Ghose, deputy leader of Trinamool Congress (TMC) in Rajya Sabha, said the statements issued by the poll panel earlier over the duplicate EPIC numbers and this meeting being called now, are "face-saving measures". She added that the TMC will keep a strict vigil till the next state elections.

"First, three statements. Now this meeting. This is just a face-saving

measure. We will keep a hawk-eye vigil till the elections," Ghose said.

On March 11, a 10-member TMC delegation had met the full Election Commission bench over the duplicate EPIC numbers. In a memorandum to the Election Commission, the TMC had also said there have been "credible allegations of Aadhaar cards being cloned and the use of these cloned Aadhaar cards to facilitate fake voter registrations." Earlier, in a note circulated to chief electoral officers of states, the Commission has directed officials to make "all attempts" to link Aadhaar numbers with electoral roll data.

"In order to ensure proper identification of electors and ensure necessary communication, all attempts should be made to link with Aadhaar and mobile numbers," read the note.

The poll body on March 2, issued a statement saying that identical EPIC numbers or series were allotted to some electors from different states and Union Territories due to a "decentralised and manual mechanism" being followed prior to shifting of the electoral roll database of all states to the ERONET (Electoral Roll Management) platform. They asserted that while EPIC numbers of some voters "may be identical", the other details - including demographic details, assembly constituency and polling booth — are different.

In another statement, the Commission said that since the allotment of EPIC series to the states and UTs in 2000, some Electoral Registration Officers did not use the correct series. They said the allotment of duplicate numbers due to incorrect series could

not have been detected as the states and UTs were independently managing the electoral roll databases.

The poll authority also said it has now decided to resolve this "long-pending issue" after detailed discussions within the technical teams and concerned state chief electoral officers in the next three months. It has also directed its poll machinery in the states to hold regular meetings with political parties and resolve issues according to procedure.

Pointing out that the Election Commission has not clearly stated on its Form 6B that seeding Aadhaar with EPIC is an entirely voluntary process and not compulsory, the party had asked how the poll panel would ensure that the alleged cloning of Aadhaar numbers does not affect the EPIC and electoral registration of voters.

Meanwhile, several other opposition parties have also demanded a discussion on the EPIC number duplication, calling it a major issue for democracy. Echoing similar sentiments, the BJD suggested an independent audit of the poll process and monitoring by citizens.

The BJD leaders said the Election Commission should conduct a periodic "process audit" of the entire election exercise by independent auditors or the Comptroller and Auditor General of India (CAG) and make its report public as is being done in several countries where democratic elections are held. They also urged the poll panel to develop a mechanism for involving citizen groups to co-monitor the election process from inception to the end, and to formulate a mechanism for conducting a concurrent audit during polling at the booth level as well as during counting to ensure trust in election process.

According to a source, the opposition parties said they are flexible with the rule under which the discussion should be held, but stressed that Parliament should discuss the issue. The duplication of voter ID card numbers in different states was raised by West Bengal Chief Minister Mamata Banerjee on February 27.

RBI assures IndusInd customers of bank's stability

he Reserve Bank on Saturday assured customers that indusind Bank remains 'well-capitalised', even as it directed the bank's board to complete remedial action relating to estimated Rs 2,100 crore accounting discrepancy within this month. Earlier this week, IndusInd Bank disclosed a discrepancy in accounting with an estimated impact of 2.35 per cent of the bank's net worth. Soon after the disclosure, massive price correction in the bank's scrip was witnessed. Basis the disclosures available in public domain, the bank has already engaged an external audit team to comprehensively review their current systems, and to assess and account for the actual impact expeditiously, RBI said in a statement. "The Board and the management have been directed by Reserve Bank to have the remedial action completed fully during the current quarter viz., Q4FY25, after making required disclosures to all stakeholders," it said.

Terror rears its head in Punjab again

blast occurred outside a temple in Amritsar around midnight when a A motorcycle-borne person threw an explosive device towards it, damaging a portion of its wall and shattering window panes, officials said on Saturday.

While no one was hurt in the incident, the explosion caused panic among residents in the Khandwala area of Amritsar. There have been many incidents of explosions targeting police posts in Amritsar and Gurdaspur in the past four months but it the first such attack on a temple. Opposition parties alleged that the incident reflected the "deteriorating" law and order situation under the AAP government. Amritsar Police Commissioner Gurpreet Singh Bhullar said the police were informed about the incident at around 2 am on Saturday by the Thakur Dwar temple priest. CCTV footage of the incident showed two unidentified persons coming to the temple on a motorcycle. After waiting for a few seconds, one of them is seen throwing some explosive material towards the temple and the two later flee from the site. Bhullar said police teams were trying to trace the men involved in the blast and they would soon be nabbed. "Our teams are following them. Like we had traced earlier incidents, this incident will also be traced," he said. A forensic team has collected samples from the spot to identify the material used in the explosion, he said.

Assuaging concerns of customers, the RBI in the clarification statement said there was no need for depositors to react to the speculative reports at this juncture. There has been some speculation relating to IndusInd Bank Ltd in certain quarters, perhaps arising from recent events related to the bank, it said. The central bank assured customers and investors that the bank's financial health remains stable and is being monitored closely by it.

IndusInd Bank had informed that the accounting lapse was noted around September-October last year and the bank gave a preliminary update to the RBI about this last week. The final number will be known after the external agency, which the bank has appointed, finalises its report by early April, according to the lender. Sharing financial parameters of the bank, RBI said the bank is well-capitalised and the financial position remains satisfacto-

As per auditor-reviewed financial results of the bank for the quarter ended December 31, 2024, the bank has maintained a comfortable Capital Adequacy Ratio of 16.46 per cent and Provision Coverage Ratio of 70.20 per cent. The Liquidity Coverage Ratio (LCR) of the bank was at 113 per cent as on March 9, 2025, as against regulatory requirement of 100 per cent.

Chartered accountants' apex body ICAI may review the financial statements of IndusInd Bank, which is grappling with discrepancies in accounting estimated to be Rs 2,100 crore.

from its deep slumber and takes action," said Warring in a post on X.

Senior Akali leader Bikram Singh Majithia said it was a "law and order failure.

Meanwhile, referring to the problems of drugs, gangsters and calls for ransom, Chief Minister Mann, while reacting to the Amritsar incident, said that these are also attempts to disturb Punjab to show it as a disturbed state.

"But our Punjab Police constantly takes timely action against anti-social elements. On the occasion of Holi, where violent incidents took place in different corners of the country, everyone in Punjab played Holi together. Punjab is completely safe in terms of law and order," said Mann.

He said the Border Security Force (BSF) has informed the state government that ever since an anti-drugs drive has been initiated in the state, the drone movement from across the border has reduced by 70 per cent.

Ranjani Srinivasan, a citizen and national of India, entered the United States on a F-1 student visa as a doctoral student in Urban Planning at Columbia University, the Department of Homeland Security said in a statement on Friday. It added that Srinivasan was "involved in activities supporting" Hamas, a terrorist organisation.

The Department of State had revoked her visa on March 5. The Department of Homeland Security said it has obtained video footage of Srinivasan using the Customs and Border Protection (CBP) Home App to selfdeport on March 11.

Secretary of Homeland Security Kristi Noem said in the statement that it is a "privilege to be granted a visa to live and study in the United States of America". "When you advocate for violence and terrorism, that privilege should be revoked, and you should not be in this country. I am glad to see one of the Columbia University terrorist sympathisers use the CBP Home app to selfdeport," Noem said.

The Department of Homeland Security had, on March 10, launched the CBP Home app with a self-deportation reporting feature for those illegally staying in the country. Individuals illegally staying in the country can use the CBP Home mobile phone application to submit their intent to depart the country. The CBP app gives such individuals the

Maharashtra gram sabha introduces unique solution for crisis situations

Tounded by unscrupulous moneylenders, threatened by anti-social elements, or stuck in a crisis? A gram sabha in Maharashtra's Solapur district has introduced a unique solution for those who suffer in silence- raise the index finger to summon help.

This resolution was passed by the gram sabha of Pothre Nilaj village in Karamala taluka on Women's Day on March 8, acknowledging the atmosphere of "fear" in society and intimidation that forces victims into silence.

This move aims to eradicate fear among villagers and restore harmony and brotherhood in the village, the resolution stat-

ed. So how will this work? The Gram Pothere Nilaj village become Sabha said the person who needed help would have to raise the index finger if feel threatened. This gesture will alert others who will rush to his/her aid, as per the resolution.

The move will help women, children, and senior citizens immensely, it said.

'Raising the index finger will signal to others that the person needs urgent help. Alert citizens will approach him to help. If the crisis is serious and real, the person seeking help will be connected to various helpline numbers related to women, children, senior citizens, and the police," the Gram Sabha said.

This concept is the brainchild of Pothre Nilaj sarpanch Ankush Shinde.

"This idea was conceptualised during a discussion with Pramod Zinjade, a social activist who has spearheaded several initiatives like eradicating certain customs related to widows in rural Maharashtra," Shinde told PTI.

Shinde said the Gram Sabha is planning to publicise this initiative among people.

He said the Gram Sabha has also urged the state government to introduce a dedicated WhatsApp number so that people can share the location, photo, and video of the person in crisis. This information can be disseminated in real-time to the concerned department who in turn will inform the local police.

Explaining the initiative, Zinjade said fear has gripped the society for various reasons, some domestic and others related to anti-social elements.

"Citizens facing problems at home and work may not muster the courage to speak out. They may be bothered by antisocial elements or harassed by money lenders for failure to repay the loan.

"The raising of the index finger will

mean that the concerned person needs help. Seeing this, others can inform the Gram Sevak and Sarpanch," he added.

The resolution comes amidst the backdrop of the latest string of videos showing violence, especially in Beed district in the Marathwada region.

Pothere Nilaj village, with a population of 6,000 and most inhabitants engaged in farming, has been following a progressive path by standing against social evils.

It had become the first village in Solapur district to adopt a resolution passed by the Herwad gram panchayat in Kolhapur district in 2022 banning customs like removing a widow's mangalsutra, toe ring, and wiping her sindoor.



Opposition mounts pressure on Omar

n a bid to corner the newly elected Chief Minister Omar Abdullah over the existing Reservation policy, the opposition party leaders have started mounting pressure by exposing the delicate fault lines between two regions of Jammu distinct and Kashmir.

After the Peoples Democratic Party (PDP) demanded fair representation for the open merit candidates based on their total population, the Peoples Conference President, Sajad Lone, Saturday launched a scathing attack against the UT administration, claiming that the whole reservation concept was rigged against Kashmir. After the formation of the popular gov-

ernment in Jammu and Kashmir, Reservation has become a major issue. The Central government's decision to add more communities to the reserved category and expand quotas in the UT over the past five years raised the tension among the open merit candidates

There are increasing objections to the Centre's move to push the reservation quota to 70 per cent in Jammu and Kashmir. Addressing a press conference in Srinagar, Lone also termed the statistics revealed by the J&K government about the issuance of Reservation Certificates as 'Shocker'.

According to data obtained through a question posed by Lone, since April 1, 2023, the Jammu region has dominated

certificate issuance across nearly all categories. Scheduled Caste certificates were issued exclusively in Jammu (67,112 certificates, 100%), with none in Kashmir.

In a post on X Sajad Lone said: "The Scheduled Tribe category showed Jammu issuing 459,493 certificates (85.3%), while Kashmir issued only 79,813 (14.7%). Similar imbalances exist in the Economically Weaker Sections (92.3% Jammu, 7.7% Kashmir), Actual Line of Control (94.3% Jammu, 5.7% Kashmir), and International Border categories (100% Jammu). Even in the Reserved Backward Area category, Jammu led with 52.8% of certificates versus Kashmir's 48.2%.

Lone emphasised that these disparities reveal a greater loss of quotas for the Kashmiri-speaking population than previously anticipated, asserting that "the whole reservation concept is rigged against the Kashmiri-speaking population and against ST or EWS living in Kashmir."

He said that even ST populations residing in Kashmir are disadvantaged, comprising only 15% of total applicants from the ST pool. "While RBA figures appear more balanced, when adjusted for Kashmir's approximately 7% larger population, the region still lags behind Jammu proportionally," he added.

Lone also criticised the committee

established by the government on December 10, 2024, to address these grievances, noting that it lacks a specific timeline for submitting its report despite previous indications of a sixmonth deadline.

In a written reply to the query of Sajad Lone, Cabinet Minister Sakeena Itoo, the minister in-charge of social welfare, said no specific timeline has been fixed for submitting the report.

'The Cabinet Sub Committee stands constituted vide Government order No 2061-JKGAD of 2024, dated 10-12-2024 to examine the grievances projected by a section of aspirants for various posts regarding reservation rules. However, no specific timeline has been fixed for submitting the report," the minister said in response to Lone, who had asked whether a six months time period had been granted to the panel to review the existing reservation policy.

The minister said 1,379 villages in Jammu and 1,229 villages in Kashmir have benefited under Reserved Backward Area (RBA), while 551 villages of Jammu zone have benefited under International Border category. Similarly, 268 villages in Jammu and 16 in Kashmir have benefited under Actual line of Control (ALC) category.

The government has also issued 27,420 certificates to the Economically Weaker Section (EWS) in Jammu division and 2,273 certificates to EWS in Kashmir valley in the past two years, effective from April 1, 2023

Instituted in 1954, these awards are announced on the eve of the Republic Day every year.

The awards seeks to recognise 'work of distinction' and is given for distinguished and exceptional achievements and service in all fields and disciplines such as Art, Literature and Education, Sports, Medicine, Social Work, Science and Engineering, Public Affairs, Civil Service, Trade and Industry etc. All persons without distinction of race, occupation, position or sex are eligible for these awards, the statement said.

The government servants, including those working with PSUs, except doctors and scientists, are not eligible for the

Padma awards. Ever since the Narendra Modi government came to power in 2014, it has starter honouring the "unsung heroes" by awarding them with the Padma awards, thus transforming the Padma awards into "People's Padma", officials said.

NDLS stampede: Two transferred officials get posting in NR headquarter

wo of the five railway officials shunted out after the tragic stampede that killed 18 passengers at the New Delhi Railway Station have been given fresh postings in the Northern Railway Headquarter.

The officials said these positions are considered "punishment postings" as they do not have any significant authority over rail operations. The rail administration had following

the tragedy shunted out five officials on March 4, 2025 in four separate orders.

Mahesh Yaday, who was removed from the post of station director, has been reassigned as Deputy Chief Operation Manager (Dy COM) for Freight Operations Information System (FOIS) at the Norther Railway Headquarter in New Delhi. According to a notice issued by the Northern Railway (NR) on March 12, 2025, the post of Senior Divisional Operation Manager for Goods (Sr DOM G) of Delhi Division was transferred to NR

Headquarter and redesignated as Dy COM (FOIS) NR.

Anand Mohan, the second official shunted out from the position of Senior Divisional Commercial Manager (Sr DCM) for passenger services (PS) in the Delhi Division, has been posted as Deputy Chief Operation Manager of Coaching (Dy COM Chg). The other two officials Divisional Railway Manager (DRM) Sukhwinder Singh and Additional Divisional Railway Manager (ADRM) Vikram Singh Rana are yet to get fresh postings. The fifth official Mahesh Chand Saini, who was posted as Assistant Security Commissioner of Railway Protection Force at the New Delhi Railway Station, was sent to Kota soon after his transfer order. Railway sources said that a high-level inquiry is underway to fix the accountability of those whose negligence led to the tragedy. "Officials guilty of negligence will not be let off with mere transfers. Strict actions follow once the report is submitted to the higher authorities," a senior railway official said.

Sunday, a mosque official said. Secretary of Shahi Jama Masjid Masood Farooqui on Saturday said an Archaeological Survey of India (ASI) team came to the mosque around noon and held a discussion about how much labour and material is required.

"We are trying to start it today, otherwise it will begin tomorrow," he said.

The Allahabad High Court on March 12 directed the ASI to undertake and complete the whitewashing at the mosque within one week.

Following the High Court order, an ASI team carried out measurements and assessments on March 13. After this the Shahi Jama Masjid's president Zafar Ali had said that the painting work will begin at the mosque after Holi. Farooqui said, "These people (ASI) are saying that they will start from tomorrow. We have told them that the High Court has given seven days, out of which three days have passed."



Three people have come here as a part of the ASI team, he said. "The ASI has brought labourers and we will also arrange for some locally." The whitewashing pertains only to the outer wall of Shahi Jama Masjid, Advocate Hari Shankar Jain, representing the Hindu side, said. After hearing counsels for the parties, Justice Rohit Ranjan Agarwal also

directed the Archeological Survey of India (ASI) to install lights on the outer portion of the mosque.

Earlier on Monday, the Allahabad High Court had directed the counsel appearing for the ASI to come up with specific averments as to what prejudice would whitewashing the outer walls of the mosque cause.

Rajasthan cops bovcott Holi celebrations: seeks removal of salary discrepancies

As usual, arrangements for Holi celebrations were made by senior officers in police lines across the state. However, police lines in Jaipur, Jodhpur, Udaipur and other districts remained empty. In Kota, Bharatpur, Pali, Sawai Madhopur and Bhilwara, celebrations continued with policemen playing Holi with senior officers including SPs, smearing Gulal and colours on each other and dancing to DJ music. Kota SP Amrita Duhan danced to the DJ beats with female police personnel. Similarly, in Bharatpur, SP Mridul Kachhawa played Holi with officers. However, the number of policemen participating was less than usual. In Bhilwara's police ground, a Holi Milan ceremony was scheduled from 9 am to 12 pm on Saturday. Senior officers including SP Dharmendra Singh played Holi. The main demands of police personnel revolve around promotions and salary discrepancies. They are calling for timely Departmental Promotion Committees (DPCs) meetings to ensure promotions, similar to other departments, increase in mess allowance among others.

ed from >> P1 The Education Department said in a press release that Columbia University currently holds more than USD 5 billion in federal grant commitments.

President Donald Trump has asserted that any college or university that allows illegal protests and repeatedly fails to protect students from anti-Semitic harassment on campus will be subject to the loss of federal funding.

Secretary of Education Linda McMahon has said since October 7, 2023, when Hamas attacked Israel, "Jewish students have faced relentless violence, intimidation, and anti-Semitic harassment on their campuses only to be ignored by those who are supposed to protect them."

"Universities must comply with all fed-

eral anti-discrimination laws if they are going to receive federal funding. For too long, Columbia has abandoned that obligation to Jewish students studying on its campus.... We demonstrate to Columbia and other universities that we will not tolerate their appalling inaction any longer," McMahon has said. In the spring of last year, large-scale pro-Palestinian protests by students against the war in Gaza erupted across US campuses as well as at Columbia University that saw encampments on the West Lawn of Columbia's Morningside campus since April 19.

The Trump administration has arrested Columbia University graduate and legal permanent resident Mahmoud Khalil for his role in leading campus protests at Columbia against Israel. Khalil, who is of

Palestinian heritage, was detained by immigration authorities and has been sent to a detention centre in Louisiana.

On Thursday, the Columbia University Judicial Board issued "sanctions" to students ranging from "multi-year suspensions, temporary degree revocations, and expulsions" related to the occupation of Hamilton Hall last spring during the Gaza protests.

"With respect to other events taking place last spring, the UJB's determinations recognised previously imposed disciplinary action. The return of suspended students will be overseen by Columbia's University Life Office. Columbia is committed to enforcing the University's Rules and Policies and improving our disciplinary processes," the university said.

Man held for morphing women's photos

23-year-old man was arrested for allegedly morphing women's photos and contacting them on social media to blackmail them, a Delhi Police official said on Saturday.

Amritsar resident Madhav Singh allegedly demanded ₹5 Lakh from a woman, threatening that he would circulate the images online if she failed to pay.

A phone containing several manipulated photos was recovered from his possession after he was arrested in northwest Delhi, police said in a statement.

During questioning, Madhav allegedly confessed to the crime, saying he blackmailed the women for "amusement".

"A complaint of extortion and cyberbullying was received from a woman who alleged that she had been contacted by a man through social media. Over time, the accused gained her trust and obtained her photographs," Deputy Commissioner of Police (Northwest) Bhisham Singh said.

Madhav Singh allegedly used multiple

fake IDs on social media to conceal his identity and refrained from sharing any personal details such as his mobile number or address, making it difficult to trace him, he said.

However, through digital forensics, technical surveillance and manual analysis, police were able to track his online activity and identify him, the DCP said.

After sustained efforts, police successfully apprehended him and the phone used in the crime was seized, he said.

The case remains under investigation as police seek to identify additional victims or potential accomplices involved in similar crimes, the Deputy Commissioner of Police (Northwest) Bhisham Singh said.

Verma inspects Rohtak **Road, review progress**

elhi Public Works Department (PWD) Minister Parvesh Verma on Saturday conducted an inspection of the ongoing drainage construction project at the Rohtak Road to review its progress. The road, a key corridor connecting Haryana to Delhi, has been in poor condition, prompting multiple complaints from local residents, an official statement of the PWD said.

The 18-kilometre stretch from Peeragarhi Chowk to Tikri Border is set for redevelopment. The drainage construction is expected to cost approximately ₹115 Crore and is scheduled for completion within 14 months. Since this project involves areas where Indraprastha Gas Limited (IGL) and three Delhi Metro stations are located, necessary permissions will be required.

Earlier this month, the Delhi government handed over the responsibility of construction of the 18-kilometre stretch from Peeragarhi Chowk to Tikri Border (Delhi-Haryana border) to the National Highways Authority of India (NHAI). PWD will handle the drainage work while NHAI will take over the construction, Verma said. According to the statement, the stretch is undergoing redevelopment, with drainage work estimated to cost ₹115 Crore and expected to be completed within 14 months.

Given that the stretch includes areas near three Delhi Metro stations and Indraprastha Gas Limited (IGL) pipelines, necessary approvals will be required. The minister has directed officials to fast-track the permission process to prevent unnecessary delays.

"Delays in obtaining approvals lead to higher costs. This should be prioritised so that work continues without interruptions,"

Verma said during the inspection. Highlighting the poor condition of Rohtak Road, Verma criticised the lack of attention from previous government.

"People often complained that no government representative ever visited this area. Now, drainage work has begun, and the entire road has been handed over to NHAI. PWD and the Flood Control Department are working together to ensure smooth execution," he said.

Emphasising strict quality control, the PWD minister issued a warning to contractors and officials.

"We are building roads and drainage systems that should last for years. If there is any compromise on quality, the contractor will be blacklisted, and responsible officials will face suspension," he said.

Verma also pointed out that bad roads contribute to rising pollution levels in the

CM receives feedback from farmers ahead of Budget

elhi Chief Minister Rekha Gupta on Saturday received feedback from the farmers ahead of the Budget of the BJP government to be tabled on March 25 and assured them of solving all their problems.

7,230 challans issued on Holi: **Delhi Police**

raffic violations surged by more than 100 per cent during Holi cel-L ebrations this year. According to Delhi Police, a total of 7,230 challans were issued on Holi this year, marking a sharp increase from 3,589 violations recorded in 2024,

The Delhi Police issued a total of 1,213 challans for drunken driving on the occasion of Holi, marking a significant increase compared to 824 challans last year. Similarly, helmet-related violations increased by 56 per cent to 2,376 this year from 1,524 challans in 2024.

Delhi police said that other offenses, including triple-riding, tinted glass violations and driving without seat belts also saw an increase. A total of 573 challans were issued for triple-riding and 97 for tinted glass violations this year. According to the statement, about 1,241 violators were booked for other traffic offenses last year on Holi, with it rising by 139 per cent in 2025 with a total of 2,971 violators booked.

Additional Commissioner of Police (Traffic) Dinesh Kumar Gupta stated, "Keeping in view the Holi celebrations on Friday, the Delhi Traffic Police implemented extensive arrangements to ensure the safety of pedestrians and motorists. Special measures were taken to curb incidents of drunken driving, triple-riding, underage driving, and stunt performances on two-wheelers."

The officer added that 84 special teams equipped with alcometres to check drunken driving and 40 joint checking teams that comprised traffic police and local police personnel, were deployed at major intersections, drinking hotspots and vulnerable locations across the capital.

These teams were stationed from 8 am to midnight to detect and prosecute traffic violators, he said.

Injured black kite rescued from NSA **Doval's residence**

n injured black kite was rescued from National Security Advisor (NSA) Ajit Doval's residence and later released into the wild after successful rehabilitation by Wildlife SOS, a statement issued on Saturday said. The rescue occurred on Thursday when the bird was found stranded inside the security control room of Doval's residence, the statement said. The kite was found collapsed on the floor unable to take flight due to visible wing injuries, it added.

Acting swiftly, the security personnel contacted the Wildlife SOS 24x7 emergency helpline to ensure the bird received immediate care. The staff carefully placed the distressed bird in a secure box to prevent further harm before the rescue team arrived, the statement said. Wildlife SOS responders transported the injured raptor to their transit facility for medical treatment and rehabilitation. After a thorough veterinary assessment, the bird was treated for wing injuries and kept under observation. With dedicated care and nutritional support, the black kite gradually regained strength and was deemed fit for release, it added.

It further mentioned that Delhi has wit-nessed a 'Satisfactory' AQI in March for



the first time in five years, since 2020.

Meanwhile, the maximum temperature in Delhi on Saturday was 33 degrees Celsius, 4.1 degrees Celsius above the seasonal average, according to the India Meteorological Department (IMD).

The minimum temperature was 18.7 degrees Celsius, while humidity levels fluctuated between 62 per cent and 50 per cent. On Friday, Delhi experienced its hottest day of the year, with the mercury reaching 36.2 degrees Celsius, 7.3 degrees Celsius above normal, the IMD stated.

The weather department has predicted generally cloudy skies with light rain or drizzle on Sunday. The maximum and minimum temperatures are expected to be around 32 degrees Celsius and 17 degrees Celsius, respectively.

The accused identified as Bhagirath (22), Sumit (22), Vivek Mehra (21) and Vicky Verma (24) are first-time offenders and have committed the crime after being influenced by social media reels, he said.

Deputy Commissioner of Police (Dwarka) Ankit Singh said, "The victim, Abhimanyu Kumar, was on his way to the office on March 8, when two motorcycle-borne assailants intercepted him at a secluded spot. When he resisted the robbery attempt, one of the accused pulled out a knife and stabbed him multiple times on his neck and stomach, before fleeing the scene."

A PCR van rushed Abhimanyu to

Indira Gandhi Hospital, where he underwent treatment. Based on his statement. a case was registered at the Dwarka North police station and a team was formed to track down the accused, the DCP said. During the investigation, police analysed CCTV footage in the surrounding areas and identified some suspects. Further scrutiny of their social media accounts and technical surveillance helped in tracking them down, the DCP added.

He said during interrogation, the accused admitted that they were inspired by social media reels and identified a cash collection agent as the target for robbery. Bhagirath, who first identified the target roped in the other three.

Following their arrest, police recovered two motorcycles they travelled on, the knife used for stabbing, and the bloodstained clothes of the accused. The four men were employed as housekeeping staff and motorcycle mechanics, the DCP said.

According to the officer, Vikas who was with Ashish when the incident happened said they were heading home to Khoda after playing Holi.

"As they crossed the NH-24 turn, their motorcycle was hit by a motorcycle carrying two people approaching from

Mandawali. A heated argument followed during which one of the bikers took out a liquor bottle from his pocket and struck Ashish on the head," the Deputy Commissioner of Police said.

He added that the bottle shattered and the assailant then used a sharp piece of the bottle and slashed Ashish's neck, which killed him. Both suspects then fled the scene, the officer said.

A case was registered in the matter and further investigation was underway. Multiple teams were formed to probe the matter

The accused's movement was tracked after analysing CCTV and automatic number plate recognition (ANPR) footage, scrutinising call records, leading to the arrest of the two prime suspects, he said.

It will feature 42 open workstations, 11 private cabins, and two meeting rooms, accommodating up to 42 individuals and 11 companies at a time, it read. It also mentioned that the facility will offer high-speed internet, plug-and-play workstations, and modern amenities to ensure seamless productivity.

Ghaziabad Namo Bharat Station, positioned at Meerut Tiraha Mor, sits at the crossroads of the Ghaziabad-Meerut

route and benefits from its proximity to Shahid Sthal Delhi Metro Station, it stated. According to the statement, the heavy footfall in this area makes it an ideal location for a co-working space, reducing commute time and offering easy accessibility for professionals.

The facility will integrate smart access through biometric entry and digital key cards, along with a dedicated digital platform for reservations, membership management and cashless transactions, it stated. Additional features will include video conferencing setups, wireless screen sharing, tech-enabled brainstorming zones, and reliable fibre-optic connectivity for seamless virtual meetings, it said.

NCRTC is also allocating commercial spaces within and around Namo Bharat stations to enhance passenger amenities and generate non-fare revenue, it stated.

Currently, Namo Bharat operates on a 55-km stretch from New Ashok Nagar to Meerut South, covering eleven stations. The full 82-km corridor, including the Meerut Metro, is expected to be completed by 2025, it added.

INDIA bloc formed for Lok Sabha polls: Karat

he opposition INDIA bloc was formed for the Lok Sabha elections and not state polls, senior CPI(M) leader Prakash Karat has said and called for a broader platform of secular opposition parties.

He also said that the alliance should be looked at with a broader perspective so that it would not be stifled solely by electoral politics.

The Indian National Developmental Inclusive Alliance (INDIA) of opposition parties came together ahead of the Lok Sabha elections to counter the BJP-led National Democratic Alliance at the Centre.

In an interview, Karat the CPI(M) interim coordinator also said there had been no discussions of the alliance at the national level after the Lok Sabha elections and added the constituent parties had their own equations in the states.

"It is a fact that the formation of the INDIA bloc and the cooperation between its constituents in certain states, if not all, definitely led to the BJP losing its majority in the Lok Sabha...," Karat said.

"Subsequently, assembly elections have taken place and I think the biggest setback for the opposition has been Maharashtra, where the Maha Vikas Aghadi did very well in the Lok Sabha polls and the BJP alliance was reduced to a minority. But the reverse happened in the assembly election," he added

The veteran CPI(M) leader also said they had not been able to come to any conclusion as the opposition alliance did very well in Jharkhand.

"We are not yet able to come to any conclusion because the situation in states differ in a very big way. For instance, in Jharkhand, the alliance in which most of them are constituents of the INDIA bloc was able to defeat the BJP," Karat said.

"The general impression after these assembly elections is that the BJP recovered ground in these polls. But I think it should not be directly linked to the fortunes of the INDIA bloc because the INDIA bloc was primarily set up to face the Lok Sabha elections," he said.

any discussions on how the alliance would proceed in the post-Lok Sabha phase and added there was a need for a broader opposition platform or unity among the secular opposition parties.

"I don't think any discussion or thought has been put into how to proceed with the post-Lok Sabha phase. There is a need for a broad opposition platform or unity of the secular opposition parties. But it (INDIA bloc) was not meant for specific state elections at that time. So, how you proceed with a broad opposition unity or platform in the coming days, I think, needs to be looked at by all the constituents, discussed and then some shape given to it," he said. Karat pointed out that alliances were already in place in states such as Bihar and

Tamil Nadu. On the contrary, one couldn't expect the CPI(M) to come together The Left leader said there had not been with the TMC in West Bengal and no one

could have expected AAP and the Congress to join hands in Delhi.

The real challenge is, post the Lok Sabha elections, will this be only an electoral platform? If it's only for elections, then election to election. The character of the INDIA bloc for assembly elections is going to be very complex," he said.

"Many constituents of the INDIA bloc cannot work together in assembly elections... So, I think the opposition unity platform should not be linked purely to the electoral field. Thought has to go in because it came together as we were all opposed to the Modi government and the BIP," he said.

Today, the Narendra Modi government still exists or is in its third term and the BJP is there as a ruling party, Karat said. "If the opposition parties are still concerned about the defence of democracy, of secularism, of federalism, there are broad parameters on which the secular opposition parties, I think, can find common ground." "It should be looked at from that basis, then you can think of forward movement," he added.

The CPI(M) leader added that instead of being stifled by conflicts and differing views, the opposition parties should have a "broader perspective".

Justice Bagchi to be sworn as SC judge on March 17

▼ustice Joymalya Bagchi, a judge of the Calcutta High Court, will on Monday be sworn in as a Supreme Court judge. Once Justice Bagchi takes oath, the Supreme Court will have 33 judges against its sanctioned strength of 34. Justice Bagchi will have a tenure of more than six years in the top court, during which he will also serve as the CJI from May 26, 2031 to October 2, 2031.

Chief Justice of India (CJI) Sanjiv Khanna will administer the oath of office to Justice Bagchi in the presence of other Supreme Court judges at a ceremony on the apex court premises. Born on October 3, 1966, Justice Bagchi will assume the office of CJI upon the retirement of Justice KV Viswanathan on May 25, 2031. Justice Bagchi's name was cleared by the central government on March 10 for appointment as a Supreme Court judge

On March 6, a five-member collegium headed by CJI Khanna recommended his name for Supreme Court judgeship. The collegium -- also comprising Justice BR Gavai, Justice Surya Kant, Justice Abhay S Oka and Justice Vikram Nath noted that no Calcutta High Court judge had risen to become the CJI since the retirement of Justice Altamas Kabir on July 18, 2013.

Justice Bagchi was appointed a judge in the Calcutta High Court on June 27, 2011. He was transferred to the Andhra Pradesh High Court on January 4, 2021. He was repatriated to the Calcutta High Court on November 8, 2021, and had been functioning there since then. He has served as a High Court judge for more than 13 years and stands at serial number 11 in the combined all-India seniority of High Court judges, including chief justices.

During his long tenure, Justice Bagchi acquired significant experience in diverse fields of law. His journey from a passionate law student to a distinguished judge of the Supreme Court of India reflects dedication, professionalism, and an unrelenting pursuit of the rule of law. Upon earning his law degree, Justice Bagchi embarked on a distinguished career as a lawyer at the Calcutta High Court. His meticulous approach, profound under-standing of the law, and unshakable



moral compass earned him widespread respect among peers and clients alike. Known for his unwavering commitment to justice, he handled complex cases with remarkable precision, ensuring fairness prevailed irrespective of the parties involved. His reputation as a principled and impartial legal practitioner paved the way for his elevation to the udiciary.

Justice Bagchi enrolled as an advocate on November 28, 1991. Twenty years later, he was appointed as a permanent judge of the Calcutta High Court, on June 27, 2011. In 2020, he was transferred to the Andhra Pradesh High Court. On November 8, 2021, he was repatriated to the Calcutta High Court. Notably, Justice Bagchi's recommendation superseded the names of at least ten senior judges.

As a Judge of High Courts, Justice Bagchi delivered important criminal and constitutional decisions, harping on progressing criminal justice protections such as the right to free legal aid, right to speedy trials in terror offences, and mitigating circumstances in death penalty adjudications. One decision, although later overturned, also emphasised on the right of minorities to administer religious institutions. Justice Bagchi also passed orders against corruption in public recruitment, observing that corruption not only eroded institutional integrity but also destroyed the social fabric of equal opportunity.

SC judge calls for more women government lawyers

nupreme Court judge Justice BV Nagarathna on Saturday hailed the Dreservation for women in gram panchayats and asserted that at least 30 per cent of law officers representing the Union and state governments must be women.

Justice Nagarathna called for the elevation of competent women advocates as high court judges in order to have greater diversity on the bench. If male advocates under 45 years can be appointed to HCs, then why not competent women counterparts, the apex court judge questioned while addressing a seminar on 'Breaking Glass Ceiling: Women Who Made It' organized here by Mumbai University.

To successfully break the glass ceiling, we must not let girls and women of tomorrow be conditioned to the anachronistic lens of gender-roles and virtues. There is no virtue for success that is exclusive to men and lacks in women," she said while pointing out that younger women lack role models and mentors to inspire, encourage and help them to navigate through and succeed in the legal profession.

"It is vital that we recognise the importance of women who shattered the glass ceiling and to follow on their path. At the same time, we must remember women who may not have made headlines through high-profile achievements but whose contributions are just as significant and left an imprint on the lives of those around them," she said.

Justice Nagarathna called for elevation of competent women advocates as HC judges. If men under 45 years can be appointed to HCs, why not competent women, the judge questioned

The lives of ordinary women whose primary roles are as mothers, wives and care-givers must also be recognised, the judge said.

Their importance is not always visible but in many ways, these are the women who hold the fort for their family members to conquer the world outside. Raising children and managing households also requires a great deal of leadership, intellectual ability, and creativity," she stated.

"Even as of 2024, women held only 14 per cent of Lok Sabha seats and 15 per cent in Rajya Sabha. They occupied less than 7 per cent of ministerial positions. The benefits of women in positions of power percolate to the commercial sphere as well," the apex court judge said. Asserting that the judiciary needs to be sensitive, independent and free from biases at every level, she said while the number of women graduates from leading law schools and universities who are working at junior levels is nearly equal to their male counterparts, it does not translate to equal representation at the workplace. "Their upward mobility is hampered by systemic discrimination. Gender diversity is particularly crucial in the professions serving society, where the presence of women plays a critical role in upholding the ideal of equality and fairness especially amongst disadvantaged groups. As far as the legal profession is concerned, at least 30 per cent of law officers representing the Central or state governments must be women," Justice Nagarathna

Plea on appointment of CAG by executive before SC

The Supreme Court is scheduled to hear on March 17 an NGO's plea seeking that the current practice of appointment of the Comptroller and Auditor General of India (CAG) solely by the executive and the Prime Minister be declared violative of the Constitution.

The PIL, filed by the Centre for Public Interest Litigation, also sought direction of the court mandating that the CAG shall be appointed by the President in consultation with an independent and neutral selection committee comprising of the prime minister, the Leader of the Opposition (LoP) and the Chief Justice of India and in a transparent manner.

It said that the direction for appointment of CAG should be similar to the appointment of other bodies including Information Commissions and the Central Vigilance Commission. The PIL will be taken up for hearing on Monday by a bench of justices Surya Kant and N Kotiswar Singh.

The plea filed through advocate Prashant Bhushan contended that the present mode of appointment of the CAG, which is done solely by the executive ie by the Prime Minister who handpicks any individual and recommends his name to the President for appointment, is unconstitutional as it is violative of Article 14 and several basic features of the Constitution. "The appointment



of the Comptroller and Auditor General of India solely by the executive and the Prime Minister of India undermines the independence of the office of the CAG, suffers from grave conflict of interest and thereby is detrimental to good governance and democracy in India. It is also manifestly arbitrary, detrimental to institutional integrity and violates several basic features of the constitution," the plea said.

It said the CAG is uniquely placed in Part V of the Constitution as one of the five institutions of the Union and a collective reading of Articles 148-151 of the Constitution along with the various provisions of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 would show that the Constitution has equated the position of the CAG to that of

a sitting judge of this court. It added the current process of appointment of the CAG is by way of an unwritten convention which is alien to the law. "Neither does Article 148(1) nor does the 1971 Act envisage a procedure which is currently being followed where the executive, and specially the Prime Minister, appoints the CAG. If this were to be so, it would obviously and naturally run contrary to the entire scheme of Chapter V

(Articles 148-151) of the Constitution of India and the 1971 Act," the PIL further said.

"By the very nature of his job, the CAG is supposed to promote transparency," the PIL said, adding that if he is to discharge his duties dispassionately without fear or favour, his appointment process cannot be opaque or arbitrary. It added that the CAG acts as a watchdog over government accounts and expenditure and he plays an important role in ensuring transparency and financial accountability in the functioning of the central and state governments as well as Panchayati Raj institutions.

The NGO said the reports of the CAG are not just used for public debates, but are also an essential source of information for several parliamentary committees, for instance the Public Accounts Committee (PAC), which then uses them to scrutinise government expenditures and debate them in Parliament leading to policy making, delivery of essential services to the public, drafting appropriate and necessary legislations, and so on.

"It is for this reason that the appointment process of the CAG should be fair, transparent and non-arbitrary. Unfortunately, despite the Constitution's best intent to keep the office of the CAG independent from any executive interference, it is increasingly witnessing political interference, thereby compromising the very purpose for which the high office was established," it added.

BJP slams quota for Muslim contractors in Karnataka

◄he BJP on Saturday slammed the Karnataka decision to reserve four per cent of government contracts for Muslims as unconstitutional, alleging that it is part of the Congress' appeasement politics and will weaken the national unity.

Prasad said several demands for separate treatment for Muslims during the independence movement had finally ended up in the country's division.

On March 10, the ED raided the Baghel residence in Bhilai town as part of the probe into a money laundering allegation against his son in the alleged liquor scam case, official sources had said. Searches were also conducted at more locations, including that of Laxmi Narayan Bansal alias Pappu Bansal, an alleged close associate of Chaitanya, under the provisions of the Prevention of Money Laundering Act they said.

The searches went on for about eight hours, during which the ED seized about ₹30 Lakh cash and some documents, sources said.

Following the raids, there were unconfirmed reports that the ED had summoned Chaitanya to record his statement on Saturday. Baghel, who was present at his house during searches, has claimed that the probe agency's action was the outcome of he BJP's frustration.

The main opposition Congress had on March 11 burnt the effigies of the BJP-led Centre and the ED protesting against the action.

The alleged liquor scam, as per the ED, was orchestrated between 2019 and 2022 when Chhattisgarh was ruled by a Congress government led by CM Baghel.

The agency had earlier said the Chhattisgarh liquor "scam" resulted in "massive loss" to the state exchequer and filled the pockets of the beneficiaries of a liquor syndicate with more than ₹2,100 Crore of proceeds of crime.

The latest incident took place in the Nandlalpur village under the jurisdiction of Mufassil police station on Friday evening. "This happened when the ASI along, with other officers, had gone to Nandlalpur village to investigate a case of scuffle around 8.30 pm on Friday.

He was attacked with a sharp weapon on his head by some people involved in the scuffle during the investigation. They were in an inebriated state.

"The ASI (assistant sub-inspector) suffered severe injuries and was immediately taken to the nearest government hospital, and later shifted to Patna for better treatment," DGP Vinay Kumar told PTI.

Singh succumbed to injuries during treatment at a Patna hospital in the early hours of Saturday, he said. "A case was registered and six persons have been arrested so far. The body has been sent for postmortem examination.

When one of the arrested accused was being taken to identify other suspects, he tried to escape from custody after snatching a police weapon. He fired at policemen, but was captured by the security personnel, who opened fire in self-defence. "The accused suffered an injury in his leg,

and is undergoing treatment at a government hospital and his condition is stable." the DGP said.

A manhunt has been launched to nab the other accused.

Commenting on recent attacks on policemen in different parts of Bihar, Kumar said all police stations have been directed to assess the situation before conducting raids in various cases.

Instructions have also been issued to always visit spots of investigation with adequate number of personnel, he said.

-CP (SP) MP Supriya Sule has equated the proposed law against urban naxalism in Maharashtra with the colonial Rowlatt Act, which she alleged might be misused against individuals or organisations critical of the government, effectively creating a police raj.

Sule demanded that the government review the draft of the bill and ensure that Constitutional values are not violated.

The 'Maharashtra Special Public Security Bill, 2024' bill, which will become the first law to tackle naxalism in the state, proposes to give several powers to the government and the police machinery in combating unlawful activities.

All offences registered under this Act will be cognisable and non-bailable.

While re-introducing the bill during the winter session of the state legislature last December, Chief Minister Devendra Fadnavis had said the law was aimed at closing down the dens of urban Naxals, stressing that the proposed legislation was not against suppressing genuine dissenting voices. Sule on Saturday claimed the bill would undermine the fundamental rights of citizens.

'Through this bill, the rights of common people to speak against the government will be taken away.

In a truly healthy democracy, dissenting opinions are respected. "The principle of democracy also values opposition voices, as they ensure that those in power remain accountable and respect public opinion," the NCP (Sharadchandra Pawar) working president stated on X.

Sule said the definition of "illegal acts" seems to grant unlimited powers to government agencies in the proposed law.

"This effectively gives the government a license to establish a Police Raj, which could be misused against individuals, institutions, or organisations that express constructive opposition democratically," the Baramati MP alleged.

She said the bill undermines the very

concept of "We, the People of India". Sule said the bill would bestow

unchecked powers on the administration which could be misused to harass individuals out of sheer vindictiveness.

"Criticising government policies and decisions, peacefully protesting, or organising marches could all be deemed illegal acts

This bill disregards the principles of ideological diversity and directly infringes upon citizens' Constitutional rights," she alleged. Sule claimed the bill grants the government the power to interfere in certain judicial processes, "posing a direct threat to judicial independence".

According to Sule, some provisions of the bill encroach upon fundamental Constitutional rights such as freedom of expression, freedom of association, and the right to a fair trial.

"Historically, the British attempted to introduce a similar law (The Rowlatt Act) to suppress opposition during colonial rule," she alleged.

Sule further said the bill is a "direct denial" of core principles of the Constitution, and we strongly condemn it. We urge the government to review the draft of this bill and ensure that Constitutional values are not violated". Fadnavis had told the winter session that

a law was needed to tackle naxalism in Maharashtra since the state lacks one.

"We have IPC (Indian Penal Code) and UAPA (Unlawful Activities (Prevention) Act). UAPA is for handling cases related to terror activities," he had told the assembly. Fadnavis said Chhatisgarh, Telangana, Andhra Pradesh and Odisha have enacted Public Security Acts for effective prevention of unlawful activities, and banned 48 frontal organisations.

The bill describes unlawful activities as indulging in or propagating acts of violence, vandalism or other acts generating fear and apprehension in the public.

Indulging in or encouraging the use of firearms, explosives or other devices, encouraging or preaching disobedience to established law and its institutions is also an unlawful activity, it said.

An unlawful organisation is one which indulges in or bets or assists, gives aid, or encourages directly or indirectly any unlawful activity. Association with an unlawful organisation will see a jail term from three to seven years and a fine of ₹3Lakh to ₹5 Lakh, itsaid.

Aaharanpur Congress MP Imran S Masood has found himself at the centre of controversy after playing Holi with Hindu activists in Deoband during the festival of colours. The Ulema, the Islamic clerics, have criticised his actions, stating that a Muslim should adhere to Shariat and refrain from engaging in non-religious traditions.

Adopting non-religious traditions is incorrect from an Islamic perspective. One should repent for such actions," he stated. The controversy has sparked debate within the community, with some supporting Masood's gesture as a step towards communal harmony, while others see it as a violation of religious norms. religious adherence in a diverse society like India. However, the controversy comes at a time when Holi and Friday pravers coincided in Uttar Pradesh. In a remarkable gesture of communal harmony, Muslims in Deoband offered their Friday prayers at 2:30 pm, after Hindus had finished playing Holi. This peaceful coordination between the two communities was seen as a symbol of unity and respect for each other's traditions.

Local residents appreciated the gesture, with one community leader stating, "This act of mutual respect and cooperation reflects the true spirit of unity that our society stands for. Despite religious differences, we can celebrate peace and harmony together."

State protocol officer involved in Rao case: DRI

he Directorate of Revenue Intelligence (DRI) has stated in the court that the Karnataka Police Protocol Officer was used in the gold smuggling racket involving actress Ranya Rao

In its argument against giving bail to Ranya, the central agency told the Special Court for Economic Offences that the accused had travelled to Dubai 27 times since January this year. Ranya is the stepdaughter of DGP rank officer K Ramachandra Rao, the Managing Director of the Karnataka State Police Housing and Infrastructure Development Corporation.

The investigation till date has unearthed the sophisticated methodology used in smuggling the gold, usage of State Police Protocol Officer to bypass security, Hawala Transaction to transfer the funds from India to Dubai to purchase gold, involvement of larger syndicate," the Directorate of Revenue Intelligence (DRI) contended.

After these arguments, the court declined bail to Ranya on Friday.

Judge Vishwanath C Gowdar, who presided over the Special Court for Economic Offences, took note of Directorate of Revenue Intelligence's contentions. "In the case on hand, the accused No 1 (Ranya Rao) possessing Resident Identity Card of United Arab Emirates and having history of traveled to Dubai on 27 occasions since January 2025, is another factor which does not incline

the court to extend discretionary relief of granting bail to accused," the Court said while rejecting her bail petion.

The Directorate of Revenue Intelligence (DRI) also said the investigation was under progress to examine international links. It stated that Ranya Rao had not cooperated during the investigation in the custody.

"It is also specifically contended that the alleged offence is cognizable, non-bailable, and punishable with imprisonment up to seven years," the court observed in its order copy.

The Directorate of Revenue Intelligence pointed out that the offence committed in this case has serious ramifications affecting the fabric of Indian economy and security.

The Court said, "The remand applications placed on record at this stage of proceedings, disclose the conspiracy hatched by the accused No1 (Ranya Rao) by colluding with State Police Protocol Officer".

"The arguments of the complainant Agency as to the usage of Hawala transaction for transfer of money from India

to Dubai and also the International links being forthcoming as per the preliminary investigation is also a factor which inclines this court to hold the accused."

The Judge also said that the accused is capable to manipulate and tamper the evidences as well as witnesses, which consequently hampers the very trial in the case on hand.

"The apprehension of the complainant as to the accused No.1 will throttle the witnesses and flee away from the process of court cannot be ruled out at this juncture," the court observed.

It further stated that prima facie at this juncture, the allegations against Ranya Rao are very much forthcoming and the concealment of the gold by her in the form of gold bars while traveling is very much transpiring her intention.

Gold bars worth ₹12.56 Crore were seized from Ranya Rao at Kempegowda International Airport here on March 3 upon her arrival from Dubai, following which searches were conducted at her residence and officials said that gold jewellery worth ₹2.06 Crore and ₹2.67 Crore in cash were also recovered. Besides Directorate of Revenue Intelligence (DRI), the Enforcement Directorate as well as the CBI (central bureau of investigation) are also probing the matter simultaneously.

In addition, the Karnataka government on March 10 appointed Additional Chief Secretary Gaurav Gupta to probe the role of Ramachandra Rao, if any, in the alleged gold smuggling activity of his step daughter Ranya.

survives car crash in **Uttar Pradesh**

The incident occurred around 7:20 pm when the animal suddenly jumped in front of Tikait's vehicle, causing a heavy impact that damaged the front of the car.

Fortunately, the airbags deployed immediately, protecting Rakesh Tikait and other passengers from any injuries. Recalling the terrifying moment,

Tikait said, "It happened in a flash. Rakesh Tikait also stated that they could not comprehend what was happening. The airbags opened and

enveloped us, saving our lives." Following the incident, the Bharatiya Kisan Union leader, who played a key role in the farmers' protest against the farm laws, emphasised the importance of road safety and the use of seat belts. On getting information, Uttar Pradesh minister Kapil Dev Agarwal and Muzaffarnagar Lok Sabha Member of Parliament Harendra Singh Malik visited Tikait's residence to check on the farmer leader. Speaking to reporters at his residence, Tikait said the nilgai jumped on to the rod from the wrong side and collided with his vehicle.

"We were wearing seat belts, which gave us extra security. Everyone must wear a seat belt. Had the vehicle been smaller, and if we were not wearing seat belts, the damage could have been greater.

"My gunman sustained minor injuries. The wild animals move at a fast speed," Tikait said, as he urged people not to drive at a high speed.

The accident highlights the frequent incidents of Nilgai collisions on highways in western Uttar Pradesh, posing a serious threat to drivers and the passengers.

t will be easier said than done but senior defender Sandesh Jhingan on Saturday said that the Indian football team's target is to beat Maldives and Bangladesh without conceding any goal in the upcoming international matches here.

India host Maldives in an international friendly on March 19, before taking on a tricky Bangladesh on March 25 in their opening match of the 2027 AFC Asian Cup qualifying third round match.

Both the matches will be held at the Jawaharlal Nehru Stadium here as the Meghalaya capital is hosting its first international games. The match against Maldives on March 19 will also mark the return of talismanic Sunil Chhetri from international retirement.

"Our main aim is to get the result in the Bangladesh match, as that would give us a good start in the Asian Cup Qualifiers, and I think the 10-day training ahead of that, along with the friendly against



Maldives will greatly help us prepare for al team needs players who are in good it," Jhingan said.

"Our target is two clean sheet victories," the 31-year-old was quoted as saying in an AIFF release. The 40-year-old Chhetri had earlier hung his boots in June 2024 after a glorious international career after making his India debut in 2005.

But he showed he is still a force to reckon with as has been seen in the 2024-25 ISL which has turned out to be Chhteri's most prolific season.

He has scored 12 goals from 24 matches to be the second highest scorer overall and highest among Indians.

Head coach Manolo Marquez re-iterated the reasons behind why he coaxed Chhetri to return to wearing India jersey once again.

Fazila Ikwaput (42', 59') increased her goals tally to 15, scoring two against Odisha, while Juggernauts' striker Pyari Xaxa (32') scored an own goal. Substitute Neha (50') scored for the hosts.

After starting off the season with two draws, Gokulam Kerala have pulled themselves up marvellously, winning six matches on the trot, and are currently placed at the top of the table with 20 points from eight matches.

While East Bengal are two points behind them, they have played a match less. Odisha, on the other hand, are third, with 11 points from eight outings.

The Malabarians were at their hosts'

throats from the start, and goalkeeper Shreya Hooda had to pull off a couple of fine saves to keep her side level in the opening exchanges. She, however, got injured closer to the half-hour mark, and had to be replaced by Anshika, who's first duty was to pull off a save at full stretch off a Fazila free-kick from close range.

Gokulam had a lucky break a few minutes later, though, as R Darshinidevi's corner from the right hit Pyari's shin and went in from inside the six-yard box.

Darshinidevi played another crucial role minutes before the half-time whistle, when she threaded a through ball into the path of Fazila, who, with just Anshika to beat, coolly slotted it into the bottom corner. The Úgandan striker could have scored yet another in the first half, when in injury time, she entered the box from the left, and had her shot blocked by the Odisha custodian. The change of ends brought some much-needed tempo to the game for Odisha, as they began to pose

some questions to the Gokulam back-line. Their efforts finally paid off just five minutes after the restart, though they might have been somewhat fortunate about it.

Neha, after beating her marker on the left flank, sent in a cross that looped over the goalkeeper and crept in at the far post.

The hosts had urgency, and it showed with their actions on the pitch. Minutes after the goal, Jennifer Yeboah, receiving a pass from Kashmina, flicked it between the lines to Pyari, but the latter's effort was thwarded by Gokulam goalkeeper Payal Basude. All of Odisha's momentum was lost just before the hour mark, however, when Anshika spilled what seemed like a regulation ball right into the path of Fazila, who duly obliged, scoring her 15th goal of the season.

Odisha just could not cope with Gokulam Kerala's waves of attacks, and Fazila could have added two more to her name with a couple of close chances in the second-half injury time.

Lewis Hamilton eighth in qualifying in Ferrari debut as Norris takes pole for F1

cLaren locked up the front row in Melbourne for Sunday's Australian Grand Prix, having dominated its rivals, including Red Bull, Mercedes, and Ferrari, whose drivers, Charles Leclerc and Lewis Hamilton, will start from seventh and eighth on the grid.

Lando Norris set a searing final qualifying lap to secure pole position, his first at Melbourne's Albert Park, and milestone 10th overall, in front of his teammate Oscar Piastri, and a record Saturday crowd of 136,347 at Albert Park.

"Not a bad way to start the year, thanks everyone," Norris said on his team radio shortly after the qualifying session ended ahead of Sunday's opening race of the Formula 1 season.

Hamilton was circumspect about his qualifying finish.

"It isn't quite where we wanted to be but overall I'm satisfied with the progress we have made over the past two days," Hamilton said.

"We didn't expect to be eight- or nine-

tenths (of a second) behind pole but given this is a weekend of firsts for me, I didn't underestimate how steep the learning curve would be?

Norris went into Q3 on the back foot after his first lap was deleted for a track limit infringement at turn four, where he put all four wheels off the track. But he delivered when it mattered with his one run. "It's a tough one, because you want to take a lot of risks, especially on this track," Norris said.

"It's a track where you've got to commit and you've got to know you know what your target is and once you've turned in, you're kind of hoping for the best in a lot of cases. "Obviously I took too many of my first (Q3) lap and got track limits, so I was in a difficult position with knowing how much risk I wanted to take, but I put it together well."

And the Brit is confident he can maintain that form in the race. "I think we were decent in Bahrain, and I think we're going to be pretty good here," Norris said. "We were pretty good here last year and that was with a much worse car, so we're



going in with one target clearly, which is to have two cars at the top."

Piastri was not unhappy to be second, having maximixed his lap, which enabled McLaren to lock out the front row for the second straight race, following 2024's season-ending Abu Dhabi Grand Prix. But the Australian hasn't given up on becoming the first Australian to win his home F1 Grand Prix. "It would be really special to be able to achieve that," Piastri said.

"But, I'm not setting my sights too to firmly on that, we've got a lot of work to do (first) to try to maximize the race tomorrow - we (also) have to see what the weather does first." Day-long rain is in the forecast on Sunday.

Red Bull's Max Verstappen qualified third, shrugging off pre-season pace concerns for the team about its RB21 car.

But he downplayed his chances of challenging the McLarens in the 58-lap race on a day when his new teammate Liam Lawson qualified well down in 18th, following a scrappy Q1 lap that questioned the team's decision to replace Mexican Sergio Pérez for 2025.

Yeah, I mean, I don't expect like any kind of miracles about it," the Dutchman said. "I think it's OK but it's not on the same level (as the McLaren). But, I'll just do my best, (and) see what happens."

Mercedes' hopes of a return to form were dashed with George Russell qualifying fourth, despite strong pace throughout practice. His 18-year-old rookie Andrea Kimi Antonelli, who skipped F3 as part of his fast track through the junior categories, was a shock Q1 exit on his F1 debut and will start 16th.

Ferrari had expectations it could challenge for the title, with Leclerc starting seventh and Hamilton eighth - for a disappointing fourth row lockout that means it'll be fighting for points, not podiums, should rain not materialize.

Racing Bulls, Red Bull's second F1 team, continued to impress in qualifying - with Yuki Tsunoda securing fifth on the grid, which is his highest placing since Brazil 2024. Isack Hadjar, his French rookie teammate, put in a solid performance to start 11th.

Williams also showed its pre-season pace was real, after the British squad got both its drivers into the top-10 with Alex Albon sixth and defending Australian champion Carlos Sainz ninth.

Alpine's Pierre Gasly closed out the top-10 with his resurgent A525 car, three places ahead of his Aussie teammate Jack Doohan.

BARFF's gripping intensity and EK **MULAQAT MANTO** SE's emotional depth left the audience deeply moved and connected, says **SAKSHI PRIYA**

heatre pulls people into its world, making them forget where they are. There is no screen to hide behind, no second take to perfect a scene, only the raw, unfiltered power of storytelling. The National Theatre Festival 2025, presented by AD Pix at Shri Ram Centre for Performing Arts, brought that power to life. With BARFF and Ek Mulaqat Manto Se, the festival turned a stage into a world where emotions ran deep, and stories demanded to be heard.

Produced by Ashvin Gidwani Productions, BARFF was not just performed but also written and directed by Saurabh Shukla, making it a deeply personal vision brought to life on stage. The gripping psychological thriller was heightened by meticulous set design, evocative lighting, and an atmospheric background score, all of which intensified the eerie stillness of Kashmir's snow-covered landscape.

When Saurabh Shukla steps onto a stage, something shifts. There's a weight in the air, an energy that few actors can command. His presence alone makes an audience lean in, waiting for the storm he is about

to unleash. He doesn't just play a role; he absorbs it, bends it, and reshapes it into something only he can create.

In BARFF, he did exactly that, Set in the snow-covered landscapes of Kashmir, the play was a gripping psycho-logical thriller that questioned truth, belief, and the burden of reality. A doctor, a desperate couple, and a child suffering from a mysterious illness - these elements came together to create an atmosphere thick with tension. But what truly made BARFF unforgettable was the way Shukla carried it. His performance was effortless yet reflective, pulling the audience into a world where certainty was a luxury.

Alongside him, Sunil Palwal and Anchal Chauhan brought their own strengths, creating a world that felt eerily close, despite its distance. The cold of Kashmir wasn't felt through visuals, but through the uncertainty, the fear, and the suffocating weight of not knowing what to believe. When the play ended, there was no rush to leave. The theatre sat still for a moment, as if shaking off the spell Shukla had cast. That is the mark of a master, when even

silence speaks after he is gone.

MANTO SPEAKS, AND THE WORLD LISTENS

If BARFF was a test of belief, 'Ek Mulagat Manto Se,' was a confrontation with truth and Produced by Collective Madness. The moment Ashwath Bhatt walked onto the stage, the theatre belonged to him. There was no need for elaborate sets or grand gestures, his presence alone

was enough. For an hour and a half. Bhatt was Shahadat Hussain Manto. He spoke not as an actor but as a man who had lived through the fire of partition, who had seen the worst of humanity and refused to turn away. His words cut through the air, sharp and unrelenting. He did not perform Manto's life; he lived it. Every glance, every shift in tone, carried the weight of a writer who wrote not for applause but because silence



She had planned a short getaway with a colleague, but they backed out the night before their trip. Instead of canceling, she chose to go alone and face her fear of solo travel

Growing up in a typical South Indian family, she was raised in a sheltered environment where travelling alone was never an option. In our society, women are often expected to have a man beside them for safety. Talking about the same, she told the Pioneer, "I have lost count of the times I've been asked, How does your boyfriend or husband allow you to travel alone? This always amuses me because I am single. Even today, the idea that a woman needs a

man for protection or requires permission to travel solo reflects how deeply these biases are ingrained. Challenging these stereotypes has been

just as much a journey as the travel itself. She further added that, "You won't believe that sitting alone in a restaurant while traveling still gets me strange looks in certain places. In some cultures, a woman dining alone is considered lonely or inappropriate, added Raksha. During my 6 week solo trip around Europe, I was stranded in Moldova at 3 AM and random taxi driver helped me safely to a nearby hostel. The freedom to do what I want makes solo travel so empowering. 
She further added that she has



asyTiger is a heartfelt labour of love by Mrs Meeta Ahuja. Born in Thailand and later settling in India after marriage, she brings to the table the very flavours she grew up with. 


